SYSTEMWIDE GRANTS ANNOUNCED/TELECONFERENCE OFFERED

The Academic Programs Office has received a request for proposals for grants being offered by the CSU Academic Program Improvement (API). The three categories for 1990-91 projects include: Improvement of Teaching and Learning, Campus Community and Student Retention, and Curriculum and Faculty Development for a Multicultural University.

Dr. Jerrold Pritchard, associate vice president for academic programs, explains the significance of the program. "It's an

opportunity for us to gain access to larger grants for projects that have been deemed of systemwide importance and the categories have become increasingly broader throughout the years." According to Pritchard, there's about \$600,000 in the systemwide pool of funds. One grant may average up to about \$40,000.

As a new aspect of this year's program, the API will sponsor a televised workshop to assist grantees in developing their proposals. The teleconference is scheduled for 10

a.m.- 12 noon, Friday, Dec. 8 in Room 87 of the Pfau Library. Viewers will have opportunities to ask questions about project eligibility, budgets, review criteria and other subjects.

Information regarding the grant proposals is available from the Academic Programs Office and from school deans. The requests for proposals contain background information on each category as well as guidelines and procedures for submitting the proposals. All proposals must be submitted to the Academic Programs Office by Thurs-

day, Feb. 15. They will be screened by the campus Committee on Quality of Instruction prior to being forwarded to the Chancellor's Office.

Rymer added that she is looking forward to working with a very fine search committee and to bringing some excellent candidates to the campus.

PRISON SITE SELECTIONS EXAMINED

The controversial issue of prison site selections was examined Thursday, Nov. 30, on campus during the first of two regional symposiums. The program was jointly sponsored by our Criminal Justice Department and the Sociology Department of Cal State, Humboldt. It was designed to bring together members of various state and county groups that have an interest in this topic.

According to Dr. Frank Williams III, Criminal Justice Department chair, "The thrust of the commentary was impact studies for potential prison sites. We anticipate that an

awareness and understanding of differing viewpoints will serve to facilitate future site selections and assist policy development.

"As the number of correctional facilities grows, we believe that information developed in the symposia will be valuable to communities, governmental bodies, agencies and citizens' groups," continued Williams. "To this end, the various views and positions expressed in the symposia will be compiled and summarized in a document which we will make available to interested persons and agencies."

NEWS FROM THE CHANCELLOR'S OFFICE

Enrollment in The California State University system has now surpassed 360,000 students according to figures released by the systemwide division of analytic studies. Fall enrollment for the 20 campuses stands at 360,784. This represents an increase of 5,678 students over the fall 1988 enrollment figures.

"This gain continues a trend that is remarkable in higher education," said CSU Chancellor W. Ann Reynolds. "In the past five years, the CSU has added more than 44,000 students. This occurs at a time when enrollments at many universities have flattened or even declined."

As enrollment increases, so have voluntary gifts. According to figures released by the systemwide University Development Office, gifts to CSU campuses reached a record \$65 million in 1988-89.

"Contributions from corporations, our alumni and the general public are extremely important to our success," said Reynolds. "The growth we've seen in giving is very heartening. It is making it possible for the CSU to grow in important areas and to deliver services that bring great distinction to our university."

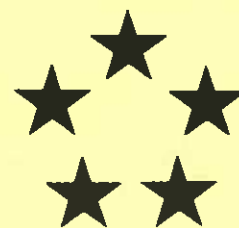
