**Subject:** COVID-19 Testing Sites in San Bernardino and Riverside Counties

In an effort to provide more testing opportunities, community drive-through sample collection events are being held throughout San Bernardino and Riverside counties at various locations and times.

The specific intent of these events is to only test those individuals exhibiting recognized symptoms. Please remember, if you are showing symptoms of COVID-19, you can still call your doctor and they can determine if you need testing.

At the testing sites, samples will be collected by public health officials by inserting a nasal swab up the nostril. The samples are then sent to a laboratory for COVID-19 testing.

In San Bernardino County, community drive-through sample collection events are currently being planned for Twentynine Palms, San Bernardino and Victorville. Additional events and event details will be announced as they are confirmed.

#### San Bernardino County

Upcoming Community Drive-Through Sample Collection Events in San Bernardino County are at:

- Big Bear Lake – Fox Farm Lot, 41850 Garstin Drive., Friday, April 17, 10 a.m. to 2 p.m.
- Joshua Tree – Copper Mountain College, 6162 Rotary Way, Wednesday, April 22, 10 a.m. to 2 p.m.
- Rancho Cucamonga – Rancho Cucamonga Quakes Stadium (LoanMart Field), 8408 Rochester Avenue, Monday, April 27, 10 a.m. to 2 p.m.

At all three locations testing is done by appointment only. Details will be announced. The locations are also posted at the San Bernardino County COVID-19 Response Community Drive Through Events webpage, <http://sbcovid19.com/community-drive-through-events/>.

#### Riverside County

In Riverside County, the testing sites are at:

- Perris – the Perris Fairgrounds, 18700 Lake Perris Drive, Tuesdays through Saturdays.
- Indio – Riverside County Fairgrounds, [46517 Arabia Street](#), Tuesdays through Saturdays.
- Lake Elsinore – the Diamond Stadium, [500 Diamond Drive](#), Sundays through Thursdays.
- Riverside – Harvest Christian Fellowship Church parking lot, [6115 Arlington Avenue](#), Tuesdays through Saturdays.

The testing times at the four locations are from 9:30 a.m. – 3 p.m.

Those who want to be tested in Riverside County must have symptoms and have an appointment before showing up at the fairgrounds. For appointments call 800-945-6171. Drive-ups without appointments cannot be accommodated. Visit <https://www.rivcoph.org/coronavirus> for additional information.
