MRS. EVANS ELECTED STAFF COUNCIL CHIEF

Mrs. Robert (Jody) Evans, Secretary to the Chairman of the Humanities Division, has been elected the first chairman of the new Staff Council.

Jesse C. Rowe, Stationary Engineer in the Physical Plant office, has been elected vice-chairman.

Mrs. Howard (Mary) Dye, Secretary to the President, has been elected secretary.

The officers were elected this week. The Staff Council set 3:30 p.m. on the second Wednesday of each month as the standard meeting time.

VOTER REGISTRATION DEADLINE IS THURSDAY

All new voters, or persons who have moved since they last voted, or persons who failed to vote in November, 1966, must register if they wish to vote in the November general election.

The deadline for registration is midnight Thursday, September 12. San Bernardino County residents (who have lived in California at least one year effective November 5, 1968) can register to vote in Room A-196 between 9 a.m. and 5:30 p.m.

Newcomers to California, who have not lived in the state at least a year as of November 5, can vote for presidential electors only. Newcomers cannot register on campus; they can only register in person at the County Registrar of Voters Office, 646 North Sierra Way, San Bernardino, prior to midnight Thursday, September 12.

College offices will be closed on Admissions Day, Monday, September 9, which will be observed as an administrative holiday for all employees working regular hours.

INSURANCE ENROLLMENT DEADLINE IS EXTENDED
