Parkview Hospital to Host Health Care Forums

Parkview Community Hospital Medical Center will host two interactive health care forums where residents of Riverside can discuss the community's health care future and concerns with some of Riverside's top health care leaders.

One forum will be conducted in English, the other in Spanish. The

first, English speaking forum is scheduled for Saturday, Oct 3 from 4 - 6 p.m. at the Ramona High School Auditorium, 7675 Magnolia Avenue, Riverside. The second, Spanish speaking forum, is scheduled for Sunday, Oct. 4 from 1 - 3 p.m. at the Ismael Villegas Community Center in Casa Blanca, 7260 Marguerita Street, Riverside. Both forums are open to anyone in the community.

"As Riverside's only community-based, non-profit hospital, Parkview has a commitment to listen to and serve the owners of this hospital - the citizens of Riverside," said Norm Martin, President and CEO of Parkview Community Hospital Medical Center. This forum serves as a two-way teaching, tool - the community learns more about the challenges facing health care in the

Heart Attack Claims Young Riverside Woman

Shock has verberated throughout Riverside, Loma Linda, San Bernardino, Los Angeles, Switzerland and other areas of the nation and world who have been touched by Susan Allen Williams.

Williams, 43, died suddenly while having dinner with her husband, Anthony Williams DDS, last Sunday in San Diego. She died of an apparent heart attack and had no prior health problems.

Williams, the daughter of the well known former insurance agents and now, owners of Pacific Hospice International, Al and Barbara Allen of Riverside, was a graduate of Riverside Poly High School, Cal State, San Bernardino and received her Juris Doctorate from Western Law School.

She will be laid to rest on Monday, 11:00 a.m., September 21, 1998, at Forest Lawn in Glendale. Funeral services will be held in the Vallejo Drive Seventh Day Adventist Church, 300 Vallejo Drive, in Glendale.

Who is this woman who summons heads of church to cancel or postpone meetings in Brazil or Australia? "She is a wonderful human being. Thoughtful, respectful and so special," said her loving mother Barbara, who feels for any parent who has gone through or may ever have to go through the pain of death to a son or daughter. "She just had a physical and everything was alright," said her mother. One of the national leaders of the Seventh Day Adventist Church was scheduled to be in Brazil but postponed his meeting to fly to Los Angeles. Pastor Dawson of Los Angeles had just arrived in Australia when he heard, he boarded the next flight to be with the family.

"Williams affected everyone she met," said Michael Teer, Broker/owner of Teer One Properties and President Elect of the Inland Area Realtors Association. "I've known the family for 20 years, they are forthright and taught their daughter well. They are a major asset to the community, I'm so sorry to see them go through this difficult time," he said.

It is ironic that Williams was an attorney for Loma Linda's Cardiac Heart Transplant Department. It was her job to prepare the necessary legal documents to facilitate the heart transplants. She loved her job.

Born into a military family, in Omaha Nebraska, Williams lived with her mother and other siblings until her father returned from the Korean War. She was educated much of her school years in Italy and Germany. She spoke fluent German, Spanish, Italian and of course English.

"She was my baby, I was there when she was born," said Addie Brandon her aunt. According to Brandon,

Ken Starr Goes After President

Outrage at Ken Starr's report found on the internet marks the feelings of some Black Voice readers. Meanwhile, the Black Caucus takes the leadership role of comforting the First Lady Hillary Clinton.

Independent Counsel Starr's report of over 400 pages is found on many sites on the ever growing worldwide web. Black Voice readers heard the sordid details on television and radio talk show programs, and the more they heard the less they wanted to tackle the issue and much less read the report.

The Black Caucus, led by its Chair Congresswoman Maxine Waters, reportedly gave Hillary welcomed support. Since that time other women's groups have come forward to rally around her.

Black Voice readers were not fully aware of the support of the Black Caucus but gave their own insight into how violated they felt the First Lady must be.

They overwhelmingly felt that President Clinton was good for the masses in the country. Most readers felt his relationship with Black people was more of an issue than anything else. Some even went so far as to believe that Ken Starr and Clinton's mean detractors set him, (Clinton) up, with Monica Lewinsky.

The report reads not like a statement of facts but a

statement of "he said, she said" in testimony in front of a grand jury. Starr and Congressional representatives have made a mockery of that process, which, by its very nature is supposed to be secret.

Readers did not condone Clinton and Lewinsky's behavior but the underlining comments were that Lewinsky was put up to do just what she did because Starr couldn't get anything else on Clinton.

Local attorney Chris Levister and her husband Dr. Ernest Levister agreed that what happened was wrong but that what Starr did was "reckless". "The act was not impeachable. He (Starr) didn't even give a copy of the charges to Clinton's lawyers. They had to get them off the internet. That is reckless," she said. The sad thing is because of her (Monica's) immunity she will get away with what she did. "She has committed some incredible sins; Ken Starr allowed her not to be accountable. She was clearly on a mission and she humiliated Hillary and her daughter."

Ernest Levister, President of the Vines Medical Society said one should remember Starr is a former tobacco lawyer and in his (Starr's) vicious pursuit of President Clinton he has misused taxpayer's dollars. "He has abused his office, and the graphic details only served to further humiliate First Lady, daughter Chelsea and tears at the fabric of our nation."

Pastor Al Smith of St. Paul A.M.E. was concerned with finding the real reason Starr was so bent on getting Clinton for anything. "What's the real issue? Is it Lewinsky, Tripp or sin, is it racism jealousy or envy? [I believe this enter episode is] based on the number of women, Latinos and Blacks placed in key positions or the fact that his first prayer breakfast was held in an A.M.E. (Black) church. Is it based on the fact that [Clinton's] daughter called Rev. Jesse Jackson for spiritual counseling or the media showing Vernon Jordan as a best friend. What's the real issue?" he said.

Nikki Ott, a reader and a dressmaker who happens to be Anglo, feels the president is like anyone else, he got into trouble. "I don't feel he is that different than anyone else, I'm sorry he got into trouble but now others are coming out admitting their sins. He needs to be left alone," she said.

Rev. William Dunston formerly of Rialto now of Alabama called to say give Washington, Ken Starr and the Republican Congress a message. "He is a great President, doing a great job. You have disgraced America by taking Clinton's personal life out of context," he said.

The message to Starr and Congress sums up those we spoke with and interviewed.

Dr. Levister said "All America must now forgive-heal, and move on- ENOUGH IS ENOUGH." Rev. Dunston said, "get on with the business of running the country." Chris Levister wants Starr and the reckless detractors to stop trying to sway public opinion with the smut he wrote. "People are confused about morality. They didn't worry about his civil right being violated," she said. Rev. Smith sums it up. "He confessed and asked for forgiveness. Even the Lord accepts that!"

Community Action Planning Program A Huge Success

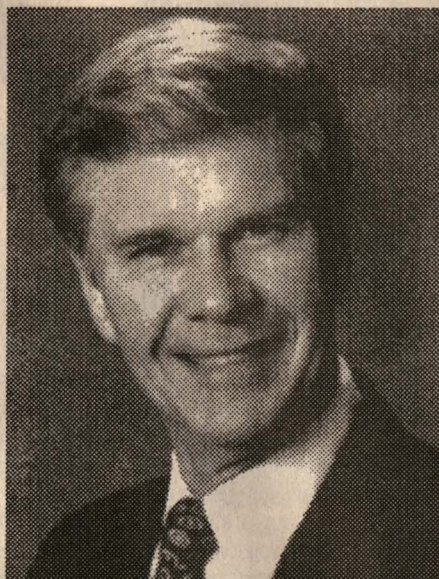

PALM SPRINGS

Surveying a spacious meeting room at a Palm Springs hotel filled with participants involved with a recent Community Action Planning Conference, Dr. Dave Long, superintendent of the Lake Elsinore Unified School District, was amazed at what he saw.

"At the same table, you had a police chief, a student and a business leader sitting together working out ways to solve problems in the community," said Long, who created Community Action Planning and brought it to the Lake Elsinore school district in 1993.

Community Action Planning is based on the assumption that the entire community is the education institution for our children. That singular purpose draws a diverse group of community leaders -- from business, local government, law enforcement, the clergy, health youth care, education -- as well as parents and students to the CAP summer conferences.

During the conference, participants plan projects to benefit the community and its youth.

"It's a fantastic process," said Sonja Wilson, president of the Lake Elsinore Unified School District Board of

Trustees and Secretary/Treasurer for the National Caucus of Black School Board Members. Wilson is currently working with volunteers trying to provide better public transportation for young people in the Lake Elsinore area.

"I go to CAP because it is an opportunity for the entire community to come together, put our ideas on the table and work together to make them happen. It's been very effective. I have seen this community change because of CAP."

The most recent CAP conference held July 19-21 in Palm Springs drew the largest crowd ever -- 171 community leaders -- more than twice the number who started the process in 1993.

Long points out that the school district is the lead agency for CAP because it takes in so many diverse communities -- the cities of Lake Elsinore and Canyon Lake, and the Wildomar, Cleveland Ridge and Horsethief Canyon areas.

"Through CAP, the walls between cities, agencies and organizations come falling down," Long said. "It works because people build relationships, and those relationships are very powerful."

This year, the number of students participating rose to 28. Students share equally with adults in planning projects.

CAP participants have committed to

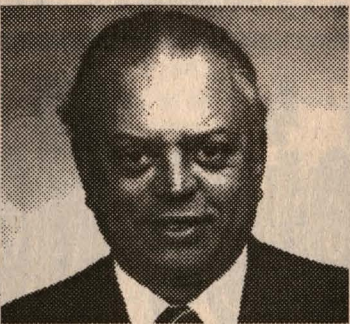

Family Talks

"It is their own fault" say racists about the present state of Native and Afro-Americans. This reminds me of a bullfight where picadores enter the arena on horseback and stab the bull several times in the neck and shoulders. The resultant bleeding makes the bull weak and tired. After most of the bull's fight is gone, then the matador challenges the bull. This is not a level playing field for the bull. Similarly, where Blacks and Indians have been nearly bled to death by racism, one can hear the "self-made man" and racists shout out: "It's your own fault that you are no better off." Welfare is typically cited as a main cause, not only of the Negroes' problem, but also of this country's troubles. Neither of these statements is true. Welfare is a symptom, not a cause. The place to look for causes is at the bringing to this country of slaves who had Nothing in Common, brain-

washing them, beating them down, ensuring that they had no reading, writing arithmetic, or manual skills, and then turning them loose to fight the matador.

By racists ignoring such handicaps and projecting blame on to their victims makes it easy to justify discrimination in overt tempered, masked, and concealed ways. Overt discrimination actions are open expressions of hatred, as with violence. The media frequently informs us of periodic "hate" crimes. Tempered actions present as segregation or appeal to prejudices. For example, politicians, by capitalizing on popular feelings of people's prejudices, maintain their own popularity with the dominant voting public. Some may accept an anti-prejudice principle, such as "live and let live," but make exceptions by rationalizing that "the Negro problem" does not let it happen. Or, if they read of some good story that conflicts with their prejudice they may regard it as not true to life.

Masked discrimination is like "smiling in your face while stabbing you in your back." For example, when a racist is interviewing an out-group job applicant, the interviewer is likely to spend less time, maintain a greater physical distance, and be

less outgoing in an easy way. Meanwhile, the interviewer is either grinning inappropriately or engaging in a stereotyped mode of deteriorated errors in pronunciation and grammar. Rudeness and gossip are other masks.

Concealed discriminations often show as unspoken or unwritten rules. For example, out-group job applicants, who are prejudicially not expected to do well, may not be given the opportunity to demonstrate their skills and qualifications to the best of their ability. On the other hand, outstanding out-group employees may advance only up to the Glass Ceiling -- a barrier so subtle as to be transparent; yet so strong that it prevents moving up on the management totem pole. From beginning to end, there are always problems of Wage Discrimination whereby salaries are likely to be lower than for white (male) counterparts. To believe that all four forms of discrimination are justified because it is the victim's fault is to enter the realm of mental illness!

invent their own designs. Specially-trained monitors in the Exhibits Hall will be present to assist visitors in making their ideas become reality.

Readers, What's On Your Mind?

VACCINES

New vaccines are being introduced that could prevent your child from a disabling life-threatening disease. Because health plans will not reimburse the physicians for the costs of immunizations given to children, our children may be at unneeded risk of a life-threatening disease.

Unfortunately, in many cases, when these new vaccines become available, reimbursement -- the physician's capitation rate -- from the health care plan or HMO to the physician, does not become available to reflect the added cost of these life saving vaccines. Capitation is a common form of payment in which a health plan provides a prepaid sum of money to a

physician or physician organization to provide health care to a group of patient.

Fortunately, the California Legislature is working to fix this inappropriate behavior of some health plans. AB 1053 (Thomson) will require health care plans to augment provider reimbursements for new childhood immunizations. This will require plans to cover all life-saving, medically necessary vaccines, and prohibit plans from including vaccine costs within

capitation rates, saving the capitated amount of money for other additional care our children may need.

Immunization makes sense, saves money, and most importantly saves our children's lives. Please contact Governor Wilson and urge his support of AB 1053. It's for our children.

To Be Equal

Those Americans who have viewed that American institution, the census, as largely the quiet province of statisticians, are about to discover how contentious counting -- and not counting -- numbers can be.

This week a special three-judge panel of the U.S. District Court in Washington ruled that the federal Census Bureau can't use a proposed new method of counting to conduct the decennial count of the American population in the year 2000.

The Clinton Administration wanted to use a method known as statistical sampling -- an approach that combines the traditional house-to-house attempt to count every person in a neighborhood with a simultaneous sample of 10 percent of households in that neighborhood. By comparing the two results, the Census Bureau claims it can estimate the characteristics and numbers of people who are missed and provide a more accurate total count.

But that proposed new approach generated bitter opposition from Congressional Republicans. They argued that the Constitution

requires "an actual enumeration," or head count, of every U.S. resident. Their opposition led to the lawsuit and the court decision.

Congressional Republicans had argued that the new approach was unconstitutional because the Constitution calls for an "actual enumeration" -- a head count -- of American citizens.

The three-judge panel sidestepped the constitutionality question, declaring instead that the Census Bureau had wrongly interpreted the federal law regarding taking the census.

For its part, the Clinton Administration reacted to the court decision by immediately filing notice to have the issue heard by the U.S. Supreme Court.

no one should think the issues in this dispute are minor or hard to fathom. This battle is about power and money -- and race and ethnicity.

In 1990, when the Census Bureau used the traditional method of trying to count every person in a neighborhood, some of the counts were significantly skewed: Census counters missed 8.4 million people. In addition, they counted another 4.4 million people either twice or in the wrong neighborhood of residence.

Since the Census count is used to, among many other things, apportion political districts and distribute federal monies, undercounting or over-counting people in particular areas can have a significant impact on political-party fortunes in state legislatures and the Congress itself. And it can also determine how much federal aid a locality does -- or does not -- get.

However, the issue of who was "under-counted" and who was "over-counted" when the traditional

head-count method was used for the 1990 census is even more sensitive.

Most of the 8.4 million people who were missed were African Americans in inner cities and Hispanic Americans in California, Texas, and New Mexico. Most of the 4.4 million who were counted twice were college students and affluent Whites who owned more than one home.

Statistical sampling, in other words, would increase the number of Blacks and Hispanics counted, which would help the Democrats and could shift money and political clout away from wealthier, mostly White districts.

That's part of the political calculus at work in the debate.

But there's a larger issue here also, one which is the foundation of our support for the use of the statistical sampling approach: It is that every American citizen ought to count -- and therefore ought to be counted.

The Census predicts that if it

uses the traditional way of trying to count every individual head -- an estimated 275 million in 2000 -- it will miss about 5 million people.

If that comes to pass, there's no reason to think Blacks and Hispanics and the poor won't make up the disproportionate share again.

As I wrote in a recent column, all Americans deserve to be counted in the Census. Their being made visible is the very foundation of democracy. That point should especially resonate with African Americans -- whom others sought for so long to make invisible, as far as democracy was concerned.

The concept of "actual enumeration" cannot be used to glibly rationalize the current process -- which by guaranteeing an undercount of America's African-American and Hispanic-American citizens effectively robs Blacks and Hispanics as groups of their rightful place in the American nation.

That's disenfranchisement, no matter how you describe it.

P. P. Brings Emergency Contraception Closer to Home

Women can receive emergency contraception packets from Planned Parenthood of San Diego and Riverside Counties in advance, without having to wait for an

emergency "EC-to-Go" -- contains emergency contraceptive pills and instructions that women can keep at home "just in case." "Our aim is to make sure every woman knows about emergency contraception and has it available when she needs it," said Mary Fjerstad, Vice President

of Patient Services.

A July 2, 1998 study published in *The New England Journal of Medicine* showed that women given emergency contraceptive pills to take home used them safely, effectively, and responsibly, and had fewer unintended pregnancies than

women who didn't have access to the pills at home. Ready access to emergency contraception did not lead women to change or diminish their use of their regular birth control method.

"We are working to reduce unintended pregnancy and the need for abortion here in San Diego," said Mark Salo, CEO. "Over 50% of all pregnancies are unintended and there is only a 72-hour window

during which we know emergency contraceptive pills are effective in reducing the risk of pregnancy. We're offering "EC-to-Go" to make sure women can get the pills in time to make a difference."

this year, including a new group working to build a community center, another organizing church youth groups to perform community service and a third working to motivate middle school students to succeed academically.

They join an impressive lineup of continuing CAP committees that have built a teen center in Canyon Lake and a parenting center in Lake Elsinore, brought an award winning We Tip crime reporting program to the school district and staged a number of graffiti removal programs.

Other CAP participants are continuing with a successful Youth Court, which diverts young first-time offenders from the juvenile justice system, and put on a "Unity in the Community Parade" highlighting local youth organizations and educators. The first parade drew 2,000 participants

and more are expected this year on Nov. 14.

CAP participants raise funds needed to complete projects. In some cases, they have been especially creative, said Steve Wallace, a local business owner who heads up the Fix It-Together Committee. The group organizes teenagers to fix up homes belonging to local senior citizens.

On one project, volunteers were just two days away from a work day but still had no paint. "We called Centex homes [a local Lake Elsinore builder]," Wallace said. "They said they didn't have any spare paint, but they gave us gift certificates for Home Depot. We went to Home Depot and got the paint. The lady who owned the house couldn't believe it when it was done."

This year CAP is reaching out to local businesses for more support. A new committee, Marketing and Public Relations, has just finished a

video promoting CAP that will be shown to business organizations and service clubs.

Tammy Fruin, first vice president of the Lake Elsinore Valley Chamber of Commerce and Business Development Officer for the Bank of Commerce, was impressed by her first CAP conference.

"It was a great experience," Fruin said. "It was nice to see 171 very positive people working together."

Long has helped a half dozen communities in California and other states beginning the CAP process and earlier this year was asked to present information on CAP during the National School Boards Association Conference in New Orleans. County Proclaims National Food Safety Education Month

SAN BERNARDINO

San Bernardino County Board of Supervisors is joining with federal government, industry and consumer organizations to proclaim September as National Food Safety Education Month (NFSEM).

The Division of Environmental Health Services has developed a free education kit for junior and senior high school students including a video, curriculum and classroom poster. "We want to teach students that we all play an important role in ensuring the safety of the food we eat," said Richard Sanchez, Food Protection Program Manager. "We are working to

increase public awareness that an invisible cause of foodborne illness -- bacteria -- may move onto food from hands or kitchen utensils and surfaces. The simple step of frequent hand and food-contact surface washing with hot soapy water is one of the most effective means of preventing foodborne illness," said Sanchez.

The Center for Disease Control found that poor personal hygiene was a contributing factor in over one-third of foodborne illness in which contributing factors were reported. "The curriculum and video will reinforce these concepts," he added.

There are 4 important steps consumers cantake to keep food safe from harmful bacteria.

• Clean - Wash hands, utensils and surfaces with hot soapy water before and after food preparation.

• Separate - Keep raw meat, poultry, eggs and seafood and their juices away from cooked food.

• Cook - Cook food to the proper internal temperature. Check for doneness with a food thermometer.

• Chill - Refrigerate or freeze perishables, prepared food and leftovers within two hours. Set refrigerator temperature at 40°F and freezer unit at 0°F.

Food safety questions can be directed to the local Environmental Health Services office.

These measures are not just for September but, also for everyday in the year.

Dear Dr. Levister: Why did my ear lobe form a scar after using earrings?

A Concerned Black Female

Dear Concerned African Americans and many other dark complexion individuals are prone to form keloids. These are smooth, thick, elevated scars that develop after a cut, burn, vaccination and yes even after insect bites in some individuals. They are unsightly at times painful protrusions that can appear anywhere on the body.

Physicians have not yet dis-

covered why darker complexion individuals are prone to this unsightly dermatological nuisance. They are ways to prevent the scars from developing and once they form to smooth them over.

Keloids run in families. Protect your skin from trauma. If you get a cut or scrape let it heal normally. If you are keloid prone avoid custom jewelry. Allergic reactions to nickel alloy or other alloys can cause inflammation eventually leading to keloids.

Black's men's tightly curled hair is prone to razor bumps that can develop into very hard to treat keloids. Consider removing your hair with a depilatory cream or telling the barber to use clippers not razors to give you a friendly shave.

If surgery is planned and keloids run in your family tell your surgeon as he can inject anti-inflammatory steroid medicine in the incision site at the time of or following your surgery.

Sleep Loss

Treatment of keloids is easier when they are forming. Treatment varies between physicians but in most instances some form of steroid application or injections are used to flatten or shrink the scar. Large keloids can be removed with the scalpel or laser then followed up with steroid injection.

If your are afflicted discuss it with a physician skilled in dealing with keloids.

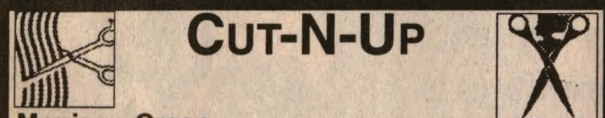

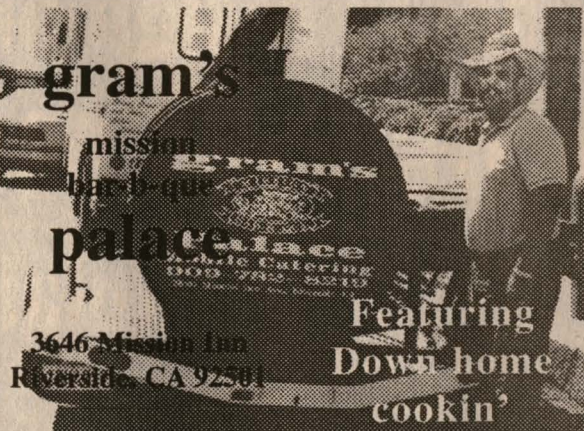

Muslim Discrimination in U.S. Increases

An organization which oversees the interests of Muslims in the United States says there has been a 60 percent increase in anti-Muslim discrimination this year compared with 1997.

A 60-page report released by the Washington-based Council on American-Islamic Relations (CAIR) details more than 280 incidents and experiences of anti-Muslim stereotyping, bias, harassment and violence.

The Council, which was established in 1994, says that although there was a 60 percent increase in discrimination cases, there was an overall decrease in acts of violence against American Muslims. The drop is attributed to the absence of such events as the Oklahoma City bombing in 1995 or the downing of TWA flight 800 in 1996 -- both of which triggered anti-Muslim violence in the United States.

"The trends documented in the report indicate that discrimination is now part of daily life for American

Muslims," says Mohamer Nimer, director of the CAIR's Research Center and author of the report. "This troubling phenomenon is no longer limited just to times of crisis."

The anti-Muslim incidents, he says, includes vandalism of an Islamic display on the White House Ellipse, termination of Muslim women employees who wished to wear a religiously-mandated head scarf and problems encountered by Muslims who must offer their prayers during work of school hours.

Currently, the total U.S. population of 270 million includes six millions Muslims. Islam, which has about 1.2 billion adherents worldwide, is one of the fastest growing religions both in the United States and in other regions of the world.

Eighty percent of the incidents in the United States took place in 15 states where the Muslim population is concentrated: California, New York, Illinois, Pennsylvania, Virginia, Maryland, New Jersey, Michigan, Ohio, District of Columbia, North Carolina, Florida, Tennessee, Texas and Georgia.

In December last year, a swastika

was spray-painted on a star and crescent display at the White House Ellipse in Washington, D.C.

The incident took place one day after the display was set up -- for the first time ever -- to mark the end of the month of Ramadan.

In Falls Church, Va., early this year, a supervisor told a Muslim employee: "If you weren't fasting here, you'd be

in Algeria blowing up people."

In Chicago, a law firm immediately replaced a Muslim employee after she refused to take off her head scarf. An investigation by the U.S. Equal Employment Opportunity Commission found the company in violation of the 1964 U.S. Civil Rights Act.

Nimer told IPS that every single

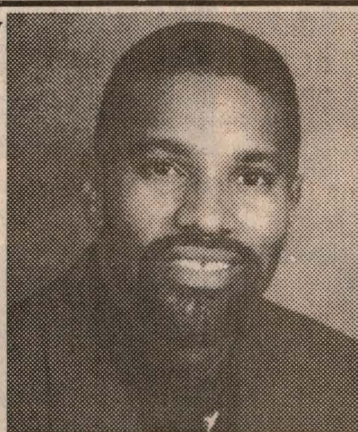

case was "verifiable and well-documented." The incidents documented in the report, he said, took place between March 1997 and March 1998.

"We want to raise the standards of discourse on minority rights in this country," he says.

Nimer says the dissemination of accurate information about Islam, coupled with increased social and political activism on the part of American Muslims, is the only solution to the problem.

The report, titled "Patterns of Discrimination," points out that many of the anti-Muslim incidents were due to ignorance of Islam, a general bias

against religious sentiment or outdated corporate policies that do not reflect increased religious diversity in the workplace.

The report is the third in a series published annually by CAIR which began documenting anti-Muslim incidents following the 1995 Oklahoma City bombing. The bombing set off several anti-Muslim incidents because of rumors that it was the handiwork of "Arab and Muslim terrorists."

The bombing was eventually attributed to individuals with ties to right wing U.S. militia groups -- with no links to either Muslims or Islam.

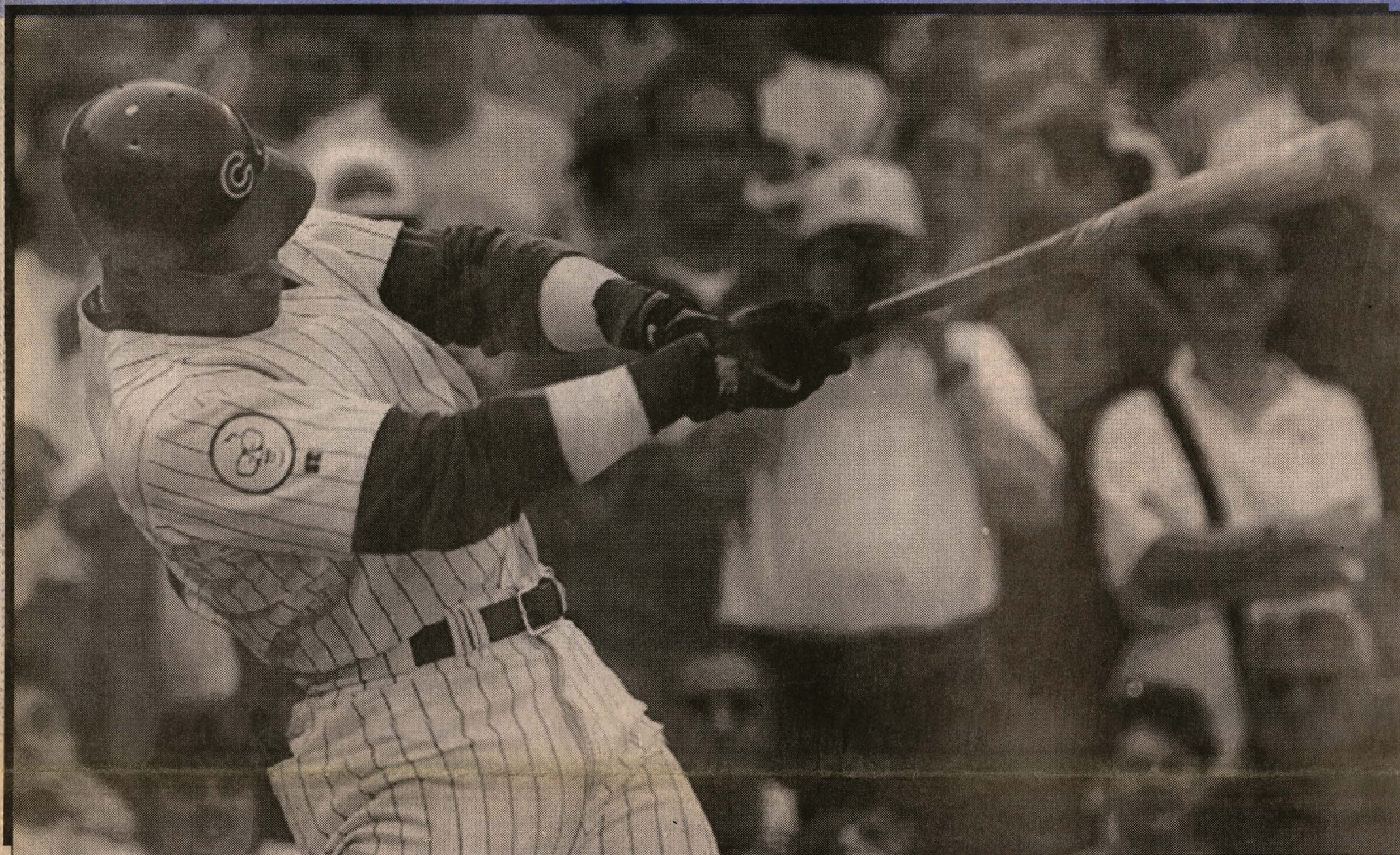

Sosa Passes Maris, Ties McGwire with 63rd in San Diego

Sammy Sosa wasn't the first to pass Babe Ruth and Roger Maris. So what?

Now he has caught Mark McGwire and rekindled this remarkable race for one of the most glamorous and prestigious records in all of sports.

Sosa hit his 61st and 62nd homers Sunday, sending tears streaming down his cheeks and Wrigley Field into euphoria.

Then the man who once sold fruit, shined shoes and washed cars in his native Dominican Republic promised that "this is not over yet."

"I'll let you know when the year is over," Sosa said when asked how many he thought he could hit.

And after four homers in three days against the Milwaukee Brewers, his favorite pitching staff for long balls, Sosa might indeed be ready to jump ahead of McGwire.

Hours after Sosa's stunning performance, McGwire was removed from a game at Houston because of back spasms.

McGwire is 1-for-14 since breaking Maris' record with No. 62 last Tuesday night against the Cubs in St. Louis.

"It's awesome, outstanding," McGwire said of Sosa. "I've been doing this for the last few years with Ken Griffey. We go back and forth.

"We've got until the 27th of September. I don't think you have to be a rocket scientist to figure out it's not over. I never once thought that was it."

When the Cubs beat the Brewers 11-10 on Sunday on Mark Grace's two-out homer in the 10th, Sosa stood in the on-deck circle, denied another at-bat and shot at No. 63.

"I thought pretty much the home run race was going to be McGwire's. But when my buddy gets hot, he can hit them in a hurry. And he proved that," Grace said after jokingly apologizing for robbing Sosa of another at-bat.

"I just hope Sammy gets the attention he deserves. Not only has he hit 62 homers, but he has carried us. He is without a doubt the MVP of the National League."

Sosa, who trailed McGwire 24-

9 in late May, homered off Bronswell Patrick in the fifth inning, sending an 0-1 pitch 480 feet into the street behind the left-field fence. He hit another 480-foot homer in the ninth, a solo shot off Eric Plunk.

That one dropped Babe Ruth into fourth place on the single-season list with 60, which he hit in 1927. Maris passed that mark with 61 in 1961. Now, amazingly, a record that had stood for 37 years has been passed twice in less than a week.

"It's unbelievable. It was something that even I can't believe I was doing," Sosa said after his ninth and 10th homers off Milwaukee pitching. "It can happen to two people, Mark and I."

With tears and sweat running down his face as he sat in the dugout after his second triumphant tour around the bases, Sosa came out for three curtain calls. Fans littered the field with paper cups and other debris while chanting "Sam-mee! Sam-mee!" causing a delay that lasted six minutes.

"I don't usually cry, but I cry inside. I was blowing kisses to my mother, I was crying a little

bit," Sosa said.

"I have to say what I did is for the people of Chicago, for America, for my mother, for my wife, my kids and the people I have around me. My team. It was an emotional moment."

Randy Maris, one of Roger's sons, phoned to congratulate Sosa.

"He wished me good luck and said he was going to watch me," Sosa said.

Commissioner Bud Selig, who was in St. Louis last week for McGwire but not at the Cubs game, also phoned. The Rev. Jesse Jackson and comedian Bill Murray were at the game to offer congratulations.

Fans stayed in Wrigley Field long after the game. Sosa, on his way to meet the press, crossed the field and stopped in front of the pitcher's mound and stopped to wave his cap.

He also sent a message to McGwire.

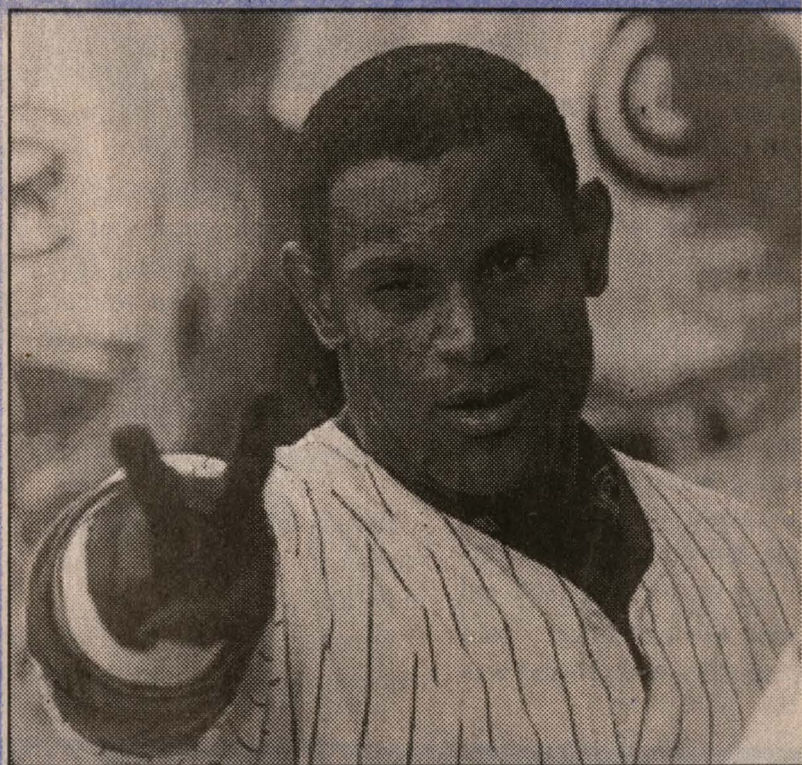
"Mark, you know I love you. It's been unbelievable. I wish you could be here with me today. I know you are watching me and I know you have the same feeling for me as I have for you in my heart," he said.

Sosa then used his trademark heart thump and said, "That's for you, Mark."

Both of Sosa's homers cleared the back fence at Wrigley Field, sending fans scrambling for balls worth tens of thousands of dollars to memorabilia collectors.

"I'm not much of a sports fan," Plunk said. "That's cool that Maris' record was broken, but it's just one more than 61. That's all."

After the first homer, a parade of fans raced after the ball as it went down the street. Sosa,

meanwhile, rounded the bases pumping his fists as the sellout crowd began stamping its feet.

By the time Sosa struck out in the seventh, the street was filled with fans. When he hit in the ninth with the Cubs trailing 10-8, they were chanting "62! 62!" -- and Sosa didn't disappoint them.

Home run ball No. 62 was caught by a man whose identity was not immediately known. Police officers surrounded him and took him to the closest station for his own protection.

"We got him out of there because we thought he was going to get his behind kicked," Sgt. Mary O'Toole said.

The man's plans for the ball were not immediately known. The fan and groundskeeper in St. Louis who got McGwire's home run balls Nos. 61 and 62 gave them to the slugger, who gave

them to the Hall of Fame.

The ball Sosa hit for No. 61 was retrieved by John Witt of Dixon, Ill., who stuffed it in his pocket and promised to negotiate with him.

Witt was sitting in a van off Kenmore Avenue outside the stadium, watching the game on a small TV when he saw Sosa swing. He got out of his van and the ball bounced a couple of times and landed at his feet.

"I didn't think I had a chance," he said. "It's an unbelievable feeling. ... How do you know how much it's worth?"

Sosa's bat and jersey were on the way to the Hall of Fame. He was on the way to San Diego, hoping to keep his homer binge going and help the Cubs keep their one-game lead in the NL wild card.

Sosa's going to have to rely on memory for historic day

Sammy Sosa's going to have to rely on his memory for his historic day, because most of the mementos went quickly.

His jersey? Off to the Hall of Fame. His bat? Going right next to Roger Maris and Mark McGwire's in the hall. And the balls he hit for Nos. 61 and 62? Forget it. The fans who got them are apparently looking for cold, hard cash.

"How do you know what it's worth?" said John Witt, who caught No. 61 and was reportedly offered a five-figure sum for it.

The St. Louis fan and groundskeeper who wound up with McGwire's 61st and 62nd home run balls immediately gave them back. No one contacted the Chicago Cubs to offer Sosa back the balls, team spokesman Chuck Wasserstrom said.

Unlike when McGwire neared Maris' single-season mark of 61 homers, the Cubs said major league baseball didn't specially mark balls for Sosa.

When No. 62 sailed over the left-field fence at Wrigley Field, it set off a mad scramble among the hundreds of fans crowding Waveland Avenue.

"I caught the ball and 50 people landed on top of me. One guy bit my left hand and wrestled the ball away," said Moe Mullins, whose hand was

bleeding. "People tried to help me catch the guy, but the cops took him off in a squad car."

The man, whose name was not immediately available, was taken to a police station near Wrigley Field, said Chicago police Sgt. Mary O'Toole. The man, described as being in his late 20s, left the police station a short time later, she said.

"We got him out of there because we thought he was going to get his behind

kicked," she said. "We brought him over here for his own safety."

The story is changing now every minute. It's a big mess.

The guy who has it is not the guy who started out with it."

Mullins later filed a police report about the incident.

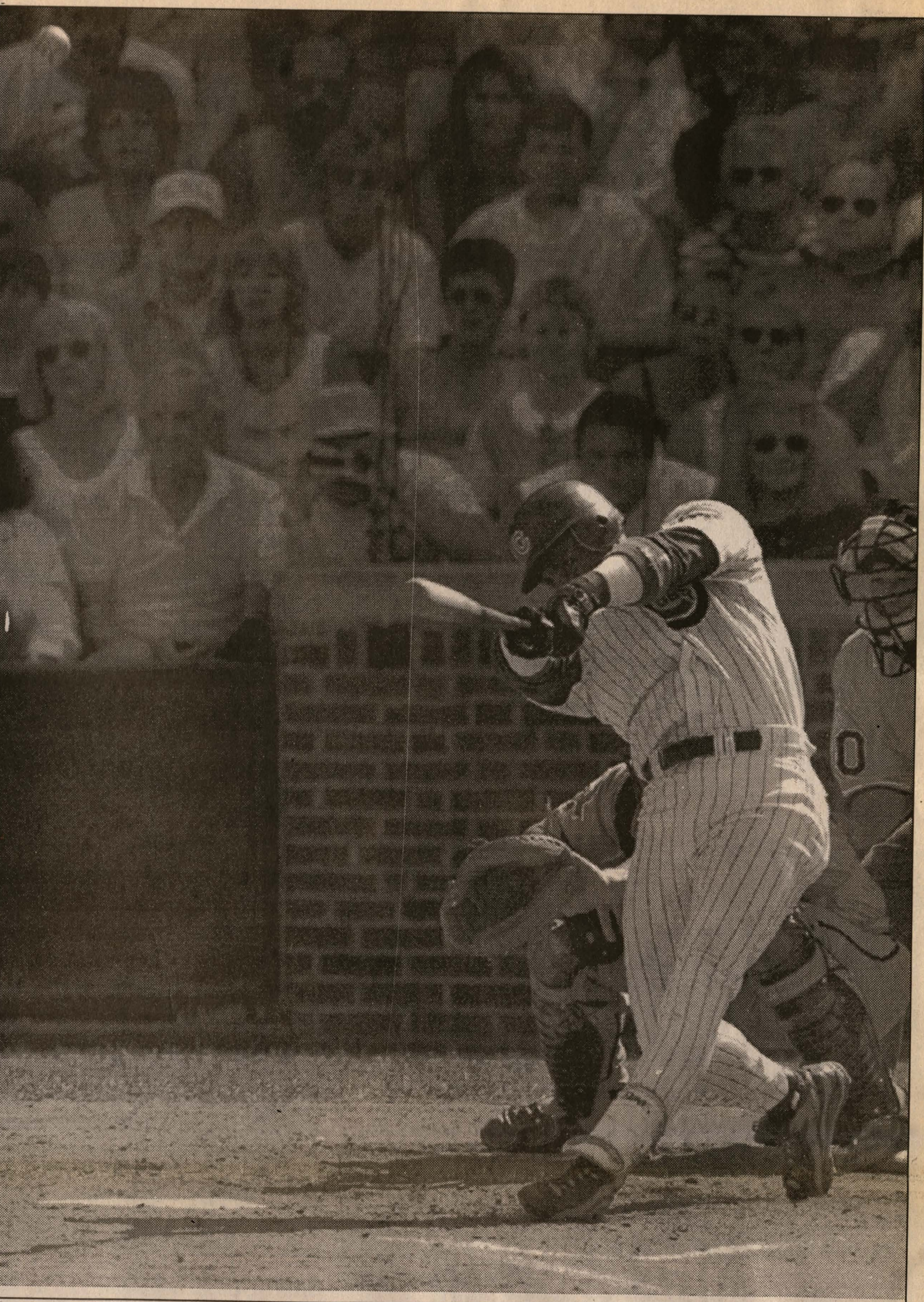
When Sosa heard fans were fighting to get the ball, he chuckled.

"If I wasn't a player, I'd be fighting, too, for that ball," he said.

Sosa didn't say whether he wanted the balls back, but he has a history of letting fans keep them. When the woman tracked down No. 56, which tied Hack Wilson's NL and club record, offered it to him, he autographed it and returned it.

He did take No. 60, giving the fan four autographed balls in return.

Sosa did look a little reluctant as he turned over his bat to

At Wednesday Press Time Sosa Joins Maris with No. 61

Before this chase is over, Sammy Sosa still might take the home run record from Mark McGwire.

Sosa became only the third player ever to hit 61 homers, moving past Babe Ruth, tying Roger Maris and pulling within one of McGwire when he connected Sunday off Milwaukee's Bronswell Patrick.

Sosa, who hit his 60th Saturday, sent an 0-1 pitch 480 feet (146.30 meters) into the street behind the left-field fence at Wrigley Field in the fifth inning.

Fans raced after the ball as it went down the street. Sosa, meanwhile, rounded the bases pumping his fists as a sellout crowd at Wrigley began stamping its feet and shouting "Sam-mee, Sam-mee."

Once he reached home plate, Sosa got a 15-second embrace from teammate Mark Grace. Sosa went into the corner of the dugout hugging his teammates along the way and then turned to TV cameras and made his trademark salute — thumping his heart, blowing kisses and making a "V" sign. He then lipped the words: "I love you, mama," to

a TV camera.

The game was being broadcast live back to the Dominican Republic, Sosa's homeland.

Sosa finally emerged from the dugout for a curtain call, tipping his helmet toward his faithful following in right field and waving to all sides of the ball park.

The ball was retrieved by John Witt of Dixon, Illinois, who stuffed it in his pocket and promised to negotiate with Sosa after the game. Witt was sitting in a van off Kenmore Avenue outside the stadium, watching the game on a small TV when he saw Sosa swing. The ball bounced a couple of times and landed at his feet.

"I didn't think I had a chance," he said. "It's an unbelievable feeling. ... How do you know how much it's worth?"

After a five-game drought, Sosa has homered in three straight games, sending the last two out of Wrigley Field. It was his ninth this season against Milwaukee pitching, his most against any team.

In his next at-bat in the seventh against reliever David Weathers, Sosa struck out swinging on a 3-2 pitch but still got a standing ovation from the crowd of 40,846, the largest at Wrigley this season.

Bill Cosby, America's most popular family entertainer, returns to the Cerritos Center for the Performing Arts for two performances Saturday, Sept. 19.

Cosby's third appearance at Cerritos is prompted by his unprecedented popularity with audiences of all ages, walks of life and socioeconomic status. He will perform at 5 and 8 p.m. in shows respectively part of Cerritos' family and comedy concert series. Tickets are \$32 to \$47 and are still available by calling 800-300-4345 or 562-916-8500.

Cosby has possessed the micas touch in all his entertainment endeavors: club comedy concerts, trend-setting television drama and comedy series, feature films, best-selling books and national television commercials. A jazz aficionado, he has even found popular success as the master of ceremonies for the West Coast's Playboy Jazz Festivals for 18 of its 20 years.

His ability to touch the hearts and humor strings of all humanity was fine-tuned as a prankster Philadelphia project youth entertaining his parents, siblings, friends and classmates. His material was always pooled from everyday happenings and the people populating his world,

thus establishing the foundation of his family-oriented and clean comedy acts. He turns the routine and uniqueness of the average man, woman and child into humorous stories to tickle audiences' funny bones worldwide.

Cosby dropped out of school in the 10th grade and enlisted in the Navy where he would finish high school via a correspondence course. Upon discharge, he received an athletic scholarship and enrolled in Temple University to complete undergraduate studies. Years later, he earned master and doctoral degrees from the University of Massachusetts.

To support himself as an undergraduate, Cosby worked as a bartender. He received \$5 for

his first stage appearance as a comedian at The Underground in a small room called The Cellar in Philadelphia. It didn't have a stage, so he did his act on a table with a chair propped on it. He recalled he had to climb over the bar to get to the "stage" but he was too tall to stand up, making him probably one of the world's first "sitdown" comedians.

Another classic comedian/comedic actor, Carl Reiner, was responsible for

Cosby's first stretch beyond the borders of comedy. He caught Cosby's act in Pittsburgh and introduced him to producer Sheldon Leonard who cast Cosby in the dramatic tv series "I Spy." Co-starring with now-lifetime friend Robert Culp, Cosby broke ground as the first African-American to star in a dramatic series. He won three Emmy Awards for the 1960s' series.

He won additional accolades and awards as America's favorite

dad in the NBC-TV sitcom "The Bill Cosby Show" from 1984 to 1992, the 1981 International Film and Television Festival Gold Award for outstanding children's program as the host of the preschool program "Picture Pages" on Captain Kangaroo's "Wake Up" program on CBS and repeated public polls as fans' favorite comedian.

Cosby also achieved television success with "The Cosby

Mysteries," "Different World," "Cosby" and revitalization of "Kids Say The Darndest Things."

He is the best-selling comedian of all time on records, each album selling literally in the millions. He has won five Grammy Awards for best comedy album, earned numerous gold records and put 21 albums and six singles on the national pop charts.

Explosive Explorers Will Highlight Monterey Jazz Fest

McCoy Tyner and Elvin Jones still possess "A Love Supreme" for seminal sax great John Coltrane.

Although their own musical ingenuity and powerhouse playing have earned them individual places of honor in jazz history, both men speak reverently of the man who led an awesome quartet in the 1960s and created and performed classic compositions sacred to all jazz musicians and fans.

Coltrane's intensive tenor, Jones' polyrhythmic percussions, Tyner's pioneering piano improvisations and Jimmy Garrison's creative, yet persistent bass lines revolutionized jazz and brought a new cutting edge to the musical art form during a six-year collaboration in the 1960s.

Tyner will highlight the tribute to vibes artist Bobby Hutcherson at the 41st annual Monterey Jazz Festival, presented by MCI, this weekend. Jones' Jazz Machine, his latest aggregation, will close the 1998 festival Sunday night. Tyner will play Saturday night.

The world's oldest continuous jazz festival will feature five main arena concerts Friday through Sunday as well as four free stages of entertainment for grounds-only ticket holders at the Monterey County fairgrounds.

The trend-setting spotlight has shone on Tyner, a professional since age 15, for 45 years. He

was playing with jazz pioneers Art Farmer and Benny Golson at age 19, but he would gain permanent acclaim -- as a member of Coltrane's most-famous quartet from 1960 to 1965.

Elvin is the youngest of the three famous Jones brothers hard bop trumpeter/bandleader Thad, bop piano pioneer Hank and Elvin, the drummer who created polyrhythms to avoid instrumental boredom - whose talents netted niches in jazz history. He played with tenor titan Solly Rollins before joining Trane and continued cutting percussive edges with Ornette Coleman and others in the post-Trane years.

"I was young, so young when I joined the quartet," Tyner said, reminiscing about his 20-year-old beginning with his Philadelphia "big brother" and family friend. "It was a big decision, but I had to go with John when he left Miles. I loved John's playing. We'd sit on his mama's porch and talk about

music and life."

Off-stage, Tyner is a quiet man, warm and laid back. That relaxed demeanor contradicts his fierce, explosive explorations of sound on stage.

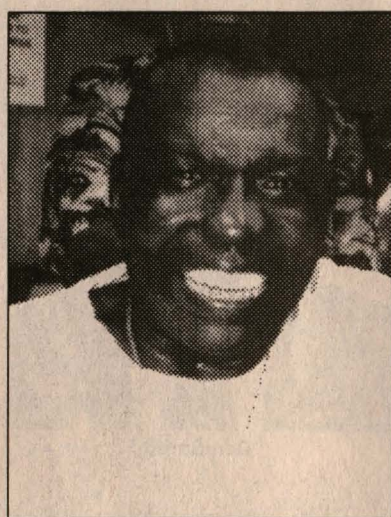
Tyner said Coltrane's humility and visionary approach to music and musicians allowed his sidemen to equally contribute to the unrelenting bombardment of notes and chords critics and fans dubbed "sheets of sound."

The magic of musical collaboration happens, Tyner asserted, when egos are subdued.

"It's not about egos at all. When you play the music, the ego is set aside. It's like raising a child. You give it nourishment and spiritual things happen," Tyner said.

Jones described the years with Coltrane as a spiritual experience, comparing the saxophonist's playing to his father's intense invocations at Wednesday night prayer meetings. The magic extended beyond the stage, embracing the four men personally and connecting them so succinctly they could stretch into new territory, he said.

Musical telepathy allowed quartet members to play effortlessly, always in sync with the mood of each other and the notes, creating a compatibility that didn't require communication, Jones said. It was a magical collaboration that couldn't be defined, wouldn't allow outside interference and was sometimes difficult to explain to the musically timid,

he added.

Jones admitted the initial response to the spirited, spiraling constancy of Coltrane's music was negative. Sophisticated geographic jazz centers in New York, Chicago, Detroit and San Francisco accepted the innovative new sound. But fans in smaller hamlets stayed away. Jones recalled a gig in East St.

Louis when no one came, another weekly engagement that drew only 10 people.

Oftentimes club owners refused to pay them. But it didn't matter because it was about music, not money, Jones said.

"Coltrane had such integrity and had no compunction about others' lack of character," Jones said. "He was a honest, pure man who carried his own burdens."

Both Tyner and Jones have sustained leadership roles in jazz, leading ensembles and collaborating with instrumental and vocal champions, retaining respect of fans and critics as artistic creators, topping record charts and remaining festival favorites worldwide.

Jones turned 71 on Sept. 9. Tyner will be 60-years-old on Dec. 11. Neither has any intention of

retiring.

"Music becomes an integral part of your being," Tyner said. "It's like losing a limb if you stop. Duke Ellington had a piano in the hospital when he died. . . (He) kept writing until the end. Eubie Blake was 100-years-old. He was just tired of living, not the music."

Cosby's literary efforts also represent unparalleled success. "Fatherhood," the fastest-selling hardcover of all time, remained No. 1 for more than half of its 54 weeks on the New York Times best-seller list. "Times Flies" had the largest single first printing in publishing history with 1.75 million copies. It, too, went to the top of the New York Times best-seller list. Literary gold was also mined with "Love and Marriage"

and "Childhood."

Cosby's feature films have included "Uptown Saturday Night" and "Let's Do It Again" with Sidney Poitier and Harry Belafonte, "A Piece of the Action" with Poitier and James Earl Jones, "Mother, Jugs and Speed" with Raquel Welch, "California Suite" with Richard Pryor and "The Devil and Max Devlin" with Elliott Gould.

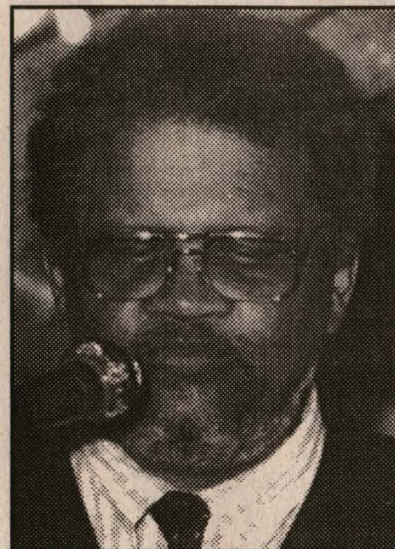
Tough Questions Raised at UCR
