- be unit three employees. Maybe we can just tighten it up a little bit so it doesn't mean that not all SSP because we have different classes of SSP that are non counselors, so I just think if we can talk about that or review it.
- 5.3.4. Senator Kolehmainen: I can double check the language, but I thought that we had to be very careful every time we referred to students service professionals, we put the Academic related after that. I believe that restricts it to counselors, but I can double check, we may have missed that in one or two places.
- 5.3.5. Provost McMahan: Because of the undergraduate we have a lot of essays in undergraduate studies and many different groups, and I don't want the staff to become confused, and more than anything Let's just triple check Senator Kolehmainen.

Overall state funding for CSU continues to be a challenge for us and it's critical that we develop philanthropy in our long term relationship with Jim and Judy Watson. Judy and Jim have been very active on our campus specifically in the College of Education, but also have been generous donors and supporting public art initiatives. President Morales spoke with Jim and Judy about the timing for this extraordinary opportunity to name our college of education and a couple of weeks ago we were delighted to learn that Mr Watson said to the President they were ready to move forward in the naming of this college. So Senators, we are bringing this forward

to you. The total gift value from the Watson family is going to be 8.4 million. We are in the process of finalizing the endowment agreement. We've been in close conversation and consultation with the Cal State University foundation legal counsel. Before we sign the actual gift agreement, the President and the provost wanted to be certain that the academic senate had an opportunity to review this to ask any questions and of course we would ask for your support and approval.

- 12.1.3. Senator Pelletier: My comment is which version should we be referring to, because it appears that a sentence that I think is an important sentence is not included in the new version. I think we should track the changes in the proposed policy, so we can see what has been eliminated, and what it's been replaced by. In the earlier mark version I'm reading, it says no faculty member shall be compelled directly or indirectly to teach a distributed learning without his or her consent. I think that's an important statement, but when I go to the new policy that sentence is not there.
- 12.1.4. Senator Hughes: So yes, that's our mode of operation. We usually do the original and then use that to do so, you can see striking in the pure clean copy. Part of this is because we have two committees working on this policy right now.
- 12.1.5. Guest Brad Owen: It was getting cumbersome when we were revising it because it's very extensively revised so what we thought we would do is take the previous version and set maps to the old version with all the strike-throughs so you could see all of the changes.

I think number 7 said that faculty assignments would be taken into consideration with class size with the Dean. I would like the committee to take a look at the appropriate document that speaks to how many students can be in each particular class. I understand that this is to advance technologies with regards to teaching, but I think that with regards to faculty workload that we have a clear understanding of what is the normal limit of the sizes of these classes. That is EPR-7636 specifically the faculty work with policy and procedures. Thank you.
