 - 5.2.2.2. FAC Chair Kolehmainen appreciated the collaboration approach of the grant with various departments in CNS..
 - 5.2.2.3. The EC members unanimously voted to refer this to EPRC.

6. President's Report

- 6.1. President Morales stated that the Winter commencement will be held at the Toyota Arena in Ontario. They will be holding the Fall Commencement in two ceremonies on Sunday, December 11, 2022, at 1:00 pm and 5:30 pm. Communication was made to the campus regarding this.
- 6.2. President Morales mentioned that today was the kickoff of the Student Services building planning process at PDC.
- 6.3. President Morales attended the Hispanic Association of Colleges and Universities 36th annual conference held October 8-10 with 90 students in San Diego.
- 6.4. President Morales brought up that the faculty office building has electricity restored.
- 6.5. President Morales said that at the President's retreat (Chancellor senior leadership retreat) which will be held in a couple of weeks there will be a major discussion about the travel ban. More information to come after the retreat.
 - 6.5.1. Chair Davis asked President Morales if tenure line needs to attend a conference in a banned location and they can't attend, how does that come into play with their RPT ?
 - 6.5.2. President Morales responded by saying that in the travel policy item 7 which says, " To complete job-required training necessary to maintain licensure or similar standards required for holding a position, in the event that comparable training cannot be obtained in California or a different state not affected" includes the training for professional development for state employees that are required to maintain licensure, or for their own progression in their work as faculty members.
 - 6.5.3. Senator Franklin-Guy clarified some of her comments from last week.

8.1.2 A discussion was held regarding AB 928. Chair Davis said the deadline for this survey is October 24, 2022, however FS next meeting occurs on October 25th, 2022. Chair Davis will reach out to Senator Steffel to see when it officially closes.

13.1 TRC Faculty Director Position [Presenters: Brad Owen and Kevin Grisham]

13.1.1 Brad Owen provided the link for the draft call for the [TRC Faculty Director Position](#).

13.1.2. Kevin Grisham discussed the history of TRC regarding full-buyouts and prefers to use half-buyout and offer the rest of the funding for faculty

development. He sees this position as programmatic and not an administrative one as it is already covered by other entities.

13.1.3 Brad Owen indicated that ATI has provided training for faculty development regarding teaching and technology.

13.1.4. Kevin Grisham indicated that faculty can't supervise (against HEERA) and under Brad there are 17 staff.

13.1.5. Brad Owen stated that his position has taken on duties that used to fall under the TRC Faculty Director.

13.1.6. Vice Chair Jones mentioned if you don't have a full-time TRC director, the concern is that the quality may go down and as such, there should be an emphasis for best practices.

13.1.7. Brad Owen mentioned that the TRC Director would be responsible for the high quality program and would be bought out for 16 hours a week.

13.1.8. Chair Davis discussed elevating the TRC and how will a part time person contribute to the elevation of the TRC if the person in this position will now be part-time?

13.1.9. Senator Kolehmainen appealed to President Morales to have a full-time TRC director and support funding for faculty development.

13.1.10. President Morales said money is not the issue, the issue is the structure, e.g., we have the FCE, which includes research and programming.

13.1.11. Chair Davis if there's a need at PDC could the individual have a full course buyout at PDC and CSUSB for consideration of justification for a full course buyout.
