# HIV/AIDS Forum Highlights Growth in Minority Cases

When Jacqueline Sheffield was diagnosed with the virus that causes AIDS in 1993, she dealt with the heartbreak by attending support groups that promoted openness and awareness of HIV. "Back then, it was like a death sentence. There was a lot of hurt and pain. These groups helped."

Now she is a person living with the virus that causes AIDS, not dying from AIDS, she told a panel of HIV/AIDS experts at a forum on April 21 in Rialto. But since Sheffield moved to San Bernardino, the ignorance and stigma associated with AIDS has worsened her condition at times. Stress takes its toll on her immune system, which has already been weakened by the virus.

"Not being able to disclose the condition causes much needless suffering among people with HIV/AIDS," she said. "I started coming out of my shell because somebody needs to take a stand."

## Obama Marks 15th Anniversary of L.A. Riots

"There is still hope for healing." Reflecting on the "bright spots" that emerged from the "darkness" of the Los Angeles riots, Democratic presidential hopeful Senator Barack Obama said Sunday that America must heal like L.A. did after the riots.

Appearing before an enthusiastic overflow crowd at First African Methodist Episcopal Church in South Los Angeles on the 15th anniversary of the Rodney King riots, Obama said the uprising was a result of mounting frustration over the lack of opportunity for young people, and especially people of color.

Recalling images of Los Angeles in flames, Obama said little has been done to fix the social and economic ills that sparked the three-day rampage that killed more than 50 people and damaged or destroyed more than 1,100 buildings.

"L.A. like America remains scarred. The wounds are still festering."

He recalled watching television during the riots and hearing about a pregnant woman who was shot in the abdomen during the chaos, the bullet lodged in the soft tissue of her unborn child's arm. He said the infant was successfully delivered, stitched up but was left with a scar.

He argued, although the riots occurred in L.A., the conditions that spawned them persist around the U.S.

"If you traveled to Chicago, you would see the same young men on street corners without hope, without prospects and without a sense of any destiny other than ending up in prison or in a casket."

He said L.A.'s metaphorical bullet remains lodged in the nation. "Not only does L.A. still have scars from that uprising, but in many American

cities we haven't even taken the bullet out. We haven't even stitched up the patient. We've got to take the bullet out before we can move forward," Obama said.

"We don't need more panels, polls, reports and commissions we need to take the bullet out. We need some surgery on the indifference to poverty in this country," he said.

Obama said the healing would come "not only by providing health care for every American, not only for every child to have a decent education, not only by ending the senseless war in Iraq, but by electing as president, Barack Obama."

"I want you to know that 15 years after the riots, change is still going to happen because of you. Together we have the power to make change."

Midway through his speech Stevie Wonder was ushered onto the church stage, "I've got to take a break - Stevie Wonder is in the house," Obama said "I grew up with Stevie Wonder, I love Stevie Wonder."

Wonder sang a song its lyrics in part "Barack Obama is going to be the next president." The congregation waved and shouted amen.

Obama responded - "Times are changing and a brighter day is on the horizon - especially if I am elected president."

Obama's L.A. speech calling for action to help impoverished Blacks came as major Democratic presidential contenders are fighting over Black voters. Earlier Obama wowed a loud diverse crowd when he joined the major hopefuls at the California Democratic National Convention in San Diego this weekend.

A Los Angeles Times/Bloomberg poll conducted earlier this month found that 41% of African-American voters surveyed backed Hillary Rodham Clinton, 34% supported Obama and 3% backed former North

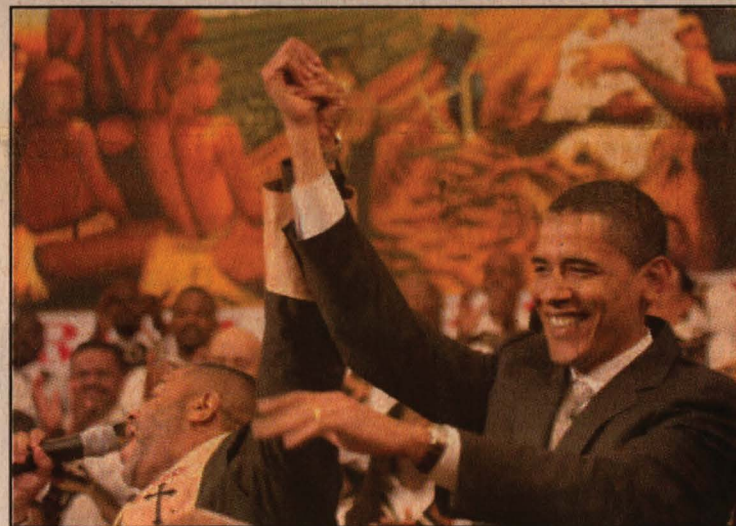


Obama received the rock star treatment that has characterized his campaign so far, but when he saw a real rock star in the front row, he paused in the middle of his speech. "I've got to take a break because Stevie Wonder is in the house," he said. "I grew up with Stevie Wonder (music); I love Stevie Wonder," he said to more applause. Wonder was ushered onto the stage next to Obama, where he sang a song saying in part "Barack Obama is going to be the next president," as the congregation amended.

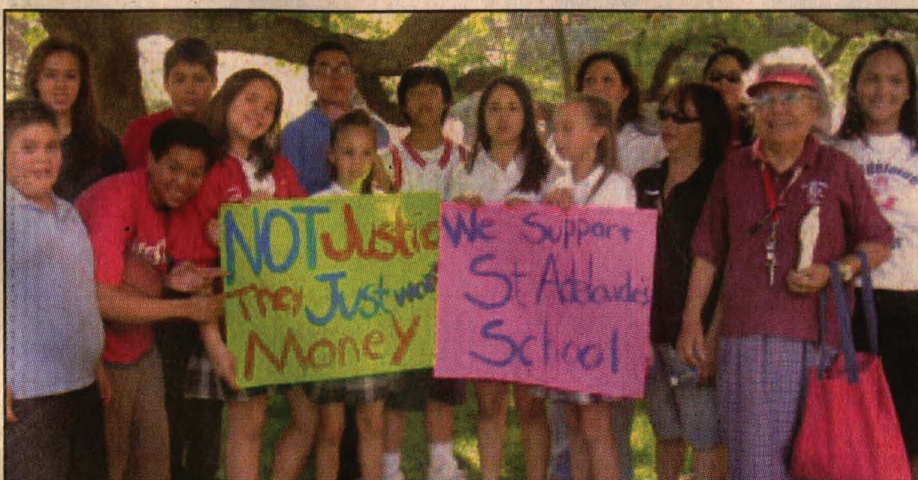

## SB Sheriff Not Pursuing Hate Crime Charges Parents: "Son Deeply Traumatized by Lynch-Style Attack"

Calling the March 12 attack at St. Adelaide School in Highland "reminiscent of a lynching," James and DeVondra Gill of Highland and their attorney James Curtis called on the Catholic Diocese of San Bernardino to acknowledge that a racially charged attack took place and take aggressive action to prevent future incidents.

At a news conference outside the Central Courthouse in San Bernardino, the Gills told reporters their 13-year-old son who is half-Black was playing with friends on the school basketball court when one student grabbed a jump rope, wrapping it around the teen's neck "and commenced to drag him around the court while three other boys called him 'a nigger slave' and threw basketballs at him."

"If this situation at its outset, had been handled properly, we would not be here today," said Curtis.

The three seventh grade boys accused of the assault face misdemeanor charges of battery on school grounds but San Bernardino Sheriff's officials citing insufficient evidence won't pursue hate crime charges. The Superintendent of Schools recommended the students involved be expelled however St. Adelaide principal Karen McDonald determined a 3-5 day suspension was the appropriate punishment. The Gills want the boys expelled.

A letter sent home to parents by McDonald on March 19 said "several of our seventh grade students experienced what could be deemed a racially discriminatory incident" and that classroom sessions were being planned to discuss the "use of certain words and the emotions and feelings that result."

Sheriff's spokeswoman Arden Witshire said investigators did not feel that the crime was racially motivated. She acknowledged after interviewing the boys involved deputies learned the same group of kids attempted similar attacks on several other students ear-

## Critics Say \$7.4B Plan "Satisfies Sealy Mattress Company" "Post Partisan" Jail Deal Adds Beds Boosts Rehab

Republicans and Democrats celebrated their vote last week to add 53,000 beds, permit the governor to transfer some inmates out of state and boost rehabilitation in California's broken prison system but before the inked dried on the legislation critics beyond the Capitol fired back.

"Trying to fix prison overcrowding by building 50,000 more beds is like trying to cure obesity by buying a bigger pair of pants," huffed Steve Fama, staff attorney with the Prison Law Office a non-profit public interest firm that represents prisoners.

"This is a deal about practical politics and beds," said Franklin Zimring, a professor and corrections expert at UC Berkeley's Boalt Hall School of Law. "It's going to satisfy the Sealy mattress company, and that's about it."

The Legislature in a 'post partisan' mood passed a \$7.4 billion spending package in an attempt to head off a judicial threat to release inmates early to ease overcrowding in prison hot spots such as San Bernardino County.

"This deal was made under considerable duress," Senate President Pro Tem Don Perata (D-Oakland) warned lawmakers. He supported the package with "grave reservations," skeptical that it would improve the troubled prisons.

The move is a welcome boost to Riverside and San Bernardino counties, where local officials are struggling with unprecedented overcrowding.

In the past SB County was forced to release as many as 1,000 felons per month.

Riverside jails are also overcrowded. County leaders have committed to hundreds of millions of dollars for construction of new jail space.

Assemblymember Wilmer Carter, D-Rialto voted for the bill calling it "a good example of people with different viewpoints working together". She said money for literacy programs, will help prisoners return to society as productive community members.

But the plan did not tackle several problems that experts say are the root causes of overcrowding. For example the package excluded any effort to address the state's discredited parole system. The spending plan also snubbed calls for a commission to review California's Byzantine sentencing laws.

"If Californians were banking on reform, they got duped," says former inmate and prison reform activist Kim Carter, president of Time for Change. Carter who also serves on a state commission addressing prison women's health issues and homelessness called the measure "bogus legislation to avoid being taken over by federal judges."

"This is a sham. There is nothing in this measure that attacks the root causes of overcrowding. Lawmakers overlooked reform key recommendations from dozens of non partisan prison experts and review boards including the highly touted Little

Hoover Commission. They ignored recommendations from criminologists - to move 4,500 nonviolent female offenders out of prison to correctional center near homes. Hot button issues like three strikes reform remain tabled.

Carter said the most glaring omission is the blatant lack of attention to finding real solutions to the system's most catastrophic failure: recidivism rates. This deal is little more than lip service throwing taxpayer money at bricks and mortar."

Nevertheless lawmakers are pressing forward saying the bi-partisan vote signaled a new air of legislative cooperation as Gov. Arnold Schwarzenegger and lawmakers attempt to tackle challenges ahead - addressing a growing budget deficit, agree to redraw the state's political map and vastly expand health-care coverage.

"It's a first step. The day's of 'gotcha' politics are over in California," said Assembly Speaker Fabian Nunez, D-Los Angeles after his House passed the prison plan 70-1. "We're ready and willing to work together."

## Fox Theatre Opens Once More Before Renovation

Visitors can tour the building from 6 to 8 p.m., Thursday, on the eve of an estimated 18-month transformation that will turn it into a performing arts center. The restoration is part of the Riverside Renaissance, the most sweeping public projects program in the history of the city.

The famed 1929 landmark movie palace

was the theater in which Rhett Butler and Scarlett O'Hara first flickered to life in "Gone with the Wind" when it was shown to a test audience in 1939. That sneak preview is now part of Hollywood legend.

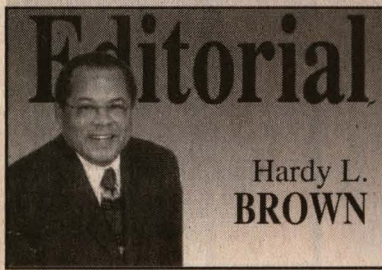
Ward 1 Councilmember Dom Betro, in whose Ward the downtown landmark falls, said the renovations is a symbol of the future of the city.

1st Ward, he fits such an instance.

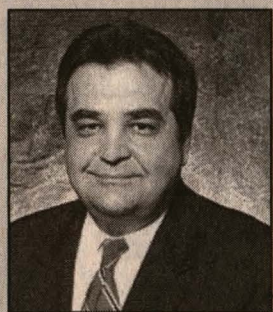

## Rather than Fight Discrimination California Department of Forestry Employee Leaves

Two weeks ago I shared a case of discrimination I was involved with several years ago and it sparked an email from a young Black man (I will use his initials LC) who works with the California Department of Forestry & Fire Protection in Riverside County. I later talked to him by telephone to verify the email and he explained to me that back in September 2006 he was involved in an incident that was racially motivated. One of the engineers where he worked made a racial comment to him, so LC turned him in to the Captain. As a matter of fact, the Captain heard the comment when it was made, so he knew LC did not make up the statement. Since the Captain did nothing about the verbal complaint, LC filed a written complaint with the department of EEOP which is an internal agency established to investigate discrimination complaints. Instead of them investigating the complaint they offered LC a transfer into another department which was granted within 24 hours. In LC's new department a co-worker decided to play a game with LC by getting a white pillowcase, putting it over his head, and pretending to be a KKK member in front of LC. LC did not think that to be funny. He again reported the incident and found the white employee guilty of pretending to be a KKK member and they fired him. However the engineer in the other department has received no disciplinary action for his racial comment.

LC's mother told him to call me because these kind of racially charged incidents go unchallenged by too many employees in the workplace because they have no idea how to get help. I shared with LC how to handle his situation and we put together a brief strategy but LC called me Monday to say he decided to take a position with the United States Department of Forestry.

This happens too often with minorities and women in the workforce. They had rather switch than fight and let others be confronted by the same ignorant coworker. Yes, there is a stigma associated with filing complaints or grievances in the workplace but you should. Then management must require all supervisors to take the complaint seriously by conducting a thorough investigation and reporting back to the complainant. Another thing is for management to have meetings with all employees to make it clear racial jokes, and comments that can be misconstrued as racial, will not be tolerated. If they find employees violating these policies swift disciplinary action must be taken. In the above situation if the first Captain had taken action perhaps the KKK employee incident might not have happened.

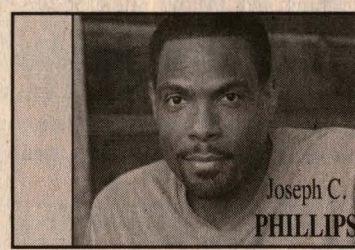
It reads:

I will live a life of redemption recognizing that life always offers a second chance to redeem the mistakes of the past.

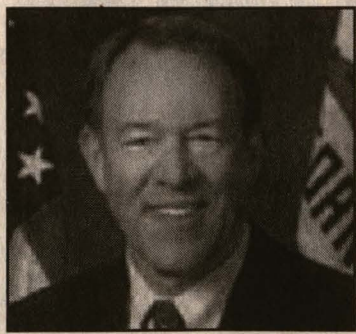

Contrary to what some would have us believe, the rights we claim are dependant not on government largesse, but on the recognition that those rights come from God. They are dependant on the recognition that with those rights come responsibilities. We have a responsibility to act with self-restraint so as not to infringe on the rights of others. We must, as the pledge suggests, respect the authority of our civil laws and civic leaders. We must pay our debts, delay gratification and contribute to -- rather than take from -- our communities.

I hung this pledge on the wall in my office as a constant reminder of the kind of man I continue to strive to become. My oldest boy recently asked if he could have a copy to hang on the wall in his bedroom. I gave it gladly. I hope it will serve as inspiration and a reminder treasure isn't always silver and gold. Sometimes it comes in the form of words written on plain white paper.

## Barack Obama and the First Presidential Debate

The press accounts of the performance of Senator Barack Obama in the first Presidential Debate at South Carolina State University give him high marks for staying in there with politicians who have been Senators or Governors for much longer.

In fact, one poll gave him the winner's edge over Hillary Clinton and the entire field. Nevertheless, he proved that despite the fact that he had not fielded complete positions on critical issues to high voting blocks like health care, social security and the like, he was able to answer crucial questions in a substantive manner equal to his colleagues that did him no harm.

The primary criticisms of the media were leveled at the fact that he did not appear presidential enough in his response to a question about Iraq that asked, if two American cities were attacked by Al Qaeda how he would change the military stance abroad to account for it. He was criticized as not being aggressive enough to say that he would attack and destroy the

enemy and that he did not use his openings to reassure Jewish voters about his commitment to their issues.

But this was also an opening for Obama to posit that the American people are tired with reckless military blusters and the blunders that it leads to by the commander in chief, as in Iraq. It would seem to me that if he has argued that the reason why he has arisen like a phoenix in the American political landscape is that the American people are seeking new leadership, it is almost certainly a desire for a leadership that is different in that it does not seek instant military mobilization abroad as the answer to every crisis. If the "enemy" is clearly identified and constitutes a real target for a limited response, that is one thing, but for Americans to approve of another proxy war is quite another.

My beef is that this debate was in South Carolina, where Blacks experience high poverty rates, lack health care, live in substandard housing, and thirst for elementary and higher education. Yet the debate scarcely touched on issues that were important to the families of the students in the college that was there host. I understand the

inside game of presidential debates as someone who helped to prepare Rev. Jesse Jackson Sr. for his debates in 1984 and 1988, and I was appalled that the Obama let this course of events take place. In the 2004 debates, if issues relevant to the Black community were not asked by the questioners, Rev. Al Sharpton raised them himself, since he was sensitive to his role as forcing the accountability on other candidates to those issues.

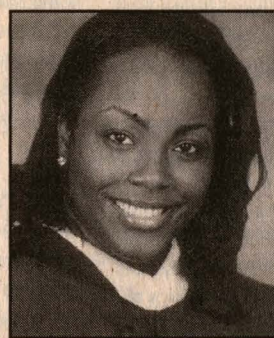
Secondly, debates have a context. In this case, the Barack Obama campaign should be reaching out to an important core constituency of the Democratic Party. Yet, there is also some rumbling that he was absent at the birthday of icon Dr. Dorothy Height where Hillary Clinton was in attendance; Obama went into South Carolina, the home of Rev. Jesse Jackson and where he won twice, yet he never called to obtain key advice about campaigning there, but Hillary did -- and went to Rev. Jackson's mother's home to pay respects.

The Barack Obama Campaign seems to be following a general election campaign strategy in the primary elections where he is keeping some distance from the Black

community. If Florida is successful in moving up its primary to January 29, it will land on the same day of the South Carolina primary. This means that if Blacks are 50% of the Democratic voting base in South Carolina and 30% in Florida, Blacks could stop whoever comes out of the New Hampshire and Iowa elections and set the tone, perhaps for the rest of the elections. In other words, the Black vote could make the difference.

So, there is a trend that has to be broken if the Black vote difference translates into a policy difference. These debates now use Blacks as a symbolic background, but ignore them when it comes to discussing the vital issues. This happened in 2004 in the Detroit, Michigan debate and when it was held at Morgan State University in Baltimore. At both venues, Fox News analysts promptly designed their own debate featuring their own concerns. The sponsors of these debates -- whoever they are -- must demand Black questioners and an agenda that speaks directly to Black issues. But if that does not happen, Barack Obama must raise them himself, or perhaps Hillary or John Edwards will.

lier that day. The sheriff's report will be submitted to the district attorney's juvenile division for review, Wiltshire said.

The Gills removed their son from the school and have not filed a lawsuit in the case. "We stand by the allegations that racial epithets were used, and this was a racially charged and motivated incident," Curtis said although the Gills filed a police report, the kid still is receiving threats of retaliation via the Internet and other sources. DeVondra Gill fought back tears saying the incident has left the couple's son "deeply traumatized".

The Gills say the so-called ringleader admitted and confirmed in the presence of his father that racial slurs were used. "We are unhappy with the school's reaction to the incident. Discipline took nearly two weeks and only after continual phone calls and discussions instigated by us," said James Gill.

San Bernardino resident Norma Jones, who is Filipino told reporters her 11-year-old grandson, who is also half-Black, was attacked by four boys at the school last year when he was in sixth grade.

"He came home with bruises and scratches. I asked him what happened. He told me he fell off a swing. He was terrified," Jones said the family removed the kid from the school after officials failed to

resolve the matter.

Curtis, a former Riverside prosecutor, Court TV anchor and commentator during the O.J. Simpson trial accused the Diocese of stonewalling and refusing to admit the attack was racially motivated. He said the family met with Bishop Assistant Robert Miller April 19 and are awaiting an outcome of that meeting.

The news conference turned into a heated shouting match when dozens of St. Adelaide students, parents and teachers challenged the family's portrayal of the incident.

"This is not about justice. This is all about money. This is a vicious attack aimed at bankrupting our school. It's the adults who are creating racism," said Neomi Savio whose five children attend the school.

A teacher who refused to give her name called the hate crime allegations "baseless and shameful." A student claiming to have witnessed the incident said the Gill's son was crying but was not badly hurt. He said a teacher broke up the attack after a few minutes.

"They were just playing," said another seventh grader carrying rosary beads. Several other students and teachers wearing school uniforms aggressively courted the media spotlight holding up crosses and hand painted signs that read "Not justice. They just want money" and "We support St. Adelaide".

Curtis accused school officials of leaking the details of the April 19 discussions.

He said he and the Gills were shocked to see teachers and students in uniform. "The lack of respect and tolerance is very disappointing and hurtful," said James Gill.

"This is despicable," said an attorney (not involved in the case) watching the news conference from the steps of the courthouse. "It's an unbridled show of arrogance clearly orchestrated and condoned by the school and the Diocese. These kids have been reduced to innocent pawns," he said.

Marie, a parent, said she learned of the news conference from a teacher. She said the teacher urged everyone to come out in support of the school. Marie said however, "in hindsight - getting the kids involved in this may have been in poor taste."

The Diocese released a statement Friday saying details of the March 12 incident remain unclear. The statement noted the Gills asked for McDonald's termination, back tuition for their son and daughter, who remains enrolled at the school, high school tuition, payment for the son's therapy and the establishment of a college fund.

The Rev. Paul Granillo, a spokesman for the Diocese, said it is against diocesan policy to discuss the discipline of students but said the matter remains under review.

"Racism and any type of abuse is unacceptable," he said. "We're working hard to make sure that the facts of this case are known and that it's dealt with in a fair and just manner to all involved."

hear thoughts and ideas on the needs that must be met.

"A shift has occurred. Most new AIDS cases are coming from the African American and Latino communities," Assembly Member Carter said at the forum. "We believe there's an unmet need in our region and resources are needed to address disparities in care."

"It's not as simple as pouring in money. Legislators can make resources available but must make sure resources are allocated effectively," said State Senator McLeod.

The panelists also came together to discuss what resources are available and how best to allocate them for the prevention of HIV/AIDS. The forum set the stage for more cooperation and leadership on the issue in the Inland Empire and Southern California. Another event is expected to be held in the future.

Minorities are not being tested, in part, because of the cultural stigma. As a result, they are not getting treated, panelists said. Underreporting creates funding shortages for services because an increased need can't be demonstrated, said Becky Nanyonjo DrPH of the San Bernardino County Public Health Department. "Surveillance has been the big push. We lost 1,400 cases and you need those cases to get the funding to help people."

Patricia Green of Brothers and Sisters in Action in Rialto said that people are getting tested but they are not coming back to get the results. One of the best methods is to pay people to get tested and pay them to get the results, she said. Testing has become simpler. For a pre-screening test, a swab of saliva is taken instead of a vial of blood.

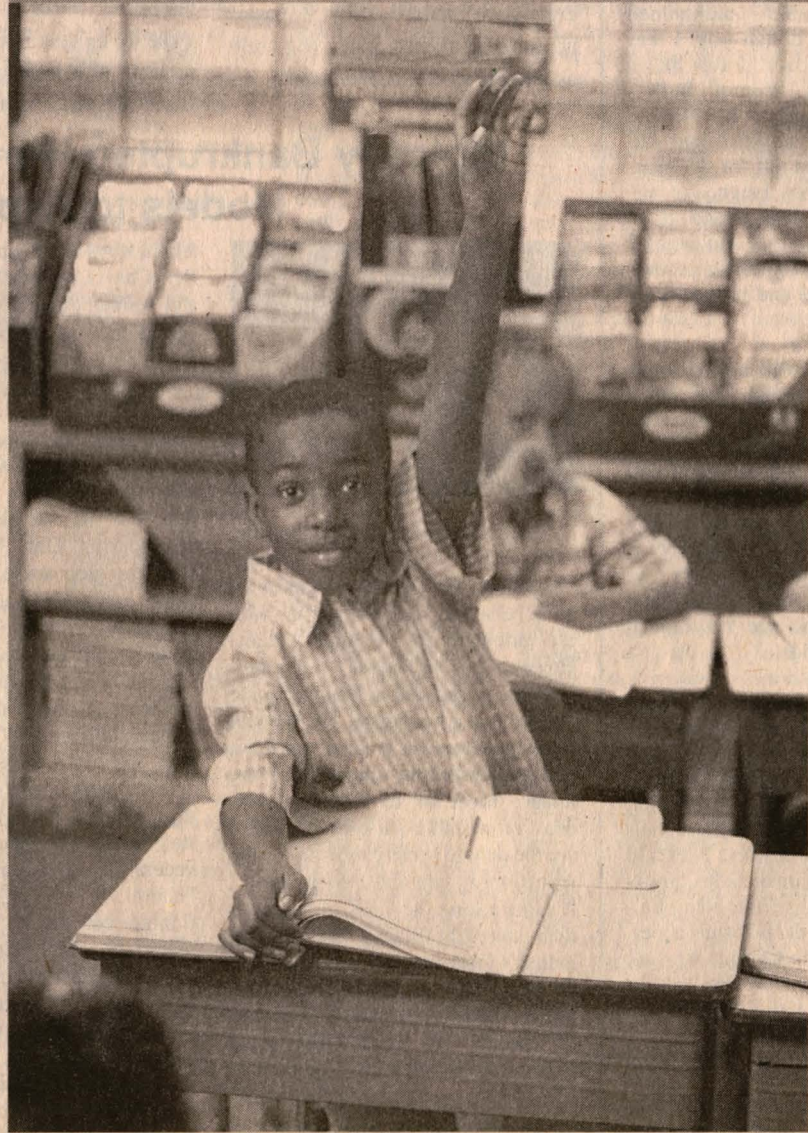
Dr. Ernest Levister MD from the J.W. Vines, Jr. MD Medical Society Inc. told the forum that with early detection, "hopefully we

can control the spread of the disease. We must educate the individual and provide culturally aware and sensitive care. Support should not be attached with a guilt trip. The support they need should be from the heart."

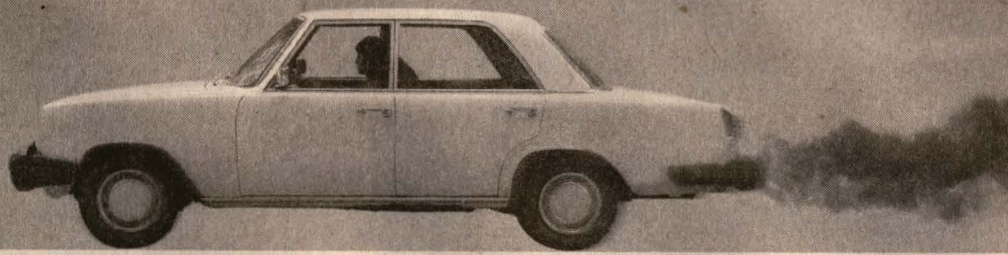

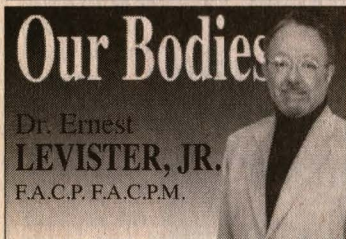

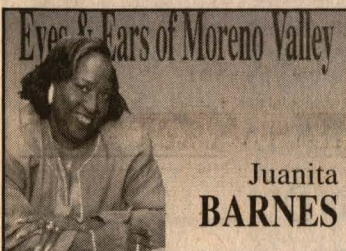


## LETTER FROM A READER "Bullying Causes Silent Hurt"

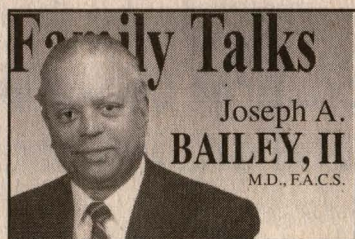

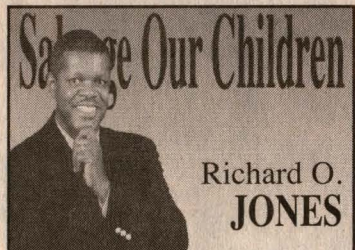

## Ethically Bankrupted Hip-Hop Veterans are Role Models to Aspiring Artists



When the executives, mentors, and role models of the hip-hop industry are among the worst examples of good behavior, impressionable youth are doomed for corrupt values. However good behavior is not a prerequisite to succeed in hip-hop, some believe it is a hindrance. The rap and hip-hop culture has created, glorified, and popularized the thug and bad boy image. Most of the main players boast of infamous background. These are the people society turns to for the reduction of vile and profane lyrics. It's like asking the KKK to put away their hatred of Blacks. The hip-hop industry feels attacked when the public campaigns to boycott their hard lyrics. Suddenly, it's art, it's freedom of speech, it's we're just poets expressing ourselves, it's the fault of society; it's everything but accountability. The Hip-Hop Summit Action Network (HSAN) referred to by this writer as HAIL STORM ACROSS the NATION, is a double-edged sword.

Russell Simmons, HSAN Chairman of the Board, uses his power to organize youth to register to vote and advocate that they get a good education while at the same time he and all of his hip-hop board members and supporters, including icons from Jay-Z to P. Diddy, from

basic survival mentality bottom. A major loss was their sound African mental health, worldview, paradigm, and archetype messages of African Tradition that had been passed down through the millennia. A fundamental point is that nothing the slaves found in the Americas enabled them or their struggling descendants to rebuild workable paradigms into any success related reproducible mindset. Instead, with only shattered pieces of philosophical rubble (i.e. those pertaining to archetype and paradigm foundational values) available for building materials, afflicted Blacks could merely haphazardly reconstruct mindsets--mindsets inadequate for thriving in USA society. Two resultant prominent mindsets of those Black Americans struggling then and

those struggling now are the "Herd" and the "Security."

A "Herd" thinking pattern feature is one of a rambling right brain nature without any ordering and coherence provided by the left brain. Outsiders must "feel" them to get a clue as to what they are saying. A "Security" thinking pattern feature is best illustrated by the negative portion of the Thinker's Scale. This scale has a positive ruler and a negative ruler separated by zero. The positive ruler represents benefits--ranging from +1 to +100 one desires in life. The negative scale--ranging from -1 to -100--concerns what one does not want in life. "Security" Blacks are oriented to doing what it takes to ensure that their basic needs are cared for. This necessarily means con-

eventually reformed. "It's because of the artists. forming to their "We" group and not getting outside that box. Hence, their talents are rarely, if ever, discovered, developed or placed in the right niche for thriving in riches.

Effective paradigm rebuilding for such struggling Blacks will not occur spontaneously because of their tendency to simply "herd" closer together when circumstances get worse and worse. Many old slave expressions kept alive in Black culture rap need updating or replacement. For example, "time will make it all right"--is not correct because time does nothing to cure self-defeating belief systems. Rather than with multiple small "Berlin Wall" type blows distributed over a period of time, the best way to topple defective belief system paradigms is with a quick-shattering stroke. In other words, a Paradigm Shift begins when a set of belief assumptions is challenged and completely dismantled (or shattered). From the resultant rubble, the destruc-

tive and the useless are discarded; the paradigm props worn down from overload or apathy or gnawed away by bad habits; and the improper use of "okay" habits undergo the "5Rs": **Rearranged, Recombined, Refined, Repaired, or Replaced.** To fashion new paradigms likely to work well inside racist America, African Tradition might suggest applying the African Phoenix ("Death and Rebirth") approach. Then follow with the African Sankofa approach ("returning to Ancient African Values and incorporating them into one's philosophical paradigm for purposes of getting through the maze of life). Both approaches are successful when one's new perceptions, values, choices, decisions, and solutions cause one to get what one wants and stop getting what one does not want.

# De La Hoya & Mayweather Duel At MGM Grand in Las Vegas

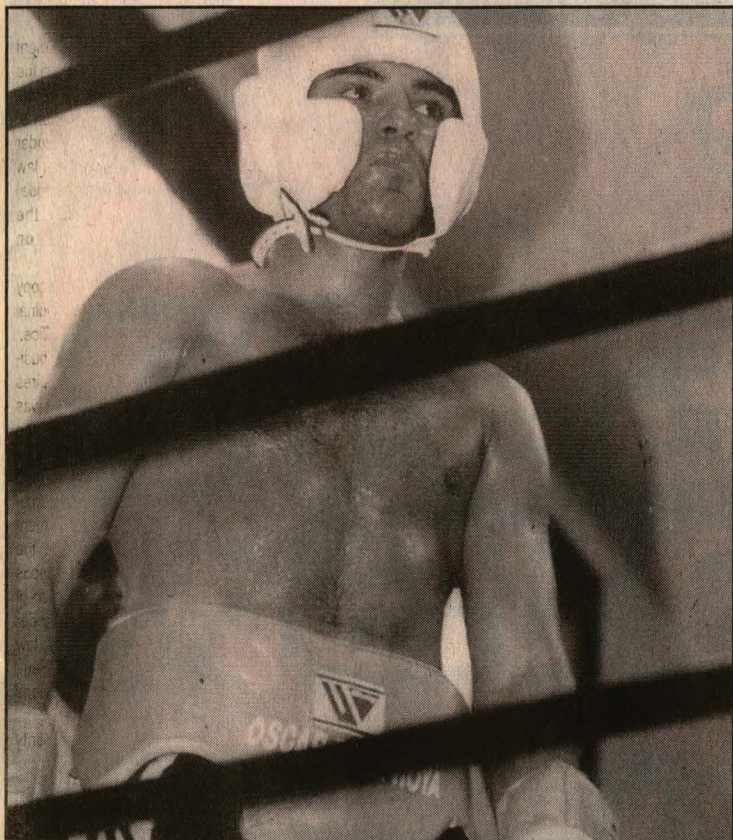

Two dynamic fighters who share a combined 14 world championship belts will meet in the center of the Grand Garden Arena for the WBC super-welterweight championship of the world.

Oscar De La Hoya (38-4) with 30 knockouts will face Floyd Mayweather (37-0) and 24 knockouts, will fight at 154 lbs., on Saturday night. The two former Olympians have completed their ten city promotional tour, during which no love was lost and no limitations

were expressed.

Floyd Mayweather Jr. is sure to bring his outstanding hand speed, defense and footwork into the ring. De La Hoya, at 5'-11" stands two inches taller and is four years older. All other tape measures are similar.

Prior to their training phases, Floyd Mayweather Sr., who had been De La Hoya's trainer for several fights, broke from "team De La Hoya" over money and expressed hesitation in training a fighter to beat his own son. The dilemma was short lived, as Oscar recruited the services of Freddie Roach.

Roach, known for his ability to mold and coach boxing styles, was the perfect find for De La Hoya. Roach, a former fighter himself,

apprenticed under the great Eddie Futch. Since those early days, Roach has molded 18 world champions including Mike Tyson, James Toney and recently Manny Pacquiao.

It was Roach's idea to solicit the services of Oscar's former nemesis and current business partner, Sugar Shane Mosely. Sugar Shane (from Pomona) has a reputation for his unique ability to mimic styles of

other fighters. He agreed to join the De La Hoya camp in Puerto Rico.

Make no mistake about it, this arrangement isn't that common in boxing. This will be no common fight. Mosely spent approximately 20 days in De La Hoya's Puerto Rican gym. There are high stakes for this one: championship belt, intrigue, pride, legacy and the largest pay per view number in the history

of boxing, just to name a few.

Roger Mayweather, formerly known as "The Black Mamba" will join Floyd Mayweather Sr. in Jr's corner. Roger won 59 of 72 pro fights during his 18 year career, to include epic battles with Julio Caesar Chavez. There will be at least three Mayweather's in one corner.

This fight may eventually look like a chase with De La Hoya trying

to get a fix on the quicker Mayweather. Oscar may be the bigger power puncher, if he can locate Floyd. Mayweather is most likely the quickest puncher in the game. Both fighters are two of the fittest the sport has ever seen. Both possess a superior defense, so a sprint to the distance would not surprise.

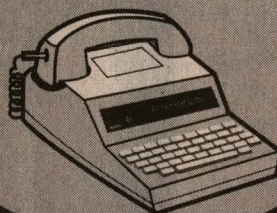

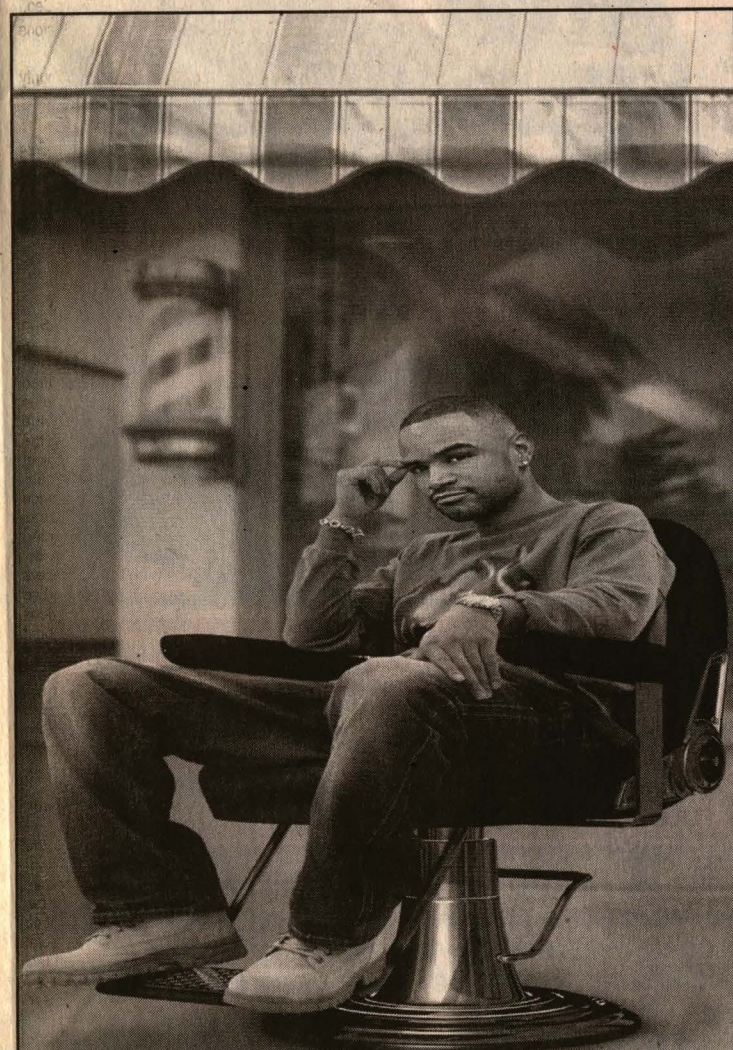

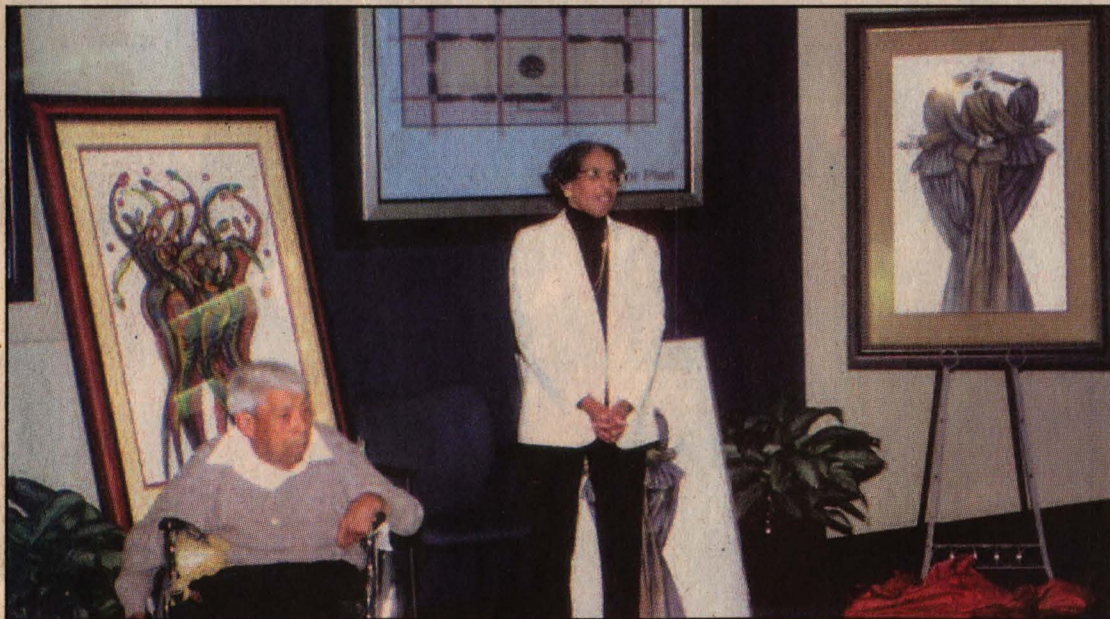

# State Funding Will Be A Boon For San Bernardino Schools

## SAN BERNARDINO

More than 10 schools in the San Bernardino City Unified School District are in line to receive millions in state funding meant to improve the quality of education for students.

The financial windfall, which was made available by the Quality Education Investment Act, could allow 13 District schools to reduce overcrowding, better train teachers, and hire more staff and counselors, all key components of a school's success. It would also allow for more training for principals at the selected schools.

"We're very happy that the state is considering giving us this money," said Superintendent Dr. Arturo Delgado. "This funding gives us an added degree of confidence that our existing programs and future plans can succeed."

To announce the projected funding, Dr. Delgado and top District officials held a press conference on Tuesday, May 1 from 11 a.m. to noon in Conference Rooms A and B of the Board of Education building, located at 777 North F Street in San Bernardino.

District officials are excited that San Bernardino Unified could receive one of the largest chunks of QEIA funding in California about \$70 to \$75 million over seven years.

Since there are more schools eligible for funding than can be supported with available funds, districts determined the order in which

schools are selected for funding. San Bernardino City Unified applied for the funding on behalf of 40 schools. Of those, 13 are slated to receive QEIA funding.

The winning schools will annually receive \$500 per pupil from kindergarten through grade 3, \$900 from grades 4 through 8, and \$1,000 for grades 9 through 12. Under the rules, each school must develop a plan describing what school administrators will do with the money.

Statewide, the Quality Education Investment Act will provide nearly

\$3 billion over seven years to schools in decile ranks 1 and 2 on the 2005 Academic Performance Index. In the initial funding year of 2007-08, the amount distributed to schools will be slightly lower. Up to \$2 million will be allocated to county offices of education to annually monitor the implementation of this reform program in funded schools.

After the first three years of full funding, schools in the program must exceed their Academic Performance Index (API) growth target averaged over the first three

years of funding. According to the law, a school funded by QEIA that continues to meet the program and achievement requirements shall be funded annually through the 2013-14 fiscal year.

The QEIA was approved in September by the state legislature. It was the result of a compromise to settle a lawsuit filed jointly by State Superintendent of Schools Jack O'Connell and the California Teachers Association against Governor Arnold Schwarzenegger and the California Department of Finance for failing to fully fund

Proposition 98 in the 2004-05 and 2005-06 budget years per an agreement made with educators the previous year.

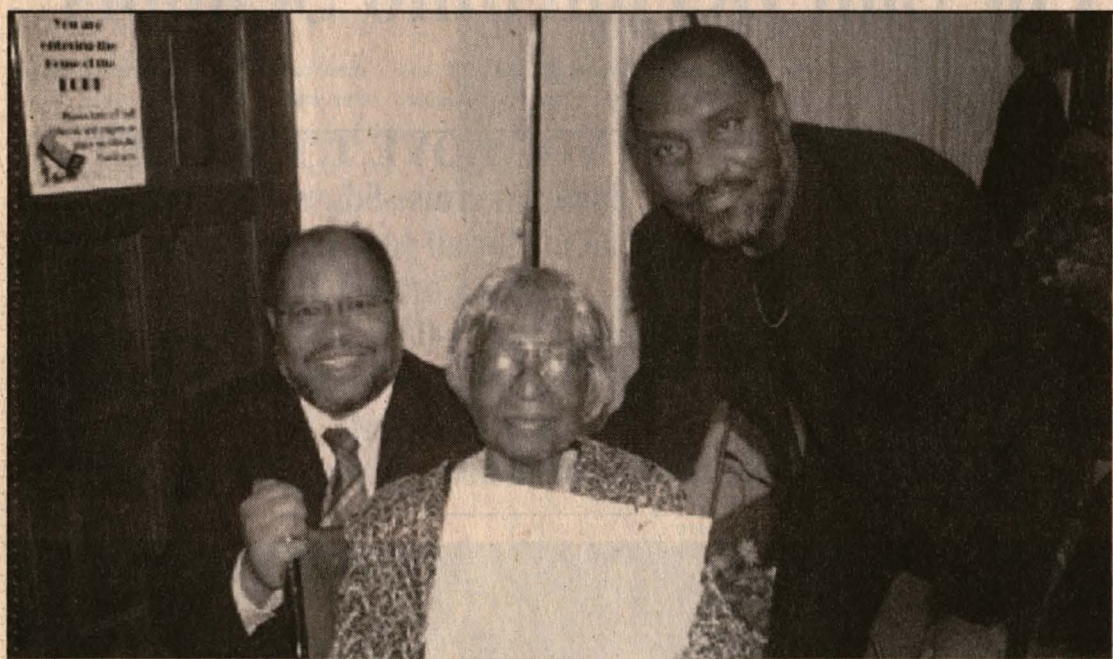

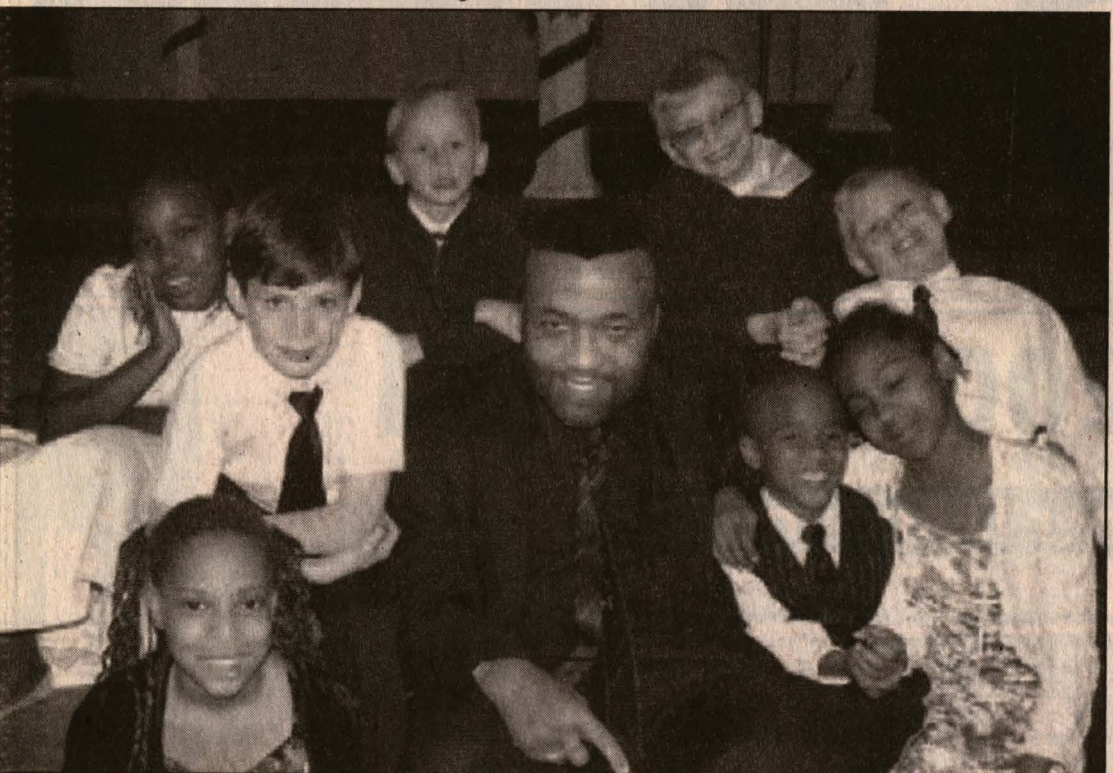

# Preventing Workplace Violence

## Local Professor Offers Advice on Steps To Avoid Incidents

Frightened workers scatter, police officers crouch behind squad cars as an angry employee roams the office with a loaded weapon. Americans have become all too familiar with the scenario as incidents of workplace violence occur around the country.

However, Dr. David Sellen, a professor at Argosy University/Inland Empire, says work-related homicides are less common than other forms of workplace violence. "Rape and physical assaults are more common," he said. "But they don't get the attention of the media."

Sellen, a professor in Argosy University's department of Psychology, teaches courses such as psychodynamics, counseling

and interview techniques. He has a law degree from Southwestern University, Los Angeles, and a doctorate in Neuropsychology from University of Southern California, Los Angeles.

Sellen works with law enforcement agencies in Critical Incident Debriefing, where psychologists help victims of violent acts normalize their feelings. He says that workplace shootings are often caused by a combination of events.

"These situations include a triggering event, such as a job termination, interpersonal trauma, such as depression, stress or substance abuse, and an unprepared workplace environment," he says. "Office buildings are often less prepared for violent acts than courthouses and police stations which often have security."

The typical workplace shooter is more often male than female, has a history of violence, tends to be withdrawn and a loner. Other signs include antagonistic and obsessive behavior and career frustration.

Workers are also under additional pressure because of the lack of stability in today's workplace.

"People tend to feel less secure in their jobs because of the way the economy has changed," Sellen said.

"The average person is likely to see a t



least three major job changes in their lifetime and most people are not prepared. People tend to think the employer will take care of

them."

Failing to prevent and protect workers from workplace violence is extremely expensive, for American companies. Sellen estimates workplace violence-related lawsuits cost

American employers about \$500 million annually.

Faced with these rising costs, more companies are being

proactive in training workers to prevent and identify potentially violent situations.

"Ever since 9-11, more compa-

nies have started offering training to help employees address grievances and to defuse situations," he said. "Many companies now offer Employee Assistance Programs (EAP) which offer free counseling for employees who are facing personal problems."

Sellen said Cal/OHSA, which is responsible for enforcing workplace safety laws in California, has strong guidelines for companies on creating a violence free workplace. They also suggest companies have a workplace violence prevention policy and committee. Cal/OHSA also gives recommendations on how employees can report potentially violent situations to the company's human resources department.

Sellen says workplace violence is preventable if companies take a more hands-on approach.

He offers these suggestions:

- Companies need to ensure that employees have workplace violence prevention training.

- Companies need to have an open line of communication to the supervisor so threats or strange behavior can be reported.

- Employees need to be active listeners. No threat should be taken lightly. Any threat should be reported to the Human Resources director or the supervisor.

- Employers need to make sure that employees have a venue to handle their grievances.

- Companies need to do in-depth background checks to screen out employees with violent histories.

- Companies planning to do layoffs can prepare employees for the change by offering counseling, career training and letters of recommendations.
