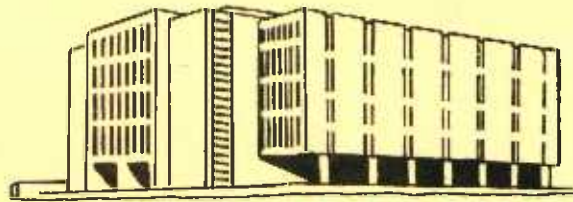

COLLEGE POLICE TRANSFERRED

Administrative responsibility for the College Police (Department of Public Safety) has been transferred to Acting Executive Dean James H. Urata, President Anthony H. Evans announced.

The department, which also includes parking officers and patrol aides, has been under the dean of students since the early days of the college. The organizational re-alignment was effective this week.

The director of the Department of Public Safety, Arthur Butler, is the campus' environmental health and safety officer. In this capacity, he also works closely with Dean Urata.

URBAN PLANNING CERTIFICATE NOW OFFERED AT CAL STATE

A new certificate that combines study of the theoretical foundation and practical techniques involved in urban planning is now offered by the college. The program is designed for private

citizens, members of planning agencies and consulting firms, and others who would like to acquire more expertise in the area. Dr. James Mulvihill (Geography) is the program coordinator.

Courses are designed to acquaint students with concepts, procedures and planning techniques such as cartography and remote sensing (aerial photography and satellite imagery). Students also will have the opportunity to take a course in environmental impact reporting and to participate in internships. Six courses, a total of 30 units, are required for the certificate. It is possible to earn the certificate entirely through evening courses.

INCOME TAX ASSISTANCE PROVIDED ON CAMPUS

Free volunteer income tax assistance will be provided by the Accounting Association from 3 to 7 p.m., Wednesdays, and from noon to 4 p.m., Fridays, Feb. 2 through March 4 in the Senate Chambers of the Student Union.

Appointments can be made by calling the Department of Business Administration, Ext. 7711.

The 17 student volunteers from the association who will be providing assistance have completed two training sessions. Suzanne Cory and Mary Moran (Business Administration) are the club advisors.

The students will help fill out forms 1040, 1040 A, 1040 EZ, as well as California state income tax returns 540 and 540 A.

FINANCIAL AID OFFICE ANNOUNCES DEADLINES

College students who need financial aid to help meet the expenses of the 1983-84 academic year should apply now. The deadline for applications for assistance through Cal Grant Programs is Feb. 9. The priority date for other financial aid is March 1. Students attending college at least half time may be eligible for assistance. About 25 types of financial aid are available in the form of grants, scholarships, loans and work-study. INTERVIEWING WORKSHOPS FOR TEACHERS PLANNED

The Career Planning and Placement Center will sponsor two workshops for student teachers to help them prepare for job interviews. The workshops will be held from 3 to 5 p.m., Monday, Feb. 7, and Thursday, Feb. 10, in PL 67. The program will include a film, questions generally asked of applicants for teaching positions and videotaped interviews in a supportive setting.

TAX SHELTER ANNUITIES PROCEDURE IS CHANGED

The procedure by which payroll deductions for tax shelters reach the companies involved has been changed. Now, each deduction will be handled entirely by the State Controller's Office. Formerly, all deductions from the 19 CSU campuses were combined by the State Controller's Office into a lump sum which was sent to the Chancellor's Office to be distributed to individual companies.

The change is not expected to affect employees, but will mean that the funds are remitted to the appropriate companies in a more timely manner. After March 1, all questions regarding employee tax-shelter transactions should be referred to David Barrow of the State Controller's Office, ATSS 492-8105. In the interim, questions should be directed to Edmond Macias, Chancellor's Office, ATSS 635-5744.

from 11 a.m. to 2 p.m. on the grounds between the Student Union and the Creative Arts Building.

The Associated Students is sponsoring the event, which features booths by various campus clubs.

The occasion also will celebrate the fifth anniversary of the Student Union with a birthday cake and ceremonies.

The German Club will hold a Fasching costume dance at 9 p.m. in the SUMP. Music will be provided by the M.W. Variety Band, a modern German ensemble. Admission is \$1 for students, \$1.50 general.

**'GALILEO' SHOWN
ON CAMPUS FREE**

Free showings of "Galileo," an American Film Theatre movie, will be sponsored by the German Club and the School of Humanities at 6:30 p.m., Wednesday, in the SUMP, and 7 p.m., Friday, in PS 10. The internationally acclaimed star Topol portrays

the 17th century astronomer in this adaptation of Bertolt Brecht's play. The cast also includes Edward Fox, John Gielgud and Margaret Leighton. Filmed in 1975, it is in color and has English dialog.

The German Club also will sponsor two free showings of "Germany: Key to Europe," a film narrated by Kenneth Richter, American film lecturer, at 6 p.m., Monday in PL 500, and at noon, Wednesday in the SUMP.

**'EVOLUTION AND HOMOSEXUALITY'
TOPIC OF LECTURE ON FEB. 5**

Dr. James D. Weinrich, a prominent researcher, writer and educator in the behavioral sciences, will give a free lecture on "Evolution and Homosexuality" at 3 p.m., Saturday, Feb. 5, in

the Lower Commons. His visit is sponsored by the Gay and Lesbian Union on campus and the Riverside/San Bernardino Gay and Lesbian Community Center.

Dr. Weinrich, who is on the faculty of the Department of Psychiatry and Behavioral Sciences at Johns Hopkins University School of Medicine, is an editor of "Homosexuality: Social, Psychological and Biological Issues," the final report of the Society for Psychological Study of Social Issues' Task Force on Social Orientation. Dr. Weinrich has conducted research and published articles on the evolution of behavior, application of scientific findings to social debates, human reproductive strategy, psychology and sociobiology, and homosexual behavior in animals.
