hen the FBI released data regarding law enforcement officers killed and assaulted in the line of duty for 2022 on March 8, it appeared to throw cold water on Riverside County Sheriff Chad Bianco's over heated rhetoric about why he believed police officers were being killed in the line of duty.

During one of his frequent visits to FOX News in March, Bianco proclaimed, "Criminals have become increasingly more violent and brazen. It's not just one isolated place. It's across the country," he offered not too long after the December 22 shooting death of Riverside County deputy, Isaiah Cordero.

Of course, no one wants to see any officer killed in the line of duty or otherwise, and data released March 8, showed just how much Bianco's statements were over hyped. Sadly, although sixty officers were feloniously killed in the U.S. in 2022, the good news is, it actually

represented a significant decrease of 17.8% from the previous year when 73 officers were killed feloniously.

Additionally, a five-year comparison showed an increase of only three deaths since 2018. Where a 10 year view on the other hand, shows a more significant increase of 33 deaths when compared to 2013.

Obviously, Bianco must have been unaware of the five year downward trend-when he's on FOX News, it seems his glass is always half empty, so it was understandably predictablethough disingenuous- that he would blame a ten year comparison increase in police shootings on what he called, [laws that] "decriminalize everything" as well as lower penalties for some offenses. He also criticized politicians who he claimed, "ridicule police." According to Bianco, this results in criminals being more



CA Leading the Way in Criminal Justice Reform with Proposed Transformation of San Quentin

Built in July of 1852, San Quentin State Prison, home to the country's largest number of death row inmates, is transitioning to a new purpose and undergoing a name change that will reflect its new direction — San Quentin Rehabilitation Center.

"California is transforming San Quentin – the state's most notorious prison with a dark past, into the nation's most innovative rehabilitation facility focused on building a brighter and safer future," said Gov. Newsom in a recent statement. "Today, we take the next step in our pursuit of true rehabilitation, justice, and safer communities through this evidenced-backed investment, creating a new model for safety and justice — the California Model — that will lead the nation."

Twenty million dollars of California's 2023-2024 budget proposal will be allocated toward this transformation, with guidance from community leaders and an advisory board consisting of criminal justice, rehabilitation, and public safety experts worldwide.

"By transforming San Quentin into a place that promotes health and positive change, California is making a historic commitment to redefining the institution's purpose in our society," said Advisory Group Co-Chair and Professor of Medicine at the University of California, San Francisco's (UCSF) Center for Vulnerable Populations, Dr. Brie Williams.

"I look forward to lifting the voices of people who have lived or worked in prisons to imagine a center for healing trauma, repairing harm, expanding knowledge, restoring lives and improving readiness for community return."

The center will focus on education, rehabilitation and breaking the cycles of crime.

"I'm interested in seeing some more restorative justice practices being brought in, to give people who are incarcerated the opportunity to repair the harm," Tinisch Hollins, executive director of Californians for Safety and Justice, said.

"Unpacking why they may have been involved [with the system] and the impact that's had on the families, individuals, and community and then how to be a part of the process of repairing that."

A few restorative justice practices that have previously been exercised in the criminal justice system are victim-impact panels, circle sentencing, and mediations between victims and people who were convicted of crimes.

Victim-impact panels do not involve direct

n May 9, 2023, Rialto residents and Inland Empire environmental activists gathered at the Rialto City Council Meeting to advocate against the continuing development of warehouses within their community, demanding a reconsideration of the vote their City Council made to approve the Pepper Avenue Specific Plan on April 25, 2023. The Center for Community Action and Environmental Justice (CCAEJ)

said in a press release that the community will protest and cease business as usual until this matter is addressed.

Environmental groups cited that the ongoing development is a leading contributor to the "erasure of community commercial, housing and open space zoning." Therefore, the community is demanding a reconsideration of the vote that approved more development, and will protest and stop "business as usual" from taking place until this matter is addressed.

Advocates who attended the weekly meeting urged council members to reconsider their approval of the Pepper Avenue Specific Plan and expressed their frustration regarding their

elected officials not prioritizing community health and safety over economic benefit.

During the public comment period, Michelle Sanchez, a Rialto community member, recited what she called the mission statement on each City Council meeting's agenda.

"You disregarded your first thing here that says Rialto will be a family first community. I don't see how you can say you care about kids and just completely pollute the area of the city," said Sanchez. Sanchez recently spent time at Rialto's Frisbie Park where she encountered not only many Rialto residents, but also families from the city of San Bernardino. She explored the idea of what another kind of development would look like for the community. "If we had a nice retail shopping center they'd probably use that as well."

'Rialto should attract high quality development and improve its physical environment," Sanchez quoted, further reading the agenda's mission statement. "I don't see a warehouse improving the physical environment of Rialto in any way, shape or form."

Elizabeth Sena, a resident of Fontana and Operations Manager of CCAEJ, showed up in solidarity with the community of Rialto and

contact between the victim and person convicted of a crime, but they provide a panel featuring surrogate victims from similar crimes to share how an attack has affected them.

Circle sentencing is another opportunity for people who are justice-involved and victims to have an open conversation. The purpose is to address all parties' concerns and develop an appropriate sentence plan.

Mediations between a victim and a person who was convicted of a crime often feature both parties in a safe space with an open dialogue. The purpose of this activity is for the person who caused harm to take accountability for their actions and help develop empathy for victims.

Examining what works

"I think that's an important piece right now, is looking at what works. Then, scaling out on the things that work and then, also creating funds and opportunities for people who have

program ideas," Hollins expressed.

"A lot of the greatest programs that we have are led by people who are impacted by the issue that they're working on. So, bringing more survivors, more people who were formerly incarcerated and rehabilitated and giving them the tools and resources to fill up those spaces [is important]."

Hollins is a crime survivor and has served as the California State Director of Crime Survivors for Safety and Justice (CSSJ). Hollins shared that she has had incarcerated family members and has also lost family members to violence.

"We don't want jail or prison to be the place where people finally get the help they need. But if this is a consequence of committing a crime or being involved in the crime, I want to make sure that our people have every resource they need to come home better, to come home healthy, to come home prepared," Hollins stated.

According to a 2021 report by the California Budget & Policy Center, which collected data from 2010-2019, Black women and men are overrepresented in California state prisons.

Black women made up 26% of incarcerated women, and Black men made up 28% of the state's prison population among men, while Black people only make up 6.5% of the state's total population.

This is why Hollins would like to see more Black-led organizations involved in criminal justice reform at the state level.

"We need to have culturally competent programs to speak to our people. We need to have Black-led organizations and programs in these places to make sure that our people get the right type of support and resources they need to come back," Hollins said.







Part 2 The Line Runs Through Here: A History of Redlining in Southern California's Inland Empire by Blaire Langley

Where The Inland Empire Story begins

he Inland Empire was one of the major epicenters of agriculture in the 19th century, encompassing two counties San Bernardino and Riverside. Through the growth of industrialization and the two world wars, the Inland Empire held its own in the fabric of California as the state's economic engine kept pace with time.

Many accounts tell the story of its beginnings, the popular owners of citrus groves, and even Booker T. Washington's visit in the early 1900s. However, the diverse stories of those who helped weave the identity of this community and the discrimination they faced are often missed.


The establishment of housing segregation, while harder to document in the Inland Empire, carried the same traits as those marked in major urban centers like Los Angeles.

Housing segregation has various impacts including interference with community connection, education, and financial longevity and as such, it is important to understand its historical imprint on Southern California's inland region.

Beginning Settlement

Native Americans inhabited the Inland Empire for thousands of years prior to both Spanish and American Colonization. According to the web application Native Land, the Inland Empire was once home to the Tongva, the Payómkawichum (Luiseño); the Kizh; the Cahuilla, and the Yuhaviatam/Maarenga'yam (Serrano) tribes whose presence date back to between 3500 and 5000 years. All of these tribes survived and are federally recognized today, including the Pechanga, San Manuel, Cahuilla and others.

In 1851, a group of Mormon settlers arrived from Utah and founded what would become San Bernardino.



According to University of California Riverside professor and author Cathy Gudis, the first group of African Americans, though small, came with this settlement. Included among them was the late Biddy Mason, an enslaved Black woman who eventually sued her owner, Marion Smith, and in 1856 won her freedom. She would go on to become one of the wealthiest real estate moguls in California by the time of her death in 1891.

The community of settlers had a shared network, traveling to and from Los Angeles to

the Inland Empire. The agricultural industry in the late 18th century meant the need for land development, which included new irrigation methods.

Many of the citrus groves were hiring Latino workers, but not as many African Americans. Hence, African Americans like the late Israel Beale, would own their own citrus groves and then clear land for others in the surrounding area for new crops. It should also be noted that available jobs were different for each group.

In the early 20th century through the 1940's,

Latinos were the larger part of the population residing in the heart of Riverside's Eastside. However, by the 1960s and into the 1970's, the Black and Mexican populations were growing at a relative pace.

The Great Migration in the early 1900's sees a large population of Blacks leaving the South and going mostly North, however, a small population does come to the Inland Empire and join the even smaller pre-existing community. Soon, the Black and Latino populations began to swell on the eastside of San Bernardino.

Migration of Blacks from the South by **Decade**

During this time, Blacks held a strong sense of entrepreneurial spirit and the rhetoric from the pulpit in Black churches on Sundays often reflected and encouraged this. Many early 20th century migrants were able to purchase property and become homeowners and business owners. Those who came later, would settled and became part of a growing Black community on the Eastside of Riverside. This area, however, would later be among those redlined during housing segregation.

Housing Segregation & Redlining

Because these migrations led to big cities like Los Angeles, there are clear markers on maps from agencies like the Home Owners Loan Corporation that show which areas were cut off and redlined thus restricting housing access for Blacks, Latinos and other minority groups.

The Inland Empire, however, does not have official redlining maps, yet various informal practices enforced housing restrictions based on race and resulted in unofficial redlining of the area, were still implemented in the region. Some of these restrictions included covenants and gentlemen's agreements.

Covenants

In the 1920s when individuals like the late Dr. Barnett Grier, a physicist that worked in the defense industry, and other Blacks with advanced degrees moved into the inland region, they began to shake things up. At this same time, the practice of covenants began. These

were put into place as deeds on homes that were used to restrict ownership on the basis of religion or race. The language would use exclusionary phrases, such as, "restricted to the white race" or "highly restricted" indicating that the housing would only be available to individuals and families who had the specified attributes. This was in an effort to "create exclusively white spaces" in the Inland Empire.

Gentlemen's Agreements

Gentlemen's agreements, where realtors, homeowners, or loan officers would agree to not sell or provide loans to nonwhites, were also made to ensure that areas would remain exclusively white. So strong were the efforts that there are accounts of white homeowners going to the city council to stop Latino homeowners from moving to all-white areas.

The practice of covenants extended beyond restricted access to average citizens and reached even Black GIs. Covenants would show better loan rates, fewer restrictions, and beautiful housing for GIs, but would follow with language that either overtly or covertly restricted access to Blacks or other nonwhites.

In 1948 the U.S. Supreme Court ruled in the case of Shelly v Kraemer that the government could not enforce restrictive covenants. However, the actions of government did not stop the white community from continuing restrictive practices. Covenants and prohibitions were still in existence by the actions of white homeowners and other community members who would take extreme measures to keep their neighborhoods all white.

Violence Ensues

It should be noted that most Blacks looking to move into all-white areas held higher degrees of education than those already inhabiting these areas and would therefore have great arguments for community contribution, according to University of California, Riverside professor and author Catherine Gudis. Therefore, housing restrictions would be the easiest way to keep Blacks and other minorities out.


Aside from the covenants in place, white community members used violence to scare away nonwhites from moving into the communities they had deemed restricted.

In 1946 the late O'day Short found property by crossing the color line in Fontana, and was met with fatal violence. After being subtly threatened by the local sheriff. Short moved in with his wife and two young children, just weeks after moving, their home was set on fire, killing both of his daughters and his wife. Short died not long after (Tilton 2022).

This was not the only violent act that took place to keep Black and brown families away. Many decided they did not want their families in these areas and would resort to moving back to unrestricted areas. These violent events continued through the early 1960s, such as the story of Lt. K.G. Jefferson a UCLA Physics graduate, whose home was bombed before he was able to move in.



Blockbusting and White Flight

After World War II, some Blacks began to push past the color lines, building homes, then helping to bring others into the neighborhoods. While some white homeowners or community members would resort to violence, most would leave and move to the suburbs.

So what is white flight? The term "White Flight" comes from an exodus that happens when white residents leave a neighborhood en masse because of the entrance of Black residents. Coinciding with White Flight enters the practice of "Blockbusting" which happened owners were persuaded to sell their properties for lesser amounts because of fear that another ethnic group would move in. These two practices would often go hand in hand, with a Black family or two moving into an area, real estate agents would use fear tactics to convince white homeowners to sell their property at a lower rate. Subsequently, the agents would then sell these properties at higher rates to incoming non-white residents.

Some Blacks in the community would organize to stop the process of blockbusting, such as the late Lois Carson.

Unfortunately, these efforts would prove unsuccessful and the result would be the strengthening of racial segregation, only in different neighborhoods.

Real Estate Agents & Steering

As Black and Latino families began successfully crossing color lines into white neighborhoods, real estate agents would often guide prospective Black homeowners into areas predominantly inhabited by Blacks and Latinos.

Some of these efforts were subtle, while others were obvious. Such as the story of the late Dr. Henry Holder, who looked for property near the Patton State Hospital in San Bernardino County where he worked.

"But when he met with a real estate agent to discuss options, the agent encouraged him to look for homes in the Muscott St. area west of the freeway. The San Bernardino Sun reported on September 5, 1965, that "after a few tries, he gave up on the option of living near work and bought a home on the Westside [of San Bernardinol."

While there were Black real estate agents like Talmage Hughes, who helped sell the Magnolia Estates, they often worked within the already segregated confines, this only encouraged and helped to cement the segregation of the area. Leading to a 70% Black community by the 1970s, for example the community within the borders west of Mount Vernon, north of Ninth Street and extending up to Highland to the wash in San Bernardino.

Conclusion

The data and accounts from residents who resided in the Inland Empire during this time make it clear that redlining in this community was a large part of the history of its formation and growth. Like other individuals who lived through an era when racially discriminatory practices were overt, the Inland Empire's Black

like her grandmother who took in people who had nowhere else to go. "emboldened".

Regardless of Bianco's proclamations, the excessive use-of-force by police officers too often leads to bad outcomes, sometimes resulting in the injury or death of an officer though more often, resulting in the injury or death of a suspect. And, it was the misuse/overuse of force incidents, that lead to the calls for transparency and disclosure by police.

Meanwhile, Bianco blames use-of-force incidents entirely on the suspects, claiming, "[I]t's solely because of the resistance from the people that we're trying to arrest."

With the Riverside Sheriff's Department having a leader like Bianco with this mindset, it is no wonder, as he explained in his own words, "Our police and our deputies are far more likely to be involved in use of force situations," he said on Fox, comparing such incidents to when he was a deputy. It's almost as if he was providing his deputies with an "excuse in advance" of future incidents.

With this in mind, is it any wonder that police shootings rose sharply in Riverside County in 2021. And in 2022, one of the 25 cases statewide being investigated by the California Department of Justice involving law enforcement officers

who shot and killed an unarmed person, involved Riverside County.


We know now, however, that Riverside did not report all such shootings last year as required by AB 1506. Reports allege the Riverside Sheriff's Department told the CA attorney general that there were at least two shootings not investigated by the state because they were probably not reported in the manner required by AB 1506.

Under AB1506, signed into law on September 30, 2020 and that took effect July 1, 2021, whenever someone considered unarmed, is shot by law enforcement the department is mandated to report it to the CA Department of Justice for review.

The Riverside County Sheriff's Department is currently under a Civil Rights pattern or practice investigation by the CA attorney general. Bianco's attitude, rhetoric and actions in this regard, remind us once again why such an investigation is warranted.

Of course this is just my opinion. I'm keeping it real.

Advocates have demanded council members reconsider approval of the Pepper Avenue Specific Plan and expressed frustration regarding their elected officials not prioritizing community health and safety over economic benefit. (pepperavenuespecificplan.com)

shared that the decisions made in Rialto affect neighboring communities like her own.

"Two weeks ago I watched this reckless voting happen on this project and I was extremely disappointed," Sena declared.

Shortly after the meeting, Sena traveled to Sacramento to support AB 1000, known as the Good Neighbor Policy. Introduced by Assembly Majority Leader Eloise Gómez Reves (D-Colton), AB 100 would "prohibit local governments from approving a warehouse or logistics facility of 100,000 or more square feet within 1,000 feet of a sensitive receptor."

In Sacramento, Assemblymembers told Sena that decisions around warehousing were primarily at the hands of local governments.

"I hope that based on your reckless decision to vote on this ridiculous project that the residents of Rialto take [that] into account for the next election process," Sena said. She added that she was baffled by the prayer these meetings open with and how the sentiment does not align with the decisions made by the council.

Along with Sanchez, other voices present at the meeting echoed the need for a collective effort from community members and activists to study and raise awareness around the health risks associated with environmental justice violations. Attendees called for "improvements and greater investment in community health, safety, small business initiatives to protect people from air pollution, loss of green spaces, and small business gentrification against vulnerable small businesses."

CCAEJ demanded that local authorities take action to address the impact of the environmental injustices that disproportionately affect marginalized communities.
