A cross the inland region this weekend the community celebrated Juneteenth in a multitude of meaningful ways, from parades to picnics, to walks and art exhibits, to informal and formal neighborhood gatherings, to meaningful conversations and informative discussions, members of the community honored their ancestors, celebrated themselves and advocated for future generations.

Although our once and hopefully—not future president—the dishonorable Donald J. Trumps brags that he alone deserves credit for making Juneteenth famous, those of us who live in the real world know that is just one among the many "BIG" lies he unabashedly proclaims.

In truth, it was the generations of enslaved Africans who survived capture, the middle passage, generations of enslavement,

Murrieta's Rickie Fowler Led US Open Field After Round Two

At the midway point, the unusually thick marine layer gave way to sunshine at the 123rd US Open in Los Angeles. Murrieta's Rickie Fowler (Oklahoma State) and Xander Schauffele (San Diego State) matched each other with 62's on day one, Fowler's followed up with a second round 68 to lead the field at 10 under par.

Fowler's accomplishments in USGA's golf majors has been quite remarkable, even though he has yet to win one. In that 2011 to 2018 span, Fowler finished in the top 10 eight times, including seconds in the Masters (2018) and US Open (2014). If he stays to form, perhaps Fowler's precision iron play and phenomenal putting could lead to his first major title.

Wyndam Clark, currently one behind at (-9), McIlroy and Schauffele at (-8), Dustin Johnson (-6) and world number one player Scottie Scheffler lurks five shots back. The warm

weather will likely tighten up the course and firm up the greens, which will bring a greater challenge for the players.

n California, an increasing number of Japanese, Jewish and other non-Black groups are expressing their support for reparations to Black American residents of the state who are descendants of enslaved people.

Around 100 grassroot organizations, motivated in part by the efforts of the Japanese American Bar Association and John M. Langston Bar Association of Los Angeles, have endorsed the work of the task force, and are calling on California to compensate Black residents for historical wrongdoings.

Donald Tamaki, an attorney, and the only non-Black member of the nine-member state reparations task force panel, stated that the groups supporting the task force are mostly Asian, Latino and Jewish. "They didn't need whole lot of persuasion," Tamaki said. "Why? Because they know the healing power of reparations. I think that, in itself, is a news story: that there's a multi-racial group of both big and small organizations representing different constituencies."

National history of reparations for other groups

The United States government has previously approved reparations for other ethnic groups to address historical injustices.

For instance, Native Americans have been given billions of dollars in compensation for land that was unlawfully taken from them. Japanese Americans received billions in compensation and some of their property was returned for being placed in internment camps during World War II.

Many of the injustices experienced by Japanese Americans occurred after President Franklin D. Roosevelt's issued Executive Order 9066 on Feb. 19, 1942, responding to Japan's aerial bombing of U.S. Military installations at Pearl Harbor, Hawaii on Dec.7, 1941. In the months following the bombing of Pearl Harbor, approximately 122,000 men, women, and children of Japanese descent were forcibly relocated to "assembly centers." Nearly 70,000 of these evacuees were American citizens.

Growing Number of California Groups Express Support for Black Reparations

They were then evacuated to and confined in 75 isolated, fenced, and guarded "relocation centers," known as "incarceration camps."

According to the National Park Service (NPS), 92,785 Californians of Japanese descent were put in temporary detention camps called "Assembly Centers." The cities of Sacramento, Los Angeles, Oakland, and San Francisco, metropolitan areas with the largest Japanese contingents, were incarcerated without legal recourse.

Japanese Americans were imprisoned based on ancestry alone. There was no evidence that they had committed any crimes against the U.S. or presented any danger, NPS explained in its "A History of Japanese Americans in California: Incarceration of Japanese Americans During World War II."

Three Japanese Americans who were involved in and knowledgeable about the Japanese American Redress Movement (JARM) testified at the California reparations task force's public meeting held in Los Angeles on Sept. 24, 2022. They educated attendees about efforts Japanese Americans made to obtain restitution for their forced removal and confinement during World War II.

Maki (President and CEO of the Go for Broke National Education Center, a non-profit organization dedicated to preserving the legacy and lessons of the Nisei World War II veterans) and Ron Wakabayashi (former Executive Director, Japanese American Citizens League) provided historical context on how Japanese Americans achieved a rare accomplishment in U.S. history by passing the Civil Liberties Act of 1988.

They received an official apology letter from the President of the United States and 82,000 surviving Japanese Americans were compensated with \$20,000 payments, which totaled to \$1.6 billion. Executive Order 9066 was officially rescinded by U.S. President Gerald Ford on Feb. 16, 1976.

Japanese drew inspiration from Black

Miya Iwataki - a special assistant to former California Legislative Black Caucus (CLBC) member and U.S. Congressmember Mervyn Dymally who represented the state's 31st District in Congress during the 1980s - was a member of the National Coalition for Redress/ Reparations for Japanese Americans. Iwataki says she drew inspiration from the activism of Black leaders like Dr. Martin Luther King Jr., Black Panther Party member Fred Hampton, the Tuskegee Airmen, and the Brown Berets, among others. She explained that it was Black leaders such as Dymally and former Oakland mayor and U.S. Congress member Ron Dellums who supported the passage of the Civil Liberties Act. Maki, Iwataki, Wakabayashi and other Nisei (second-generations Japanese Americans) and Sansei (third generation) are urging the state to compensate Black descendants of chattel slavery and provide a formal apology for harms suffered in California.

"First, I want to acknowledge the difference in our fight for reparations for the injustice of the (incarceration) camps and the 400 years

n May, California Attorney General Bonta announced that the U.S. Court of Appeals for the Second Circuit approved OxyContin manufacturer Purdue Pharma's bankruptcy reorganization plan.

California is expected to receive \$486 million of the \$6 billion settlement to fund opioid addiction treatment and prevention programs.

"The opioid crisis has left a trail of pain, grief, and destruction across the nation that will leave its mark on generations to come. Its ringleaders

 Purdue Pharma and the Sackler family – bear responsibility for causing much of this grief," Attorney General Bonta said in a press release.

Bonta hopes that the funds awarded from the settlement can be utilized to heal communities. While Purdue Pharma faces the consequences, the Sackler family, who privately owned Purdue, are shielded from such consequences and financial responsibility.

Some key takeaways mentioned in the settlement are that the payments will be spread out over 18 years. In addition, institutions can remove the Sackley family name from buildings,

scholarships, and fellowships.

In 2021, Bonta announced a \$26 billion settlement with three major pharmaceutical distributors: Cardinal Health, McKesson and AmerisourceBergen, it included Johnson & Johnson, a company that manufactured and marketed opioids.

California is expected to receive \$2.05 billion from this settlement, and payments will continue until 2038. The money will be used for opioid remediation. In early June, a few more opioid settlements were announced with Opioid manufacturers Allergan and Tegra. Settlements with pharmaceutical companies CVS and Walgreens were also attained.

California stands to gain up to \$375 million from the Teva settlement and up to \$205 million from the Allergan settlement, \$470 million from the CVS settlement, and another \$510 million from the Walgreens settlement.

Juneteenth: Remembering Freedom's Promise

The Juneteenth holiday marks the public commemoration of slavery's abolition in the United States.

Since the end of the Civil War, Black folks have gathered annually to remember Emancipation Day and to celebrate their lives as free citizens. Yet,

the history of Juneteenth shows that the holiday has always been more than a day of public remembrance.

Since the earliest Freedom Day celebrations, African Americans have used the festivals as a space to demonstrate their active engagement in U.S. political culture and to expand the boundaries of their freedom and citizenship. In many ways, the story of Juneteenth is the story of Black Americans making their own freedom while pushing the country to fulfill its promises of equality.

On June 19, 1865, in one of the final acts abolishing chattel slavery, enslaved African Americans in Texas received official notification that slavery was over. As historian Shennette Garrett-Scott has noted of the postponed announcement, "freedom delayed was just as sweet" for enslaved people in Texas. During the final years of the Civil War, thousands of enslavers in the deep South relocated to Texas in attempt to avoid liberating their human property. Some had to be forced by Union troops to emancipate their enslaved workers, but with relatively few Civil War battles taking place west of the Mississippi River, the Union was slow to arrive in Texas. Texas's remote western location made it easier for southern whites to avoid the consequences of the Civil War, but it also placed Black folks further away from the "grapevine telegraph" that might have informed them earlier of slavery's abolition.

An uneven path toward freedom

On June 19, 1865, Union General Gordon Granger arrived in Galveston, Texas to issue his General Order No. 3, notifying all remaining enslaved persons in Texas of their liberation. This act took place two months after the end of the Civil War and two-and-a-half years after Abraham Lincoln issued the Emancipation Proclamation, signaling the slow and uneven path toward freedom.

The June Nineteenth date has come to represent the day when all Black people were emancipated, but all enslaved persons were not free on June 19, 1865. In border states outside of the Confederacy, enslaved persons were not fully free until December 1865—six months after Granger gave the order in Texas. Some enslaved persons were emancipated even before the Emancipation Proclamation went into effect in 1863. In Washington D.C., the Emancipation Act of April 1862 liberated enslaved persons the year before Abraham Lincoln's proclamation went into effect. Still others celebrated emancipation when the opportunity presented itself.

Ambrose Douglass, a formerly enslaved man from North Carolina remembered a continuous cycle of celebration upon seeing Union troops arrive in their town: "I guess we must acelebrated 'Mancipation about twelve times in Harnett County [NC]. Every time a bunch of No'thern sojers would come through they would tell us we was free and we'd begin celebrating." Ambrose Douglass's experience represented one of the earliest moments Black folks made meaning of their emancipation. Those freedom making acts would be repeated by millions of Black people in the years and decades after slavery. Without provisions from the federal government to help establish themselves as free and independent citizens, each freed Black person made their own freedom the best way they could.

Celebration meets resistance

Emancipation Day celebrations were an extension of Black freedom-making practices. As early as 1866, Black folks began gathering to

celebrate emancipation, or, Jubilee Day. Early celebrations often took place in Black churches and private spaces, featuring prayers, readings of poems and political speeches. They included food, music and entertainment, including Black Civil War veterans donning their uniforms and parading in front of the cheering crowds. The festivals themselves were public displays of Black liberation and achievement. Event goers often displayed American flags prominently to show pride in their new status as free Americans. Yet, Emancipation Day celebrations were almost immediately met with resistance. City officials used segregation mandates to foreclose upon African Americans' efforts to celebrate in public spaces. In some places, local whites enforced noise ordinances to shut down the festivities. In the newspapers, southern whites declared Freedom Day celebrations unpatriotic and potentially dangerous. But Black folks gathered anyway.

In East Texas, freedom colonies and all-Black towns hosted some of the largest Juneteenth celebrations in the South, prompting other states to adopt the June Nineteenth date for Freedom Day celebrations. To avoid trouble with segregation laws, communities held events in churches and other privately-owned spaces instead of assembling in public. Organizers continued to host Juneteenth events despite disapproval by city officials. In Houston in the 1870s, Black community members circumvented the segregation ordinance by purchasing a 10acre plot which they named Emancipation Park and they carried on with their Juneteenth celebrations as they had before. By continuing to hold Juneteenth celebrations, African Americans insisted on exercising their political rights as free people to assemble together, remembering and celebrating collectively their journey out of slavery. By exercising their rights as free people, African Americans insisted on exercising their rights to Juneteenth celebrations and these events became a space for Black folks to enact their rights as free citizens and to help others make the most of their political rights.

To asset in your overall assessment of the dashboard please consider the following:

In relation to all hate crimes, 58% of reported incidents during this five year period were racially targeted, followed by Gender/ Orientation bias (24%), Religious bias (15%), and Disability (3%). The majority of offense types during this period were verbal slurs followed by graffiti. This map provides a view of all hate crimes by type during the report period (2016 to 2021).

Please note that in 2019, the Orange County Sheriff disclosed they unintentionally underreported four 2018 hate crimes during the reporting cycle.



Hate Crimes and Accountability


Data reveals there is little consequence for bad behavior as it relates to hate crimes. Generally, only 35% of hate crimes are referred for potential prosecution and of those, only 50% (18% off all crimes) are filed. 58% of cases filed are disposed, and of those, 49% are convicted as a hate crime. the other 51% are either not convicted of a hate crime, or not convicted at all. This means of all the hate crimes committed in the state of California during this five year period, ess than 6% resulted in a hate crime conviction.

There are occasions when crimes were filed and then prosecuted as a "bias related crime" and not convicted as a "hate crime". In such instances although the perpetrator is held accountable, the jury or judge did not agree that the crime was motivated by hate.




Racial Bias

The majority (48%) of racial hate crimes during this period were Anti-Black at 28%, followed by Anti-Hispanic/Latino at 11% and Anti-Asian at 7%.

Data from the U.S. Centers for Disease Control and Prevention (CDC) indicate that in 2021 there were over 80,000 overdose fatalities involving opioids in the United States. In California there was close to 6,000 opioid

Prescription opioids are not the primary cause of overdoses in Riverside County, according to Wendy Hetherington, the branch chief of epidemiology & program evaluation for Riverside University Health System. Hetherington is also the principal investigator for the Riverside Overdose Data to Action (RODA) program.

Numbers tell the story


RODA partners with the Emergency Management Services Agency in Riverside County, the Sheriff's Office, probation offices, and behavioral health programs to gather data in order to understand the scope of the opioid crisis in the region.

"Iwillsayrightnow80%ofouroverdosedeaths involve fentanyl and/or methamphetamine," Hetherington said.

"There are more overdoses that involve the combination of both fentanyl and methamphetamine than there are overdoses with fentanyl on its own or methamphetamine on its own."

In 2021, there was an increase in overdoses in the Black population which decreased in 2022. The Latinx population has experienced a steady increase in overdose fatalities, which is concerning, Hetherington noted.

Hetherington cited demographics where

there has been an increase in overdose fatalities, such as people experiencing homelessness who are considered to be a high-risk group during the drug crisis. Twenty-five percent of people who overdose are unhoused.

Adults over 35 make up approximately three out of four overdoses in the county. Preliminary data showed that five overdoses occurred in people under 18 in 2022. According to RODA's latest count, there were 859 overdose deaths in Riverside County in 2022.

Seeking solutions

One solution to addressing the drug crisis in Riverside County is eliminating the stigma around those suffering from drug abuse and focusing on decriminalizing those addicted to drugs.

Over the years, as African Americans have faced persistent challenges, Juneteenth celebrations have continued to emphasize Black political and social empowerment in the face of injustice and inequality. In the 1890s, with increased efforts to disenfranchise Black male voters, festivals featured booths with information about citizenship and voting rights for African Americans. During the Great Migration of the early twentieth century, when Black folks left the Jim Crow South with hopes of finding greater opportunities in northern and western locales, they brought their Juneteenth traditions with them. The celebrations waxed and waned over the years, often in response to the political condition of Black people at the time. The racial terror of the 1930s prompted fewer communities to celebrate Juneteenth out of fear of a violent backlash. During World War II, when Black soldiers were subjected to racism at home after fighting fascism abroad, a revival of Juneteenth celebrations emphasized the importance of equal rights for all citizens. During the era of the Civil Rights movement, there were fewer celebrations across the country

as Juneteenth festivities took a backseat to freedom marches and other efforts by African Americans to organize politically. But after the landmark civil rights legislation of the 1960s, Black communities again celebrated Freedom Day, using Juneteenth as a way to connect past struggles for freedom with their contemporary struggles for full liberation.

In the last forty years, Juneteenth celebrations have continued to respond to political issues affecting the Black community, including the war on drugs, mass incarceration, police and state violence, and efforts to disenfranchise Black citizens. The festivals often still feature booths and events that highlight political rights, self-determination, and education. In 2021, in the wake of George Floyd's murder and a spate of other violent events, the U.S. government made Juneteenth a federal holiday to remind us that the United States is a nation of free citizens. Yet African Americans and many other minoritized people are still fighting to experience the fullness of freedom's promise.

Living in the wake of slavery, African Americans continue to experience racism and skewed life

chances, including poor access to health care, premature death, violence, incarceration, limited access to education, and a host of other political and social issues. A quick glance at Juneteenth events hosted in Southern California this year shows that festivals are again responding to the needs and demands of Black communities. In response to the pandemic and the ongoing threats against Black life, many festivals are prioritizing health and wellness events this year, including mental and physical wellness activities, COVID testing and vaccinations, and self-defense instruction.

Juneteenth continues to be a celebration of Black life and culture while reminding us that the nation still has work to do as the struggle for freedom continues.

Natasha McPherson is an Assistant Professor of African American History at the University of California Riverside. Professor McPherson received her Ph.D. in History from Emory University. Her research examines the lives of southern Black women living in the wake of slavery and Reconstruction. She is currently completing her book manuscript, Women and the Making of Creole New Orleans.

history of enslaved people," Iwataki testified. "We're not here to make recommendations or to prescribe lessons learned. I am here to share the experiences of NCRR and all volunteer grassroot organizations that fought for reparations and to express our continued solidarity for Black reparations."

Support of Jewish community

In September 2022, the San Francisco Black and Jewish Unity Coalition held reparations teach-ins at Congregation Sherith Israel in San Francisco. Secretary of State Shirley Weber, who authored the legislation, Assembly Bill 3121, that created the task force when she was an Assemblymember, was one of the speakers. Congregation B'nai Israel hosted a 90-minute reparations information session in Sacramento on June 11. Presented by Sacramento Jewish opera singer Lynn Berkeley-Baskin, over 20 people – Jewish and Japanese — attended the event to hear Chris Lodgson from the Coalition for a Just and Equitable California share his experiences as one of the grassroots leaders driving California's movement for reparations. Germany has openly acknowledged past aggressions committed during the Holocaust. According to a June 202 report by Steven J. Ross in the Jewish publication the Forward, the German government has paid out \$92 billion to Holocaust survivors over seven decades. In the United States, the country has "failed to reckon with the consequences of centuries of slavery," Ross writes. "As laws advancing revisionist history sweep our nation's state legislatures, Americans who favor a national reckoning with our own complicated past would do well to take a lesson from Germany," he explained.

Ross, a history professor at the University of Southern California (USC) continued, "If we want to truly heal as a nation, we must first acknowledge both the long history of slavery

and the pain its legacy still causes – and take tangible steps to right our collective wrongs," Task force next steps

The task force will hold its final meeting and submit its final report to the California legislature on June 29. The meeting will start at 9:00 a.m., in the First Floor Auditorium of the March Fong Eu Secretary of State Building, located at 1500 11th Street, downtown Sacramento. "If there are helpful takeaways from our experience, I hope that they will contribute," Wakabayashi said of Japanese Americans' fight for reparations. "It would help repay a great debt. The Black civil rights movement generated the Japanese American Redress Campaign and led the struggle for human rights in this country."

Every year we must remind successive generations that this event triggered a series of events that one by one defines the challenges and responsibilities of successive generations. That's why we need this holiday.

their supporters, to continue the generational resistance against injustice, to make the same compelling arguments for fairness in America appealed by previous generations and to do so supported by equal passion and buoyed by data which, in the process, makes it more difficult-for those who perpetuate a white racist mindset--to coherently and intelligently deny the need for change.

Today, with determination we are creating space for ourselves at the table where decisions are made and, in the process, we are finding ways to bring an even louder voice of consciousness, a measure of fair compromise, and serving as a bulwark against what has been an historical mantra against progress progress—the word "wait."

As we mark Juneteenth 2023, in addition to remembering that we've waited long enough and that "we are our ancestors wildest dreams" we must also remember that on Juneteenth we celebrate more than freedom from chattel slavery.

On this day, in addition to freedom of our bodies, we celebrate the hope and promise that accompanied it. It reminds us that we must continue to resist partial citizenship as we advocate for the fullness of what it means to be an American.

This includes everything from access to the franchise; to education; to the right to own property and equal access to the instruments of finance to make homeownership possible (coupled with the unencumbered access to live where we choose); to healthcare; to social justice; to an unbiased criminal and judicial system; to fair compensation for our labor; and the equitable distribution of tax dollars needed to sustain and enhance our communities.

As noted above the freedom we celebrate on Juneteenth encompasses more than the act of emancipation. It reminds us that we cannot rest on our progress. Like those who came before us, we still have work to do. Ella's Song, written by Dr. Bernice Johnson Reagon in honor of the great civil rights and human rights leader, Ella Baker, stated this charge eloquently when she wrote, "We who believe in freedom cannot rest until it's won."

Of course, this is just my opinion. I'm keeping it real.

this issue in the United States that the war on drugs hasn't been successful, and continuing down this path is not going to prevent more overdoses unless you're truly addressing the root causes about why people become addicted in the first place," Hetherington said.

Dr. Andrew Subica, a health disparities researcher and associate professor of social medicine at the University of California, Riverside, discussed bringing more harm reduction programs to the Inland Empire.

Harm reduction services are considered controversial because they include safe injection sites. They also provide syringe and naloxone distribution services. Data shows that harm reduction services help prevent overdose deaths and the transmission of infectious diseases.

"Harm reduction tries to meet people where they're at and then minimize the negative health impacts on their lives," Subica said.

"It does, over time, allow people to build a connection. Then, that's where you can eventually try and get them resources, including employment and get them health care because people who use substances often have a lot of mental or physical health problems."

After the connection is made, there is an opportunity to enroll those struggling with drug addiction into detox programs, but the key is to avoid pushing them into abstinence because then "you might lose them," Subica emphasized. Riverside needs programs that protect the health of everyone who suffers from drug abuse because there has been an upward trend in overdoses of methamphetamines for twelve years. It is trending toward thirteen years by the

sexual orientation related hate crimes is Anti-Gay (male), followed by Anti-LGBT. The data also confirms that Gender/Sexual Orientation related crimes have been on the rise since 2015. The majority of offense type against this group were verbal slurs.

Religious Bias

During the five year period of this report the majority (61%) of religious hate crimes were Anti-Jewish, followed by Anti-Islamic.

Hate crimes motivated by Religious Hate decreased from 208 incidents in 2019 to 180 incidents in 2020, then rose 22% in 2021 to 220 incidents.

The majority of offense types were graffiti followed by "other".
