Bonta Joins Amicus Brief in Defense of Tansgender Students



An Axios report released in December 2022, painted a dire picture revealing 54% of trans and nonbinary youth surveyed in CA, "seriously considered suicide," and 19% of those surveyed said they actually "attempted suicide" in the past year. (legacy.lambdalegal.org)

A ccording to the National Institution of Health, data indicate that 82% of transgender individuals have considered killing themselves and 40% have attempted suicide, "with suicidality highest among transgender vouth."

The growing need to appropriately and lovingly support these young people as they work their way to adulthood in a nation where many are hostile to their identities is evidenced by the crisis being experienced here in California related to suicide among transgender youth.

An Axios report released in December 2022, painted a dire picture revealing 54% of trans and nonbinary youth surveyed in California, "seriously considered suicide," and 19% of those surveyed said they actually "attempted suicide" in the past year.

We can not turn a blind eye to their plight.

For this reason, I applaud the action of Attorney General Rob Bonta who, at the end of June, joined 16 other attorneys general in an amicus brief in support of the Ludlow School Committee's efforts to create a safe and supportive environment for transgender children and all students.

The Ludlow School, located in Massachusetts, is facing a challenge to its policy that seeks to prevent the unnecessary disclosure of a student's gender identity.

In the AG's friend-of-the-court brief, they reiterated the role of states in supporting "safe, inclusive school environments that help all children learn, thrive, and grow into contributing members of society."

In announcing the amicus brief, Bonta stressed the importance of respecting all students' identities including those who are continued on page 14

he U.S. Food and Drug Administration (FDA) granted full approval to the Alzheimer's drug Legembi (lecanemab) on July 6, after the drug was initially given accelerated approval in January.

Legembi is the first Alzheimer's drug that has shown a significant reduction in the growth of amyloid-beta plagues from the brain of people in the early stages of Alzheimer's. Following

the FDA's approval, the Centers for Medicare & Medicaid Services (CMS) agreed to cover a substantial portion of the medication after they initially declined to do so until the drug received traditional approval.

"With FDA's decision, CMS will cover this medication broadly while continuing to gather data that will help us understand how the drug works," CMS Administrator Chiquita Brooks-LaSure said in a statement.

Roughly 6.5 million Americans 65 years of age and older were living with Alzheimer's disease in 2022, according to a report by the

Alzheimer's Association.

Tia Delaney-Stewart, director of Diversity, Equity, and Inclusion for the Alzheimer's Association, California Southland Chapter, explained that the FDA's approval of Legembi will positively impact patient access, especially where access to barriers continue to exist. Eighty percent of the Black population reports access barriers to health care and support for Alzheimer's and other dementias, while 33% of Hispanic populations report experiencing discrimination related to health care access, Delaney-Stewart noted.

"While we know this is not a cure, Legembi addresses the underlying biology of Alzheimer's and substantially changes the course of the disease by delaying its progression," Delaney-Stewart said in an email.

The FDA's approval was permitted after a clinical trial verified that the drug has clinical benefits. With the approval comes a boxed

he California Legislative Black Caucus (CLBC) held a press conference to condemn the recent Supreme Court of the United States' (SCOTUS) decision on affirmative action.

"In the wake of today's Supreme Court decision, the California Legislative Black Caucus is extremely disappointed in the continual unraveling of hard-won fights for civil rights,

equity, and the dismantling of systematic racism," said Assemblymember Lori D. Wilson (D-Suisun City), Chair of the CLBC.

"However, our unwavering commitment to continue the fight against the legacy of racism and discrimination that still impacts society today has not been shaken," Wilson continued at the press conference held July 5. "We understand the work we do as legislators is vital to ensure equitable access and opportunity are available to Black Californians and remain steadfast in our dedication to advancing policies that improve the lives of all our constituents."

On June 29, the SCOTUS ruled 6-3 to outlaw affirmative action in college admissions. The ruling resulted from cases brought against Harvard University and the University of North Carolina in which plaintiffs argued that affirmative action policies at those schools discriminated against Asian American and White Students.

The SCOTUS' opinion which breaks with 45 years of legal precedent, states that considering students' race to diversify student bodies violates Title VI of the Civil Rights Act of 1964 and the Equal Protection Clause in the Fourteenth Amendment.

Last week, U.S. Rep. Barbara Lee (D-CA-13) wrote an opinion piece on the SCOTUS's decision. She reflected on being present when Prop. 209 eliminated affirmative action programs in California in the areas of public employment, public education, and public contracting from providing "preferential treatment" based on race, sex, color, ethnicity, or national origin.

The measure affected admissions and other programs at the state's public universities and funding for public schools (kindergarten through 12th grade), community college programs, as well as government contracting.

"I argued against ending affirmative action in California before the (University of California) UC Board of Regents over 20 years ago," Lee posted on Twitter on July 2. "I knew then what I know now: ignoring race doesn't make racism go away. It makes it worse."

On the same day as the SCOTUS' decision, the California Task Force to Study and Develop Reparations Proposals for African Americans submitted its 1,075-page final report to the California legislature.

The report includes 115 recommendations continued on page 13

warning that informs patients and caregivers of the potential risks associated with Leqembi, namely amyloid-related imaging abnormalities (ARIA), which can present as temporary swelling in some areas of the brain and may also appear with small spots of bleeding in or on the surface on the brain.

Alzheimer's remains an incurable cognitive disease and while Leqembi will not stop Alzheimer's from getting worse, a clinical trial showed promising results of slowing the progression of the disease. In a group study of 1,795 patients with Alzheimer's disease, Leqembi administered every two weeks through intravenous infusion resulted in the slowing of cognitive and functional decline by 27% over the course of 18 months.

While some experts acknowledge the

limitations of Leqembi, the drug has much more approval than another Alzheimer drug, Aduhelm, which was granted accelerated approval in 2021 by the FDA. In one trial the drug showed

evidence to have slowed the progression of the disease, but in another trial showed no slowing of the disease.

A 2022 congressional investigation into the FDA's approval of Aduhelm noted that the FDA's approval process was "rife with irregularities." Medicare also declined to cover the costs for patients. Biogen priced Aduhelm at \$56,000 per year.

Japanese pharmaceutical company Eisai and U.S. manufacturer Biogen, maker of Alzheimer's drug Aduhelm, have partnered to produce and market the drug. Leqembi will cost \$26,500 a year — 80% of which Medicare will cover for individuals with "Original Medicare" who will pay a 20% coinsurance of the Medicareapproved amount for Leqembi, once they meet their Part B deductible. For other Medicare

CA Sees Stark Increase in Hate Crimes Over Last Decade

t the end of June, Attorney General Rob Bonta and the California Department of Justice released its 2022 Hate Crime in California Report.

While some populations saw a stark decrease in hate crime events, overall, the number of hate crimes in California has continued to increase.

Looking back, 2014 had the lowest number of reported hate crimes in the last decade, with 758 reported incidents. Despite 2014 results, however, hate crime events in California exploded during the last ten years, increasing 145.7 percent.

"This report is a stark reminder that there is still much work to be done to combat hate in our state. I urge local partners and law enforcement to review these findings and recommit to taking action," said Attorney General Bonta in a press release.

"An attack against one of us is an attack against all of us."

Center for Healthy Communities Workshop Focuses on Imp

s health care a right or a privilege?" Dr. Emma Simmons asked as she addressed the audience during a Center for Healthy Communities (CHC) community workshop on June 29.

Attendees remained quiet as they contemplated the question.

A few people spoke up, explaining that health care should be a right, but in America, it's a privilege to have access to health care.

"Health care is a fundamental human right," Dr. Simmons asserted. Dr. Simmons is a Health Sciences Clinical Professor at the University of California, Riverside, senior associate dean of student affairs and the Salma Haider Endowed Chair for the Thomas Haider Program at the UC Riverside School of Medicine.

While community members nodded in agreement, the reality in the U.S. is health care is not treated as a fundamental right. According to a 2023 report published by the Commonwealth Fund, a private and independent research organization, the U.S. is the only high-income country where a large portion of the population lacks any form of health insurance.

In 2021, U.S. health care spending reached \$4.3 trillion — \$12,914 per person, according to the National Health Expenditure, which monitors total health care spending. Despite spending the most on health care among highincome nations, the U.S. is the only one of these countries that does not offer universal health and has the worst health outcomes.

The U.S. has the highest maternal mortality rate across high-income countries, with Black birthing people having a higher rate -2.6times higher - than White and Hispanic populations, according to a 2021 report from the U.S. Centers for Disease Control and Prevention (CDC).

In a country where access to health care is not a fundamental right and underrepresented communities experience the health inequities, Black and brown people are forced to become

advocates for themselves and others in order to access equitable health care.

The CHC community workshops have fostered a safe space for community members to ask medical professionals questions, hear from the perspective of providers and gain knowledge on what actions to take while interacting with health care institutions.

As the three-part community workshop series comes to an end - for now - these workshops set out to inform the public about the findings from CHCF's "Listening to Black Californians" survey and equip the community with tools for addressing the shortcomings of the health care system.

Creating partnerships and being involved in vour care

Simmons's presentation focused on addressing how disparities exist across gender, race, ethnicity and a host of other factors. While she acknowledged the lack of equity in the health care system, Dr. Simmons discussed how individuals can take action in particular instances. The presentation sparked a conversation on how patients and providers need to recognize one another's role in health care and realize that their relationship is a partnership — "not a dictatorship," Dr. Simmons said.

"What do we do when physicians don't listen to us? How do we get them to listen?" Community member Grace Nyanzwii asked. Nyanzwii explained how physicians had constantly ignored her friend and downplayed her symptoms. After several consultations, her friend was diagnosed with lymphoma, a type of cancer that impacts the lymphatic system.

Dr. Simmons took Nyanzwii's question and asked the audience. Attendees shouted responses like "get a second opinion" and "file a complaint." Dr. Simmons agreed. She explained that part of taking action is asking questions about what providers say and knowing the right questions to ask.

Developing a relationship with your provider

is one of the most important things a patient can do to become more involved in their care. according to Dr. Adwoa Osei, director of UC PRIME. For doctors who are juggling dozens of patients and patients who feel unheard, Dr. Osei believes that communication is key, but the "art of communication" is lost.

"This person took an oath to do you a service," Dr. Osei emphasized. Providers are overworked and appointments with patients often feel rushed, but Dr. Osei reminded the audience that providers are human too, and need empathy just as patients do. There are things patients can do to support physicians with providing the service that they want, such as addressing doctors with simple pleasantries as a courtesy and having a prepared list of questions regarding what the visit is about. Fostering a relationship with a provider helps create a partnership that will prioritize the patient's health needs.

The importance of advocacy

Throughout the CHC's community workshop series, one theme has been clear regarding the changing landscape of health care in the U.S.: Patients have to act as advocates on behalf of themselves and their loved ones as they navigate the health care system. There was once a time where patients took doctors at their word, but those days are long gone.

As inequality reveals itself to be embedded into every facet of health care institutions, advocacy has become an essential tool utilized by patients to demand adequate care. With the health care system constantly transforming in the wake of the pandemic's exposure of institutional racism and inequitable care, patients are forced to be their own advocates in order to achieve the best health outcomes.

"We only have one life, one body," CHC Communications Director Michelle Burroughs said. "We have to be active in our health journey."

After the community workshops conclude, Burroughs often reminds the audience that "no one is going to save us." With those words, she encourages the audience to participate in the workshops by asking questions, sharing their

experiences and gathering all the information they can to take back to their families and communities.

While the community workshop series has concluded in Riverside, Burroughs and her team hopes to host a similar community series in San Bernardino, to further share the information across the Inland Empire.

Anti-Black hate crime incidents increased by 27.1%, and hate crime events rose from 513 in 2021 to 652 in 2022.

"We must sound the alarm. Hate is on the rise. These numbers show that it is imperative that we take swift and decisive action to halt the rise of hate crimes targeting the Black community and be an ally against hate in partnership with the Jewish and LGBTQ+ communities," said Assemblymember Dr. Corey Jackson in a statement to Black Voice News.

Jackson's office also emphasized the importance of Assembly Bill 1079. If passed, AB 1079 will create radio, social media, and television campaigns to discourage discrimination based on disability, gender, nationality, race/ethnicity, religion, or sexual orientation.

Under AB 1079, the Department of Public Health director would appoint a nine-member team with expertise in marketing and messaging. "By passing AB 1079 into law, we can tackle the root causes of such crimes, promote education and create an anti-hate, antiracist, and anti-xenophobic state," said Jackson.

Other Categories


Anti-Asian hate crimes decreased this year after having record-high numbers in 2020 and 2021 during the COVID-19 pandemic.

According to the report, 101 Asian individuals were attacked in hate crime events in 2020, which was a 102% increase from 2019, when 50 people were reported as victims of hate crimes.

Anti-Asian bias events fell from 247 in 2021 to 140 in 2022.

Among religious groups, the biggest increase in hate crimes was against the Jewish community. Anti-Jewish events increased by 24.3%, from 152 in 2021 to 189 in 2022.

California data is indicative of what is seen across the country, which shows a significant increase in anti-Jewish attacks in the past year. In 2022, the Anti-Defamation League (ADL), a Jewish, anti-hate nonprofit, governmental organization, identified 3,697 antisemitic incidents across the United States —a 36%

increase from the 2,717 incidents recorded in 2021.

Antisemitic incidents in 2022 were recorded as the highest number on record since ADL began tracking antisemitic incidents in 1979, according to the Anti-Defamation League.

Similar to religious and race/ethnic groups, hate crimes motivated by a sexual orientation bias increased by 29%, from 303 in 2021 to 391 in 2022.

Prosecutions and convictions

The FBI defines a hate crime as a "criminal offense against a person or property motivated in whole or in part by an offender's bias against a race, religion, disability, sexual orientation, ethnicity, gender, or gender identity."

However, these crimes are often difficult to prosecute because you need to prove not only that the incident occurred but also the state of mind of the suspect as to whether or not his/her action was motivated by hate.

As a result, there are occasions when a crime can be filed and prosecuted as a "bias-related crime" but not convicted as a "hate crime." This occurs when a judge or jury does not agree, based

on the evidence, that the crime was motivated by hate.

There were 122 hate crime cases in the state, with a court disposition noted in this report. Of those, 43.4% were hate crime convictions, 45.9% were other convictions, and 10.7% of the cases did not result in convictions.

In Riverside County, 22 hate crime cases were referred for prosecution, during this reporting period, and 17 were filed as hate crimes. In San Bernardino, 11 hate crime cases were referred for prosecution, and 10 were filed as hate crimes. Hate crimes can be challenging to track because not all attacks are reported.

For example, some members of marginalized communities may be more hesitant to report an incident because they don't know how to navigate the legal system, or they fear the possibility of blowback from the police department and the lack of faith that anything will be done.

In addition, members of the LGBTQ+ community may hesitate to come forward, fearing the possibility of being "publicly outed," according to the research collaborative Tackling Hate.

and a request for a formal apology from the state for state laws, policies and practices that disproportionately and negatively affected Black Californians.

Ethnic Media Service and California Black Media invited litigators who defended Affirmative Action before the U.S. Supreme Court to reflect on the court's ruling and its broader impact two days after 11 members of CLBC convened at the State Capitol to express their opinions on the ruling.

A discussion about next steps for racial equity, including a lawsuit against "legacy admissions" at Harvard, was also addressed. Legacy admissions give special consideration to children of alumni during enrollment decisions.

Part of the litigation team, Jin Hee Lee, Director of Strategic Initiatives at the Legal Defense Fund (LDF), was one of the participants on the panel. LDF represented clients of color and alumni organizations at Harvard who opposed the dismantling of Affirmative Action, from the trial level to the Court of Appeals, to SCOTUS.

"It will make it extremely difficult for universities to be able to consider race as part of the admission process," Lee said. "(The decision) is a blow to efforts to advance equal opportunities and racial equality in our educational system which suffers from tremendous dysfunction and inequality."

Three days after SCOTUS's ruling, the Lawyers for Civil Rights (LCR), a legal nonprofit in Boston, filed a civil rights complaint against Harvard with the Education Department, LCR is arguing Harvard's legacy admissions process unfairly benefits White family members, many who donate money to the school. According to College Transitions, approximately 75% of the top 100 colleges in the U.S., including all Ivy League schools and most elite private universities, favor legacy status.

Sen. Steven Bradford (D-Gardena), vice chair of the CLBC, expressed his views on legacy admissions.

"This begs the question: is this court committed to putting everyone on an equal footing? Well, then legacy admissions should be addressed as well if that's the case," Bradford said. "A recent study found that 43% of White students admitted to Harvard were admitted based on legacy, based on family members, based on donors, based on athletes, or again, based on faculty or staff. Why should children of alumni and wealthy donors get special treatment? This is wrong."

Justice Clarence Thomas, the second Black man appointed to the high court, wrote that the decision exposes universities' admissions policies as "rudderless, race-based preferences" to ensure a specific racial mix in their classes.

Those who disagree with the court's ruling believe the fight for racial justice in higher education, particularly for African Americans, is

Not surprisingly, the case against the Ludlow School was brought by a pair of conservative groups, the Massachusetts Family Institute and the Child and Parental Rights Campaign joined together in a symbiotic pact rooted in discrimination.

manufacturing, automotive and machine repair, construction, finance and business, health care, homeland security, hospitality, information technology, renewable resources and energy, retail sales and services, and transportation.

"Job Corps offers a path to apprenticeships and higher-paying careers in the nation's fastest-growing industries. Our graduates fill a critical need for employers and the economy," said Job Corps national director Rachel Torres.

Eligible individuals can join Job Corps free of charge, allowing them to pursue their career aspirations without the burden of student debt. The program also offers on-campus housing, meals, health care services, and job search assistance, ensuring participants have a supportive environment to thrive in.

To qualify, applicants must meet certain criteria. Those receiving benefits such as SNAP, TANF, or free or reduced-price school lunch are eligible, as well as individuals who have experienced homelessness or were formerly in foster care. Job Corps also offers expedited enrollment for young adults who meet the age requirements but lack stable housing.

Torres expressed the advantages of Job Corps for both students and employers, stating, "For students, we are a path to careers, certifications, and connections - all without student debt. For employers, we're a possible solution to their workforce pipelines. It's a winwin for Californians."

Recently, Job Corps unveiled a newly revamped national website along with individual campus websites nationwide. The updated platforms feature virtual tours, a 24/7 virtual assistant named Corey, and an interactive map that allows users to locate a campus based on their preferred location, industry, or specific training area.



"For people not enrolled in Medicare, including many treatment-eligible individuals under age 65, we expect other payers to ensure burden free access. It is time for all payers to deliver broad access," said Joanne Pike, Alzheimer's Association president and CEO in a statement.

CMS plans to add a requirement that providers prescribing Leqembi submit medical information about each patient before and during treatment. The collection of information will be kept in a registry. Researchers will have access to the information to conduct future studies regarding how the drug can help people with Medicare.
