Trustees Implement Recent IRS Ruling

Beginning with the February paychecks, most Cal State employees will take home a few dollars more from their paychecks because of a CSU Board of Trustees ruling decision.

The Trustees adopted provisions last week to implement a recent Internal Revenue Service ruling relating to tax treatment of retirement contributions paid by CSU employees who belong to the Public Employees' Retirement System (PERS).

Beginning with the February pay period, retirement contributions from an eligible employee's salary will be deducted before federal and state taxes are withheld. This means that taxes will not be due on the employee's share of retirement contributions until he/she retires or is otherwise separated from service and the contributions are received. Current taxable income will be reduced by the amount of the PERS contribution, thereby reducing current federal and state income tax withholding.

University employees not covered by PERS are those individuals appointed for less than six months and less than half time. They do not pay into the PERS program and receive no benefits from it.

For employees who belong to PERS and also are covered by a collective bargaining contract, the CSU and the appropriate union must agree that this benefit will be provided. Agreements have been reached with three unions and talks with other unions are underway.

Other actions by the trustees at their January meeting include:

- * Designated age 70 as the mandatory retirement age for CSU employees, to conform to Assembly Bill 398; clarified appeal procedures for continuation of employment beyond age 70 upon certification of adequate performance, and included Management Personnel Plan employees in the provisions.
- * Adopted internal regulations to allow current or newly hired employees to receive reimbursement for moving and relocation expenses, within budgetary constraints, incurred by change of residence because of a new assignment, promotion, or other reasons. Determination of who is to receive such reimbursements and the amounts will be made by the chancellor or campus president.
- * Directed the chancellor to provide a receptacle for deposit of lottery revenues, taking appropriate action, including legislative action if necessary, to have such a fund established and to provide the Board with sole discretion for use of the funds, within the laws established by Proposition 37.
- * Adopted the five-year Academic Plans for the 19 campuses, covering the years 1985-86 through 1989-90. The plan for the San Bernardino campus includes approval to develop an M.A. in rehabilitation counseling. If the degree program is approved, it would be implemented next fall. The university also has approval to develop a B.A./B.S. program in industrial studies, an M.S. in health science, a B.S. in nutritional science and a B.S. in speech pathology and audiology. Once a degree is on the master plan, the university may proceed to develop the proposal which shows need, local support, facilities and budget. After this proposal is approved, the degree program may be offered.

**Teaching Panel To
Discuss Careers Feb. 6**

With the shortage of teachers still a major problem in the Inland Empire, Cal State will bring together a panel of educators to discuss careers in the field Wednesday, Feb. 6.

Sponsored by the Career Planning and Placement Center, the free session is open to anyone who is interested in becoming an elementary or secondary school teachers. Speakers will represent the San Bernardino City and County Schools, business and the university.

Dr. Ward McAfee (Academic Affairs) will moderate the discussion. Panelists are: Dr. Ernest Garcia, Karla Hallum, Dr. Ellen Kronowitz and Dr. Phyllis Maxey (all Education); Les Murray, chairman of the education committee from the San Bernardino Chamber of Commerce; Lorne Bargmann, associate superintendent for personnel; and Dr. Dan King, director of certificated personnel from the San Bernardino City Unified School District; Robert Bullock, program manager for personnel services, and Dr. Augustine Ramirez, assistant superintendent, both from the San Bernardino County Schools.

Topics to be discussed include credentials, teacher shortages, areas of teacher needs and how to enter the teaching program.

**Phyllis Benson Performs
Harpsichord Concert Feb. 10**

"A Bach, Handel, Scarlatti Birthday Celebration" Sunday, Feb. 10 will feature Phyllis Benson (Music) on the harpsichord celebrating the 300th birthyear of the composer.

The concert repertoire will include Johann Sebastian Bach's "Tocatta in D Major," George Frederic Handel's "Suite No. 5 in E Major" with the popular "Harmonious Blacksmith" Air, Bach's "Fifteen Two-Voice Inventions" and Domenico Scarlatti's "Five Sonatas."

Ms. Benson, who also teaches in the San Bernardino Community College District, has performed in Austria, Denmark, Germany and Switzerland on piano and harpsichord. She is planning her sixth European concert tour this fall as well as a mid-west USA tour.

A winner of many awards for her work including the Theodore Presser Music Scholarship, Ms. Benson is listed in the World's Who's Who of Musicians. She holds a master's degree in historical performance practices from the University of California.

The concert will begin at 7:30 p.m. in the Recital Hall. Tickets, available at the door, are \$3.50, general admission; \$1.75, students and senior citizens.

Professional Activities

Dr. Gene Andrusco's (Accounting and Finance) article, "On the Investigation of Causality Among Economic Policy Variables," has been chosen by the Arkansas Business and Economic Review to be published in the "1984 Selected Arkansas and U.S. Economic Indicators."
