



Betrayal

Riverside County is home to one of four California Representatives counted among the "Disgraceful 126"

t was a remarkably shameful act, not surprising, but shameful nonetheless.

To imagine 126 Republicans from the U.S. House of Representatives joining an amicus brief in support of a Texas lawsuit in the Supreme Court to overturn the results of the presidential election by ignoring the will of the people was disturbing.

What added insult to injury was the suit's obvious effort to disenfranchise Black voters in the swing states of Pennsylvania, Michigan, Wisconsin and Georgia.

It left a shameful mark on the face of democracy, for those in the inland region, the state of California and the country. Their act was another wake-up call to the realization that America's democracy is in danger.

Counted among those who sought to undermine the federal government was Riverside's own Ken Calvert who has held office since 1993 and represented the county's 42nd Congressional District since 2013. Calvert was not alone among California Republicans who sought to betray the country. He was joined by three other California representatives including: Doug LaMalfa, Congressional District 1; Kevin McCarthy, District 23; and Tom McClintock, District 4.

In the brief they asserted as members of congress, "[I]t presented the concerns shared by untold millions of their constituents, that the unconstitutional irregularities involved in the 2020 presidential election cast doubt upon its outcome and the integrity of the American system of elections. [T]he broad scope and impact of the various irregularities in the "Defendant" states necessitate careful and timely review by this court."

The Supreme Court dismissed the frivolous case out of hand.

What do we make of these constitutional charlatans who so frequently wrap themselves in the statute as if it were a coat of armor, cling to it as if it were a shield against pigmentation, all the while violating it with wanton disregard when they cannot twist it to their purpose?

This is not Belarus. This is not Zaire. This is not any other country where dictators work their

will against the wishes of the majority, aided and abetted in their corruption by subservient sycophants.

Are these people so deeply rooted in their racism, so tied to their beliefs of White Supremacy they would rather



destroy a nation than live up to the unfulfilled promise of this fledgling democracy? Or are they just acting out what has always been apparent to Blacks and other people of color in this nation that when the constitution was written with all its brilliant flourishes they know, like we know the founders of this country never envisioned a nation of color. Is that what they really mean when they say they are "originalists?"

At this point it might be interesting to note the original seal of the United States proposed by Thomas Jefferson, Benjamin Franklin and John Adams included an image of Moses leading the Israelites out of their bondage in Egypt to the "Promised Land of freedom and liberty." And if that were not ironic enough for a slave-holding nation, consider the proposal for the obverse side—the likenesses of Hengist and Horsa, the two brothers who supposedly led the first Anglo-Saxon settlers in Britain. The obverse side included the quote: "Rebellion to Tyrants is obedience to God."

After fervent discussion the proposal was rejected. According to historian and author Edward J. Blum, in part because, although it inspired resistance to England, there were concerns it could put ideas into the heads of slaves that Jefferson did not want and also raised issues of what freedom meant both religiously and racially. They apparently believed freedom was from God (Exodus) but also from Anglo-Saxons (Hengist and Horsa).

The design recommended to Congress by the authors of the constitution on Aug. 20, 1776 included a shield with symbols of countries from which the US was populated—England, Scotland, Germany, Holland, France and Ireland, with the motto, "E Pluribus Unum."

FDA Panel Backs Emergency Use for COVID-19 Vaccine

An advisory committee for the U.S. Food and Drug Administration met and voted Thursday, Dec. 10 to approve an emergency use authorization request from Pfizer and BioNTech for their COVID-19 vaccine. Although the Centers for Disease Control and Prevention still needs to weigh in, the nod from the FDA panel potentially cleared the way for some groups to start getting vaccinated within days.

Report for America Selects Black Voice News for 2021 Newsroom Grant

This week, Report for America announced Black Voice News (BVN) is among 64 news agencies from across the country selected to participate as host partners for 2021.

A national news service program, Report for America (RFA), will place more than 300 journalists in the field to cover important local stories in the coming year.

BVN will host one emerging journalist to help expand its focus on data journalism in ways that inform, inspire, and engage readers on issues of importance to the community.

Though 2020 continues to be a year of challenges, it has also served as a beacon, shining a spotlight on the frailties of current and historical, social, and political (dis)orders and in the process, challenged the media to meet the moment.

"Our purpose is always to foster a community that is informed and inspired to seek collaborative and constructive solutions to issues whether at the municipal, state or federal level," said BVN Executive Editor Stephanie Williams. "We are looking forward to the

promise of 2021 and the content our publication will deliver with the addition of a data journalist inspired and professionally equipped to help bring these important stories to life supported with data and using a variety of media across multiple platforms."

She continued, "We are grateful to Report for America and its continued commitment to small news organizations like ours who are dedicated to telling stories "of and for" our communities but often lack the resources to dive into many of the most important, and at times, complex questions of the day."

In an environment where lines are being intentionally blurred between rumors, facts and falsehoods, readers everywhere look to local news outlets to be purveyors of truth, accuracy, and authenticity, "With Report for America's support, BVN is better positioned to focus on community issues that are often unreported," Williams stated.

Owed to longstanding racial and economic disparities in the Inland Empire, the coronavirus pandemic is impacting Blacks from every

direction whether it is a lack of healthcare, higher COVID-19 death rates, unemployment rates, housing and/or food insecurity, etc. In response, the data journalist joining BVN will focus on capturing where and how issues like health, economic mobility, housing, food insecurity and criminal justice interlock across communities of color in the region and the role these matters play regarding the impact of the virus.

Broadening BVN's ability to tell stories of those who live the experiences of these systemic inequities and who ultimately drive the data, is essential. The Report for America program is another step in this publication's efforts to build on and expand its reporting from the ground-up by merging the two—stories and data—in ways conducive to informing readers and compelling much needed change.

Report for America will pay half the salary up to \$25,000 for the new data journalist and BVN, with the support of readers like you, will cover the balance.

Biden Picks CA AG Xavier Becerra to Lead HHS, Coronavirus Response

President-elect Joe Biden has picked California Attorney General Xavier Becerra to be his health secretary, putting a defender of the Affordable Care Act in a leading role to oversee his administration's coronavirus response.

Separately, Biden picked a Harvard infectious disease expert, Dr. Rochelle Walensky, to head the Centers for Disease Control and Prevention. And he announced a new role for Dr. Anthony Fauci, the government's top infectious disease expert.

If confirmed by the Senate, Becerra will be the first Latino to head the Department of Health and Human Services, a \$1 trillion-plus agency with 80,000 employees and a portfolio that includes drugs and vaccines, leading-edge medical research and health insurance programs covering more than 130 million Americans.

Biden's selection of Becerra and Walensky was announced early Monday in a press release from the transition office. People familiar with the decision had confirmed the picks to The Associated Press on Sunday night. Biden also announced other top members of his health care team, though some posts remain unfilled.

Becerra, as the state of California's top lawyer, has led the coalition of Democratic states defending "Obamacare" from the Trump administration's latest effort to overturn it, a legal case awaiting a Supreme Court decision next year.

A former senior House Democrat, Becerra was involved in steering the Obama health law through Congress in 2009 and 2010. At the time he would tell reporters that one of his primary motivations was having tens of thousands of uninsured people in his Southern California district.

Becerra has a lawyer's precise approach to analyzing problems and a calm demeanor.

But overseeing the coronavirus response will be the most complicated task he has ever contemplated. By next year, the U.S. will be engaged in a mass vaccination campaign, the

groundwork for which has been laid under the Trump administration. Although the vaccines appear very promising, and no effort has been spared to plan for their distribution, it's impossible to tell yet how well things will go when it's time to get shots in the arms of millions of Americans.

Becerra won't be going it alone. Biden is expected to stress a coordinated response to the virus when he publicly introduces his team this week.

Businessman Jeff Zients was named as Biden's White House coronavirus coordinator. An economic adviser to former President Barack Obama, Zients also led the rescue of the HealthCare.gov website after its disastrous launch in 2013. Former Surgeon General Vivek Murthy, a co-chair of Biden's coronavirus task force, is returning to his post as the nation's doctor, with broader responsibilities. Biden announced Fauci will be the president's chief medical adviser, while continuing as director of the National Institute of Allergy and Infectious Diseases.

Adding to the group are national security expert Natalie Quillian as co-director of the coronavirus response and Yale public health specialist Dr. Marcella Nunez-Smith, who will head a new working group to reduce health disparities in COVID-19, a disease that has taken a deeper toll among minorities.

The core components of HHS are the boots on the ground of the government's coronavirus response. The Food and Drug Administration oversees vaccines and treatments, while much of the underlying scientific and medical research comes from NIH. The Centers for Disease Control and Prevention takes the lead in detecting and containing the spread of diseases. The Centers *continued on page 17*

Groundbreaking Appointment: Liane Randolph to Chair CARB

ast week California Gov. Gavin Newsom made another historic appointment when he named Liane Randolph as the first African American to Chair of the California Air Resources Board (CARB).

"Cleaner air is essential for California's families and Liane Randolph is the kind of bold, innovative leader that will lead in our fight against climate change with equity and all California's communities at heart," said Gov. Newsom regarding her appointment.

Randolph's credentials are a testament to her qualifications. She has served as a Commissioner at the state's top regulatory agency, California Public Utilities Commission, since 2015. She was Deputy Secretary and General Counsel at the California Natural Resources Agency from 2011 to 2014 and an Attorney at Pillsbury, Winthrop, Shaw, Pittman from 2007 to 2011, and previously served as Chair of the California Fair Political Practices Commission from 2003 to 2007, where she was also a Staff Attorney from 1996 to 1997.

During her career Randolph spent time as San Leandro City Attorney and was a Principal at Meyers Nave from 2000 to 2003, where she was an Associate from 1997 to 2000. Her career also included a stint as an Attorney at Remcho, Johansen and Purcell from 1994 to 1996 and an Associate at Manatt, Phelps and Phillips from 1993 to 1994.

Shana Lazerow, Legal Director of Communities for a Better Environment issued the following statement regarding Randolph's appointment: "The CARB Chair appointment carries with it a tremendous responsibility to California's environmental justice communities. Ourcommunities are feeling the impacts of climate change compounding the already-unacceptably polluted air we breathe. We have appreciated Commissioner Liane Randolph's dedication at the California Public Utilities Commission and look forward to working with her to bring climate solutions and innovative approaches to emissions reductions that empower California's most vulnerable populations. Particularly in this time of pandemic, California's low-income

communities of color need CARB to lead as an agent of positive change."

For years, the California Air Resources Board has often acted more aggressively than the federal government when it comes to issues related to air quality and climate change and over the previous four years California has butted heads with the current administration over stricter emission limits for vehicle manufacturers.

Mary Nichols, CARB's current chair, is rumored to be on President elect Joe Biden's short list to lead the Environmental Protection Agency. However, according to a report by KQED, a coalition of some 70 California environmental justice groups, national environmentalists and other organizations sent a letter to Joe Biden's transition team asking the incoming president to avoid picking Mary Nichols.

The letter claimed in part, "[Nichols is] not the right person to oversee and implement climate and environmental programs for the country." The letter highlighted what they described as her "bleak track record in addressing environmental racism." It included the following statement: "Mary Nichols and the California Air Resources Board (CARB), under her leadership, have repeatedly disregarded the

recommendations of the environmental justice bodies established to uphold the integrity of California's environmental policies, especially as to how they harm or benefit low-income communities of color in the most polluted areas of the state."

Nichols, who served as chair once before in the early 1980s, will end her second tenure as CARB chair this month. This time she served about 13 years from 2007 to 2020.

Last month the Black Voice News reported a group of Black employees at CARB had banded together and presented the agency with a13page letter detailing claims of widespread, routine, and systemic racism. Although 5.5% of the state's population is Black, Blacks are underrepresented in CARB—only 4.4% or 73 of the agency's 1627 employees are Black.

Nichols also came under fire earlier this year for appearing to compare the brutal death of George Floyd who died struggling for breath under the knee of a Minnesota police officer in May, to the ongoing struggle for clean air in relation to environmental racism.

The governor's comments about Nichols, which did not reflect these concerns, were filled *continued on page 17*

Riverside's "Constitutional" Sheriff

iverside County Sheriff Chad Bianco garnered national attention recently with a Trump-ish style declaration and public notification of his refusal to enforce the newest stay-at-home order that took effect beginning 11:59 p.m. on Sunday, Dec. 6.

When the Riverside County Board of Supervisors was asked to weigh in on the issue of enforcement and the position taken by Bianco, spokesperson Brooke Federico said the county's enforcement position has always been to educate first.

"When we receive a complaint about a business operating outside of the current state restrictions, the complaint is reviewed by a county enforcement team," Federico said. "If the business is an eatery or other

business that is permitted by the Department of Environmental Health (DEH) (e.g., tattoo salons and pools), then an inspector with the DEH will reach out to the business to go over the current orders and what modifications must be made."

She further explained if the business in violation is not permitted by DEH then the County Counsel's office will reach out and review the orders and modifications needed.

"This is an educational approach and we've found that most all businesses contacted come into voluntary compliance."

Federico said, however, when a business has continued to operate outside of the current state orders, there have been times when the county

has taken civil court action.

"Civil court actions include issuing cease and desist orders or seeking a temporary restraining order from the court," she said. "These efforts are focused on events that could become super-spreader events."

Although Bianco also supports educating residents to comply, few were surprised by his position not to enforce compliance, nor his over the top defiance as it aligned with previous stances taken during an earlier closure.

"The metrics used for closures are unbelievably faulty and not representative of true numbers and are disastrous for Riverside County," Bianco said.

When the IE Voice and Black Voice News asked him to explain what he

based his comments on about the data being "unbelievably faulty" and not representative of Riverside County, and whether he could provide data to the contrary and its source. Rather than responding to the inquiry, Sergeant Albert Martinez offered the following on Bianco's behalf: *"We* have been doing community update videos and they have been very well received by Riverside County residents. Along with the videos, text is also being released."

In this regard it is possible Martinez had not reviewed the negative twitter reactions posted by many.

He continued, "We have found that when we release videos and text

updates, the public is better informed with a contextual account of the statement rather than snippets sometimes reported by the media and taken out of context. This is a good example of its effectiveness. Our position has been consistent throughout this pandemic. The Sheriff has also been vocal that he and most all other law enforcement agencies would not actively enforce violations of the orders."

Despite Martinez's protestations, he was pressed further. After noting he had not answered the question about the data, he was once again prompted for a response to its source and what Bianco meant about the state's data being "unbelievably faulty." There was no further response.

Bianco is not alone in his defiance. Nearly a third of sheriff department's around the state including San Bernardino County are refusing to enforce the state order.

Interestingly, according to a report by Politico, there is a movement composed of current and former members of law enforcement identified as "constitutional sheriffs" who believe sheriffs are the ultimate authority in their jurisdiction. Although there is no evidence Bianco is part of this movement, his actions regarding the stay-at-home order certainly fits the image. Some have even accused these sheriffs of having ties to White Supremacy.

Politico cited a couple of examples of constitutional sheriffs' belief in absolute power:

"In 2013, 500 sheriffs nationally agreed not to enforce any gun laws created by the federal government. In Utah, almost all elected sheriffs signed an agreement to protect the Bill of Rights—and fight any federal officials who tried to limit them."

They are dubbed "constitutional sheriffs" because the role of sheriffs is defined in state constitutions. For example, Article XI Sec. 1 (b) of California's constitution reads in part, "The Legislature shall provide for county powers, an elected county sheriff, an elected district attorney, an elected assessor, and an elected governing body in each county."

This means the position of sheriff cannot be eliminated without

amending the Constitution, and to Bianco's point, there are few restrictions on their power.

Although sheriffs are elected by the people, readers may also be surprised to learn once they elect a sheriff, they, as voters, have little power over them. Consider what happened recently in Los Angeles County when voters tried to place term limits on their local sheriff. The sheriff sued and won. As reported by the Los Angeles Times, the court found a sheriff's term limits cannot be altered by the voters.

Bianco was also asked to explain what he meant by "[The] medical field is so split on this virus it is about time to apply some common sense." And again, he failed to provide specifics,

stating only, "If you seek information from more than one news source, these opinions are easy to find, doctors and other medical professionals have differing opinions on benefits of masks, social distancing, and lockdowns."

Yet, respected experts from around the world have stressed if people would comply with three basic recommendations—face masks, social distancing and hand washing—it would curtail the virus' spread. Today, America's failure to embrace and adhere to these simple preventative measures has resulted in it leading the world in COVID-19 infections and deaths.

The sheriff is adamantly against enforcement and the Board of Supervisors is taking a measured approach, but here are the facts:

• On Tuesday, Dec. 8, the county reported 11,000 new cases (most, they explained, due to a backlog). On Wednesday, Dec. 9 there were 4,103 new coronavirus cases and 26 additional deaths.

• On Thursday, Dec. 10 there were 3,729 new coronavirus cases and 12 additional deaths. And on Friday, Dec.11, hospitalizations in the county surpassed 800 and the ICU bed availability had dropped to 4.2%, far below the 15% baseline established by the state and the death toll reached 1,573.

• Also, on Friday, the county's case total reached 112,950 making Riverside only the 11th county in the nation to surpass 100,000 total cases according to John Hopkins University. In addition, Kaiser has placed mobile morgues at three of its hospitals in the inland region.

As evidenced by the data accrued since Bianco recorded his statement, conditions in the county have deteriorated.

Bianco also accused Gov. Gavin Newsom of turning public opinion against California sheriffs.

"Why is he crying victim on behalf of California sheriffs," a county resident inquired.

To many, this seemed disingenuous when considering Bianco's track record of flexing his own authority.

In June, the Riverside County Board of Supervisors considered a review of the Sheriff's Department policies related to the use of force and other issues. Bianco defied the review, calling it politically motivated and challenged the board's authority to comment on policies he set for the department.

"It's not your job to tell me what to do," Bianco said. He ultimately stated he would form an advisory council, but he alone would decide who should participate.

The issue of having virtual autonomy as

an elected sheriff aligns with the "constitutional sheriff" theory and may be playing a major role as sheriffs across the state flaunt their autonomy and authority in defiance of the governors. They appear more in alignment with the philosophies adhered to by many Republicans across the country. However, this is about more than politics, it is ultimately about power.

As the number of infections and deaths continue to rise and the economy teeters on the brink for many while it has already failed for millions of others, the parallel epidemic of equity, justice, and police reform in 2020 sustains as residents continue pushing for police reform despite the raging virus. Throughout the year, activists have pulled at threads of criminal justice issues and legislators have written bill after bill with some succeeding while others fail.

Yet, there is hope in the potential to put a check on those powers if inland area voters have courage to act where the Board of Supervisors may fail. In October, Gov. Newsom signed into law AB1185 which authorizedbut did not mandate-a county to establish a sheriff oversight board to assist boards of supervisors with those duties as they relate to the sheriff. The law provides this can occur either by action of the board or through a vote of county residents.

"Without a mandate the measure appears powerless unless the local board of supervisors operates independent from the influence of local police unions who opposed this legislation; or a local measure is placed on the ballot and voters have an opportunity to decide for themselves," as reported by Black Voice News Oct. 5, 2020.

At the time the bill passed, Bianco was obstinately opposed.

"Politics is killing our country and this is an example," he said. He further complained the legislation implied the sheriffs were doing

something wrong and needed to be fixed. Maybe that was the point of the legislation. "The fundamental way residents of this great county determine the direction of their agencies, including the office of the sheriff, is at the ballot box. That is real oversight and accountability," Bianco's sentiments were firmly enforced by Bill Young, president of the Riverside Sheriffs Association.

Under existing law, sheriffs are empowered to preserve the peace, etc. but the law also requires the board of supervisors to oversee the official conduct of all county officers to ensure they perform their duties faithfully. Sheriffs certainly fit this definition though many like Bianco believe because they are elected, they are free to act autonomously.

At least 40 states across the country have

elected sheriffs and many were courted by the Trump administration. For example, in Sept. 2018 during the peak of the 'Build the Wall' campaign and his ongoing battle with sanctuary cities, during a meeting between some of the nation's sheriffs (44) and officials from ICE and U.S. Customs and Border Protection, the New York Times reported Trump appeared before them and delivered a diatribe against media outlets critical of his administration-the sheriffs applauded and cheered. They also presented Trump with a plaque that read, "There's a new sheriff in town."

Although Bianco was not elected sheriff until Nov. 2018, since taking office, there are questions about whether he has purportedly joined the pantheon of Trump supporters? This may be rooted in his appearances on Fox News.

However, it may be more closely tethered to his "Politics is killing our country," and "It's not your job to tell me what to do" mentality.

Citizens have four ways to reign in so-called "constitutional sheriffs" like Chad Bianco. Facilitate a recall; vote them out at the end of their four-year term (Bianco in 2022); approve a ballot measure establishing a sheriff oversight board; or revise the state constitution.

Kaiser Erects Temporary Morgues at Selected Facilities in Inland Region for Covid-19 Deaths

ate last week a Kaiser employee (who did not wish to be identified) reached out to the IE Voice and Black Voice News to advise a temporary morgue was delivered to the facility where he worked. He was concerned about the rising death rates in the community and wanted to share what he had observed.

In an exclusive exchange with Kaiser Permanente (Kaiser) a spokesperson confirmed what the employee stated he witnessed and explained that "Kaiser Permanente is taking all necessary steps to meet the extraordinary challenges facing our 15 hospitals in Southern California caused by the surge in COVID-19 patients."

As of Monday, Dec. 7, Kaiser had 1,003 cases being treated for COVID-19 in hospitals across Southern California, and hospitalizations were increasing.

"Unfortunately, not every patient will recover; some will not survive, and we have to be prepared for that possibility," Kaiser told the IE Voice and Black Voice News.

"Due to the unprecedented demand being placed at local mortuaries and county morgues, temporary morgues have been brought in at several of our facilities," the spokesperson said. "In the Inland Empire, mobile morgues



are currently in place at Fontana, Ontario and Moreno Valley medical centers, and will be used as needed."

The healthcare provider described the action as part of its commitment to meeting the health care needs of the communities it serves during these challenging times. "But Kaiser Permanente cannot fight this pandemic alone."

The provider implored the public to help slow down the spread of the coronavirus to relieve

stress on area hospitals by wearing masks, maintaining social distance, washing hands and avoiding gatherings outside of the immediate household.

"Following these simple guidelines and adhering to new statewide stay-at-home orders will reduce pressures on our frontline nurses and doctors and save lives this holiday season," Kaiser said.

for Medicare and Medicaid Services, or CMS, provides insurance coverage for more than 1 in 3 Americans, including vulnerable seniors, as well as many children and low-income people.

Biden still has not picked the heads of FDA and CMS.

Under President Donald Trump, CDC was relegated to a lesser role after agency scientists issued a stark early warning that contradicted Trump's assurances the virus was under control, rattling financial markets. The FDA was the target of repeated attacks from a president who suspected its scientists were politically motivated and who also wanted them to rubberstamp unproven treatments.

As CDC director, Walensky would replace Dr. Robert Redfield, who accurately told the public coronavirus vaccines would not be available for most people until next year, only to be disparaged by Trump as "confused." Walensky is a leading infectious disease specialist at Massachusetts General Hospital and has devoted her career to combating HIV/AIDS.

Becerra's experience running the bureaucratic apparatus of the California attorney general's office, as well as his success working with Republicans, helped seal the pick for Biden, said a person familiar with the process but not authorized to comment publicly. Becerra had worked with Louisiana's Republican attorney general to increase the availability of the COVID-19 drug treatment Remdesivir in their states. He's also worked closely with other Republican attorneys general on legal challenges against opioid manufacturers.

Early in California's coronavirus response, Becerra defended broad shutdowns Gov. Gavin Newsom had put in place to curtail the pandemic, including limits on religious gatherings. Three churches in Southern California had sued Newsom, Becerra and other state officials because in-person church services had been halted.

Biden's offer was extended to Becerra on Friday. The president-elect has been under pressure from the Congressional Hispanic Caucus to appoint Latinos to the Cabinet.

Previously Becerra had served for more than a decade in Congress, representing parts of

Los Angeles County. He had also served in the California state assembly after attending law school at Stanford.

His mother was born in Jalisco, Mexico, and emigrated to the U.S. after marrying his father, a native of Sacramento, California, who had grown up in Mexico.

Becerra often cites his parents as his inspiration, saying they instilled in him a strong work ethic and a desire for advancement. His father worked road construction jobs, while his mother was a clerical employee. Becerra is married to Dr. Carolina Reyes, a physician who specializes in maternal and fetal health.

In an AP profile published last year, a lifelong friend of Becerra's said he learned to stay calm and self-controlled in high school as a varsity golfer and an exceptional poker player. Becerra studied the advice of famous golfers while practicing with a set of used clubs costing less than \$100.

"I am extremely thankful to Mary Nichols. Randolph was not the only CARB appointment made by the governor this week. He also appointed John Balmes, Davina Hurt, Gideon Kracov and Tania Pacheco-Werner to serve on the Board. According to the governor's office, Air Resources Board members who are representatives of an air pollution control district receive no compensation.
