or those who followed the breaking news about Amazon's leaked memo and then took time to read it got a real glimpse into the conniving that goes on behind the scenes in major corporations.

I'm sure their cunningness is not unique. In fact, having spent years on a vice-president's staff for another major corporation in my previous life I might even venture to say it is probably pretty common.

In this instance, however, it struck me as particularly sleazy for a number of reasons beginning with this statement from the memo that feigns concern for public health.

"Enhance Amazon's reputation in the health arena as Amazon Health plans to scale in California, proactively supporting PP and connecting our health teams to our CE grantees in the same or adjacent space, such as DAP Health and San Ysidro Health."

Meanwhile, the area is designated a 'diesel death zone' by physicians due to high rates

of asthma, cancer and respiratory illnesses associated with ozone and air pollution.


Or, in another example where Amazon seeks to promote their concern for the environment: "Positively affect legislative attempts to ban Single Use Plastic by showcasing Amazon as a leader in sustainability and counter the voices of environmental activists against Amazon. We will highlight our Climate Pledge, renewable battery investments in SoCal, new electric trucks at the Port of LA, the sustainable story around drone deliveries."

Meanwhile, speaking of the environment, San Bernardino and Riverside Counties continue to rank first and second respectively for the worst ozone pollution in the United States. And both counties also have the dubious honor of also ranking as the worst in annual particle pollution nationally, according to the 2022 State of the Air

# Temecula Valley USD Policies Violate Constitutional and Statutory Rights, Says AG Bonta

Attorney General Bonta Files Amicus Brief in Support of Temecula Valley Unified Students' Constitutional Rights

arlier this week, California Attorney General Rob Bonta filed an amicus brief in Riverside Superior Court in the case, Mae M. v. Komrosky. The brief is in support of a challenge by teachers, students, and parents to two Temecula Valley Unified School District (TVUSD) Board of Trustees' enactments that violate students' constitutional and statutory rights.

In one instance, TVUSD Board Resolution 21 purportedly prohibits the teaching of "Critical Race Theory," and it includes sweeping language that would censor, for example, Native American history and Martin Luther King Jr.'s "Letter from Birmingham Jail."

Board Policy 5020.01, allegedly compromises students' safety, well-being, and privacy,

and violates their equal protection rights, by mandating the forced outing of transgender and gender-nonconforming students without their consent. The policy is a duplicate of the Chino Valley Unified School District (CVUSD) Board of Education's forced outing policy; Attorney General Bonta secured a preliminary injunction halting that policy in October.

"Schools have an obligation to provide a safe and inclusive learning environment, with curricula that reflect the contributions of California's diverse communities," Bonta insisted. "Temecula Valley Unified's policies banning inclusive curriculum and forcibly outing transgender and gender-nonconforming students single out California's most vulnerable individuals, severely harming their well-being and academic success."

Bonta further affirmed how in the face of ongoing attacks in California and across the nation,his office "will continue to stand up against any measures that compromise the civil rights of students."

# More about the TVUSD policies in question

On August 22, 2023, TVUSD's forced outing policy took effect. It requires schools to inform parents, with minimal exceptions, whenever a student requests to use a name or pronoun different from that on their birth certificate or official records. The forced outing is authorized to proceed without the student's permission and even when doing so would put them at risk of harm. The policy requires notification if a student requests to use facilities or participates in programs that don't align with their gender or sex on official records.

The FAIR Education Act (FEA) mandates the accurate representation of cultural and racial diversity in educational curricula, particularly in social studies for grades one through twelve.

In September, Assembly Bill 1078 (AB 1078) expanded the FEA requiring the inclusion of contributions from "people of all genders," "Latino Americans," "LGBTQ+ Americans," and other groups in social sciences instruction. But

E thnic Media Services in association with California Black Media, the National Weather Service and the California Governor's Office of Emergency Services, hosted a briefing on how the public can plan to keep safe during what could be severe weather this winter.

Storms, power outages and flooding are expected to be more common occurrences as well as increasingly cold temperatures this winter. In order to stay safe in what is expected to be another intense storm season, several experts offered tips and information on how to prepare.

The speakers included Diana Cross Palio, Assistant Director of Crisis Communications and Public Affairs at the California Governor's Office of Emergency Services; Bianca Philjicker, meteorologist from the National Weather Service, Western Region headquarters; and Yasmin Ortega, Deputy Press Secretary with the California Department of Insurance.

According to Philjiker, El Nino conditions or the warming of layers of water at the ocean 's surface mixing with cooler water from below, causes a shift in moisture and the jet stream which in turn can cause more intense weather conditions.

#### **Stay Informed**

According to Cross Palio, it is important to follow some basic tips to be prepared during this winter's storm season including signing up for weathe r alerts:

"Go to listocalifornia.org/alerts," she advised, stressing the site provides emergency alerts that are specific to your city, county or your region. Alerts will give you and your family the latest updates from the government about extreme weather conditions in your area including winds, snow, mudslides and flooding and will send alerts directly to your phone.

#### Make A Plan

It is also important to make a family plan in case you have to evacuate your home. Emergencies can occur anytime. Everyone should know where and when to meet in case you are not together when an emergency happens.

If you are separated from loved ones, you

should have the name, address and phone number for an agreed upon person. Someone who does not live close by, who everyone can keep in contact with if you are separated from your loved ones when a weather emergency happens. All your family members should also have a written list of emergency phone numbers in case there is an interruption of telephone and or cellular service. In addition, families should have an emergency bag with food, water, medications and important documents, such as insurance papers etc. and you should have a list of emergency shelters if they are needed. To find help in your area visit disasterassistance. gov. The public is asked to make sure to check on family members and neighbors who may live alone or are elderly or ill.

"It's really important to ask every single person to check on friends, neighbors and loved ones during an emergency and even better to

A n internal Amazon memo detailing the online retail giant's 2024 goals to expand the company's influence and combat labor union efforts for equitable pay and improved working conditions was leaked this week to Ontariobased nonprofit labor organization Warehouse Worker Resource Center.

"Amazon sees our community as nothing more than warehouses and bodies to staff those warehouses," said Sheheryar Kaoosji, executive director of the Warehouse Worker Resource Center, in a statement. "It's a paper thin facade and they should invest just as much time into actually addressing working conditions, pay and the extreme environmental cost to Southern California and the people here."

Titled "Community Engagement Plan 2024 – Southern California," the eight-page memo examines Amazon's community engagement efforts across the Inland Empire, including in San Bernardino where the KSBD Amazon Airhub resides — the largest air facility on the West Coast and one of three air hubs in the nation. The Associated Press independently verified the document's authenticity.

In an email to Black Voice News, Amazon Spokesperson Jennifer Flagg called an online post of the leaked document "a blatant mischaracterization of Amazon's work."

The document gives a closer look at Amazon's engagement practices and their plans for gaining favor in the region through cultivating favorable relationships with local politicians and local organizations who have not spoken out against the company in order to alter public opinion regarding the company's controversial practices. In the memo, the company noted that there aren't enough "Amazonians serving on prominent boards in Southern California."

Part of the memo notes, "California has the most independent sellers on Amazon across all 50 states. To combat the perception that Amazon hurts small businesses, we will spotlight small business sellers at our CE sponsored events as guests, or feature them on facility tours."

in spite of these laws, in December 2022, the TVUSD Board passed Resolution 21, severely restricting students' ability to learn about the roles and contributions of diverse groups throughout U.S. and California history.

In May, the TVUSD Board took additional extreme action when it initially voted not to adopt the TVUSD Curriculum Committee's recommendation to approve the "Social Studies Alive!" curriculum for grades one through five. The vote was based on its opposition to any discussion of the roles and contributions of members of the LGBTQ+ community, particularly civil rights leader Harvey Milk.

In response, Bonta and Governor Gavin Newsom issued a joint statement urging the Board to provide information regarding its decision to reject the textbook, and the TVUSD Board changed course and adopted the curriculum, while pushing the chapter associated with LGBTQ+ rights to the end of the school year.

#### About the brief

In the amicus brief, Bonta expresses support

for the plaintiffs' motion for a preliminary injunction against these two enactments. The brief sets forth how the TVUSD Resolution 21's ban on inclusive curriculum violates students' right to receive information and ideas through classroom teaching and reading under the California Constitution; violates the FAIR Education Act and AB 1078; and discriminates against students of color by restricting their opportunity to see figures like themselves reflected in their curricula.

In addition, Bonta argues that the district's forced outing policy violates California's Equal Protection Clause by unlawfully discriminating against and singling out transgender and gendernonconforming students; violates California Education Education Code Sections 200 and 220, and Government Code section 11135, which prohibit discrimination on the basis of gender identity and gender expression; and violates California's constitutional right to privacy.

# Tapestry: "The Cultural, Ethnic, and Racial Threads of an Evolving Community"

he 2020 Census has unveiled a profound transformation in the demographic landscape of the United States, with the percentage of people identifying as multiracial experiencing an unprecedented surge.

According to Census data, the multiracial population has catapulted from 2.9 percent in 2010 to a staggering 10.2 percent in 2020, comprising 33.8 million individuals. While some of this increase can be attributed to adjustments in the Census methodology, there is a consensus that the burgeoning number of multiracial Americans is a result of shifting societal attitudes, changing laws, and a rise in immigration from Latin America and Asia.

The journey towards recognizing the diversity within the American tapestry began in 2000 when the U.S. Census allowed individuals to choose more than one race. This groundbreaking decision was influenced by advocates for multiracial people and families who sought acknowledgment of their unique identity, according to Pew Research Center.

Delia Douglas Haight, the president of Multicultural Americans of Southern California, an advocacy organization, notes the crucial role that advocacy played in this policy change.

communication, diversity, and inclusion, recognizing the complex and multifaceted nature of identity.

In an interview with Haight, she shared examples of successful initiatives by MASC that have effectively fostered understanding and unity among diverse populations. Notably, the organization played a pioneering role in changing the 2000 U.S.Census, advocating for the option to check more than one racial identity. The organization's annual events, including the Loving Day celebration, LOMA film festival, and educational seminars, showcase the richness of backgrounds within the community, facilitating cross-cultural learning and dialogue.



California, and the likelihood that two people chosen at random would be of a different race, hate crimes have persisted in tandem. Between 2016 and 2020, there were over 7,000 hate crimes reported and the reported incidents were coupled with a racially diverse population, according to the Diversity Index.

Anthony Jerry, Assistant Professor of Anthropology at the University of California Riverside attributes these hate crimes to the impact of individuals changing their racial identity on societal dynamics. That such shifts can be perceived as threatening by those who rely on a fixed definition of race for their own understanding of identity. "It creates real tension in society where some people don't know where they now exist," he said. "When people feel they have a lot to lose, they respond violently."

As the multiracial demographic landscape dynamic transformations, undergoes acknowledgement of the region's changing representation holds the potential to become a bridge to deeper multicultural understanding,

via X (formerly Twitter), by California Labor AFL-CIO Union Leader and former State Assemblywoman, Lorena Gonzalez-Fletcher who described the memo as "a PR plan that preys on communities in need to keep wages low [and] environmental damage aggregated in low income communities..."

Last October, Amazon workers of the KSBD facility hosted walkouts, strikes and pickets in an effort to push for fair wages and safety measures at the facility. Amazon workers who participated in these events were later targeted and surveilled in what they described as "unionbusting tactics."

The memo recognizes demands for wage increases as a "significant concern" as well as ongoing legislation that supports warehouse moratoriums and environmental legislation which they emphasize as being "detrimental to Amazon's interests." The document listed strategies they can employ in order to "[showcase] Amazon as a leader in sustainability and counter the voices of environmental activists against Amazon."

Several local advocates, activists and leaders learned of the leaked document and addressed Amazon's memo, including Assemblymember Eloise Gómez Reyes (D-Colton) who is referenced in the memo as an advocate for warehouse moratoriums and environmental justice, and therefore a threat to Amazon's interests.

"I wear it as a badge of honor for being recognized for standing up for both environmental justice and workers," Gomez said in a statement. "In the Inland Empire, where we continue to struggle with some of the poorest air quality in the country, I am dedicated to crafting California Sustainability at Pitzer College.

The report emphasized the worsening health impacts the growing warehouse industry has had on the region as result of warehouseinduced pollution which "has created a state of environmental injustice and a public health crisis in San Bernardino and Riverside Counties."

"This is shocking, but not surprising, this only validates every effort we have done as an organization to hold corporations and

policies that safeguard both health and good jobs."

A 2023 report called "Region In Crisis" found that there are more than 300 warehouses that are 1000 feet or less from 139 Inland Empire schools and over 600 warehouses surround these same schools at 1,500 feet. The report, included in a letter sent to Gov. Gavin Newsom, was developed by the Center for Community Action and Environmental Justice (CCAEJ), Sierra Club (San Gorgonio Chapter ) and the Robert Redford Conservancy for Southern developers like Amazon, accountable for their negligence and perpetrating unsafe and unhealthy communities in the Inland Valley," CCAEJ Executive Director Ana Gonzalez said in a statement.

"Not to mention the conditions they have created of displacement of housing and low wages that in fact lead to hunger and homelessness, shame."

As the memo outlines new approaches and strategies to community engagement *continued on page 19*

Don't get me wrong, Amazon did make references to "air" at least four times in its secret memo but it had nothing to do with concerns over the region's air quality or the health implications resulting from it. As with any corporate sociopath all the references to air were in relation to itself... and its "air" hub.

Amazon touted how it would leverage its philanthropic efforts to develop third party advocates and coalitions. They must view this as a really great idea, because it's mentioned twice in the document.

"Bolster third party advocates to support our Southern California legislative agenda. For example, develop five go-to community partners that I can call on to rally behind any priorities. Will do this by focusing on these relationships, and cultivating deep trust and friendship..." through partnership and sponsorship efforts." In this regard I think it is important that we keep in mind that all money is not good money.

Next, as we enter an election year, I think it is important that the community also take heed to Amazon's desire to gain more political control. Maybe we should consider a litmus test for candidates at the local and state levels next year, like asking their positions on building more warehouses in the region. I highlight this because one of the key strategies noted in the leaked document states, "There are currently not enough Amazonians serving on prominent boards in Southern California."

Another point in the document I found interesting was their clarity about the types of groups they will not support with donations, etc. Who would think they would single out something as important to community culture as an art gallery?

It's true. Here is what Amazon said, "We will not continue to support organizations that did not result in measurable positive impact on our brand and reputation. Additionally, we will not fund organizations that have positioned themselves antagonistically toward our interests. For example, in 2022 and 2023 we donated to The Cheech Marin Center for Chicano Art & Culture in Riverside. In 2023, the Cheech Center exhibited a local artist who depicted an Amazon facility on fire, and the artist then gave an interview

expressing hostility towards Amazon. We will not donate to The Cheech."

It seems like a petty, vindictive form of retaliation. But, it is a striking warning to other nonprofits in the area who could benefit from their support. It is basically telling everyone, "Keep your mouth shut or go somewhere else for funding."

I applaud The Cheech for its courage and for not compromising its integrity. It seems there are others, including taxpayer funded museums that want to stay as far away from anything that could be perceived as critical of the warehousing giant.

One thing this memo affirmed for me is that despite its protestations—it appears Amazon may retaliate after all. I say this because in January we reported on an Amazon worker, Sara Fee, who claimed she was put on paid suspension and investigated by Amazon for organizing in support of workers' rights. She was also surveilled and targeted by Amazon union busters, officially known as labor and employee relations consultants.

We reached out to Amazon for their version of the story and they eventually responded claiming the charges were without merit. In other words, the employee's suspension was not retaliation. They claimed Fee, "acted in an unprofessional and inappropriate manner that violated our standards of conduct. She was temporarily suspended with pay, and has returned to work."

We printed their response, but that was not enough. They tried to pressure the reporter and later myself.

We refused to acquiesce to their request to change the story.

In the beginning of my communications with Amazon on this issue they claimed they were excited to establish a relationship Black Voice News, encouraged us to reach out at any time and even offered to give our photojournalist a tour. Of course, the discussion regarding the article ended on professional terms. However, months later when I called to arrange a tour for our photojournalist–we were denied.... Was that retaliation? I'm sure you know what I think.

Of course this is just my opinion. I'm keeping it real.

he USC Trojans (7-5) accepted a bid to play Louisville (10-3) in the Holiday Bowl, to be played in San Diego on December 27th.


The Trojans had certainly hoped for a return the PAC 12 championship and perhaps make a run at a national title, but a poor second half against improved conference opponents kept them from that goal. Heisman trophy winner Caleb Williams will not play in-order to prepare for the NFL draft.

An improved UCLA Bruins squad (7-5) will play Mountain West Champion Boise State (8-5) in the LA "Gronk" Bowl, to be played at SoFi Stadium on December 16th. The UCLA defense was much improved in 2023 as they kept the Bruins competitive throughout the season. Sadly, their five-star recruit, quarterback Dante Moore has decided to enter the portal and leave the school.

In this last year of the four-team playoff, a significant shuffle at the top occurred last weekend. Michigan (13-0) secured their number one ranking by beating Ohio State 30-24 in the Big 10 Championship. Then, reigning national champion Georgia, lost the SEC championship to nemesis Alabama on Saturday night 27-24, which gave the Crimson Tide their ticket into the national playoffs.

If you live with someone dependent on medical devices you can contact the utility company to ask about what you can do to insure they are not affected during power outages.

You should also make a review of your insurance policies as a part of your emergency plan.

#### **Flood Insurance**

According to Ortega, flood insurance is not a requirement in the state of California and most homeowners and business policies don't cover flooding or other hazards caused by weather emergencies without additional coverage. However the state of California does offer flood insurance policies to home and business owners through FEMA. in the Inland Empire for 2024, it lists three things Amazon will keep a close eye on: labor organizing among Amazon delivery service partners, community organizations who don't accept charitable donations and warehouse moratoriums.

"Through employee volunteerism or our charitable donations, it is always Amazon's intention to help support the communities where we work in a way that is most responsive to the needs of that community," Flagg said in an email.

Over the last several years community members and local activists have encouraged cities to pass warehouse moratoriums that limit the expansion of warehouses within communities like Moreno Valley, Fontana and Beaumont in which warehouse expansion proposals were voted down earlier this year. One of these proposals suggested the construction of warehouses next to high school sports fields.

# Antonio Gates Honored as Charger Hall of Fame Inductee

Antonio Gates, the 16-year veteran All-Pro tight end, joined by ex-quarterback Phillips Rivers and several Charger teammates was honored and inducted into the team's Hall of Fame in front of home fans at SoFi Stadium.

A native of Detroit, where he was a multisport talent at Central High School, Gates initially accepted an offer to play basketball at Kent State University. He had always thought of himself as a basketball player where he excelled on the court. His basketball team made the NCAA's prestigious Elite 8 in 2002. He always assumed that the NBA would be his destiny.

In that NBA draft of 2002, the scouts evaluated Gates as a 'tweener', too big to be a guard and at 6'4" too short to be a power forward. He was still quite an athlete, so much so that as many as 19 NFL teams expressed interest in having him try out. Perhaps former Falcon All-Pro Tony Gonzalez (Cal) was that mold before him as he played division one basketball like Gates did, also excelling as a 6'5" NFL star.

"My dream had always been to play in the NBA, but I believe destiny brought me to the NFL," said Gates.

#### Gates' career performance

Gates played in San Diego for 14 years and the last two in Los Angeles. He was creative, reliable, consistent and extremely durable by any NFL standards, missing only seven games over sixteen years. Gates caught 955 passes for nearly 12,000 yards and 116 touchdowns in the regular season, including 51 more catches in the playoffs.

In the mold of the great former Charger Kellen Winslow, Gates became a dominant player at his position in his modern era. His ability to use his unique size and athleticism to elude a defender, shield his body, elevate and make so many iconic catches for one team over 16 years, is remarkable.

In Sunday's game at SoFi, the Chargers lost a tough one to rival Denver, 24-7. Most critical, the Chargers lose their star quarterback Justin Herbert to a broken index finger and he will miss the remainder of the season. Backup Easton Stick will take snaps against division rival Las Vegas Raiders on Thursday night.
