

EDITOR'S NOTES

2022 Was The Deadliest Year To Be In Riverside County Jails

t is alleged that in Riverside County people are frequently overcharged for purported crimes which can result in some individuals being confined to county jail because they cannot afford the bail. Whether an individual is guilty or innocent, this should not be a death sentence and yet 2022 was the deadliest year in a decade for those confined to Riverside County jails.

After months of records requests, examinations and summations of documents and data, and a series of relevant, probing and insightful interviews, Black Voice News is proud to introduce a report of our investigation into in-custody deaths in Riverside County jails in 2022.

The report is the result of a collaborative effort between Black Voice News, the Investigative Editing Corps and Report for America and produced with support from inewsource, a nonprofit investigative newsroom in San Diego.

The work of former Black Voice News reporter Prince James Story, with contributions from freelance reporter Gail Fry, offers a compelling narrative of what contributed to the most deadly year in Riverside County jails in more than a decade while also exploring the sheriff department's near snail's paced movement toward compliance with provisions detailed in a near decade's old consent decree which called for improvements within the jails.

The feature story is supported with two companion articles. The first, shines a spotlight on Riverside County Sheriff Chad Bianco and the additional article highlights what Riverside County officials can learn from the experiences of the San Diego County Sheriff's Department as it grappled with systemic issues within its own

Sec. of State Certifies Candidates for March Primary, Including Trump

r. Shirley N. Weber, the California Secretary of State, has certified a list of 20 candidates, including former Pres. Donald Trump, for the state's presidential primary election scheduled for March 5, 2024.

Weber made the decision on Dec. 28 to certify Trump despite calls from a number of prominent Democrats, including California Lt. Gov. Eleni Kounalakis, to disqualify him. They cite the former president's actions and inactions during the Jan. 6, 2021, insurrection at the U.S. Capitol as a violation of Section 3 of the 14th Amendment, which should disqualify him from public office.

Responding to Kounalakis, Weber emphasized that removing a presidential candidate is a matter of public interest and must be handled within legal parameters and in the best interests of all California voters.

"It is incumbent upon my office to ensure that any action undertaken regarding any candidate's inclusion or omission from our ballots be grounded firmly in the laws and processes in place in California and our Constitution," Weber stated.

So far, Trump's quest to run for the presidency has been blocked by two states, Maine and Colorado. Appeals of the decisions in both states are expected to be heard by the Supreme Court



In a letter to Weber dated Dec. 20, Kounalakis urged the Secretary of State "to explore every legal option" to remove Trump from California's 2024 presidential primary ballot following the Colorado Supreme Court's ruling in Anderson v. Griswold.

he high death rate in San Diego County's jail system has troubled attorneys, lawmakers and community activists for years. It has prompted audits, lawsuits and a new state law to enact jail reforms.

The same crisis is unfolding in another nearby jail system. In Riverside County, the jail death rate rose significantly in 2022, surpassing

that of San Diego and most large California counties, according to an inewsource analysis.

Nineteen people died in Riverside County jails in 2022. They were primarily young Hispanic men awaiting trial. They ranged in age from 20 to 78 years old. They died from overdoses, suicides and other causes. Like in San Diego, their families want answers and

accountability.

Pressure is building in Riverside. The California Attorney General's Office opened an investigation into the jail system in February, and at least five lawsuits were filed in May by families of the deceased.

inewsource spoke with advocates and decision makers who have been directly involved in pushing for reforms in San Diego's jails. They reflected on their successes, their failures and what people in Riverside County can learn from

their efforts.

"It isn't just a San Diego problem," said California State Senate President pro Tempore Toni Atkins, a Democrat who represents San Diego in the Legislature.

"You've got numbers from LA County, Riverside — you've got a number of counties that are under consent decree," said Atkins, referencing court-mandated reforms in the jails.

"This means that it is a culture issue and continued on page 8

something that needs to be addressed statewide."

Atkins' jail reform bill, SB 519, grew out of conversations with activists and officials in San Diego County over the past few years as the death toll in detention centers climbed. It was signed into law by the governor on Oct. 4.

The new law gives the public access to reports of in-custody deaths — records the San Diego County Sheriff's Department has fought against disclosing in an ongoing court case. It also establishes a new governor-appointed official to review death investigations with the help of medical and mental health professionals.

While Atkins called the law "a step forward, absolutely," she also acknowledged her work isn't done.

Earlier versions of the bill called for more oversight power of county jails, but the text went through rounds of revisions that removed some of its teeth. In an early draft, the in-custody death reviewer could have taken over jail operations from a problematic sheriff's department. Now, that reviewer can only make recommendations.

"I had to negotiate, and I had to compromise," Atkins said.

The path toward jail reform in San Diego has frustrated activists who have faced numerous obstacles.

Gretchen Burns Bergman, the founder of the addiction recovery program A New PATH, said the sheriff's department hasn't always been cooperative with her team. When her nonprofit donated hundreds of kits of naloxone — an overdose reversal drug — to the jails during the COVID-19 pandemic, correctional officers did not use them because of resistance from union leadership. The kits eventually expired.

"To think about the months and how many people lost their lives because this wasn't implemented when they said it would," Burns Bergman said. "It was heartbreaking."

San Diego County Sheriff Kelly Martinez

made a commitment to improving jail conditions when she began her term last January. But advocates pointed to several ongoing points of tension.

Despite promising to make in-custody death reports public, the sheriff's department has only posted summaries online. And while drug screening has ramped up for incarcerated people when they enter the jails, Martinez has resisted calls to screen the correctional officers.

Burns Bergman acknowledged that well-intentioned reforms can get weighed down in bureaucracy. She encouraged community members in Riverside and elsewhere to keep reminding county leaders of the changes they wish to see.

"It's all about the people on the ground," Burns Bergman said. "Like we are just constantly bugging the criminal justice system for these reforms."

After a Number of Deaths in Riverside County Jails in 2022, Sheriff Faces Calls for More Accountability

iverside County Sheriff Chad Bianco has been at the center of a firestorm of issues since he was sworn into office in 2019.

As COVID-19 swept the nation, a judge had to order Bianco

As COVID-19 swept the nation, a judge had to order Bianco to establish protocols to protect people in custody. The sheriff also refused to enforce a state vaccine mandate for his employees, describing his stance as "the last line of defense from tyrannical government overreach."

The same year, Bianco defended his membership in the Oath Keepers. In an interview with LAist, he said he didn't remember joining the group and that people misunderstood the goals of the far-right militia, some of whose members were convicted of seditious conspiracy in the Jan. 6,

2021, attack on the U.S. Capitol.

Now, the Sheriff's Department in the fourth-largest county in California is being investigated by Attorney General Rob Bonta for alleged civil rights violations. Bonta launched the inquiry in February 2023, citing conditions in the jails, among other issues.

"The investigation will seek to determine whether [the department] has engaged in a pattern or practice of unconstitutional policing amid deeply concerning allegations relating to conditions of confinement in its jail facilities, excessive force, and other misconduct," according to a news release from the California Department of Justice.

Justice officials said they won't comment on an ongoing investigation. Bianco has dismissed Bonta's investigation as "political."

enforcement agency in the country," Bianco said. "We have one of the largest in the state. And we have to make sure that we have one of the best in the state."

But public concern about the Sheriff's Department has risen since the inquiry was announced, between the record-high 19 jail deaths in 2022 to drug smuggling and other charges against deputies.

So too have questions about Bianco and the department's accountability to the public.

In early November, Assemblymember Corey A. Jackson, D-Moreno Valley, asked Bonta to expand his investigation to include sex and drug trafficking after deputies were arrested in three incidents — using drugs, trafficking drugs and engaging in sexual acts without consent with incarcerated women.

"Ever since the pandemic, there's been a lot of red flags about how people are treated — the illegal activity happening in the jails," Jackson said. "That's why we've asked the Attorney General to expand his investigation to find out what's really going on. Because it's clear that the public is losing trust in the Sheriff's Department."

Bianco holds unique power in Riverside County as the elected sheriff, coroner, and public administrator. California is among three states that allow the coroner and sheriff to be the same person.

Advocates for police reform argue that it's a conflict of interest for a law enforcement officer to oversee autopsies of people who died at the hands of other officers. In a 2017-2018 session, a Riverside County Civil Grand Jury recommended that the sheriff outsource the autopsies to avoid a "perception of a conflict of interest by the public." The sheriff at the time rejected the idea.

But nearly 20 years ago, the department contracted with Orange County for several years to perform autopsies on people who died in custody. Riverside ended the arrangement because of costs for autopsies (\$5000 per person) and delays in receiving the information, according to a report by the grand jury, which is empaneled to review local government issues.

In 2023, a state bill to separate the coroner and the sheriff's office failed.

Bianco has significant latitude over his affairs, but the Riverside County Board of Supervisors approves his budget. This year, his combined budget is about 12% of the annual county budget of \$8.6 billion.

When the jail deaths increased in 2022, Bianco briefed supervisors in private, said 3rd District Supervisor Chuck Washington. Supervisors were concerned, but he added that Riverside was not alone: In-custody deaths have risen in other state jurisdictions, and drugs are smuggled into jails in other counties too.

Manny Perez, 4th District Supervisor, wouldn't comment on the sheriff or deaths. He said to represent his constituents successfully, he has to work in good faith with people he may disagree with to effect change.

"I am not interested in speaking ill or negatively about other policymakers, especially through the media or social media platforms," he said in an email.

Supervisors could hold the Sheriff's Department accountable for jail improvements, said Luis Nolasco, an attorney with the ACLU of Southern California, which asked the attorney general to investigate the sheriff's office on behalf of several local organizations. They could restrict additional funding if the sheriff doesn't improve jail conditions, Nolasco said, but he acknowledged that the supervisors would likely reject that route.

"You know it's a political game," he said. "Unfortunately for the supervisors, the Sheriff's Department also knows that."

Problems with the jails and law enforcement existed before Bianco, he said.

Nolasco suggested the county create an Office of Inspector General or an alternative oversight committee for the department, as some other communities have done, that includes people directly affected by the criminal justice system.

A 2020 California law allows counties to

create a watchdog group or oversight committee with subpoena power to monitor sheriffs. Riverside County hasn't created an oversight committee.


Jackson said he supports more oversight of the Riverside County Sheriff's Department.

"Police don't do a good job policing themselves," he said. "And we must do that. It's time for us to have another layer of accountability."

New Doula Benefit 'Life-Changing' for California Mom

When Mia Bloomer found out she was pregnant with her fourth child, she wanted a different birth experience. She wanted to feel empowered, informed, and heard—elements she found lacking during her earlier births.

Somewhat by accident, Bloomer, 26, found Priya Kalyan-Masih six months into her pregnancy. Kalyan-Masih is a doula, a professional childbirth companion who provides emotional support, physical comfort, and education to women before, during, and after pregnancy. Bloomer hadn't realized Medi-Cal would cover the service until she visited an informational fair near her home in the High

Desert region of Southern California.

Medi-Cal, California's Medicaid program for low-income residents, started offering the benefit in January — but doulas have wrestled with the program's bureaucratic requirements and what they say is insufficient pay.

"Priya really listened to me. Out of all my births, this was the most peaceful and stressfree," said Bloomer, who is a student working part-time as an in-home caregiver and at a detox center. "The fact that I didn't have to pay anything out-of-pocket was life-changing."

Having Kalyan-Masih at her side was critical for Bloomer because her partner — now fiancé — was imprisoned a few weeks after she found out she was pregnant, which would have meant she'd have to navigate her pregnancy and delivery without him.

Across the country, doulas are being enlisted

to combat rising maternal mortality rates. In 2021, the most recent year for which data is available, about 1,200 women in the U.S. died from pregnancy complications either during pregnancy or within six weeks afterward, about 60% more deaths than were reported two years earlier, according to the Centers for Disease Control and Prevention.

The numbers are starkest for Black women and their children. In 2021, Black women died

at more than 2½ times the rate of white women. Doulas are distinct from the medical team and act as advocates for birthing parents. A National Institutes of Health study published this year found that doula care was associated with reductions in cesarean sections, epidural use, length of labor, premature deliveries, and maternal stress.

During Bloomer's pregnancy, Kalyan-Masih assisted with strategies such as mapping a birth plan and coaching Bloomer on breathing techniques to ease her anxiety.

Less than a year after Bloomer moved from Texas to be with her fiancé, Tim Smith, he was arrested for firearm possession while on probation for drug-related charges. That left

Department spokesperson David Ladieu said the office is working collaboratively with other jail systems facing the same challenges, namely, "aging facilities, industry wide staffing challenges, and a population that is diverse and requires high levels of care."

In November, Martinez announced a nearly \$500 million plan to modernize the county's aging jails over the next decade. Officials are expected to report back to county supervisors in June on how they plan to fund the improvements.

"Providing a safe and secure facility for incarcerated individuals and our staff is a priority for Sheriff Martinez," Ladieu said. "She is earnest in having a coordinated approach to medical and mental healthcare, as well as reentry programs in our jails to address the underlying issues of rehabilitation and reintegration."

Paul Parker, executive officer of the county's Citizens Law Enforcement Review Board (CLERB), said the sheriff's department is committed to improving jail conditions.

CLERB's mandate includes reviewing incustody deaths. Not long after the sheriff began her term in December 2022, Parker said he was given permission to visit the scene of every death that occurs in county jails and incorporate that information into his reports.

Still, CLERB only serves an advisory role to San Diego's elected sheriff, who has a lot of autonomy.

Oversight in Riverside County is even less robust. There is no independent review board, and the county supervisors have little authority over the department beyond approving its annual budget.

Parker encouraged Riverside County officials to set up a civilian oversight board. While not perfect, he said the board has successfully pushed for more transparency in the jail system.

"Even if they're doing everything possible,... no one's gonna believe you if you're law enforcement," Parker said, emphasizing that it's important "to have someone external and to not be afraid to have that come in."

A 2022 CLERB report found an alarming number of "excess deaths" in San Diego County jails and concluded that the county's jail mortality rate was the "most acute" among California's 12 largest counties at the time. The report prompted a state audit that reaffirmed the board's concerns.

The board is still pushing for access to internal sheriff's department reports and for drug screenings of jail staff.

"I think we have set the foundation for how an external entity can at least call and get the attention of the sheriff and the media," Parker said.

The first major report in recent history on the San Diego jails was published in 2018, revealing a lack of proper treatment for disabled and mentally ill incarcerated people. Since then, a plethora of media exposés and other outside scrutiny has criticized the conditions of the detention centers.

Aaron Fischer, co-author of the 2018 report, said many of the same problems he wrote about still persist today.

Fischer is a lawyer who filed a class action lawsuit against San Diego County on behalf of families of those who died in the jails. Despite the continued challenges, he said he has hope and knows there is common ground with the sheriff's department.

"It's not a zero sum game," Fischer said. "The safety and wellbeing for people who are incarcerated is not at the expense of public safety or staff or county resources or any of these countervailing interests."

"When you do it right, it can benefit everyone."

Donald Trump is ineligible to appear on the state's ballot as a Presidential Candidate due to his role in inciting an insurrection in the U.S. Capitol on January 6, 2021," Kounalakis wrote. "This decision is about honoring the rule of law in our country and protecting the fundamental pillars of our democracy."

Weber wrote back to Kounalakis, saying that she is guided by her "commitment to follow the rule of law."

"As California's Chief Elections Officer, I am a steward of free and fair elections and the Democratic process," wrote Weber. "I must place the sanctity of these elections above partisan politics. As you may not be aware, my office has been engaged in multiple lawsuits regarding the former president's appearance on the ballot."

Weber also acknowledged the complicated nature of the issue and her decision regarding it.

"We can agree that the attack of the capitol and the former presidents' involvement was abhorrent, there are complex legal issues surrounding this matter," she added.

At the time, she didn't know what questions to ask or what to expect, including how to cope with postpartum depression.

"With a doula, I would have been more informed," Bloomer said as 6-month-old Tiara babbled on her lap. "I would have felt more empowered. I would have had the kind of support that would have made me a better mom."

Bloomer in Victorville, on the edge of the Mojave Desert, far from friends and family.

In Smith's absence, Bloomer was grateful for Kalyan-Masih's companionship and reminders to take care of herself, she said.

But what meant the most was Kalyan-Masih's willingness to weave Smith into the birth without judgment, she said. Kalyan-Masih acted as his eyes and ears at the hospital in June, running around with Bloomer's phone so Smith could meet his newborn daughter, Tiara, via FaceTime.

"It meant everything. I mean, I'm locked up and I saw the baby before Mia did," Smith recalled, laughing. "Priya made everything possible. She held the phone. She was running around when the baby came out. She made it feel like I was there."

Smith met Tiara in person when he was released a month later.

Kalyan-Masih's presence also led to a noticeable difference in how medical staff treated her, Bloomer said.

During her previous deliveries, she felt the medical professionals had been pushy and dismissive. For example, when her son Thaddeus was born last year, she said, doctors pressured her to get an epidural against her wishes after Smith left the room to grab her lunch.

"When I had Priya in the room, they were more attentive to my needs and didn't treat me like my opinion didn't matter," Bloomer said. "It wasn't an argument or debate. It was just like, 'OK, that's what we're doing."

Medi-Cal covers up to 11 doula visits before and after pregnancy, and support during labor and delivery — and patients can petition for extra postpartum visits. Doulas can also be paid by Medi-Cal for providing support during and after miscarriages or abortions.

"I always explain it as obstetricians and midwives are the ones catching babies, and doulas catch Mom," said Kalyan-Masih, who is a medical doctor by training and a doula since January.

Kalyan-Masih is pleased with California's investment in doula services but said it has been a challenge to maneuver Medi-Cal's

administrative requirements, like acquiring business licenses.

Samsarah Morgan, a doula and founder of the Oakland Better Birth Foundation, said the business license fees, in addition to Medi-Cal's reimbursement rates, prevent some doulas from participating in the program.

The state pays doulas fixed rates per visit, adding up to \$1,154 if patients schedule the standard number of nine visits before and after birth, in addition to labor and delivery. Doulas can make up to \$2,078 through Medi-Cal if patients schedule additional postpartum visits. The \$1,154 rate is more than twice what the state initially proposed in 2022, and Morgan said that she's grateful for the increase — but that it's still not enough.

In her own practice, most clients pay \$2,500 to \$3,500, typically out-of-pocket since, in her experience, many private insurance plans don't cover doula services, she said.

"I want to work with clients who are on Medi-Cal, but I also need to pay my bills," Morgan said.

Griselda Melgoza, a spokesperson for the Department of Health Care Services, which administers Medi-Cal, said the department pays doulas the same as other providers — including doctors, nurses, and physician assistants for the same services. The department has proposed rate increases for doula services next year, which would vary by type of delivery. A doula who provides the standard nine visits and attends a vaginal delivery, for example, would be paid \$2,180, 89% more than the current rate. Preliminary data shows that 50 doula claims were processed statewide as of July 31 and that claims from that time frame are still coming in, Melgoza said. She added that the department is working to make the benefit more accessible. In November, for instance, it eliminated most referral requirements, removing a hurdle for patients.

Bloomer said she wishes she had been able to work with a doula during previous pregnancies, especially when she was carrying Lucas, her first child, at age 19.
