

merica has a penchant for war.

Whether it is ours or someone else's, whether declared or undeclared, this nation stands ready, at any and every given opportunity, to exercise its military prowess directly or by proxy.

Although many of this nation's undeclared wars are often pursued under the guise of humanitarianism, how can we genuinely accept such a premise when so many humanitarian needs go unfulfilled within the borders of this country.

In 1967, Martin Luther King Jr. spoke about poverty in America. "The curse of poverty has no justification in our age. It is socially as cruel and blind as the practice of cannibalism at the dawn of civilization, when men ate each other because they had not yet learned to take food from the soil or to consume the abundant animal life around them. The time has come for us to civilize ourselves by the total, direct and immediate abolition of poverty."

More than 50 years since King spoke those words we have advanced militaristically and yet remained stalled when it comes to meeting the human needs of the most vulnerable among us. King spoke about how war "robs society of the funds to uplift the poor." And yet, we continue to spend with wanton abandon in support of

# Gabriel Maldonado Named Inaugural Commissioner to CA Racial Equity Commission



Established through Governor Newsom's Executive Order N-16-22, California's Racial Equity Commission is tasked with recommending tools, methodologies and opportunities to advance racial equity and address disparities facing historically underserved and marginalized communities and will provide technical assistance to state and local governments to advance racial equity statewide. California's Racial Equity Commission (Commission), established by Governor Gavin Newsom in September 2022, recommends best practices and opportunities to address both racial equity and inequities facing historically underserved and marginalized communities in the state.

The 11-member Commission provides technical assistance to state and local governments to advance racial equity statewide.

The Commission, established as part of Executive Order N-16-22, also mandates state entities not only embed but also institutionalize racial equity strategies across their policies, programs, and initiatives.

Gabriel Maldonado, founder and Chief Executive Officer of TruEvolution in Riverside, a health and justice organization serving LGBTQ+, youth, seniors, and people living with HIV in San Bernardino and Riverside counties, was appointed as an inaugural Commissioner by



Medi-Cal through the ongoing expansion. Under the expansion, known as the Ages 26 through 49 Adult Expansion, full-scope coverage includes access to primary and preventive care, as well as prescription drugs, vision care, mental health care and specialists.

In addition to expanding access to more Californians, the state is taking more steps to protect reproductive rights and ensure privacy with Assembly Bills 254 and 352, which set out to protect and restrict the sharing of health

records related to abortion, pregnancy loss and menstrual health data.

"I'm thrilled the Governor has signed my reproductive privacy bills. Patients seeking care in California will be safer when they return home," Assemblymember Bauer-Kahan (D-Orinda) stated in a press release last year.

"Currently, information sharing through digital charts and period tracking, including abortions, can be seen, reported, and criminalized once patients leave California. AB 352 and AB 254 will secure this data to keep abortion seekers, providers, and helpers from being arrested.

Additional reproductive laws include the Contraceptive Equity Act of 2022 (Senate Bill 523), which expands coverage of contraceptives by a health care service plan without co-pays for prescriptions at in-network pharmacies.

neighborhoods and places that are navigable without a car are currently very desirable. Depending on where you live, you can bike, scoot, or drive a rental car parked on the street—with a credit card and enough money, of course. But for many Californians, a personal car is the only way to get to the places they need to go, and many of those places aren't walkable.

Cars are expensive and still one of the most important purchases that a buyer can make. Unfortunately, some auto dealers and sellers take advantage of the public by engaging in what are called auto retail scams. This type of scam or fraud costs consumers billions of dollars each year.

In response, the Federal Trade Commission (FTC) which protects the public from unfair business practices has created the Combating Auto Retail Scams (CARS) rule. The rule protects the public from auto retail scams or fraud when

As these new California laws double down on improving health care access to residents, another new law that took effect seeks to double down on drug penalties related to the opioid crisis. According to state officials, nearly 7,000 Californians died due to opioid-related overdoses in 2022.

Assembly Bill 701, signed into law last year, adds three years to the sentence for dealing more than one kilogram of fentanyl, and sentencing increases as the weight of a substance gets larger. AB 701 also classifies fentanyl on the same list of controlled substances that include heroin and cocaine which carry harsher penalties and sentencing enhancements for drug traffickers and dealers. Fentanyl is a synthetic opioid drug that can be fatal if even a small dose is taken.

While this bill aims to target high-level drug traffickers through the criminal justice system, Wendy Hetherington, chief epidemiologist for the County of Riverside Department of Public Health, explained that due to the complex drug situation in the U.S., it will take a "multidisciplinary effort" to address the opioid crisis.

"I know law enforcement needs to work on addressing the cartels and the drugs that are getting into the United States illegally, but then also be supportive of prevention efforts, like harm reduction and treatment and addressing trauma," Hetherington said.

Harm reduction focuses on engaging with people who use drugs and incorporating prevention, risk reduction, and health promotion strategies to promote health and safer living.

"It has to be a full, comprehensive picture. I think, oftentimes, that focus is on the law enforcement side of control and prevention, when it really has to be a more holistic approach," Hetherington emphasized.

According to Hetherington, 2023 preliminary data in Riverside County showed a relatively similar or slightly lower rate of overdose data compared to 2022. While official data will not be available until June, this preliminary data hints at a slowing rate of overdoses in the region, which is "good news," said Hetherington.

This suggests that harm reduction and prevention strategies are working such as expanding the availability of Narcan and ongoing awareness campaigns about the dangers of using fentanyl alone.

Gov. Gavin Newsom signed AB 701 last October along with a series of bills that focus on fentanyl treatment and education.

Authored by Senator Dave Cortese (D-San Jose), Senate Bill 10 requires local education agencies in California to include protocols for responding to student opioid overdoses in their mandatory school safety plans. The bill, called "Melanie's Law," is named after a 15-year-old who died as a result of a fentanyl overdose in her high school bathroom.

"SB 10 was our top priority because fentanyl has left a trail of devastation across California, and our bill establishes a series of concrete solutions to protect young people," said Senator Cortese in a press release last October.

Melanie's law also requires the California Department of Education to distribute informational materials containing awareness and safety advice regarding opioids.

they coming, they're bringing their parents along. Those are things that I like to see within the community.

**BVN:** What do you enjoy doing this month, or even year round, to commemorate Dr. King?

Rose Mayes: I enjoy the roundtable discussions regarding some of the issues on civil rights. To me, it's very important that we discuss the various points of view and various issues that we are actually experiencing within not only our homes, but our workforce and in the community as a whole, such as diversity, equity and inclusion. We need to continue to discuss the same issues that we've discussed before because they're coming back. We might as well just be for real about it and start talking about it, rather than running away from it and pretending that it's not happening within our workplace, within our community, within our churches, and even within our personal lives.

**BVN:** What are some of Dr. King's work and legacy that you feel is most prevalent today?

Rose Mayes: I'm very thankful that in 1964, the Civil Rights Act was coupled with the Federal Housing Act, and how it became more powerful because without the Civil Rights Act of 1964, we would not have had any enforcement. We would have just been going through the motions of counseling people about what their rights and responsibilities were under the Fair Housing laws, but because of the Civil Rights Act, signed into law by President Lyndon Johnson, we now have those particular rights with some enforcement power behind them.

We just didn't stop with housing. We went on to fight for fairness in education and fair employment. And now even in housing, we see that we have to go the extra mile because we thought we had it all covered through laws preventing discrimination [in] renting or purchasing. Now we've got to look at the appraisal part of the process, where when people go to a certain zip code, they find there is

still discrimination in housing appraisals. What we need to do, is to start educating ourselves in every facet of our lives, and educating the next generation. We have to constantly come to the table and talk about it and make sure that everyone is aware of it: you can be discriminated against in any area of your life, even health or technology. Let's just be realistic, think about it, talk about it.

**BVN:** Can you speak to Civil Rights achievements in the IE that readers should be aware of and celebrate?

Rose Mayes: I'm very proud of the fact that both San Bernardino and Riverside Counties work together. First, with the short range goals here in Riverside County, in the naming of Dr. Martin Luther King Street. We could not find anything but one item that was named after Dr. Martin Luther King back in the '70s, and '80s, and that was actually in the Riverside Community College District where there was a

building named after Dr. King. But we continued on and we started seeking, trying to have a street named after King, and that happened.

Also, there was not a room in the Riverside Unified School District named after anybody of color. So we submitted for a school in the Woodcrest area to be named after Dr. Martin Luther King Jr. There was a big fight over that. There were many, many ugly things said. However, we were able to succeed in getting that done in a predominantly white community.

This year, we are doing celebrations all the way from having a walk-a-thon to having church discussion groups to having workshops. You name it. It's our time to make sure that we educate the young people on what they need to do to carry on King's legacy. We [must] remember that there are some people who lost their lives behind making sure that we have a right to do the things that we can do today and not to take it for granted.

The rule, which requires transparency in the vehicle shopping process, includes key provisions regarding pricing, add-on products and services as well as buyers' consent.

#### Fraud or Scam

For most people the words fraud and scam are interchangeable, and Malini Mithal, Associate Director of the Federal Trade Commission (FTC) Division of Financial Practices concurred, "There's not actually much difference," he explained. "A lot of times if someone is lying to you about a product that's fraudulent behavior. That's a fraud, [and] it can be called a scam as well. The reason we use the term scam is that sometimes it's a little bit broader."

When it comes to scamming the public the intent of the scammer is not the focus according to Mithal. "Sometimes people think the word fraud has to include intent that you did something on purpose which is not necessarily what's needed under the FTC Act. We're very focused on what a consumer thinks, regardless of whether the speaker was intending something or not."

Although some consider fraud more of a legal term according to Mithal, acknowledging there are different legal standards in court. However, in our day to day speaking, scam "is a broad word that encompasses fraud and other illegal conduct."

#### What is the CARS Rule?

Explaining the CARS Rule, Mithal shared that it focuses on two very harmful practices that consumers experience beginning with "bait and switch" tactics, where dealers advertise a certain deal like a low price, to get you to come to the lot. But, once you're there and you spend time on the lot, you learn that the car is way more expensive than what was advertised.

The second scam the new rule aims to combat is "junk fees" which primarily refers to hidden charges that the dealer and consumer have never spoken about and the consumer doesn't want and that are easy to hide in contracts. This

can include such items as extended warranties, guaranteed automobile or asset protection or so-called "GAP" agreements, VIM etching, coatings that are supposed to protect the vehicle and many other items.

Mithal went on to say that the rule will save money and time. Honest car sellers and dealers will also be helped by the new rule because they will not have to compete with scammers, fraudsters and their fraudulent practices.

The rule states dealers can't lie about terms or conditions Dealers also must tell consumers the offering price that's the actual price anyone can buy the car for and consumers don't have to buy add-ons. Consumers must also be told what each charge is for and agree to pay it.

#### **Fraud A Preventable Crime**



conceal the poor condition of used cars and often lure consumers with advertisements of cars they do not have or do not intend to sell. These are other examples of "bait and switch." Other dealer scams can include attempting to inflate the interest rate at the time of financing. The Consumer Fraud Investigations Unit of the Riverside County District Attorney's Office advises that in order to prevent fraud, the public must educate itself advising, "As the first line of defense against fraud, consumers must be constantly on guard."

Consumer fraud is a uniquely preventable crime, the Riverside County Fraud Unit advises on its website advising, "By learning about current rip-offs in the marketplace and by following basic tips on smart consumer behavior, you can protect yourself and help us protect all the consumers of Riverside."

The new FTC CARS Rule becomes effective July 30, 2024.

military activities while we squeeze federal pennies in support of the poor. The lack of largess in this regard is evident in the data.

Today, America is making fiscal contributions on at least three war fronts that have been in the news in recent months and years:

On February 24, 2022, Russia invaded Ukraine and by early December the U.S. had directed more than \$75 billion in assistance to Ukraine.

On October 7, 2923, Hamas attacked Israel and although the U.S. already provides Israel \$3.8 billion in support of its military and missile defense every year, by early November, 2023, the Biden administration had requested an additional \$14.3 billion for added military assistance to Israel.

In another instance, the Department of Defense (DOD) provided about \$54.6 billion in military support to Saudi Arabia and the United Arab Emirates (UAE) over the six year period from 2015 through 2021 for actions in Yemen and yet, it could not even confirm whether the military equipment for which it was intended was actually used for unauthorized purposes. On the other hand, the U.S.provided Yemen with \$1 billion in humanitarian aid in 2022, as the conditions in that country reached a crisis. It seems in this case America is funding both sides.

This is just the tip of the iceberg in warrelated spreading in the last few years. It totals \$148.7 billion dollars and America is not even at war.

In the meantime, this country reached a record level of homelessness in 2023 according to the Department of Housing and Urban Development, a 12% jump from 2022, In addition, the Department of Agriculture found hunger in the U.S. rose sharply in 2022. About 44.2 million people lived in households that were food insecure.

The hard reality is that it does not seem to matter which political party is in power, how many people sleep on the street or how many babies go to bed hungry at night in this nation, military might continues to take precedence "

# Annual Black Caucus MLK Jr Breakfast Uplifts King's Legacy; Need to Generate Wealth

On Jan. 11, the California Legislative Black Caucus (CLBC) honored the legacy of Dr. Martin Luther King, Jr, at a breakfast celebration held at the Grand Ballroom of the Town and Country Event Center in downtown Sacramento.

The annual CLBC event was attended by about 200 people, including members of the Legislature from diverse backgrounds, community leaders, staffers from the State Capitol, among other attendees.

"It was an honor to host this year's annual Martin Luther King, Jr. Day breakfast. The California Legislative Black Caucus put on another lively event with great discussion on ways we can honor Dr. King's legacy and uplift all Californians," CLBC Chair, Assemblymember Lori A. Wilson (D-Suisun City), posted Jan. 11

on the social media platform X.

At the breakfast, Assemblymember Reggie Jones-Sawyer (D-Los Angeles), a member of the CLBC, served as the master of ceremonies at the breakfast held four days prior to the date that would have marked King's 95th birthday on Jan. 15.

CLBC members Assemblymember Chris Holden (D-Pasadena) provided the invocation and Assemblymember Kevin McCarty (D-Sacramento) led the Pledge of Allegiance. Sen. Steven Bradford (D-Inglewood), Vice Chair of the CLBC, shared a message from members of the Black Caucus.

Bradford revealed a little unknown fact about Dr. King's name. He was born Michael King, Jr., on Jan. 15, 1929. In 1934, his father, a pastor, traveled to Germany where he was inspired by Protestant Reformation leader Martin Luther, Bradford said.

"As a result, King, Sr. changed his own name

as well as that of his 5-year-old son," Bradford shared.

To the delight of the audience at the event, sponsored by Vertex Pharmaceuticals, vocalist Nia Moore-Weathers performed a powerful rendition of the Black National Anthem, "Lift Every Voice and Sing," a hymn written as poem by National Association for the Advancement of Color People (NAACP) leader James Weldon Johnson in 1900.

Wilson held a 30-minute fireside chat with guest speaker Kwame Anku about Dr.

King's life, achievements, and vision, and the importance of building wealth in Black families and communities.

Anku is the founding managing partner and chief investment officer of Black Star Fund, an early-stage venture capital fund. He got the idea to start the fund on the urging of Roger "Prince" Nelson, the singer, songwriter, multi-music instrumentalist who passed away in 2016.

Anku was named the 2022 Entrepreneur of the Year by Sacramento Metropolitan Chamber of Commerce and was also among 21 distinguished recipients of the prestigious Aspen Ascent Fellowship awarded by the Aspen

Institute. He said King's famous 1963 address at the Lincoln Memorial in Washington, D.C., the "I Have a Dream speech," could have been more aptly titled "America, It's Time to Look in the Mirror" reflecting its core messages of accountability and denied justice.

"We're telling ourselves how great we are but we're not living up to the promise that we've made to ourselves because that's the bedrock of what we do when he said we have come here today to cash the check," Anku told Wilson. "So, we've come to cash the check because this check guarantees us the riches of freedom and the security of justice. So now we're not just cashing that check. Now, we are writing those checks."

This year marks the 57th Anniversary of the CLBC. For nearly six decades, the CLBC has been a key advocate for issues such as fair housing and the prevention of homelessness.

Historically, the coalition of Black lawmakers has actively resisted redlining in banking and insurance in California, and fought against apartheid in South Africa, among other issues.

The CLBC plans to continue the legacy of Dr. King by developing legislation around its current priorities, which include pursuing reparations for eligible Black Californians, criminal justice reform, environmental justice, and helping to ensure greater access to education and enterprise for African Americans. During the 2024 legislative session, the CLBC aspires to secure funding for critical programs and organizations working to enhance the lives of Black Californians.

Today, there are 12 members of the CLBC serving in the California Assembly and Senate.

**BVN:** Are there any final words or thoughts you'd like to add?
