# Urgent Action Needed-Hate Against Black Students in Schools




A new report, covering the five year period 2018 - 2022, highlighted over 30% of juvenile victims of hate crime experienced the offense while at school. In 2022, 66% of the race-based hate incidents occurring in U.S. schools targeted Black students. (Graphic by Chris Allen, VOICE)

hen claims of "Racism as a Public Health Crisis" rang out in 2020 calling for an overdue plan of action to heal its victims as COVID-19 and the murder of George Floyd collided with a new generation of activists, their sense of urgency for change was palpable. Conditions in America compelled them to picked up the torch of justice as they breathed new life into the struggle for equity and equality,

Despite these efforts and the municipal declarations made in response, some of the most important areas of concern, including acts of racism against Black children and youth, remain unchanged. In fact, acts of hate perpetrated

against them have increased exponentially according to the just released Hate Crime at Schools report that explored incidents of hate at schools across the country for the years 2018-2022.

During the five year study period over 30% of juvenile victims of hate crimes in the country experienced the offense while at school. And in 2022, according to the report, data shows 66% of the race-based hate incidents that occurred in U.S. schools that year targeted Black students. Stronger Together Now (STN), a nonprofit that hosts community events in the Inland Empire, is suddenly faced criticism and questions about the future of its events held in the City of Redlands as expressed at the Redlands City Council Meetings on December 19, 2023, and January 16, 2024.

Martin Guerrero, told the city council at its January 16, meeting, "Why? Because of one word—inclusion."

"This word triggers fear in those who believe supporting all communities and cultures threatens their individual existence," Guerrero opined while explaining how the organization is creating space and collective care where everyone belongs, and it is not threatening anything.

Guerrero stated the city council had couched their criticism as more about business and

commercialization to avoid the inclusion issue and keep their voters.

Public speakers at the December 19, 2023, and January 16, 2024, city council meetings raised objections to the fact that Stronger Together Now has featured a drag queen as a singer at one of their events.

Guerrero understood critics considered the event a public display and were concerned it would indoctrinate students. The drag performer is part of STN's Lumos Festival, a Latina, Hispanic, Mexican, Marikana, and Indigenous Celebration, and drag is part of their history, Guerrero explained while acknowledging that not everybody is comfortable with that history. Many at the city council meetings questioned

STN's ties to the City of Redlands to which Guerrero responded that six of its board members live in the City of Redlands, however, they do not have a "brick and mortar" place of business in the city. STN used a Rialto address, as their physical address. A physical address is required for a business license in the state of California.

Others at the meetings questioned why STN held events in the City of Redlands. According to Guerrero, it is due to the strong community support and donations they receive, which STN uses to distribute to other nonprofits serving the Inland Empire, and at free giving markets



s we enter Black History Month 2024, once again the nation is confronted with more alarming realities of bigotry and hatred coming from a new report showing that 66% of the race-based hate incidents that occurred in U.S. schools last year, targeted Black students.

Even as many Americans turn their focus to Black History Month, it is difficult to ignore the increase in hate continuing to manifest across the country and nothing can be more concerning than the cruel impact this can have on the psyche of Black children, youth and young adults. Yet, the recently released Federal Bureau of Investigation (FBI)

Uniform Crime Reporting Program's newly released special report, Hate Crime in School, makes it clear the nation must pay attention.

The report, which covered the five year period 2018 to 2022, highlighted that over 30% of juvenile victims of hate crime experienced the offense at school, while nearly 36% of juvenile offenders of hate crimes committed the heinous acts on school campuses.

The report shows, in raw numbers, that of the 828 hate incidents in schools that were motivated by racial bias in 2022, 547 or 66% targeted Black students. Though down slightly from the 68% of targeted Black students in 2021, it follows the trend noted in the FBI's most recent

overall hate crimes report, where more than half of race-based crimes in 2022 targeted Black people.

The hate crime offense most commonly reported during this period was intimidation followed by destruction, damage or vandalism of personal property. The next category in magnitude of incidents reported, was simple assault.

Total reported hate crime incidents and offenses in schools increased from 7,181 incidents in 2018 to 11,643 incidents in 2022. According to the FBI report, the hate incidents at schools compared to the overall incidents of reported hate crimes fluctuated over the study period with a notable drop in 2020 that possibly resulted from school closures due to the COVID-19 pandemic.


The percent of all reported hate crimes at school ranged from a low of 3.9% in 2020 to a high 10.0% in 2019 and 2022. Regardless of the fluctuation in this regard, what remained consistent was the incidents of hate crimes occurring in schools retained a third place

ranking as the location where reported events of hate most commonly occur following those that happen at places of residence or on the road.

The report further revealed the fourth quarter of the calendar year, October through December, to be the period when most hate crimes at schools occur, with October standing out as the most common month, averaging 4.1 offenses per day.

Prior to 2010, School/College was the only school data collected as the location of a criminal offense and was used for all school locations, regardless of the age or advancement of enrolled students. In 2010, however, two additional categories were added, Elementary/Secondary and College/University. This was done to distinguish the demographics of the enrolled students at the location of school-related offenses. Although agencies are encouraged to specify Elementary/Secondary or College/University when identifying schools where hate incidents occur, the original comprehensive School/


During each year of this report period, Elementary/Secondary schools were the most frequently reported school-related locations where incidents of hate occurred.

As noted, anti-Black or African American incidents were the most common bias type of hate crime offenses at schools with 1,690 incidents reported during this period, followed by Anti-Jewish and Anti-Lesbian, Gay, Bisexual, or Transgender, with 745 and 342 offenses respectively. An offense can also involve more than one bias type.

Following Anti-Black or African American bias,

with 1,690 reported incidents during the report period, was Anti-Jewish and Anti-Lesbian, Gay, Bisexual, or Transgenderbias related events with 745 and 342 offenses respectively. An offense can also involve more than one bias type.

The FBI's Uniform Crime Reporting (UCR) Program has collected and published data on hate crime incidents in accordance with the Hate Crime Statistics Act of 1990 for more than three decades.

The rising incidents of hate across the country and its impact on schools appeared already on the radar of California Governor Gavin Newsom when he announced on September 23, 2023, state plans to support victims and help prevent acts of hate by launching the first major statewide multilingual "CA vs Hate" awareness and education campaign, while also reminding educators about the importance of anti-hate awareness inclusion in education.

At the time Newsom said his action was motivated by "recent high-profile incidents," including the horrific murder of a shop owner in Cedar Glen, located in the San Bernardino mountains. The new investments and resources are intended to further the fight against hate by building on the state's existing efforts to empower diverse communities and address discrimination.

"As hate-fueled rhetoric drives increasing acts of bigotry and violence, California is taking action to protect those who are targeted just for being who they are," said Newsom. "We're bolstering our support for victims and anti-hate programs and tackling ignorance and intolerance through education to prevent hate from taking hold in our communities."

The actions announced by the governor included \$91.4 million to 173 local organizations across the state to support victims, provide resources, and facilitate antihate prevention measures as well as the state's first major statewide media campaign entitled "CA vs Hate" that includes print, radio, and digital ads to run in English, Spanish, Chinese, Vietnamese, Tagalog, Korean, Tongan, Mixtec, and Hmong. The ads are designed to focus on traditionally hard-to-reach communities.

The effort also includes a letter to all public school leaders in the state highlighting the legal responsibilities to ensure ethnic studies curricula. The curricula is intended to give students a chance to "see" themselves in the fabric of the state.

"An attack on any of our communities is an attack on everything we stand for as Californians," declared Newsom.

#### Atty Gen. Rob Bonta, Lawmakers, Announce Legislation to Protect Youth Online

Attorney General Rob Bonta joined Sen. Nancy Skinner (D-Berkeley) and Assemblymember Buffy Wicks (D-Oakland) to announce two pieces of legislation designed to protect children online.

The bills are Senate Bill (SB) 976, the Protecting Youth from Social Media Addiction Act and Assembly Bill (AB) 1949, the California Children's Data Privacy Act.

Skinner authored SB 976, which addresses online addiction affecting teenage users, while Wicks's bill, AB 1949, takes on big tech by proposing data privacy and children rights protections.

"Social media companies unfortunately show us time and time again that they are all too willing to ignore the detriment to our children, the pain to our children, the mental health and physical challenges they face, in order to pursue profits," Bonta said.

SB 976 would allow parents to control the nature and frequency of the content their under-18-year-old children see on social media. Notifications from social media platforms would also be paused from

Anti Bias Attacks at School.

Sadly, the findings were not an aberration. Cumulatively, the numbers not only reflect findings revealed in the FBI's overall hate crimes report, they also are reflective of the incidents of anti-bias hate against Black students each individual year of the five year study period.

While considering these results it struck me that while we may lament and opine about the reality in the data, maybe as a Black community, we need to do less contemplating and more noise making. When Asian hate crimes increased during the pandemic, the nation lost its mind and threw everything but the kitchen sink at getting attention on the issue. When immigrant children were placed in cages during the Trump administration, it drew international condemnation. When hate crimes against the Muslim community spiked in the wake of 911, the national media paid attention and supportive communities rallied in response. And, whenever tensions rise in the Middle East or extremists spout words of hatred against the Jewish community, many Americans are apoplectic in demanding an end to anti-semitism.

But, when year after year, incidents of antibias hate against Blacks outpace every other group by leaps and bounds; when year after year acts of hate against Black children, youth and emerging adults at schools outpace other groups in great numbers, we must ask ourselves, where is the similar outrage? Where are the calls to action? Where are the national and statewide anti-hate campaigns? Where is the federal/statewide funding to focus like a laser on this issue?

Yes, there is funding for anti-hate campaigns and such campaigns are certainly warranted. But where is the specific, targeted effort to put an end to the hatred aimed at our children, our youth, our young adults, Black people in general, being experienced and tallied year after unrelenting year?

I don't mean to imply that major incidents of hate against Black people are ignored. Certainly, there is always an outpouring of response when occurrences like the massacre at Mother Emanuel Church or the slaughter at the Buffalo grocery store or the COVID-19 pandemic, or the murder of George Floyd or, or, or. But, when it

comes to the death of Black dignity, Black mental health, by a thousand cuts year after year, there is silence.

We in the Black community should be demanding more attention, more mitigation, more funding focused specifically on this issue. Consider this—bias motivated hate crimes against Blacks in schools went from 237 in 2018 (the highest among any group) to 547 in 2022 (again the highest in any group). This reflects a 230% increase in anti-bias crimes against Blacks in the nation's schools. Again, where is the outrage?

I don't mean outrage without reason. I mean outrage against the threats to the future of Black children.

These acts of hate go far beyond just hurt feelings. A policy statement from the American Academy of Pediatrics (AAP) issued in 2020, declared, "Racism is a social determinant of health that has a profound impact on the health status of children, adolescents, emerging adults, and their families."

The statement further noted that evidence to support the continued negative impact of racism on health and well-being through implicit and explicit biases, institutional structures, and interpersonal relationships is clear.

In 2023, a study published by the American Journal of Psychiatry showed that racial inequities (including trauma) can lead to changes in the brain structure of children causing conditions like post-traumatic stress disorder.

The AAP policy statement stressed the importance of acknowledging the role of racism in child and adolescent health. It noted how such acknowledgement will empower pediatricians and other health professionals "to proactively engage in strategies to optimize clinical care, workforce development, professional education, systems engagement, and research in a manner designed to reduce the health effects of structural, personally mediated, and internalized racism and improve the health and well-being of all children, adolescents, emerging adults, and their families."

This is great, but we should be preventing such psychological/emotional damage even more aggressively than we are working to mitigate it. Although the Hate Crimes at Schools report was not disaggregated by state, the need for targeted awareness, prevention and mitigation exists. Experts note how such acknowledgement is important and yet, when strategies for anti hate programs are funded and discussed, the historical fact that Blacks continue to be the most attacked group in the area of anti-bias overall, and Black children, youth and emerging adults specifically, year after year, it is rarely, if ever mentioned as a stand alone concern, let alone highlighted as an area of critical importance. It is usually swallowed up as part of the general concern.

Take for example consider this press release from last May titled Governor Newsom Announces the Launch of CA vs Hate, a New Statewide Hotline to Report Hate Acts in California, although Black Americans were ticked off on the list of communities targeted, there was nothing in the memo that pointed out their status as being consistently the most targeted group year after year; or this press release issued in June, 2023, from the CA Civil Rights Department titled, In First Month Since Official Launch, California vs Hate Receives 180 Reports of Hate Acts Across California and Connects Californians with Support, not a mention of the need to focus on anti-Black bias.

In September 2023, Cal Matters reported that although Blacks in the state of CA only represent 6% of the population, they represent about 30% of its reported hate crime victims and yet "the Black community appeared to receive only a fraction of the grants the state is disbursing." These comments were made in reference to the \$90 million in grant funding California is spending to fight hate.

Based on the data, there is little doubt the Black community has a right to demand more.

Of course, this is just my opinion. I'm keeping it real.

based in the city that are having to pay increased fees for the use of space in the city.

Additionally, Broome objected to having his tax dollars support an organization like STN, that had a drag queen at an event in downtown Redlands, and that parents, who may not want their kids to be exposed to drag queens, were not notified of the drag queen's participation.

"I don't think the city should waive fees for STN, a group based in Rialto, while they are raising fees for residents," public speaker Joshua Hall expressed at the December 19, meeting, while also objecting to having drag queens in a public park describing it as social engineering and indoctrinating children into the LGBTQ+ lifestyle.

During public comments at the council's December meeting, Michael Paisner, Chris Bishop, Janelle Guerrero, and Pollyanna Flores expressed their appreciation of STN, whose work provides important value to the community and attempts to break down barriers to assist marginalized people and bring communities together

During this meeting, Mayor Eddie Tejeda, Mayor Pro Tem Paul Barich, and City Council Members Denise Davis, and Jenna Guzman-Lowery, all voted in favor of waiving the fees, with Mario Saucedo voting no, thus waiving the fees for STN's Giving Sunday Event which was held on January 28, 2024, within Ed Hales Park.

During public comments at the council's December meeting, Tyler Smith voiced his support of the group's efforts to be a positive force, adding how the Giving Sundays events promote peace, unity, and inclusion within the community.

Saucedo objected to approving the waiver of fees for STN based on the number of events STN was requesting and what he viewed as the events becoming more of a commercial endeavor.

Mayor Pro Tem Paul Barich expressed concerns about whether STN has business licenses and health certificates, however, expressed his intent to attend the event.

Also, during the January meeting, Mayor Eddie Tejeda, Mayor Pro Tem Paul Barich, and City Council Members Denise Davis, Jenna Guzman-Lowery, and Mario Saucedo all voted in favor of waiving the fees for STN's Giving Sunday Event to be held on February 25, 2024 at Ed Hales Park.

midnight to 6 am and controls would allow parents to set time limits on their children's usage based on their discretion.

Skinner stated that the longer that kids are on their phones during the day, the higher the risk for depression, anxiety and other related issues.

Bonta and 33 other attorney generals had previously filed a lawsuit against Meta, owner of the popular social media applications Instagram and Facebook. The filing claims that the company purposefully uses algorithmized content that harms younger audiences.

"Social media companies have the ability to protect our kids, they could act, but they do not," Skinner said.

The Child Data Privacy Act would strengthen existing protections for data privacy under the California Consumer Privacy Act (CCPA). The lawmakers argue that the law does not have effective protection for those under 18 years old.

"In a digital age where the vulnerabilities of young users are continually exploited, we cannot afford to let our laws lag behind, our children deserve complete assurance that their online experience will be safeguarded from invasive practices," Wicks said.
