When it Comes to Our Children's Education, There Should Be "No Surprises"

When news broke this weekend that the Perris Union High School District was meeting Tuesday, Mar. 5, to discuss the elimination of the district's Diversity, Equity and Inclusion Department, its District Equity Team, program specialists responsible for mental health services—and other cutbacks, a groundswell of resistance began among parents and concerned members of the community.

The Perris Union High School District however is not the only educational system feeling the economic squeeze which are likely to lead to layoffs and the probable discontinuance of much needed programs for our children and youth.

In mid February, the Goleta Union School District in Santa Barbara County, announced it was struggling with a budget deficit and would be laying-off and taking other measures to cut costs.

In late February, the Pasadena Unified School District Board of Education announced at least 200 staff layoffs.


And, on Monday, it was reported the Santa Barbara Unified School District announced it is planning to take a similar course.

It seems California school districts are headed for a crisis. Reports indicate the state's budget deficit continues to grow and is now estimated to be around \$73 billion according to one report that also indicated, "the state's legislative analyst's office predicts continued operating deficits through 2028."


Adding to the pressures on school districts is the looming reality that the state's Local Control Accountability Plan — the three year budget and accountability strategy for disadvantaged students is set to expire this year.

Adding further fuel to the financial pressure

Rainbow Push Coalition President & CEO, Rev. Dr. Frederick D. Haynes III, Issues Clarion Call for Solidarity with Palm Springs Section 14 Survivors

Rev. Dr. Haynes, national civil rights leader and successor to Rev. Jesse Jackson, addressed a diverse coalition of Section 14 Survivors, descendants, supporters, and community members at The Church of St. Paul in the Desert during prayer vigil in honor of Black History Month.

On Sunday, February 18, Rev. Dr. Frederick Douglass Haynes III of Friendship-West Baptist Church and the Rainbow PUSH Coalition, one of America's leading civil rights organizations, joined the Palm Springs Section 14 Survivors and descendants, local clergy members, and supporters as an honored guest at The Church of St. Paul in the Desert in Palm Springs.

The gathering of more than 100 people brought together Palm Springs residents from across faiths, backgrounds, sexual orientations, and ages in unity to honor Black History Month – including the history of the Black community of Palm Springs. Participants at the event prayed for justice and healing for the Survivors of Section 14 and their descendants, and clarity for city leaders.

“What is occurring right now in Palm Springs is a beautiful show of unity across faiths, backgrounds, races, sexual orientations, age, and beyond. This city has an opportunity to be a leader, and to show the rest of the country how much good can come from standing together and doing the right thing for each other. It's as simple as that,” said Rev. Dr. Frederick Douglass Haynes III, President & CEO of the Rainbow PUSH Coalition. “The survivors of Palm Springs Section 14 have waited too long for justice. Today, we lift our hearts and hands in prayer for the leaders of this beautiful city to seek a path forward that honors the past and allows justice to be realized here.”

Rev. Dr. Haynes, renowned national civil rights leader, prophetic pastor, and advocate for racial justice, was recently appointed by Rev. Jesse Jackson to succeed him as the President of the international human and civil rights organization, the Rainbow PUSH Coalition. The Rainbow PUSH Coalition was founded by Rev.

Jesse Jackson in the 1970s, and for the first time in more than 50 years, has a new leader in Rev. Dr. Haynes.

“Black history is American history – and that means speaking candidly about the past, even if it creates discomfort,” said Areva Martin, Esq., lead counsel for the Section 14 Survivors. “The sixties and fifties weren't that long ago, but for my clients, the destruction of their homes, possessions, and community sixty years ago has deeply impacted their lives to the present day. With strong allies across the region and state – now, with Rev. Dr. Haynes, a national civil rights leader joining us – we are building a powerful coalition of supporters and allies, and our movement is being recognized by leadership

here in Palm Springs and beyond. We are grateful for the support we have received, and for the prayers of everyone across this city and region. Hopefully by this time next year, we will honor Black History Month in Palm Springs with a celebration of justice achieved.”

The prayer vigil took place at The Church of St. Paul in the Desert, where a diverse group of clergy joined Reverend Jessie Thompson and Reverend Dan Kline to continue lifting up prayers for healing and justice.

“We are truly grateful to Rev. Dr. Haynes, Rev. Kline, Rev. Thompson, and community organizations like Brothers of the Desert and the Stonewall Democrats for standing beside us on our mission to make our families whole again,”

Nestled in Riverside County is Moreno Valley, the Inland Empire's Blackest city. With the second largest population in the county, Moreno Valley is just one example of the growing communities in the Inland Empire, home to the third largest Black population in the state — soon to be the second.

Mapping Black California (MBC), Black Voice News' data unit, recently published the "Black Equity Fund Report," which examines the socioeconomic factors that impact the lives

continuing that fight, while charting a course toward greater equity and empowerment for the Black community."

MBC was tasked with developing this data report by the IE Black Equity Fund under the stewardship of Inland Empire Community Foundation (IECF). The IE Black Equity Fund was created in 2020 to provide financial resources to Black-led organizations. The Fund has raised more than \$6 million to support these organizations.

Using data, the report analyzes how Black residents experience barriers to access across health, education, housing and wealth, and how these factors impact their wellbeing.

According to the data, there is a sizable disparity in life expectancy among different demographic groups in the IE. Black men have a life expectancy of 72 years — eight years shorter

Community Reflections at BVN's Celebration of Black History

Community members joined a discussion led by Dr. Paulette Brown-Hinds and Hardy Brown II about Black history, the origin of Black Voice News and their work as local government watchdogs. The conversation chronicled the legacy of Black Voice News and examined community stories told through text, data, visuals and mapping mediums.

Black Voice News photojournalist Aryana Noroozi set up a pop-up news station to capture portraits and conduct interview sessions with attendees to learn more about their family history, connection to the IE and personal celebration of Black history. As Black History Month 2024

comes to a close, Black history in the Inland Empire occurs every day. Check out what the community had to say about their lifelong celebrations of Black history in their pop-up sessions below.

Jeannette Roberts, 65, Sherina Roberts, 34, and Journie Bland, 6, are three generations that each call San Bernardino home. Jeannette's parents moved to the region from Alabama and Oklahoma. Her connection to the community started at a young age as she recalled watching the drill team at SB Valley College with her late mother. She cherishes the Black Cultural Foundation, especially the Inghram Library as she knew Dorothy Inghram personally.

Jeannette Roberts said her favorite memory of celebrating Black history was the parade held every year near her home. Sherina Roberts also shared this as one of her favorite memories, fondly recounting getting up early with family and friends to watch.

Journie Bland said she recognized Martin Luther King Jr. on a shirt after learning about him in school.

“[I hope that they] introduce her generation to [reading] the newspaper... It's nothing like getting that newspaper. That's what this is all about – the newspapers, [to] have it in your hand,” said Jeannette Roberts, about Bland’s generation.

Sherina Roberts used to work for Cheryl Brown, Publisher Emeritus of the Black Voice News, when she was a California Assembly

member, making calls for her office.

“I hope we come together more,” Roberts said about the Black community today. “[It’s] s-Such a negative world, we need to try to come back as one.”

April Anteur moved to Ontario from Los Angeles with her family in 1994, then to the City of San Bernardino in 2001, where they have been ever since.

Anteur cherishes being together with her family and hopes where she currently lives continues to stay safe and walkable.

When it comes to Black history, “We can do absolutely everything,” Anteur said. “There’s nothing that we can’t do given the opportunity and taking it. We’re going to excel.”

Janita Moore’s mother moved to San Bernardino when she was five years old in 1969. Moore’s grandmother came to Blythe, California in 1949 with her parents who were sharecroppers from Arkansas.

“My family has always celebrated our Blackness and always made it a priority to

make sure that we were a part of a community where we celebrated our culture, we celebrated our history, and just made sure that we knew who we were,” Moore said about her upbringing in San Bernardino.

She added that while a teacher at Hardy Brown

College Prep, she shared her passion for Black history with her students. Today she works in education policy.

important to have conversations that are hard, and that are leading people to make their own choices about how to fit into the diaspora.”

Moore learned Black history in school, but was surrounded by it when she came home. She recalled always seeing photographs, magazines and a Black encyclopedia that her grandmother and mother’s God mom whom she called Joanne Dion, an organist at a Church in San Bernardino, would share with her.

“I was always surrounded by an understanding of Black history so it taught me just [to] seek it more,” Moore said.

Denise Davis and Aaron Shorter became engaged last November and are celebrating their child’s first birthday in March. Davis came to the Inland Empire from Las Vegas in 2002 to attend college and Shorter moved from Indianapolis to Perris when he was two years old.

“One of the things I love most about our families is that we have a lot of shared values. Obviously, [from] different backgrounds,

different life experiences, but really shared values around equity, social justice and inclusion,” Davis said.

“I just really hope people really start seeing some equity,” Shorter said about his hopes for the Black community and humanity as a whole. “The state that our country is in [we’re] seeing a lot of rights and freedoms and things being challenged, if not taken away... I hope people don’t get led astray.” He urged everyone to vote.

Davis attended a diverse high school in Las Vegas where she remembered Black history being taught, but her strongest memories of Black history came from her uncle at home.

“His parents were leaders in the Civil Rights Movement in Las Vegas. His mom was actually the first Black show girl on the Las Vegas Strip,” she said. “Growing up celebrating holidays with

than the regional average (77 years) and 12 years less than Asian men (90 years).

“This report provides data-driven insights that reveal how anti-Black racism continues to profoundly shape life outcomes and opportunities for Black IE residents today,” said MBC Project Director Candice Mays in a press release. “We hope it serves to expand awareness and galvanize collaborative efforts to build a more just, equitable and inclusive future for the region.”

The Black Equity Fund was launched during the height of the COVID-19 pandemic and ongoing racial protests. Health disparities among Black populations became more prevalent during the pandemic as data showed disparate outcomes in COVID-19 cases, deaths and vaccination access.

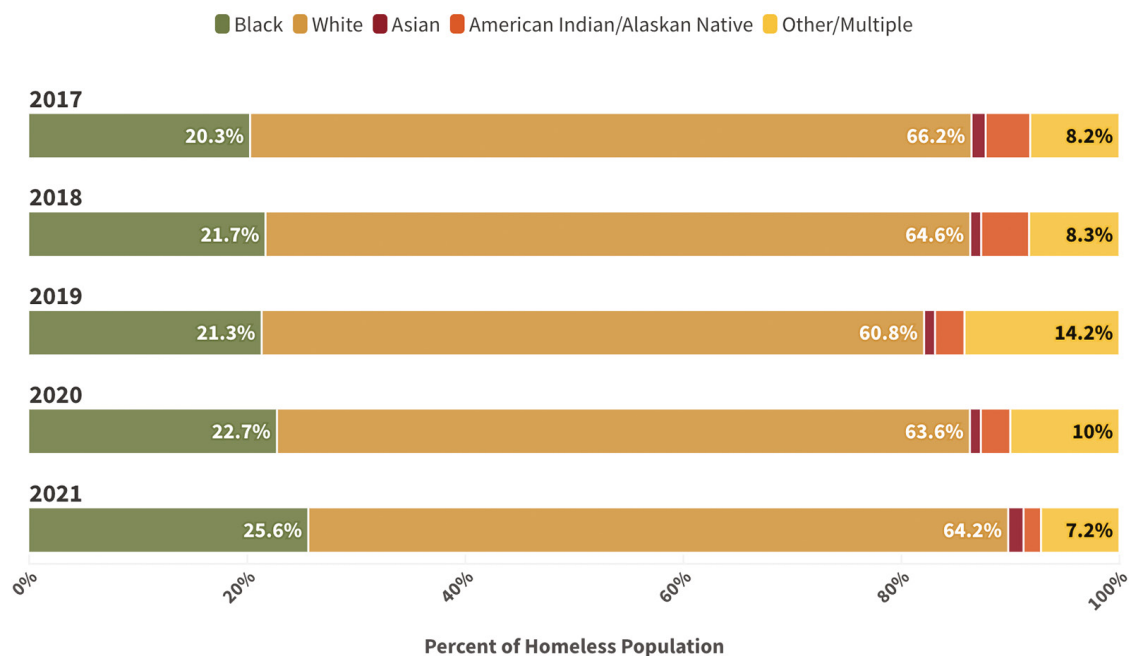
These outcomes, coupled with ongoing and heightened racial tensions, resulted in the need for more resources from Black-led organizations whose mission is centered on advancing the health, wealth and wellbeing of Black communities.

“When it comes to providing financial resources to our Black-led and serving organizations, the stark disparities revealed by the data cannot be overlooked,” said Michelle Decker, president and CEO of IECF, in a press release. “To tackle these disparities, we will continue raising dollars with the support of our donors who want to see a region that works for everyone.”

Financial support from the Black Equity Fund has allowed Black-led organizations to increase their capacity, fund new initiatives and expand others, and pour back into the community. Last year, 71 Black-led and serving community organizations were awarded grants from the Fund.

Across the IE, there are dozens of Black-led organizations working to support Black residents facing disparate outcomes and impacts. According to the report, Black communities across the Inland Empire are overrepresented among the houseless population, making up 22% unhoused individuals counted in the 2020 Inland Empire Point-in-Time (PIT) Count,

Data from the Black Equity Fund Report demonstrates how Black residents in the Inland Empire face disparate outcomes across health, housing, education and even life expectancy. The chart above demonstrates how Black homeless individuals are overrepresented in the IE, making up 22% of unhoused individuals counted in the 2020 Inland Empire Point-in-Time (PIT) Count, despite only accounting for roughly 7% of the population.

despite only accounting for roughly 7% of the population.

Black Equity Fund grantees like the Time for Change Foundation are supporting the most vulnerable houseless individuals. Since 2001, the organization has been helping homeless women and children “achieve self-sufficiency” by providing housing and services.

“This report underscores the urgency of continuing the fight for greater empowerment and opportunities that match the strength, contributions and potential of the Inland Empire’s Black community,” said Dr. Paulette Brown-Hinds, publisher of Black Voice News, founder of MBC and past chair of the IECF board, in a press release.

As the Inland Empire’s Black population continues to grow, addressing these ongoing socioeconomic challenges will require a “multi-pronged approach,” according to the report.

This approach includes addressing the origins of past discriminatory policies, the legacy of those policies and “proactively charting a course for future interventions.” To do so will require the collaboration of community leaders, policymakers, businesses and community members.

With the upcoming primary election on March 5 and later general election, Black residents of the Inland Empire have the opportunity to engage with their leaders and ignite change through civic action. While civic engagement among Black communities has been noted as robust with high voter turnout (71%), especially in presidential elections, Black voter turnout remains lower during midterm elections. Black residents have the ability to create change by electing leaders who will prioritize their needs and who will work to create equitable policies.

said Pearl Devers, Founder and President of the Palm Springs Section 14 Survivors. “For those of us who remember the destruction of our neighborhood, it wasn’t some land far away or some time long ago. We are living Black history, and we are committed to keeping the memories of our families alive as we continue to pursue justice for what happened to us just down the street.”

“Black history and LGBTQ history isn’t in the past, it’s being created now and we all have a responsibility to improve our communities so that the choices of the past are not repeated,” said David Weiner, Chair of the Stonewall Democrats of the Desert. “Today’s gathering in prayer, leading with hope and unity, is a powerful reminder that only light can overcome darkness, and no matter who you are, who you love or where you are from, every human deserves to be treated with dignity and if harmed, deserves restitution. It’s time for the city to make it right.” “As we all commemorate Black History Month, it is a time to reflect on how far we’ve progressed and how much more we have left to do,” said Tim Vincent, President of the Brothers of the Desert. “As Black men and members of the LGBTQ community, we are all too familiar with the fight to be treated with decency, respect, and to push for justice when harmed. Palm Springs is a progressive, welcoming community, and the Palm Springs Section 14 Survivors share that love for the city. But the survivors of Palm Springs Section 14 have waited too long for justice, and it is up to all of us to support their cause.”

Joining the Section 14 Survivors in producing this program were the Stonewall Democrats of the Desert, Brothers of the Desert, Special Needs Network, Inc., Civil Rights Attorney Areva Martin, Martin & Martin LLP, The Church of St. Paul in the Desert, Desert Highland Gateway Community Action Association, the Palm Springs Black History Committee, and a coalition of diverse clergy.

cooker are current negotiations between school districts around the state and the California Schools Employees Association (CSEA). CSEA is the largest classified school employees union in the nation and represents about 240,000 school support staff across California. It appears, at least regarding the San Bernardino City Unified School District (SBCUSD), that all sections of the contracts can tentatively be discussed. In early February, SBCUSD reported some progress in their negotiations, but progress between the union and other local school districts is unclear. These negotiations will either place upward fiscal pressure on school districts or leave employees under pressure if needed benefits and/or wages increases are not successfully negotiated. It's a no win situation.

And if all of the above were not enough to raise concerns, on February 28, the national Center on Budget and Policy Priorities (CBPP) the final round of federal Elementary and Secondary School Emergency Relief (ESSER) funds is set to end soon and states are required to commit all remaining funds by September 2024.

In total, school districts across the nation received nearly \$200 billion dollars in additional funding in response to the COVID-19 pandemic. According to the CBPP, "The financial impact of the expiration of ESSER funds for states and school districts will be exacerbated by several factors including costly state tax cuts,

the diversion of resources to school vouchers, inadequate school funding formulas, elevated costs, and an uncertain revenue outlook."

So, the question is, "Now what?" The state's budget deficit may be the one wild card in this scenario but beyond that, the expiration of COVID-19 funding, contract negotiations with CSEA and the expiration of the Local Control Accountability Plan were all expected. Where are the plans to mitigate these impacts? Our children look to us to assure the quality of their education and all that undergirds it. We elect boards to manage these issues on our behalf. We should not be caught off guard on key issues especially to this extent. To make matters worse, it is now left to the whim of each school board as to where cuts will be made in personnel and what programs will go on the chopping block. Most of us have been around the block a few times and already know what usually goes first.

This is a call to action. Get involved. Pay attention to what decisions are being made by your local school boards. Know what cuts are being considered (if any) and how your local school board is making its decisions in this regard. If you disagree with their actions, I implore you to raise your voice on this issue.

Of course, this is just my opinion. I'm keeping it real.

them, talking with them over dinner about what they went through to help desegregate the Las Vegas Strip has always been really powerful for me.”

Andre Harrington, Kathryn Ervin and Kristi Papailler, natives of Washington D.C., Detroit and Louisville respectively, each found a home in the Inland Empire after joining California State University, San Bernardino’s (CSUSB) theater department. They are the only three Black professors within the department.

Harrington said he was reminded of Black history during a recent morning while cooking with a cast iron skillet. He remembered when a colleague, a UCLA anthropologist, “spoke about her grandmother that walked from Tennessee to northern California and brought the frying pan,” he said. “So, the tenacity, the longevity of a frying pan — that’s what I thought about today.”

Ervin moved to the region in 1989 as the first Black faculty member of CSUSB’s theater department. She served twice as chair of the department. “I cherish our longevity, strength

and resiliency, and especially this year,” Ervin said about the Black community. “I am struck by how we keep on keeping on in spite of everything that's going on. There's a lot to be thankful for and there are people still doing the work.”

Growing up, most of Ervin’s knowledge of Black history came from church.

“It wasn't a thing [in school] when I was growing up until much later, so Black history was when you went to church and they told you who graduated and why we're proud of them, who joined the service and so every first was named in church.”

Andrea Shorter came to the region as a child, with her brother Aaron, from Indianapolis in 1979 when her father took a job in telecommunications to build cable infrastructure as the area developed.

Shorter said that there are few Black folks in the region that had the means to connect people and build a community movement like the Brown family, referring to Hardy and Cheryl

Brown, publishers emeritus of Black Voice News and their children, including Dr. Paulette Brown Hinds and Hardy Brown II, hosts of the day's event.

“The Black Voice has just grown in such a way that it's so multidimensional to me, how it's developed. It's really thought outside of the box in a number of ways in terms of how it's integrating and how it serves communities,” Shorter said.

profit group deeply rooted in the history and legacy of Palm Springs, composed of more than 1,000 survivors and descendants of Palm Springs Section 14.

Section 14, a one-square-mile area just east of downtown Palm Springs, was a vibrant community of predominantly African American and Latino residents. From the late 1950s through the 1960s, the City of

Palm Springs, seeking commercial development, demolished this thriving community, destroying homes, personal property, and belongings without warning.

This destruction led to significant economic, physical, and emotional trauma for the residents of Section 14 and their descendants, who have not been able to recover the generational wealth that was taken from them. The survivors and descendants, with the support and counsel of leading civil rights attorney Areva Martin, continue to seek justice and restitution. Their mission transcends monetary compensation, it is a quest for acknowledgement of the past, communal healing, and the establishment of restorative measures that ensure such injustices are never repeated.
