# Earnings Gap Shrinks for Poor Blacks While Class Differences Expand for Poor Whites

O.S. Census Bureau and Harvard University Research released a report in late July which indicates that while the low-income earnings gap between Blacks and whites has narrowed, the gap between low and high income young white adults, has widened.

What the heck does this mean? What's the bottom line? Well, it appears that young Blacks are making some economic progress—even though the gap between Blacks and whites is still too wide. While on the other hand, young whites from low-income families appear to be faring much worse than they did in previous generations. The study's findings are insightful.

To begin with, the analysis focused on the evolution of income mobility between only two generations that were about 15 years apart. The first group included children born in 1978 and the second group looked at those born in 1992. The study considered the income levels of the two groups at the age of 27. And, it included children born to both low-income parents (about \$26,000 annual income) and high-income parents (about \$95,000 annual income).

The findings revealed that Black children born

to low-income parents in 1978, went on to earn \$12,994 less per year than their white counterparts. However, for Black children born to low-income parents in 1992, the earnings gap shrunk by nearly a third to \$9,521.

On the other hand, white children who were born to high-income parents in the 1978 cohort went on to earn \$10,383 more than low-income whites born that year and for those born in 1992, the class gap among whites exploded to \$13,202, an increase of nearly a third.

The report credited the shrinking race gap between Black and white low income earners to a combination of "improved mobility" for lowincome Black children and "declines in earnings" for low-income white children.

The growing class gap was credited to both declining mobility for white children from low-income households and improvements in mobility of white children from high-income households.

There was hardly any noticeable change in the class gap for Black children during the study periods because Black children—whether they are born to high- or low-income parents saw

Health Emergencies and Temperature-related (HEAT) Illness and Deaths Act, the bipartisan National Earthquake Hazards Reduction Program (NEHRP) Reauthorization Act of 2024, and his bipartisan Accelerating Networking, Cyberinfrastructure, and Hardware for Oceanic Research (ANCHOR) Act. #### **Preventing HEAT Illness and Deaths Act**

As the climate crisis continues to escalate, extreme heat events in the United States are becoming more frequent, longer-lasting, and more severe. During the last week in JulyJust last week, the world experienced the hottest two days in recorded history. This summer, counties across California have shattered temperature records, with many residents experiencing dangerous, continuous temperatures over 110 degrees.

The Preventing Health Emergencies and Temperature-related (HEAT) Illness and Deaths Act, co-led by U.S. Senators Edward J. Markey (D-Mass.) and Kyrsten Sinema (I-Ariz.), would address the rising health risks of extreme heat. The Preventing HEAT Illness and Deaths Act would improve and expand interagency efforts to address extreme heat exposure, provide \$100 million in financial assistance for community projects to reduce exposure to extreme heat, and inform recommendations for federal action on heat-health issues.

Padilla called on the Occupational Safety and Health Administration (OSHA) to establish the first-ever federal safety standard to protect workers from the severe risks of excessive heat.

n May, the Education Data Initiative published some concerning facts regarding student debt statistics among racial and ethnic groups. Not surprisingly, it reflected dramatic differences in "financial health, habits, and resources" available from one community to another.

The report found Black and African American college graduates owe an average of \$25,000 more in student loan debt than white college graduates. It highlighted how four years after

graduation, Black students owe an average of 188% more than white student borrowers; In addition, Black and African American student borrowers are the most likely to struggle financially due to student loan debt making monthly payments of \$260. This data further highlights the need for tuition relief.

On July 31st, President Biden took another major step in his ongoing effort to cancel student debt for approximately 30 million Americans. These proposed rules build upon the Administration's existing work that has approved more than \$168 billion in student loan relief for nearly 4.8 million borrowers through various actions.

These additional rules, if finalized as proposed, would bring the total number of borrowers eligible for student debt relief to over 30 million this fall, including borrowers who have already been approved for debt cancellation by the Biden-Harris Administration over the past three years.

On August 1, the U.S. Department of Education (Department) began emailing all borrowers with at least one outstanding federally held student loan to provide updates on potential student debt relief, and to inform them they have until August 30 to call their servicer and opt out if they do not want this relief.

It is important to note, however, that the rules intended to provide this relief are not yet finalized, and the email does not guarantee specific borrowers will be eligible. The Department will provide additional information to borrowers once the rules are finalized this fall.


These rules, if finalized as proposed, would bring the total number of borrowers eligible for student debt relief to over 30 million, including borrowers who have already been approved for debt cancellation by the Biden-Harris Administration over the past three years.

"These latest steps will mark the next milestone in our efforts to help millions of borrowers who've been buried under a mountain of student loan interest, or who took on debt to pay for college programs that left them worse off financially, those who have been paying their loans for twenty or more years, and many others," said said U.S. Secretary of Education Miguel Cardona in a written statement.

In April, the Administration released its first set of draft rules that proposed authorizing the Secretary of Education to grant student debt

### CDC Updates IUD Placement Guidelines to Address Pain and Trauma

The Centers for Disease Control and Prevention (CDC) published new recommendations to physicians about pain expectations and how to manage the pain during and after the process of inserting an intrauterine device (IUD).

An IUD is a t-shaped contraceptive device used to prevent pregnancy for up to 10 years. According to a 2022 report published by the United Nations, 161 million people use this form of contraceptive worldwide.

With the first IUD approved in 1984, the CDC's new guidance comes decades after patients have complained about the traumatic procedure and sometimes painful symptoms that follow. While there are two types of IUDs: copper and hormonal, there are five different brands of IUDs that are approved for use in the United States by the U.S. Department of Food

& Drug Administration (FDA). There are four hormonal IUDs: Mirena, Kyleena, Liletta and Skyla; and one copper IUD: Paragard.

"Before IUD placement, all patients should be counseled on potential pain during placement as well as the risks, benefits, and alternatives of different options for pain management," the guidance states. "When considering patient pain, it is important to recognize that the experience of pain is individualized and might be influenced by previous experiences including trauma and mental health conditions, such as depression or anxiety."

As horror stories about IUDs have been traded online, the CDC's guidance comes years after patients have endured painful insertion, with others experiencing pain from the IUD dislodging. The updated guidance offers a suggestion of lidocaine as an option for IUD placement, noting that the use of the local

anesthetic "might be useful for reducing patient pain."

Prior to the new recommendation regarding the use of lidocaine, patients were recommended over-the-counter pain relief options such as ibuprofen, but for many, that did little to address the pain during the procedure. In a 2023 study that assessed the pain of IUDs by type among 1,076 women, 26 (2.5%) women reported no pain, 167 (16.4%) light pain, 319 (31.3%)

moderate and 506 (49.7%) intense pain.

An article published in the National Library of Medicine reviewed published literature to examine the gap regarding official procedures for pain management during IUD implantation. The findings from the review "revealed a lack of uniformity across practices when performing IUD insertions,"

"Black women experienced the most anticipated pain compared to other races," the report noted. "Regarding non-pharmacological methods, different insertion techniques, tools, and the use of a cold compress were found to not affect the level of pain during IUD insertion."

The pain experienced by women during IUD insertion is one example of the pain gap that women experience compared to men within healthcare. Black and brown women experience the pain gap with an additional factor of race/ethnicity when compared to

Bernardino chapter of the NAACP, where she addressed issues related to criminal justice reform and the high incarceration rates in Black communities. Her focus on reducing the prison population and emphasizing rehabilitation over incarceration resonated strongly with local Black leaders and community members.

As a U.S. Senator, Harris returned to the Inland Empire visiting Fontana's California Steel Industries campus. This visit underscored her commitment to workforce development, particularly in technical fields. Harris met with students and educators at the Industrial Technical Learning Center, "InTech", a facility focused on equipping workers with skills needed for high-tech jobs. She emphasized the importance of federal funding for such initiatives, criticizing proposed budget cuts that could hinder workforce training programs vital to the region's economy.

 $Harris' most \, recent \, visits \, to \, the \, Inland \, Empire$ as Vice President have centered around pressing national issues, including disaster recovery and infrastructure. In January 2022, she visited San Bernardino to announce significant federal funding for wildfire prevention and recovery efforts, a critical concern for many communities in California. During this visit, Harris highlighted the Biden administration's commitment to addressing climate change and its impacts, which have disproportionately affected regions like the Inland Empire.

Throughout her career, Harris has also made it a point to engage directly with the Black community in the Inland Empire, participating in town halls and community meetings focused

Her focus on workforce development, education, disaster recovery, and the specific needs of the Black community resonates with the local population and underscores her understanding of the region's challenges. As Harris continues her political career, her relationship with the Inland Empire will likely remain a significant aspect of her broader efforts to address national issues from a local perspective.

At the time, we were still dealing with the aftermath of the Tyisha Miller shooting by Riverside Police officers, so this conversation was particularly poignant.

The next time she came to visit, I was president of the San Bernardino branch of the NAACP. I invited her to St. Paul AME for a candidate's forum. Being the NAACP, we had to be fair and invite her opponent, but he ignored our request. So, we set a chair for him on the other side of the podium. Kamala laughed with her special laugh and won over the folks in our community.

Her enthusiasm is genuine. If you check out the photographs in this article, you'll see how much joy she exudes. That joy never diminished.

When I ran for the State Assembly, she came back again for one of my fundraisers. When I told her that the San Bernardino County District Attorneys were meeting in the same hotel, she was excited to meet as many of them as she could, so we crashed their party. I was well-known, and as I introduced her to local attorneys, she captivated them with her signature joy. Some had heard of her through San Bernardino District Attorney Michael Ramos, while others were simply wide-eyed at meeting her. She never meets a stranger.

The next time she came to San Bernardino was to campaign for Senator. We visited several churches together. At New Hope Missionary Baptist Church, she was fascinated to meet young men running for the Socialites Beautillion (a cotillion for young men). Her joy was again on full display as they welcomed her. Kamala has a special love for young Black men—they hold a special place in her heart.

hear people saying they don't know who President Kamala Harris is: well, I want to tell you about my relationship with her and how she has impacted San Bernardino and Riverside Counties.

My first meeting with Hardy Brown, Sr. Kamala Harris took place Publisher Emeritus at the Black Voice News office in San Bernardino in 2010 when she was running

for California Attorney General. With that introduction, I shared with her my years of experience working on political campaigns in San Bernardino and Riverside Counties. I explained that in the Inland Empire and in California, you have to build coalitions with different races, labor unions, business leaders, political parties, various professions, faith leaders, and civil rights organization leaders because the Inland Empire is a moderate, conservative, middleincome community. You have to be genuine, and most of all, honest, realistic, and fair with people. You have to let them know that you will work just as hard for them, regardless of race, gender, or economic or educational status. That is how Blacks and Latinos have been elected to offices like school boards, city councils, water boards, and the state assembly in the Inland Empire since the midsixties.

Kamala shared with me where and how she was raised, her education, work experience, and her vision of being a fair Attorney General for all citizens, with special attention to those who have no voice. After she was elected, she kept her word and returned to the Inland Empire several times. Kamala Harris is the real deal and a very good listener. She is an enforcer of the law while showing mercy and understanding to those impacted by it.









For those who need evidence of her connection to the Inland Empire, you can review the many pictures of her interactions with our community.


I wholeheartedly endorse Vice President Kamala Harris for President of the United States and Governor Tim Walz for Vice President.

Among Black children born to low-income parents in 1992, the earnings gap shrunk by nearly a third to \$9,521. Meanwhile, among low-income whites born in 1992, the class gap among whites increased by nearly a third to \$13,202. (graphic source: census.gov)

comparable improvements in their earnings.

Earnings were not the only area where the gaps closed between Blacks and whites. According to the report similar patterns of shrinking race gaps and growing class gaps were also noted in other areas. Included among them were shrinking gaps in educational attainment, standardized test scores, marriage rates, and mortality.

For those of us in the Black community who continue to look for evidence of tangible progress toward equity in this country, this report noted that "the likelihood of growing up in a low-income household and remaining low-income as an adult actually narrowed by nearly 75% between Black and white children born in 1978 and 1992."

The narrowing gap is attributed to the combination of a 6% decrease in poverty persistence among Black children and a 5% increase in poverty persistence among white children.

This study also looks at trends by county. While

Black-White race gaps shrunk and white class gaps expanded in nearly every part of the country, the magnitude of these changes varied substantially across regions.

The change in household income among Blacks in San Bernardino County between 1978 and 1992 cohorts was an increase of 4.3%. For Riverside County the increase was far less at .9%.

Finally, the research found there were few earnings changes among other racial and ethnic groups during the periods included in the report.

Although this data is indicative of some progress, the quest for economic equity persists. As a result, the struggle for economic justice continues.

Of course, this is just my opinion. I'm keeping it real.

Earthquake Hazards Reduction Program (NEHRP) through Fiscal Year 2028. The bill would authorize a total of \$175.4 million per year from FY 2024-2028 across the four federal agencies responsible for long-term earthquake risk reduction.

#### **ANCHOR Act**

The Accelerating Networking, Cyberinfrastructure, and Hardware for Oceanic Research (ANCHOR) Act, co-led by U.S. Senator Dan Sullivan (R-Alaska), would facilitate cybersecurity and telecommunications upgrades for oceanographic vessels in the U.S. Academic Research Fleet. The ANCHOR Act would require the National Science Foundation (NSF) to plan improvements for these critical oceanographic research vessels. The fleet includes three vessels in California, which recently discovered extensive World War II-era munitions on the seafloor at the San Pedro DDT dumpsite.


These ships and their submersibles play a central role in important priorities such as exploring our ocean, studying climate change, and improving national security. First commissioned decades ago, these ships are in need of new infrastructure and maintenance, especially with foreign naval cyberattacks on the rise.

"As Americans continue to face extreme, record-breaking heat waves, authorizing dedicated funding to prevent heat-related illnesses and deaths remains critical as well. I'm also glad my colleagues recognized the urgent need to upgrade crucial cybersecurity and telecommunications infrastructure as our research vessels face increasing cyberattacks," Padilla stated.

relief to tens of millions of borrowers across the country, including those whose balances have grown due to runaway interest and those who entered repayment on their loans a long time ago, among others.

If these rules are finalized as the Department has proposed, they would authorize the Secretary of Education to provide partial or full debt relief for the following groups of borrowers: Borrowers who owe more now than they did at the start of repayment; Borrowers who have been in repayment for decades; Borrowers who are otherwise eligible for loan forgiveness but have not yet applied; And, borrowers who enrolled in low-financial value programs.

Borrowers will only be eligible for the proposed relief if they have entered repayment at the time that the Department would be determining eligibility, after the proposed rules are finalized.
