

KEEPING IT REAL

Restricting Cell Phone Usage in Schools



California Gov. Gavin Newsom sent letters to school district officials recently, urging them to restrict students' use of smartphones on campus beginning immediately. (Chris Allen, VOICE)

Today, cell phones have almost become an additional appendage. We carry them around as if they are as sacred as an arm or a leg. We'd be lost without them and our children are the same.

If at some level, this did not sit quite right with you, maybe the ancestors are trying to tell you something and now, so is our governor.

California Gov. Gavin Newsom sent letters to school district officials recently, urging them to restrict students' use of smartphones on campus beginning immediately.

California is not unique in this regard. It is among the cadre of states around the nation—both red and blue—scrambling to take action as everyone struggles to digest data showing the concerning reality that "excessive smartphone use among youth is linked to increased anxiety, depression, and other mental health issues." Newsom stressed in his letter.

He also reference a PEW Survey that found "72% of high school and 33% of middle school

teachers report cell phone distractions as a major problem". Newsom also pointed to a report by Common Sense Media that found "97% of students use their phones during the school day for a median of 43 minutes."

The governor went on to stress how when you combine all of this information, with the U.S. Surgeon General's warning about the risks of social media, "it is urgent to provide reasonable guardrails for smartphone use in schools," he argued.

Although many still disagree with this policy the proof is in the "pudding" so to speak. According to the governor, schools that have already implemented policies have shown improvement in test scores and reduced bullying.

In the meantime, what has taken California and America so long to address this issue, especially when we've known since before COVID that our children were suffering.

Enhanced Care Management takes a wholeperson, interdisciplinary approach to care to addressclinicalandnon-clinicalneedsofmembers with the most complex medical and social need and serves as a safety net of care coordination for high-risk groups, including, but not limited to, individuals experiencing homelessness.

"Our unhoused population has inadequate access to shelters and experiences a lack of food and care," said Glenn Tsang, Policy Advisor for Homelessness and Housing for the California Department of Health Care Services. "These members tend to have extensive medical and mental health needs that are difficult to address in an unstable living environment. To help address their needs, the Enhanced Care Management benefit builds consistent connections to medical care, mental health care, substance use disorder treatment, and housing stabilization services."

Addressing Health-Related Social through Needs Community **Supports** Community Supports are services or care settings, in addition to those required under the California Medicaid State Plan, that Medi-Cal managed care plans may elect to offer. The goal of Community Supports is to provide services that address a member's health-related social needs that may be exacerbating their health condition, such as housing instability. Among the 14 services available as Community Supports services, six are specifically focused on helping unhoused members.

Many of these services empower highrisk individuals and families to live healthier lives in less restrictive settings and avoid unnecessary emergency visits and inpatient nursing facility admissions. They include services that go beyond traditional care received in a doctor's office and may include housing deposits, housing transition and navigation services, housing tenancy and sustaining services, short-term post-hospitalization, recuperative care, and day habilitation.

Street Medicine

Street medicine is a set of health and social services developed specifically to address the unique needs and circumstances of individuals experiencing unsheltered homelessness, delivered directly to them in their own environment. The fundamental approach of street medicine is to engage people experiencing unsheltered homelessness

n Thursday, August 21, Assemblymember Buffy Wicks (D-Oakland) announced the establishment of a first-in-the-nation partnership between the State, news publishers, major tech companies and philanthropy.

In a press release Wicks unveiled two, multiyear initiatives that outline the parameters of these initiatives. The first will provide ongoing financial support to newsrooms across state amd the second will launch a National AI Accelerator.

Regina Wilson, Executive Director, California Black Media shared her thoughts about the importance of these initiatives. "California is leading the way with this first-in-the-nation investment to protect the press and sustain quality journalism. This fund will help news outlets and journalists adapt to a changing landscape with new tools and funding to embrace emerging technologies."

Wilson stressed, "This is especially helpful for ethnic and community media which is comprised largely of under-resourced family businesses whose strongest connections are to their community."

Together, the partnerships will provide nearly \$250 million in public and private funding over the next five years. The majority of the funding is slated for local newsrooms. \$100 million will be front loaded in the first year to kick-start the partnerships. There is also the possibility of the total investment increasing in the coming years if additional funding from private or state sources becomes available.

In support of the initiatives CA Governor Gavin Newsom declared, "This agreement represents a major breakthrough in ensuring the survival of newsrooms and bolstering local journalism across California — leveraging substantial tech industry resources without imposing new taxes on Californians."

"The deal not only provides funding to support hundreds of new journalists but helps rebuild a robust and dynamic California press corps for years to come, reinforcing the vital role of journalism in our democracy," Newsom added.

886 to help ensure the sustainability of local journalism, as news outlets across the country continue downsizing and closing at alarming rates. A Northwestern University study published last year found an average of two and a half newspapers in the United States close every week. California has lost more than 100 newspapers in the last decade alone. Meanwhile, since 2005, our nation has lost two-thirds of its newspaper journalists.

Multi-faceted support

The new initiatives include what's being described as "multi-faceted support" for publishers across California to address challenges that have impacted the depth and breadth of news coverage in the state. The

initiatives will help ensure the sustainability of existing and new online publications. The initiatives place an emphasis on small, local outlets and community-facing journalism.

"As technology and innovation advance, it is critical that California continues to champion the vital role of journalism in our democracy," said Assemblymember Buffy Wicks. "This partnership represents a cross-sector commitment to supporting a free and vibrant press, empowering local news outlets up and down the state to continue in their essential work. This is just the beginning. I remain committed to finding even more ways to support journalism in our state for years to come."

"I Promise to be a President for All Americans." DNC Ends with Rallying Speech from Kamala Harris

The final night of the Democratic National Convention featured Kamala Harris formally accepting her party's nomination for the presidency. Arriving on stage at Chicago's United Center to roars of applause, Harris began her remarks with storytelling — which has been a key aspect of her campaign thus far — reminiscing about her childhood and sharing how her parents, both immigrants, met and raised her and her sister.

"My mother was 19 when she crossed the world alone, traveling from India to California with an unshakable dream to be the scientist who would cure breast cancer," she shared. "When she finished school, she was supposed to return home to a traditional arranged marriage. But as fate would have it, she met my father, Donald Harris, a student from Jamaica."

While Harris' father has played a noticeably less visible role in the canon of Harris' life, she emphasized that, "From my earliest years, he taught me to be fearless."

"A president for all Americans"

As expected, Harris also lambasted her opponent and took pains to distinguish what she promises as president from what former president Donald Trump would bring. In particular, she committed to a peaceful transfer of power — making clear reference to the Jan. 6 insurrection, which has been a continuing theme at the convention.

"I will be a president who unites us around our highest aspirations. A president who leads and listens, who is realistic, practical and has common sense," she said. "I promise to be a president for all Americans. You can always trust me to put country above party and self."

On Israel and Gaza

Then came policy. Harris promised to pass a middle class tax cut, the John Lewis Voting Rights Act, a bipartisan border protection bill,

and a bill to protect reproductive freedom — among other things, including ushering in, "An opportunity economy, where everyone has the chance to succeed." Of course, the Democrats will have to take the house and senate for much of these aspirations to be possible.

On foreign policy, Harris said she will "stand strong with Ukraine and our NATO allies." But all ears were perked to hear her remarks regarding the war on Gaza, which has cast a shadow over the convention proceedings.

"President Biden and I are working around the clock because now is the time to get a hostage deal and a cease-fire deal done," she said. "And let me be clear. I will always stand up for Israel's right to defend itself, and I will always ensure Israel has the ability to defend itself."


Protestors who marched on the DNC have called for the U.S. to end aid to Israel, including through an arms embargo.

Mentioning the Hamas Oct. 7 attacks at a music festival, Harris was full-throated in her defense of Israel, but also made space to give voice to the Palestinian struggle.

"At the same time, what has happened in Gaza over the past 10 months is devastating. So many innocent lives lost. Desperate, hungry people fleeing for safety, over and over again. The scale of suffering is heartbreaking.

"President Biden and I are working to end this war, such that Israel is secure, the hostages are released, the suffering in Gaza ends and the Palestinian people can realize their right to dignity, security, freedom and selfdetermination."

This part of her speech earned Harris some of the loudest applause of the night, showing that the fate of Palestinians is becoming a central concern of the left — even among rank and file

California news publishers will be the beneficiaries of a News Transformation Fund, to be administered by the UC Berkeley School of Journalism, providing financial resources that preserve and expand California-based journalism. The funding will include contributions from technology platforms and the State of California, supporting innovative new investments that promote local journalism. The funding will support California-based state and local news organizations, particularly those serving California local news deserts, underserved and underrepresented communities, as well as outlets that prioritize California coverage.

"The University of California is proud to partner with Governor Newsom and legislative leaders to bolster the critical work of local news organizations and journalists in California," said UC President Michael V. Drake, M.D. "Californians depend on robust local and diverse news organizations to stay informed about their communities, and the University and specifically the UC Berkeley School of Journalism stand ready to support this endeavor."

Funding for the initiative will be complemented by direct support from the State. This support will help news organizations keep and grow newsroom staff and offsetting the costs of producing local news and information.

"A vibrant press is crucial for strong communities and a healthy democracy. This is a first step toward what we hope will become a comprehensive program to sustain local news in the long term, and we will push to see it grow in future years," said California News Publishers Association CEO Chuck Champion and Board Chair Julie Makinen. "We will work with the state and tech companies to make the most of this initiative. We're grateful to Assemblymember Wicks for her passionate advocacy on behalf of our 700-plus member newsrooms."

The quest for official marketing and advertising support

Partners in this initiative also reiterated their strong commitment to strengthening newsroom and ownership diversity for ethnic and underserved communities. The Governor also announced his support for AB 1511 (Santiago), which aims to increase the state's ongoing commitment to place official marketing, advertising and/or outreach advertising with local and underrepresented media outlets.

"Ethnic and community media outlets in California have a long history of serving as trusted messengers of culturally responsive news to historically underrepresented and underserved communities," said Assemblymember Miguel Santiago. "These initiatives ensure that California is embracing private sector innovation while developing partnerships with and seeding investments from the public sector to empower local publishers and journalists that are vital to a healthy, thriving democracy."

Maximizing Artificial Intelligence

The new initiatives will also give researchers and businesses access to new resources enabling them to explore the use of AI to tackle some of the most complex challenges facing society, and strengthen the workforce through a new National AI Innovation Accelerator.

This effort be administered in collaboration with a private nonprofit, and will provide organizations across industries and communities — from journalism, to the environment, to racial equity and beyond — with financial resources and other support to experiment with AI to assist them in their work.

The AI accelerator will empower organizations with the new technology, and complement the work of the Journalism Fund by creating new tools to help journalists access and analyze public information.

ach week, community members from across the Inland Empire gather, to protest the genocide occuring in Palestine since shortly after the Hamas attack on Israel in October 2023, that killed about 1,339 Israelis, mostly civilians. To date, more than 40,000 Palestinians have been killed in retaliation. Earlier this month, the U.S. approved a \$20 billion weapons package sale to Israel, which included fighter jets and advanced air-to-air missiles. Meanwhile negotiations for a ceasefire coupled with discussions for the release of prisoners taken by Hamas in the October attack, including some Americans, continues.

With the Democratic National Convention complete, there are less than two months until the Presidential Election and local protesters continue to voice their concerns regarding national and local leaders. During a weekly demonstration, protesters in the Inland Empire voiced their disappointment with the Democratic party and their support of Israel, from President Joe Biden to Congresswoman Norma J. Torres who represents the 36th Congressional District representing Bloomington, Chino, Fontana, Montclair, Ontario, Pomona and Rialto.

"It's just been very disheartening to know that there are many of us — there's a lot of constituents in Norman Torres' district who are anti-genocide, who want an arms embargo, who want the bare minimum, which is a ceasefire, and she continues to support the exact opposite of that," said Arianna Harrison, an organizer and founder of Ontario United for Liberation.

Last year, Harrison, a resident of Ontario, saw a post from fellow community member Luis Salazar about meeting up to protest the violence and attacks in Palestine. She brought her brother and the three of them walked down the street in protest where another man joined them.

"There were just four of us protesting on Euclid Avenue in downtown continued on page 13



California Democrats Send Impressive Delegation to History Making, 2024 Democratic National Convention

alifornia Democrats sent 496 delegates and 35 alternates to the Democratic National Convention in Chicago this year. Among the delegates and alternates were relatives, friends, co-workers, neighbors and associates from around the state committed to doing their part to help heal the political divide in America and set the nation on a positive course to the future.

The list of political big hitters who participated as delegates this year is long and impressive. California's delegation, led by Governor Gavin Newsom, included CA Secretary of State Shirley Weber, Senators Laphonza Butler and Alex Padilla, Rep. Pete Aguilar, Los Angeles Rep. Maxine Waters, Attorney General Rob Bonta, Los Angeles Mayor Karen Bass, San Francisco's London

Breed, civil rights and labor leader, Dolores Huerta and labor leader, Lorena Gonzalez Fletcher. California Democratic Party Chairman Rusty Hicks and House Speaker Emerita Nancy Pelosi were also in attendance, among others. Little could this year's slate of delegates have known when they were officially selected in April and May, that they would be part of history in the making.

Newsom and Harris are not just political allies. Also described as long-time friends, Newsom appeared to take pride at Convention in Chicago, Tuesday evening when he committed California's delegate votes—the largest number of any state—to Vice President Kamala Harris, putting her over the top as the Democratic presidential nominee during a ceremonial

roll.

"Kamala Harris has always done the right thing, a champion for voting rights, civil rights, LGBTQ rights, the rights for women and girls. So, Democrats and independents, it's time for us to do the right thing, and that is to elect Kamala Harris as the next president of the United States of America" declared Newsom as he stood to cast California's delegates to Kamala Harris, placing her over the top in the number of delegates needed.


Delegate Lynn Summers, who represented the state's 33rd Congressional District, talked of her emotions and experience that evening, "I cried being able to witness history," she shared via text. "Being able to be a part of the process to vote for Ms. Harris to be the Democratic's presidential nominee. With all the things that I grew up listening to. My mother and my grandmothers and all the women in my circle have pushed and fought for this moment," Summers added. "This shows that change doesn't happen fast but with hard work and women's networking and determination, we made it," Summers proclaimed!

Pledged delegates are allocated to the presidential candidates according to the results of the March 5, 2024 Primary. In this instance, due to Biden' withdrawal from the race and endorsement of Vice President Kamala Harris, the delegates allocated to Biden were absorbed by Harris. At-Large and Party Leader and Elected Officials (PLEO) delegates are chosen by the Presidential Campaigns being mindful of affirmative action goals.

Each of the state's 52 congressional districts are allocated district-level delegates and alternates. The numbers are determined by the presidential and gubernatorial voting from the 2020 elections. To be selected as a delegate candidates must apply. Delegates are subsequently selected, based on party caucus rankings. At-Large delegates are selected from a statewide pool. This provides another way for Democrats to participate in the national convention.

California Democratic Party Leaders and Elected Officials (PLEOs) also participate as delegates to the convention. Included among them are big-city mayors and statewide elected office holders, state legislative leaders and state legislators, in addition to other state, county and local elected officials.

Youth Mental Health Improves, but Concerns Persist, CDC Report Finds



The recently released Youth Risk Behavior Survey Data Summary & Trends Report published by the Centers for Disease Control and Prevention (CDC) highlighted decreases among the percentage of Black and Hispanic students who had suicidal thoughts or who attempted or considered attempting suicide between 2021 and 2023. As concerns about youth mental health continue to grow, a new Centers for Disease Control and Prevention (CDC) report found that there have been some improvements in youth mental health over the last few years.

According to the Youth Risk Behavior Survey Data Summary & Trends Report, from 2021 to 2023, there was a decrease in the percentage of students overall who experienced persistent feelings of sadness. The report also examined students' experiences in 2023 and trends from 2013-2023.

The reported highlighted decreases among the percentage of Black and Hispanic students who had suicidal thoughts or who attempted or considered attempting suicide between 2021 and 2023. Specifically, there were decreases in the percentage of Black students who attempted suicide, from 14% to 10%, and who were injured in a suicide attempt from 4% to 2%.

"Although we could be doing better with increased mental health resources for our youth, that there has been more mental health conversations that are happening, some of our youth are starting to become more comfortable with discussing mental health and being open about it, and potentially there could be some improvements because of that," explained Heylee Barriola Chagzoetsang, assistant program director of the Teen Line, a program of Didi Hirsch Mental Health Services.

As local and state agencies work to address the youth mental health crisis, several resources such as the Teen Line have been developed to support youth with their mental health. The Teen Line is a free hotline that connects youth with trained teen "listeners" with peer support and mental health resources. According to Didi Hirsch Mental Health Services, in 2023, teen listeners responded to more than 6,400 calls, texts and emails from youth across the U.S. and the world.

Although the report noted improvements in

youth mental health, there were other issues that impacted students according to survey findings. Findings from the 2023 survey found that nearly a third of students reported that they had ever experienced racism in school, with Asian students more likely to report ever experiencing racism than other groups.

Additionally, almost one in five students reported being unfairly disciplined at school, with Black students more likely than white and Hispanic students to report being unfairly disciplined.

"These data show that we've made some progress in tackling these issues in recent years, which proves that they are not insurmountable.

However, there's still much work ahead," said CDC Division of Adolescent and School Health Director Dr. Kathleen Ethier in a press release. "Considering the vital role schools play in promoting health and well-being, it is critical to address school-based violence and safety concerns."

In 2023, more than three in five LGBTQ+ students experienced persistent feelings of sadness or hopelessness. One in five LGBTQ+ students attempted suicide during the past year.

Chagzoetsang attributed these rates to stigma, discrimination, potential family rejection and limited access to mental health care among LGBTQ+ students. She addressed the needs for schools and communities to create a safe space for youth to "mitigate some of the negative effects" on the mental health of youth.

Across the state, Gov. Gavin Newsom has launched a Master Plan for Kid's Mental Health. Earlier this year, the state launched two free mental health apps called BrightLife Kids and Soluna which grant youth access to one-on-one video sessions, coaching, secure chat and other tools.

Additionally, there are several Inland Empire-based support groups, programs and tools for youth who are struggling with their mental health:

Teen Line

National Alliance on Mental Illness

(NAMI) Inland Valley is a nonprofit organization of families and individuals whose lives have been affected by mental illness, and connects people with resources.

Ontario," she explained. "Then, after that, it kind of turned into, 'Hey, can we keep this going? What's a better day of the week? Is there anyone else in our city that cares about this?"

Harrison described how their meetups shifted into weekly protests joined by a growing number of community members and local community organizations from nearby cities such as Chino and Pomona, with a turnout of at least thirty people.

"The issue of Palestine is not a single issue,"

Harrison, an Iranian American, explained. "It's such an intersectional issue that there are many points of entry to get involved in this work, in the work of dismantling complicity from whatever place you're in."

Every Sunday community organizations Ontario United for Liberation and Chino Valley for Palestinian Liberation host a protest. Both groups formed last fall in response to the atrocities in Gaza and have been gathering since to organize and take action against systemic oppression.

In 2019, the CDC reported that among high school youth between the ages of 14 and 18 years, there were 2,039 suicides nationwide. Suicide was the reason for about 33.9% or nearly one of every three injury-related deaths among this age group. Between 2009 and 2018, the suicide rates in this same age group increased by a shocking 61.7% from 6.0 to 9.7 per 100,000.

In addition, between 2008 to 2020, the National Center for Biotechnology Information reported the rate of death by suicide increased for youth between the ages of 12-17 by a shocking 70.3% from 3.7 to 6.3 per 100,000 population.—another red flag that something was wrong. And then, of course, came COVID-19.

The questions I keep asking myself are: If the data shows it's bad for the children and if we continue to watch the suicide rates among youth increase, why is it taking us so long here in America to take the legislative action necessary to make this a requirement to protect the children?

Other countries are way ahead of us on this issue. A number of them have already taken action, banning cellphones in school classrooms, with France leading the way as far back as 2018. Other countries with bans include England, Finland, Israel, Australia, Ontario, Greece, Ghana, Rwanda, and Uganda, Russia, Sweden, China, Italy, Netherlands, and the United Kingdom.

Here in the U.S. states are now taking action to restrict cell phone use as well. Red state Florida was first to implement such a ban last year. While here in California, many school districts up and down the state were moving forward on their own, implementing cell phone policies for their school districts while well intentioned state laws intended to establish mandatory requirements are still working their way through the legislature. Meanwhile, it appears San Bernardino Unified School District has had classroom phone policies for years according to a recent report.

The movement here is California is all possible thanks to AB 272 signed into law by Newsom in 2019. The bill authorized school districts to regulate the use of smartphones during school hours. The bill gave authorization—but not a mandate.

Of course, it would not be America if there were not many on the other side with a different perspective. They argue against banning cell phones in classrooms, for some important reasons. Some merely because they want to be able to reach their children at all times. Still others cite the nation's shameful history of mass school shootings. They want their child(ren) to have access to a cell phone at all times in case of an emergency.

I certainly understand concerns on both sides of this issue. However, a 2023 report by Education Weekly, noted that about 97% of students of all students use their phone at school. The median usage is 43 minutes—about the length of an average class period. And Education Weekly reported last year that one in five students, fully 20%, receive more than 500 notifications a day.

Nearly all students—97 percent—use their phones at some point during the school day, for a median of 43 minutes, the study found, or about the length of a full class period in many schools.

For us as a state, as a nation to be running behind most developed nations on this is unconscionable especially since we've known for years we were heading for a crisis. We need to master technology and not let technology master us and what is best for our children.

Of course, this is just my opinion. I'm keeping it real.

exactly where they are and on their own terms to maximally reduce or eliminate barriers to care access and follow-through.

Medi-Cal Expansion

Starting on January 1, 2024, all eligible Californians qualify for full scope Medi-Cal coverage, regardless of immigration status.

This expansion allows even more Medi-Cal members to potentially qualify for Enhanced Care Management and Community Supports, among other services, to improve outcomes for California's most vulnerable populations.

"By expanding Medi-Cal, we're addressing the root causes of health disparities and providing equitable access to quality health care, leading to a healthy California for all," said Tsang.

How Providers Support Members

Providers are vital in delivering Medi-Cal's expanded services, ensuring the most vulnerable members receive the care they need. These providers include, but are not limited to, housing service providers, housing organizations, and other organizations that have an existing footprint consistent with Community Supports activities and in the communities they serve. Providers are essential in providing dedicated care management, ensuring seamless transitions and continuous support across various housing settings.

Street medicine providers also offer direct medical care to individuals on the streets, build trust by consistently providing compassionate services, and use comprehensive care management platforms for efficient coordination. Providers include Federally Qualified Health Centers, mobile medicine units, and many other organizations that provide care to unsheltered members living on the street.

They collaborate with community-based organizations and community support systems like schools, food banks, and housing agencies, and offer proactive support when patients transition through emergency departments, homelessness, or incarceration.

Encouragement to Seek Services

If you or someone you know is experiencing homelessness or is at risk of homelessness, Medi-Cal's expanded services offer vital support for members enrolled in a managed care plan to improve their health and well-being.
