## Trump's Labor Impact Sparks Call for Black Voters to Support Harris

This Labor Day weekend I reflected on the number of Blacks who voted for Donald J. Trump when he ran for president in 2016—14% of Black men and 6% of Blacks overall. In light of everything that transpired during his tenure as president, I am baffled by the idea of any person of color who plans to cast a vote for Donald Trump in November, especially when you consider the harm he has done to the nation as it relates to labor and other key issues.

Looking beyond his rabid and unapologetic racism and misogyny, disrespect for the country's veterans and homophobic attitude toward members of the LGBTQ+ community, his catastrophic track record regarding labor also rates high on the list of disappointments related to his leadership or lack there of.

It was obvious during his presidency that

Trump had a very cozy relationship/partnership with big corporate players intended to destroy unions at worst and/or to render them impotent at best. The proof is all around us. Despite his promise to "stand with the workers" during his first campaign, in a press statement issued by the AFL-CIO last September, the union's Deputy Director of Public Affairs, Steve Smith, wrote, "Former President [Donald J.] Trump spent four years in office weakening unions and working people while pushing tax giveaways to the wealthiest among us."

Smith went on to make the AFL-CIO's case against the former president. He stressed how Trump had stacked the courts with judges who are willing to roll back workers' rights on the job; how Trump made union members less safe at

## Empowering Young Minds: Medi-Cal's Enhanced Mental Health Services for Inland Empire Youth



edi-Cal, California's Medicaid program, covers one in three Californians, including more than 50 percent of the state's youth. In California, nearly 300,000 youth are coping with depression, and 66 percent of them do not get the help they need, according to Governor Newsom's Master Plan for Kids' Mental Health.

Black children and children of color make up nearly 75 percent of children on Medi-Cal, yet they face significant barriers to accessing mental health services. Despite an overall decline in the suicide rate in California, youth — particularly Black, Latino, and female Californians — have seen disproportionate increases in suicide rates. According to data from 2022, about 4.3 percent of low-income teens on Medi-Cal have undergone depression screenings and received follow-up treatment. Among Indigenous youth, the screening rate is a little more than half that

(2.3 percent). However, more screenings are probably occurring that are not being reported due to data capture issues.

To improve access to Medi-Cal mental health services, DHCS implemented a "No Wrong Door" approach to seeking care. In other words, any Medi-Cal member can receive timely access to covered mental health services regardless of where they first seek care, whether at a county mental health office or their Medi-Cal health plan.

#### **Medi-Cal Covered Mental Health Services**

Medi-Cal covers a wide range of services to support the emotional, psychological, and social needs of members. Medi-Cal can cover such services as:

• Individual, group, and family therapy Crisis counseling

- Case management
- Medication for mental health conditions
- Depression and anxiety screenings
- Drug and alcohol treatment services
- Other treatments for significant or complex mental health as necessary

Paula Wilhelm, Deputy Director for Behavioral Health at the California Department of Health Care Services (DHCS), emphasized the state's commitment to transforming behavioral health services, which covers both mental health and substance use disorder treatment, under Medi-Cal.

"Mental health is just as important as physical health, and all of our health outcomes are intertwined," Wilhelm said. "DHCS is partnering with health plans and care providers to transform the way behavioral health services are delivered to Medi-Cal members."

Governor Gavin Newsom's Children and Youth Behavioral Health Initiative (CYBHI) is a monumental investment in strengthening mental health services for young Californians. This initiative focuses on prevention, wellness, screening, assessment, outpatient, and community-based treatment.

#### **Mental Health Virtual Services Apps**

In January 2024, DHCS, in collaboration with Kooth and Brightline, launched two mental health virtual services platforms, which you can download as android and apple apps, BrightLife Kids for children aged 0-12 and Soluna for teenagers and young adults aged 13-25.

These platforms connect individuals to free coaching and provide educational content, assessment tools, care navigation services, peer communities, and crisis and safety protocols to all California youth and their families, regardless of insurance coverage.

These services aim to complement existing mental health services by offering additional care options and resources for parents,

## Black Breastfeeding Week Aims to Reclaim Narrative and Center Stories for Breastfeeding Justice

Infants who are breastfed have reduced risk of asthma, obesity and Type 1 diabetes, according to The Centers for Disease Control and Prevention, but Black infants have a lower rate of breastfeeding compared to their white counterparts.

August 25 through August 31 marks Black Breastfeeding Week, an annual awareness

It's highlighting the significance of Black breastfeeding because for so long and so often, our community has been told that we shouldn't breastfeed or have been offered formula instead of actually being offered breastfeeding opportunities

week that addresses the disparities among Black women and the stigma associated with breastfeeding. Created in 2012 by three Black reproductive and maternal health experts, Kimberly Seals Allers, Kiddada Green and Anayah Sangodele-Ayoka, this year's theme for Black Breastfeeding Week is "Reclaiming Our Narrative & Centering Our Stories for Breastfeeding Justice."

As studies examine the breastfeeding rates

and factors that contribute to the lower rate of breastfeeding among Black families, advocates continue to provide resources, educate and create safe spaces for communities to provide narratives and context to these rates.

"It's highlighting the significance of Black breastfeeding because for so long and so often, our community has been told that we shouldn't breastfeed or have been offered formula instead of actually being offered breastfeeding opportunities," said Aiyana Davison, a certified nurse midwife and founder of The Village House.

According to a 2019 Centers for Disease Control and Prevention (CDC) study that examined infants born in 2015, "among all infants, Black infants had a significantly lower rate of any breastfeeding at age 3 months (58%)

than did white infants (72.7%)." The rate was also lower among infants at six months.

The study recognized that Black mothers experience a greater number of barriers to breastfeeding, including a lack of knowledge about breastfeeding, inadequate support from health care institutions, and social norms.

Black Breastfeeding Week is an opportunity for Black mothers and community health advocates to "reclaim what belongs to us as well, especially with the longstanding history of enslavement and things like wet nursing, where we were breastfeeding other people's babies before we were breastfeeding our own," Davison explained.

Historically, enslaved new mothers were forced to serve as wet nurses for slave owners'

icture this: more Californians are reaching retirement age, and the state is preparing for a rapidly aging population in the coming decades. To support this shift, California is expanding resources for caregivers and improving nursing facilities. However, the Inland Empire, which will experience much of this growth, is already grappling with a shortage of resources for its aging population. Black Americans, especially Black men, are among the most vulnerable, adding another layer of complexity to the challenges ahead.

As California faces a rapidly aging population, with projections showing that by 2030 one in five residents will be over 65, the state is

taking steps to prepare for the growing demand for age-related services. This demographic shift is pushing the state to enhance support systems. The Inland Empire is expected to bear the brunt of this surge, yet it is already struggling with a shortage of resources to care for its elderly. Black elderly individuals in particular face considerable difficulties as they age. Compared to White older adults, African American seniors encounter significant health disparities, such as reduced life expectancies and a greater risk of chronic illnesses like hypertension, diabetes, dementia, stroke, and cancer, according to an analysis from the American

## The Inland Empire's Aging Population Will Need a Greater Share of Resources

According to the California Department of Finance, by 2040, the number of residents aged 80 and older is expected to double, reaching nearly 320,000 and the population of 65 and older adults will reach almost one million people in the Inland Empire by 2040.

The population aged 65 and older is expected to grow more in the Inland Empire than in the state overall by 2040—58% compared to 45% statewide.

"This demographic shift is putting a lot of pressure on healthcare and in-home care services, which are already stretched thin," said Shannon McConville, research fellow at Public Policy Institute of Southern California.


The projected impact of this demographic shift in the Inland Empire is multifaceted.

Economically, there will be a significant increase in healthcare costs, with estimates indicating that spending on long-term care services could rise by 30% in the next 10 years. Socially, the growing elderly population will lead to a higher prevalence of chronic conditions, increased isolation, and greater demand for mental health services. The strain on families and caregivers is also expected to intensify, as many will struggle to balance work responsibilities with caregiving duties.

Long-term care insurance and out-of-pocket expenses are typically designed for institutional care, leaving home care unaffordable for many. This can push people to leave their jobs to care for loved ones, making it hard to cover rent and basic needs without income.

In-home care is becoming a major solution for California's growing elderly population, according to Brandi Wolf, policy and research director for SEIU Local 2015.

"Supporting consumers to remain at home allows them to receive professional care while staying connected to their community," Wolf said. She added that familial care doesn't compromise quality of care.

## California Grapples with Aging Population Growing

California's older adult population is growing quickly, and older adults will make up 25% of the state's population by 2030.

In preparation for this population shift, Governor Gavin Newsom called for a Master Plan for Aging (MPA), a 10-year blueprint to build a California for all ages and abilities by 2030. The MPA was created in partnership with older adults, consumers, providers, local officials, private funders, and the Legislature, according to Susan DeMarois, director of the California Department of Aging.

The California Department of Aging is working with various stakeholders to implement the MPA, with caregiving being one of its Five Bold Goals, "putting an important focus on family and friend caregivers as well as the direct care workforce," DeMarois said.

The MPA's Goal Four: Caregiving That Works, focuses on caregiving, which includes paid family leave, training and virtual care expansion. The CalGrows workforce training and development program is a key initiative under the MPA. CalGrows offers caregivers access to over 600 free online and in-person courses to enhance their skills. Paid direct care workers can qualify for incentive payments for completing these courses and applying their knowledge, but only through August 2024. While unpaid family and friend caregivers can take the courses, they are not eligible for incentives. The courses will remain available to all Californians through September 2024.

Additionally, California supports unpaid caregivers through the Family Caregiver Support Program, offered by Area Agencies on Aging and Caregiver Resource Centers. These programs provide counseling, services like home repairs, respite care, and more, to assist caregivers in supporting their loved ones.

## Caregiving Demands and Skilled Nursing Facilities for Aging Californians

Current data on California's aging population

and in-home care needs, particularly in the Inland Empire, shows a projected 682% increase in the 65 plus population by 2060, the highest growth rate in the state. This will significantly impact long-term care services as the population ages.

According to the California Department of Aging report, the demand for home care aides and personal care assistants is projected to increase by 47%over the next decade. Currently, there are approximately 25,000 in-home care workers in the Inland Empire, but estimates suggest that this number will need to increase to at least 40,000 to meet future needs.

"Locally, the Inland Empire is not prepared for this rapid growth," said Ben Jauregui, Inland Empire Health Plan's manager of Integrated Transitional Care and founding board chair of the Inland Coalition on Aging. "There is a shortage of caregivers, a need for more training, and a need for more supportive services for informal caregivers."

According to Jauregui, the California Master Plan for Aging identifies "Caregiving That Works" as its fourth goal, to acknowledge the need for improved preparation and support for all caregivers, including paid, unpaid, family and friends. Another proposed solution is the CalGrows program which aims to train caregivers. However, it is a short-term program.

At the same time, the cost of in-home care is rising, driven by California's high business expenses and competitive wages in other industries, such as fast food. It might be more appealing for someone to work in fast food at \$20 an hour rather than as an In-Home Supportive Services (IHSS) home care provider earning \$16, \$17 or \$18 per hour, according to Jauregui.

"More support is needed in this area," he said.

## **Legislation Considered to Support Family Caregivers**

Several bills are currently being discussed to enhance support for family caregivers, including AB 518, which amends the existing paid family leave program to expand eligibility for wage replacement benefits. Currently, workers can receive benefits for

caring for a seriously ill family member.

This bill extends coverage to individuals who take time off to care for a seriously ill "designated person," defined as anyone related by blood or with a relationship equivalent to family. Workers can identify this designated person when filing for benefits. The bill revises relevant definitions and will take effect on Nov. 1, 2024.

Caregivers benefit from existing laws like the California Family Rights Act (CFRA) and Paid Family Leave (PFL), which provide up to 12 weeks of job-protected leave and wage replacement for up to 8 weeks when caring for family members. Additionally, while the state has considered caregiver tax credits, like a proposal offering up to \$5,000 in tax relief, comprehensive tax credit legislation hasn't yet passed. Pending bills, such as AB 1119, aim to further protect caregivers by prohibiting workplace discrimination based on caregiving responsibilities.

## Black Californians Encounter Distinct | Challenges

In parts of California, rising costs of living and challenges accessing resources for Black Americans remain persistent, at times, leading to poor health outcomes for seniors and added stress for the family caregiver.


Black Voice News collected data from various counties in California, revealing that Black residents are struggling more than others to keep up with living costs. This issue will significantly affect the elderly, who need expensive care.

In San Bernardino County, the Black population aged 65 and older is projected to increase by 26.4% by 2035. The average annual living cost for a single person in this county is \$51,324, and nearly half, 49.6%- of households led by seniors in the area earn less than this amount.

By 2035, the Black population aged 65 and older in Riverside County is expected to increase by 39.4%. The average annual living cost for a single person in the county is \$54,276, and 41.4% of senior-led households in the region earn less than this amount. With average living costs continued on page 19

## Military Veteran and Community Activist and Leader Walter Jarman, Remembered

"It was during the summertime in the midsixties when I was working at Southern California Edison as a Customer Serviceman and was driving down 2300 W. Victoria or 6th Street on my way to turn on a customer's lights when I passed a house and noticed this man standing in the front yard washing his car," wrote Black Voice News Publisher Emeritus, Hardy Brown Sr., sharing his memories of Walter Jarman who passed recently. His life was celebrated at the New Hope Missionary Baptist Church on Saturday, August 31.

"I said to myself, he looks like 'Big Boy' from Trenton. So, I turned around and went back to his house and asked him, "Are you Walter Jarman from Trenton, [North Carolina]?" And his response was 'Yes." We started laughing with excitement and started

talking about growing up in Trenton. After the surprise finding each other, we exchanged our contact information, and our families began a relationship like our families had in Trenton. So, you know by now, Big Boy is the nickname for Walter Jarman."

Brown continued, "The Jarman's had a tobacco farm on Highway 41, just outside the town limit and when I was still in elementary school, I helped them on their farm putting in tobacco for two summers.

Walter was several years older than me, but the entire Walter Jarman Sr. and Floyd Brown Sr. families were well connected in the NAACP, Masons, church and other community issues. As a matter of fact, I talked with his dad, Mr. Jarman, in 1976 while home on a family vacation and I have a picture of Cheryl and Mr. Jarman in front of my dad's house. Mr. Jarman came by my dad's house to talk about some issues the local NAACP was involved with because Mr. Jarman was the president at that time."

Walter Jarman Jr. was born November 9, 1937, in Jones County in a small town near Trenton, North Carolina to Walter Jarman and Hagar Dillahunt Jarman. He would later resettle in Southern California where he earned a Master's Degree in Criminal Justice from California State University, San Bernardino.

He was a military veteran who served in the United States Air Force and upon his retirement from active duty, he served in the State of



California Highway Patrol (CHP) for thirteen years before transferring to become an Alcohol Beverage Control licensing agent.

Throughout his life, Walter maintained a strong and extensive commitment to both civic and community activism, including organizations like the NAACP San Bernardino where he served as Branch President for several years. He was also Executive Director of San Bernardino NorthWest PAC, treasurer of N.O.B.L.E, (National Organization of Black Law Enforcement), the 6th Ward City of San Bernardino Police Commissioner, a New Hope Missionary Baptist Church Trustee, Chairman of the Multimedia//Cyber Security Committee, and San Bernardino Valley College Gospel radio host. In his spare time, Walter enjoyed playing his guitar and singing with a quartet, the Loving Five. Walter was a member of New Hope Missionary Baptist Church for more than 30 years.

children, pulling them away from breastfeeding their own children, according to law professor Andrea Freeman in her article written for the Hastings Law Review Journal.

Divided into three parts, Freeman's article "demonstrates how society has consistently devalued Black maternal love bestowed on Black children" and "explores how the aspirations of pediatricians to legitimize an emerging medical field and evolving technologies of artificial milk perpetuated the racial divide in breastfeeding."

Her article also traces the practices and policies that have contributed to racial disparities in breastfeeding rates among Black women, including intense formula marketing tragedies in the 1950s (Pet Milk), the distribution of free formula through government programs, a lack of "baby-friendly requirements" in hospitals and inadequate workplace breastfeeding accommodations.

In California, the law protects the right to breastfeed or chestfeed in public, with or without a covering, in hopes of reducing stigmatization and embarrassment which lead to barriers to breastfeeding, the California Department of Health noted.

With awareness campaigns like National Breastfeeding Month and Black Breastfeeding Week, advocates seek to educate and provide resources to those who are unaware about lactation rights, support groups and community gatherings that encourage discourse surrounding breastfeeding or chestfeeding.

"I want folks to know that breastfeeding, just like labor and birth, is a normal physiological function of our bodies. We're designed to feed our babies from ourselves. But also, I want people to feel uplifted in the methods and how they feed their baby because sometimes, for whatever reasons," Davison explained. "Sometimes there are hiccups with breastfeeding, and it might not be as readily accessible, even though it seems easy access."

Breastfeeding can be hard and tiresome, but there are several resources for those in need of support. Across the Inland Empire, there are

lactation experts like Devona Robertson, doula and lactation consultant, and Janisha Howard, a student of the International Board Certified Lactation Consultants. Howard hosts weekly support circles via Zoom.

This week amplifies the stories of Black mothers, organizations across the Inland Empire are hosting events to commemorate the week:

- Black Infant Health, presented by the San Bernardino County Department of Public Health, is hosting a family friendly event on Thursday, August 29 from 10:00 a.m. to 2:30 p.m in San Bernardino.
- The Sankofa Birthworkers Collective of the Inland Empire and The Village House is

hosting a community event that welcomes "any past or present parents who have every given or desired to give their babies human milk" on Saturday, August 31 from 12:00 p.m. to 5 p.m. in Moreno Valley.

Additional support resources also include:

- The Inland Empire Breastfeeding Coalition hosts weekly and monthly educational virtual meetings about lactation and breastfeeding. Additionally, the Black Breastfeeding Task Force holds virtual monthly meetings every 4th Friday at 1:00 p.m.
- Milky Mama, a Black-owned company that produces lactation treats and beverages to support breastfeeding.

work because he rolled back provisions intended to keep them safe; and even more egregious, Trump gave big corporations "free rein to lower wages and make it harder for workers to stand together in a union."

Trump is counting on Blacks not paying attention to his impact on the economy, or his racist rantings or any of the other acts he's implemented that do not support uplifting the working/middle class, and/or pits one group of Americans against others. If the race for the White House was not so numerically close and American voters less unpredictable, I wouldn't concern myself about members of the minority communities who still support Trump, but there is too much at risk and the race is too close. Democrats need an overwhelming victory and even that may not be enough. Every vote will count.

A Pew Research poll in May showed seven percent of Black voters over 50 identified or leaned Republican and 17% of Black voters under the age of 50 aligned with the Republican Party. But when Kamala Harris entered the race a few short weeks ago, support for Trump in the Black community shifted. A more recent Pew Research poll shows Harris ahead among Black voters but still 16% of Black men and 10% of Black women are leaning Republican. What's it going to take to wake them up?

It would be nice if we could just ignore their misguided political leanings and commitment to a man who could care less about them; if we could just remind them that he is not worthy of their loyalty to him. If they don't believe me, all they have to do is remember how disloyal Trump was to the minions who stormed the Capitol on his behalf January 6, 2021. They were on their own once arrested, tried and convicted.

The AFL-CIO's summary of Trump's disastrous impact on labor and his assault on the economic rights of federal workers showed:

He undermined workers' merit-based civil service system, granting managers a license to freely discriminate and retaliate against workers.

He restricted union representatives' ability to advocate for their members on the job.

He targeted workers' freedom to negotiate on workplace issues, including reasonable accommodations for those with disabilities, employee training, overtime, telework and flexible work schedules.

He revoked the Department of Education's previously negotiated union contract and illegally imposed an anti-union directive, stripping 3,900 workers of all previously negotiated rights and protections.

He stripped away protections for rank-andfile workers at the Department of Veterans Affairs, prompting a 60% rise in firings in the second half of 2017 alone.

He repeatedly turned a blind eye to misclassifying up to 30% of workers as independent contractors.

Trump also made several trade deals that were anti-worker including an anti-worker trade deal with South Korea that failed to secure key labor and human rights protections.

He proposed a 78% cut to the International Labor Affairs Bureau, the federal agency responsible for promoting a fair global playing field for workers.

And, Trump has proposed \$400 million in budget cuts that would slash the Trade Adjustment Assistance program for those who lose their jobs to imports over the next decade.

All of this, in addition to his attack on workers' health and safety in the work place in addition to Trump's failure to keep his promises to the steel industry is another strong reason to keep him away from the Oval Office a second time.

Remember, Trump promised to protect jobs in the steel industry but instead more than 16,000 manufacturing jobs were lost. He also promised to "bring back manufacturing jobs and invest \$1 trillion to rebuild U.S. infrastructure in Rust Belt states." During his four years as president, however, he talked a good game but never advanced any infrastructure legislation.

Meanwhile, it seems that more and more people are waking up to Trump's duality– promising one thing and delivering just the opposite. His running mate and Republican candidate for Vice President, Senator J. D. Vance, was booed by union members at the "

International Association of Fire Fighters (IAFF) conference on Thursday, August 29. Another glaring example that Trump is bleeding support from unions.

I can only hope that those Blacks who are still mesmerized by Trump's insanity for one reason or another, come to their senses and vote in their own best interests, in the interests of their loved ones, their community, and their ancestors.

It may sound trite. It may sound cliche. It may be a phrase that is overworn, but in truth, I can't think of a better way to say it than simply put, "This election, every vote counts." Also, if you choose not to vote, you are in essence casting a ballot for Trump.

This November, do your part to build and sustain a better America. Support labor. Support equity in the workplace. Support Kamala Harris for President.

Of course, this is just my opinion. I'm keeping it real.

surpassing \$50,000 annually and a substantial portion of senior-led households earning below this threshold, many will struggle to afford basic necessities and healthcare. The growing gap between income and living expenses highlights a critical need for targeted support and resources to ensure that Black seniors can maintain a decent quality of life amidst escalating financial demands.

California's Inland Empire faces significant challenges as it prepares for a substantial increase in its aging population. The unique struggles faced by Black seniors, including economic disparities and higher costs of living, further complicate the situation. To address these issues, California is implementing various legislative measures and support programs, but the data shows continued efforts and expanded resources will be crucial to effectively support the aging population and ensure equitable access to care.
