# Hate Speech in San Bernardino and a **Message About Accountability**

The incident of hate speech that occurred during last week's San Bernardino City Council meeting by a faceless, unknown coward who spewed his vile comments via telephone, certainly raised the ire of the community to a fever pitch with passion not seen since the uprising of 2020.

In its wake, the city has offered an official apology, the community has gathered together in solidarity and the police are pulling out all the stops to identify the racist culprit— and with the IP address it is possible they just might identify the individual... and then what?

How do you change people's hearts and minds? That is the operative question and certainly if we knew the answer to it, then as a community, as a state, as a nation, we would have applied it long ago and such incidents would be a thing of the past. That being said, positive things are happening in the wake of the incident.

In addition to community dialogue and acts of solidarity as experienced during the San Bernardino Community Stand Against Racism

held Monday, October 23, we are looking to apply the law that may not be able to change hearts and minds, but can certainly impose accountability. In this instance, the accountability option is California Penal Code 403 which makes it a crime for a person to willfully disturb or break up a public meeting. CA Penal Code 403 is the best option for accountability in this instance because hate speech is not a crime.

In June, Black Voice News, in partnership with Mapping Black California, released a report, Mapping Hate, where we examined incidents of hate in California by county across a five year period, 2016 to 2021. What stood out was firstly, that Anti-Black or African American hate crimes continue to be the largest bias incident victim category and secondly, the majority of offense types during this period were verbal slurs. But again, I must reiterate that hate speech is not a crime though it is considered a hate incident which is defined as "an action or behavior motivated by hate but which, for one or more reasons, is not a crime."

arivel Castaneda and Adrianna Rodriguez of the Riverside County Department of Public Services in partnership with Black Voice News shared information about MediCal (California's version of Medicaid) unwinding to community members at the Civil Rights Institute of Southern California on Saturday, October 14.

The community outreach effort was in partnership with Black Voice News as part of the publication's Pop-up Newsroom initiative, a new strategy designed to bring important news and information directly to members of the community at local events.

More than 15 million beneficiaries are at risk of being disenrolled from Medicaid nationally and more than 225,000 California residents having already lost their Medi-Cal coverage during this process due to several challenges such as not returning Medi-Cal renewal paperwork, not receiving their mail due to an address change, or benefit eligibility issues.

At least 439,000 households in Riverside County depend on Medi-Cal benefits and there are about 456,527 households in San Bernardino County subscribed to the health care service, making the need to understand the Medi-Cal unwinding process critical to the many inland area residents who rely on it for their health care coverage.

"We are out in the community helping individuals complete these packets, so they can retain benefits," explained Castaneda, emphasizing the importance of making the registry window and being able to receive preventative care.

It is important that beneficiaries respond to renewal forms they receive in the mail indicating they need to submit information. They are required to complete and return the form as soon as possible in the pre-paid return envelope provided. The form can also be submitted online, in-person or by phone. The renewal process can take up to 90 days.

If a resident is no longer eligible for Medi-Cal, they should consider other affordable insurance options like Covered California, the free online marketplace for low-cost health insurance plans.



Serafin's most recent encounter with the law occurred on August 27 when he was arrested on suspicion of driving under the influence after reportedly colliding with a parked car.

This incident marked the second DUI arrest for Serafin, as court records reveal he was previously convicted in 2018 for driving under

the influence, with a blood alcohol level of .08 or higher. In addition to his DUI history, Serafin also faced misdemeanor vandalism charges in 2015 related to purported vehicle burglaries.

During a recent board meeting, nearly a dozen individuals expressed their concerns about Serafin's continued presence as board president. Dolores Holmes, a concerned parent, made a heartfelt statement, emphasizing the impact of Serafin's actions on the community and children. She questioned the appropriateness of Serafin's behavior, both as a school board member and in his personal life, asking whether he truly represented positive attributes for the students.

"I came here today to let you know that all the decisions made by you affect my children, the children of our community, and my family. Yes, we all make mistakes and deserve a second chance, however, not the same mistakes over and over again," stated Holmes. "I'm a believer that our words and our actions encourage or discourage people. Do you really think you are encouraging positive attributes to our students as our president?"

In response, Serafin acknowledged his imperfections but maintained his resolve to become a better person. "I am not a saint. I take responsibility, and I pray daily to the creator, to my ancestors, to the sun and to the moon. I strive to be a better person and will be a better person," he declared.

Serafin's troubles extend beyond his legal issues. Concerns have also emerged about his conduct during board meetings, including his use of foul language. School board member Melinda Young called for Serafin to resign due to his history of using inappropriate language



## **NAACP Demands Investigation Into San Bernardino City Council Meeting Hate Incident**

The San Bernardino Branch of the NAACP is calling on the City of San Bernardino to investigate a racial incident that occurred last week.

During the public comments section of a council meeting on Oct. 18, Amy Malone, a Black resident of San Bernardino was interrupted by racial slurs from a commenter who was viewing the meeting remotely.

The anonymous commenter told Malone to "go back to Africa" and called her the N-word. She was also called a "bitch."

Malone was shocked by the comments and insisted that they be addressed immediately.

"You should apologize for what just happened," said Malone to the city council members present.

The local branch of the NAACP also reacted to the incident, calling it "disgusting."

"It is with a heavy heart that we must deal with racial insults being tossed at the Black community on 10/18/23 as they cautioned the mayor and council not to hire Mr. Charles Montoya as City Manager because of his public legal issues cause from being fired by the Mayor and Council from Avondale, Arizona," wrote Chache Wright, NAACP San Bernardino Branch President.

"A letter signed by Mayor Kenneth N. Weise (Avondale, AZ) lists these five alleged reasons for Montova termination. 1. Montova did not live in Avondale as required by his employment contract. 2. Demanding funds from the city he was not entitled to according to his contract. 3. Failing to make timely payment on a loan he had borrowed against his retirement account. 4. Receiving tuition reimbursement payments beyond what his contract allowed. 5. Refusing to repay vehicle reimbursement funds that he was paid in error," the NAACP statement continued.

Before she was interrupted, Malone was expressing her objections to the hiring of Montova because of past misconduct and his questionable professional past. She was one of several residents who opposed his hiring because of his checkered employment history. According to some of the protestors, Montoya also has a history of filing lawsuits against previous employers.

According to news reports, Montova clashed with Avondale board members and raised concerns about nepotism prior to his dismissal. He was terminated for not living within the city

limits. However, his attorney argues that the city unlawfully terminated him without giving him adequate time to address the problem.

Montoya said he was fired out of spite. During an appearance at the meeting, he said he had no regrets about his decision. The case is currently proceeding to federal court.

Despite these concerns, the city council approved Montoya's hiring. Montoya has previously worked as a city manager in California

A statement posted on the city's website says that the official recording of the meeting has been edited to remove the offensive language.

The Centers for Disease Control and Prevention recommends new covid-19 booster vaccines for all — but many who need them most won't get them. About 75% of people in the United States appear to have skipped last year's bivalent booster, and nothing suggests uptake will be better this time around.

"Urging people to get boosters has really only worked for Democrats, college graduates, and people making over \$90,000 a year," said Gregg Gonsalves, an epidemiologist at Yale University. "Those are the same people who will get this booster because it's not like we're doing anything differently to confront the inequities in place."

As the effects of vaccines offered in 2021 have diminished over time, boosters have been shown to strongly protect people against severe covid and death, and more modestly prevent infection. They can have a dramatic impact on those most likely to die from covid, such as older adults and immunocompromised people. Public health experts say re-upping vaccination is also important for those in group housing, like prisons and nursing homes, where the virus can move swiftly between people in close quarters. A boost in protection is also needed to offset the persistent disparities in the toll of covid between racial and ethnic groups.

However, the intensive outreach efforts that successfully led to decent vaccination rates in 2021 have largely ended, along with mandates and the urgency of the moment. Data now suggests that the people getting booster doses are often not those most at risk, which means the toll of covid in the U.S. may not be dramatically reduced by this round of vaccines. Hospitalizations and deaths due to covid have risen in recent weeks, and covid remains a leading cause of death, with roughly 7,300 people dying of the disease in the past three months.

Tyler Winkelman, a health services researcher at Hennepin Healthcare in Minneapolis, said outreach of the intensity of 2021 is needed again. Back then, throngs of people were hired to tailor communication and education to various communities, and to administer vaccines in churches, homeless encampments, and stadiums. "We can still save lives if we are thoughtful about how we roll out the vaccines."

Complicating matters, this is the first round of covid vaccines not fully covered by the federal government. Private and public health insurers will get them to members at no cost, but the situation for some 25 million-30 million uninsured adults predominantly low-income people and people of color — is in flux. On Sept. 14, the CDC announced a kickoff of plans to temporarily provide vaccines

for the uninsured, at least partly through \$1.1 billion left over in pandemic emergency funds through the Bridge Access Program.

Costs are probably an issue, said Peter Maybarduk, at Washington-based advocacy organization Public Citizen. Moderna and Pfizer have more than quadrupled the price of the vaccines to about \$130 a dose, compared with about \$20 for the first vaccines and \$30 for the last boosters, raising overall health care costs. Maybarduk pointed out that the U.S. government funded research involved in developing mRNA vaccines, and said the government missed an opportunity to request price caps in return for that investment. Both companies earned billions from vaccine sales in 2021 and 2022. Moderna's latest investor report predicts another \$6 billion to \$8 billion in covid vaccine sales this year and Pfizer expects \$14 billion. Maybarduk suggests the government would have more funds for equity initiatives if so much weren't being spent on the boosters through Medicare, Medicaid, and its access program. "If these vaccines had been kept at the same price, what decisions would be made to expand

the response?"

People age 75 and up have accounted for more than half of the country's pandemic deaths. But whereas the first vaccines were quickly taken up in nursing homes, boosters have been less popular, with fewer than 55% of residents in Arizona, Florida, Nevada, and Texas getting the bivalent booster released last year. At some facilities nationwide, rates are below 10%.

Jails and prisons have seen some of the largest U.S. outbreaks — yet booster uptake there often appears to be poor. In Minnesota, just 8% of incarcerated people in jails and 11% in prisons have gotten last year's booster, according to analyses of electronic health records by the Minnesota EHR Consortium. About 38% of people in prisons in California are up to date on boosters. Boosters make a difference. A study of California prisons found that among incarcerated people, the effectiveness of the first two doses was about 20% against infection, compared with 40% for three doses. (Prison staff saw

# **Senator Laphonza Butler Opts Out of 2024 Senate Race**

ecently appointed Senator Laphonza Butler (D-CA) will not seek election in 2024 to fill the Senate seat for a full

The only Black Senator currently serving in the U.S. Senate, Butler was recently appointed to the seat by CA Governor Gavin Newsom to complete the term left open with the passing of Senator Dianne Feinstein on September 29, 2023.

The first openly LGBTQ, the second Black Senator to represent the state of CA and only the third Black woman to serve in the U.S. senate in the nation's 247 year history, Butler's appointment was celebrated by a cross-section of communities across the state and around the nation.

Newsom had previously committed to appoint a Black woman should Feinstein be unable to complete her term and Butler proved a worthy choice with her long history as a Democratic strategist, union leader and further political experienced gained having served as an advisor to Vice President Kamala Harris' 2020 presidential campaign.

Her decision not to enter the race may be viewed as prudent by some considering the field is already crowded with a slate of well-known and popular Democratic candidates including, Congresswoman Barbara Lee, a member of the House Democratic leadership team and former chair of the Congressional Black Caucus; Congressman Adam Schiff, former chair of the House Intelligence Committee; and Congresswoman Katie Porter, who represents parts of Orange County and is the former deputy chair of the Congressional Progressive Caucus. These, however, are just some of the Democrats who have already entered the field. Some of these candidates have already secured millions of dollars in campaign donations according to reports.

On the Republican side, at least two candidates have declared their intention to enter the Senate race including Steve Garvey a retired

professional baseball player and attorney Eric Early. Some of these candidates have already added millions of dollars to their campaign coffers.

#### **Butler's Decision**

Explaining her reasons for choosing not to enter the race on X Butler offered, "I've spent the past 16 days pursuing my clarity – what kind of life I want to have, what kind of service I want to offer and what kind of voice I want to bring forward," she began. "After considering those questions I've decided not to run for Senate in the upcoming election. Knowing you can win a campaign doesn't always mean you should run a campaign. It may not be the decision people expected but it's the right one for me. "

Butler also cited concerns for family during an interview with FOX last week, where she highlighted the reality of harassment. "My mother is 70 years old, she didn't sign up for this. My daughter is 9, she didn't sign up for this and so I'm thinking about my family and my family's safety," she opined. "I have already gotten my first piece of hate mail and a stranger has shown up at my door and so that is a real contemplation for me."

As Butler made her future plans clear regarding CA's 2024 Senate bid, the race was already being highlighted as one of the highest profile contests to watch in the coming year.

On November 5, 2024, there will be two ballot items for the same Senate seat—a special election to fulfill the final weeks of Feinstein's seat in the 118th Congress that ends January 3, 2025 and a general election for a full term Senate seat in the 119th Congress that begins January 3, 2025.

week. we saw narrative that dominated 2022 get thoroughly debunked. Last year, political candidates, and much of the media that covers them, practically shouted about a murder and crime wave.

The FBI just released its 2022 data. Homicides are

down. Violent crime is down. While property crime is up, it's still well below a decade ago.

Violence is far too complex to point to a single reason for trends. But we shouldn't let this moment pass without recognizing the historical recent investments in community-centered public safety.

Communities are boldly asserting what they need to be safe-and building solutions to achieve it. The work is producing tangible reductions of violence.

Unfortunately, our backing of these transformative strategies hasn't matched their potential. Our nation's response to violence has always been punishment, which intensifies the root causes of violence and acts as a multiplier of harm. We have poured money into policing and prisons for years; isn't it time to fully support successful community-driven strategies?

California recently took a stride in this direction when Gov. Newsom signed AB 28, which will tax manufacturers of guns and ammunition, sending \$75 million into community-centered public safety.

That amount might feel substantial until you contrast it with how our country funds public safety: a 2019 DOJ report showed spending of \$300 billion annually on police, prosecutions, prisons, and supervision across the entire justice system.


Meanwhile, all levels of government have invested approximately \$250 million annually, over the past two years, into communitycentered strategies, a stark contrast in how we prioritize and invest in safety.

Given the proven success of community initiatives against the harms of traditional strategies, we have to wonder: Could we be investing differently and have greater impact?

These community initiatives take many shapes. The solutions to violence require a collective strategy that addresses the root causes. Right now, much of that \$250 million goes to community violence intervention (CVI) — and not nearly enough to organizations on the ground.

This historic investment in CVI is a critical step to achieving safety in all of our communities. But it is just the "tip of the spear," according to Eddie Bocanegra, senior advisor in the U.S. Office of the Assistant Attorney General. He's pointing to a larger thinking — our investment needs to expand beyond singular efforts. Our communities deserve more than just CVI.

A more diversified approach is having undeniable success. Look at Newark, NJ, where Mayor Ras J. Baraka has launched initiatives that center community in formal public safety strategies. One result: a 60year low in homicides. Organizations like the Newark Community Street Team, The HUBB Arts and Trauma Center, and New Direction are aligning efforts in allyship with the city's Office



Although there is currently a lot of passion in the community among those angry about what occurred and who are pressing for accountability, I would ask that instead we consider this in the equation. During the five year period of our Mapping Hate report, among the things that stood out were that the majority of racial hate crimes during this period were Anti-Black (28%). The data also revealed there is little consequence for bad behavior as it relates to such hate crimes. Generally, only 35% of hate crimes are referred for potential prosecution and of those, only 50% (18% off all crimes) are filed. From there 58% of cases filed are disposed, and of those, 49% are convicted as a hate crime.

The other 51% are either not convicted of a hate crime, or not convicted at all. When you crunch the numbers, what this means is that of all the hate crimes committed in the state of California during the five year study period, less than six percent resulted in a hate crime conviction.

The quest for accountability is a word used ad nauseam in relation to criminal justice. For example, how often do we hear officials—especially law and order enthusiasts who never saw a jail they did not want to fill—talk about the need for those who commit crimes to be held accountable—especially Black folks. But when it comes to crimes, hate crimes in particular

committed against Black people we have to stop and ask: Where is the accountability?

Hate speech as experienced during the San Bernardino City Council meeting last week is hurtful and should not be tolerated, but again, it is not a crime. However, there are real hate crimes being perpetrated against Blacks and other minorities that continue to go unpunished with very little notice.

One of the ways we can truly channel frustration over what happed and make a difference is to demand that police agencies put as much energy into holding perpetrators of hate crimes accountable as they do in over arresting, over-charging and over-convicting Black people far out of proportion to their presence in the population.

Of course this is just my opinion. I'm keeping it real.

of Violence Prevention and Trauma Recovery to make community needs the foundation of its public safety efforts.

In Baton Rouge, LA, a community that for years has been one of the country's most violent cities, community and elected officials have united to truly address violence as a public health issue. They are investing in community-driven violence intervention and prevention strategies, leading to double-digit reductions in homicides, shootings, and violence this summer.

It is vital that we create a comprehensive approach to building safety that includes reentry programs, non-carceral crisis response teams, diversion initiatives, youth programs that deliver opportunities, domestic violence initiatives addressing domestic violence, and substance abuse or misuse support programs.

Conventional policing, which is largely reactive, relies predominantly on punitive responses. This approach fails to address the underlying causes of community violence and harm. But cities like Newark, Baton Rouge, and many others nationwide are seeing significant gains in public safety by tackling root causes of violence head on: poverty, the housing crisis, substance abuse, and much more.

As our understanding of safety evolves, we must prioritize and invest in these communitycentered interventions that focus on health, well-being, and opportunities for all.

Our goal of a holistic and non-punitive approach to safety is becoming a reality in policy and implementation. U.S. Rep. Cori Bush's "People's Response Act" embodies this changing landscape, redefining our thinking of public safety in our country by placing community well-being over punishment.

Coalitions like the Community Safety Working Group and Invest in Us are at the forefront in advocating for federal policies that include a wide-ranging view of safety. Their endeavors highlight the fact that this work transcends isolated efforts. The goal is a cohesive strategy to create safety centering strategies that resonate with the diverse communities they intend to serve.

As we move forward toward true community

safety, we stand at a defining moment. The success stories attest to the real benefits of putting community at the heart of our safety strategies.

This shift requires more than "commitment." It requires a profound reevaluation and investment. Our shared vision of a more equitable and secure future demands no less.

uncertain terms," according to the statement.

"The city apologizes to anyone who heard what was said. Our community will not tolerate this type of hateful language in our public meetings, or anywhere. The city is working to identify the individuals who made the comments. The City Clerk and her staff, along with our IT department, are working with the San Bernardino Police Department on this. We have identified all the IP addresses that were in the queue at the time and are working to identify those that were involved. SBPD is investigating this as a violation of California Penal Code 403."

The offensive comments are part of a

phenomenon known as Zoom bombing, which gained prominence during the coronavirus pandemic when many groups and businesses were forced to conduct most meetings via the videoconferencing platform. these meetings were not properly secured, unauthorized individuals could join the chat and make inappropriate comments.

The San Bernardino NAACP says it plans to file a formal request for an investigation into the hate incident and the hiring of the city manager with the city. It will also share that request with State Attorney General Rob Bonta and the U.S. Department of Justice.

"The NAACP Legal Redress Committee is currently in the process of compiling relevant information and plans to transmit this information to the appropriate authorities next week, accompanied by their official request," Wright concluded.

at public meetings, echoing the sentiments of parents who had previously complained about his unprofessional behavior behind the dais.

Although Young proposed Serafin's resignation during a board vote, the motion failed by a tied 2-2 vote.

Serafin's supporters argue that the DUI arrest should not impact his role on the board, while others, including Erika Zamora, have expressed that it's time for a change as Serafin's actions do not align with the district's values.

Despite growing calls for his resignation, Serafin has given no indication that he plans to step down from the board. In his first public statement after his most recent arrest, he described it as a "personal matter" and remained tight-lipped on the issue. Serafin cited personal challenges, including the recent deaths of his great-grandmother and grandfather, as a contributing factor to his actions.

The controversy surrounding Matthew Serafin's behavior and legal issues is undeniably shaking the Val Verde Unified School District, raising critical questions about leadership, accountability, and the representation of community values in the education system.

larger benefits from three doses, an effectiveness of 72%, presumably because the chance of infection is lower when not living within the facilities.)

Low-income groups are also at heightened risk, for reasons including a lack of paid sick leave and medical care. In surveys of homeless people in California, about 60% reported chronic health conditions, said Tiana Moore, the policy director at the Benioff Homelessness and Housing Initiative at the University of California-San Francisco. Studies have found that members of this community age more rapidly, with people in their 50s experiencing strokes, falls, and urinary incontinence at rates typical of people in their late 70s and 80s.

Booster rates among people who lack housing are largely unknown, but Moore is concerned, saving they face high barriers to vaccination since many also lack medical providers, knowledge about where to go

for vaccines, and the means to get there. "Many of our participants talked about concerns about leaving their belongings when unsheltered since they don't have a door to lock," she said. "That underscores the need to meet people where they are in an effective booster campaign.'

Black and Hispanic people have faced higher hospitalization and death rates than white people throughout the pandemic. And these groups are significantly less likely to be treated with the covid drug Paxlovid than white patients. (Hispanic people can be of any race or combination of races.)

Uneven rates of booster uptake may exacerbate these inequalities. An analysis of Medicare claims across the U.S. found that 53% of Hispanic people and 57% of Black people age 66 and older had received a booster by May 2022, compared with about 68% of their white and Asian counterparts. Disparities were most dramatic in cities where booster uptake among white people was above average. In Boston, for example, 73% of white people were boosted compared with 58% of Black people.

People opt out of vaccination for many reasons. Those living farther from vaccine sites, on average, have lower rates of uptake. Misinformation spread by politicians may account for disparities seen along political lines, with 41% of Democrats having gotten a bivalent booster compared with 11% of Republicans. Lower vaccine coverage among Black communities has been found to stem from discrimination by the medical system, along with worse health care access. However, many Black people who hesitated at first eventually got vaccines when given information and easy access to them, suggesting it could happen again.

But Georges Benjamin, executive director of the American Public Health Association, said the downturn of reporting on vaccination and covid rates makes it harder to tailor outreach.

"If we had the data, we could pivot quickly," he said, adding that this was once possible but that reporting lapsed after the end of the public health emergency this spring. "We've gone back to the old way, re-creating the conditions in which inequities are possible."

Research shows that many people who use vapes to quit smoking cigarettes end up using both products, making Big Tobacco a killing. The tobacco industry has spent decades funding studies to give their claims the illusion of credibility, paying big bucks to influence public perception, securing 'special editions' of scientific journals, and releasing self-funded research that says their vape products are safer.

Vape use is an urgent public health concern in California, especially among young adults. Currently, 11.2% of young adults use vapes, the highest among any age group. These young adults were among middle and high school students during the height of the tobacco industry-created youth vaping epidemic.
