Riverside County Doubles License Plate Cameras as Part of a Nationwide Mass-Surveillance System

n case you missed it, a couple of weeks ago the Riverside County Board of Supervisors approved a new contract for automatic license plate recognition (ALPR) cameras.

The contract will more than double the existing number of cameras—-increasing the number ALPR's from about 210 to 538.

By the way, the cameras, contracted through the manufacturer, Flock Safety (Flock), have been in operation in Riverside County for about three years.

Of course, the Riverside County Sheriff's Department justified the need for these additional cameras by claiming the usual "violent crimes" rationalization even though

violent crimes are down across the nation and in Riverside County the violent crime rate in 2021 was 296.1 per 100K compared to 307.4 per 100K in 2019. But then again, I ask rhetorically, when does reality matter when it comes to funding the police?

This is just one more example of how we truly live in an Orwellian world and our officials are willing to pay top (taxpayer) dollars to make sure "big brother is always watching." The \$6.9 million dollars it's costing for this added intrusion in our lives could certainly be better spent in a county where 9.1% of its families live in poverty, 13.6% of its children *continued on page 14*

Rising Cases of Congenital Syphilis in Newborns Highlight Need for Timely Testing and Treatment

Cases of syphilis in newborns in the U.S. Ccontinue to rise, according to a recent report issued by the U.S. Centers for Disease Control and Prevention (CDC). The report emphasized a tenfold increase in cases in 10 years with a total of 3,761 cases of congenital syphilis in 2022 compared to about 335 cases in 2012.

"The congenital syphilis crisis in the United States has skyrocketed at a heartbreaking rate," said CDC Chief Medical Officer Dr. Debra Houry in a press release. "We're calling on healthcare providers, public health systems, and communities to take additional steps to connect mothers and babies with the care they need."

Syphilis is a sexually transmitted infection (STI) that is caused by bacteria and is spread through sexual contact. The infection evolves over four stages: primary, secondary, latent and tertiary, where symptoms and signs can progress.

Symptoms of syphilis in the primary stage include sores and can progress in the secondary

stage to multiple sores and rashes. In the latent stage, there are no visible symptoms and without treatment, syphilis can exist in the body for years, according to the CDC.

"Syphilis is sometimes referred to as 'the Great Pretender' because symptoms can often appear like other diseases throughout the first stages," according to a statement from San Bernardino County's Department of Public Health. "However, syphilis should be included

in testing for STDs, especially since symptoms can go away on their own but create other complications later."

Congenital syphilis is a disease that is the result of a mother with syphilis passing the infection to the baby during pregnancy. Syphilis during pregnancy can result in miscarriages, stillbirth and infant death among other long-term medical issues. In 2022, 231 stillbirths and 51 infant deaths were reported to the CDC.

The CDC's report found that nearly nine in 10 cases of newborn syphilis in 2022 could have been prevented "with timely testing and treatment during pregnancy." More than half of cases were among people who tested positive, but never received adequate or timely treatment. *continued on page 8*

W ith the holidays approaching and temperatures beginning to drop, health officials continue to monitor upticks in seasonal respiratory viruses.

Similar to previous years, COVID-19, flu and respiratory syncytial virus (RSV) cases are expected to increase in coming weeks. The U.S. Centers for Disease Control and Prevention (CDC) have been monitoring the spread of respiratory viruses throughout the year to learn more about the winter season outlook ,while also continuing to stress that immunization remains "the safest strategy for avoiding hospitalizations,

long-term health outcomes, and death."

On Nov. 16, the CDC announced the availability of a treatment used to protect infants against severe RSV disease. RSV is a virus that impacts the lungs and respiratory tract. Mild symptoms of RSV include cold-like symptoms and in some infants can result in lower respiratory tract diseases such as pneumonia and bronchiolitis.

"CDC and FDA are committed to expanding access to this important immunization so that

more parents have peace of mind during the winter virus season," said Dr. Nirav D. Shah, CDC's principal deputy director, in a statement.

The treatment for RSV, Beyfortus, is a monoclonal antibody designed to protect infants and children against severe RSV.

According to the San Bernardino County Department of Public Health (SBCDPH), historically, the county has experienced an increase in emergency room visits and hospitalizations due to flu-like illnesses around the holiday season. SBCDPH is monitoring these illnesses and updates a public dashboard every Wednesday. As of now, the county is experiencing a 4% average of total emergency room visits related to flu-like illnesses within the last week.

InJuly, the U.S. Food and Drug Administration (FDA) approved the new treatment for those who are at risk for developing severe disease. One dose of the drug is administered as a single

Roughly 40% of cases occurred in mothers who were not in prenatal care. In an emailed statement, the California Department of Public Health (CDPH) noted that "maternal risk factors associated with congenital syphilis in California include a lack of or late prenatal care, substance use, experiencing homelessness, a previous history of syphilis, and incarceration in the previous twelve months."

One important risk factor for contracting syphilis is where people live. Some counties have higher rates of syphilis among reproductiveage women than others. Other factors that contribute to the rising cases of syphilis include social and economic factors that have created barriers to high quality prenatal care and ongoing declines in prevention, infrastructure and resources, explained Bethan Swift, CDC Epidemic Intelligence Service Fellow.


Swift works with the Riverside County Department of Public Health. In July, the department issued a public health advisory regarding "concerning syphilis trends" and the national shortage of Bicillin-LA, an antibiotic used to treat syphilis and other bacterial infections. Riverside County reported 42 cases of congenital syphilis in 2021, which represented a 55.6% increase in cases since 2019.

In San Bernardino County, congenital syphilis has primarily impacted Hispanic/ Latino infants, Non-Hispanic white infants, and Non-Hispanic Black or African American infants, according to the County Department of Public Health.

According to the CDC, California had the 11th highest congenital syphilis rate of all states in 2021. Thirty-seven of California's 61 local health jurisdictions reported at least one case of congenital syphilis in 2021. The CDPH reported congenital syphilis cases increased from 33 cases in 2012 to 528 cases in 2021.

In 2022, there were 615 congenital syphilis cases reported to CDPH. The highest congenital syphilis rates were among those who identify as American Indian/Alaska native (941.3 cases per 100,000 live births) and African American (383.6/100,000), compared to Hispanic populations (173/100,000) and white populations (133.42/100,000).

In an effort to address congenital syphilis cases, the CDPH's Sexually Transmitted Rates of primary and secondary syphilis among women aged 15-44 years by county

Diseases (STD) Control Branch has expanded syphilis screening recommendations for the prevention of congenital syphilis. Additional recommendations include at least one screen for syphilis for all sexually active people who could become pregnant, with additional screening for those at increased risk.

"Ensuring syphilis screening among pregnant people (and timely treatment if positive) is a first step toward prevention of mother to child transmission of syphilis," according to CDPH.

In order to address the increase in congenital

syphilis, an expansion of adequate services must occur to ensure that more people are accessing prenatal care and are getting screened, as well as getting prenatal care earlier, before the third trimester. Expansion also includes implementing syphilis screenings for people who are or could become pregnant in other settings like jails and homeless encampments.

As Thanksgiving approaches, pumpkins are on the minds of many. Pumpkin, a vegetable native to North America, has been prominent in the Fall season for centuries. In 1796, Amelia Simmons published American Cookery, the first cookbook written by an American and published in America, and pumpkin pie was one of the recipes. Over the next century, it became a staple in the American home each Thanksgiving.

In the present day, Costco reportedly sold 6.1 million pumpkin pies in September through December of 2019. 2.1 million of those pies were bought in the three days leading up to Thanksgiving.

According to the U.S. Department of Agriculture, in 2022, farmers in the top six pumpkin-producing states harvested more than 1 billion pounds of pumpkins combined. Illinois produced 634 million pounds of pumpkins in 2022, which was more than the other 5 most productive states combined. Indiana produced 161 million and California 122 million pumpkin pounds. while Michigan and Pennsylvania each produced about 90 million pounds.

For Adrian Venegas, an Ontario resident and farmer, pumpkins are a part of not only every season, but every day.

Venegas was born into a family of dairy farmers. During the 2008 recession, when the dairy industry took a hit, the Venegas family found a way to subsidize losses — by opening a pumpkin patch.

Since dairy farmers do not work directly with consumers, but with a dairy broker to sell milk, Venegas said selling pumpkins changed this dynamic and unexpectedly brought him closer to the community.

The Ontario family farm, with the pumpkin patch in the front and dairy farm in the rear, provides an opportunity for the community to pick their own pumpkins in the field. Venegas believes few people in the Inland Empire region have had the opportunity to do their own pumpkin picking.

This year, however, Venegas faced unique challenges with growing the crop. October's scorching heat waves that followed the Santa Ana winds, which blew away plant coverage,

caused a large portion of pumpkins to rot.

But Venegas said that any losses from rotten pumpkins actually work themselves out on the dairy side of Venegas Family Farms because the pumpkins are mashed into feed for the cows. This pumpkin feed in turn produces better milk. Venegas described this as a full circle phenomenon.

Earlier this month, the pumpkin farm closed for the season. While consumers continue to purchase pumpkin products throughout the holiday season, Venegas begins preparing for 2024 immediately. November is a time where he clears the land and prepares for new seeds to be planted, though there is some uncertainty with the upcoming season.

The land that Venegas Family Farm leases is being sold to developers for industrial development. They expect to stay put through November 2024, but are not yet certain. But, if farming has taught Venegas one thing, it is that there are some things he can control and many others that he cannot. He chooses to focus on what he can.

Combating Racism as a Public Health Crisis, Part 1 Holding Leaders Accountable

Mapping Black California's Racism as a Public Health Crisis Dashboard is a convenient tool to analyze how governing bodies and nongovernmental organizations have declared racism as a public health crisis and how they plan to address its impact. The dashboard examines the impact of racism on communities of color and analyzes how these declarations will address the systemic impacts.

Editor's Note: Mapping Black California (MBC), created by Black Voice News, is a project that aims to collect and publish data to help eliminate systemic inequalities. One of MBC's projects is an interactive map of official declarations by local and regional government officials establishing racism as a public health crisis. The aim of this is to provide a resource for tracking and holding these entities accountable for following through on declarations and statements. For this series, Black Voice News partnered with The Starling Lab for Data Integrity, a research lab anchored at Stanford University's School of Engineering

and the University of Southern California's Shoah Foundation. The Lab prototypes authentication technologies and principles to bring journalists, legal experts and archivists into the emerging world of the decentralized web. These tools underscore the importance of accuracy and serve to combat mis- and disinformation. Decentralized tools can create a technological chain that identifies the history, or "provenance," of a piece of digital content, serving to reduce information uncertainty and bolster trust in digital content. n some ways, 2020 can be characterized as the year Earth stood still.

On March 11, 2020, the World Health Organization (WHO) reported 118,000 cases worldwide and on March 11, officially declared a global pandemic as the coronavirus had already swept through 114 countries and killed 4,291 people since January 2020. By March 19, California Gov. Gavin Newsom declared a state of emergency and issued a stay-at-home order.

Time seemed to stop as cities mandated that their residents stay home and shelter-in-place as health officials and the government grappled with a rapidly spreading deadly virus.

The second time Earth stood still was on May 25, 2020. For exactly 9 minutes and 29 seconds, the world watched as George Floyd, a 46-year-old Black man, was murdered by white Minneapolis police officer Derek Chauvin. Recorded on camera by Darnella Frazier, 17, the video quickly went viral and reignited a wave of rage among Black communities across the globe.

The murder of Floyd gave rise to a wave of protests across the world as communities, leaders and advocates called for an end to violent and racist practices carried out by police officers against Black people. Floyd's murder was not the first time a Black person died in police custody or as a result of police actions in 2020. Months before Floyd's death, 26-year-old Breonna Taylor was killed by Louisville police officers while she was asleep.

Early on in the pandemic, available data showed that Black populations experienced higher rates of COVID-19-related deaths in the U.S. According to an analysis by KFF, when adjusting for age, American Indian/American Native, Black and Hispanic people had higher rates of death compared with white people throughout the pandemic.

The California Department of Public Health began tracking COVID-19 data in January 2020 and found the COVID-19 death rate for Black people was 19% higher than the rate for all Californians.

contributed Factors that to the disproportionate rate of cases and deaths were Black people and people of color made up a large portion of "essential workers" - those

facilities...," the declaration listed.

who worked throughout the pandemic and who were exposed to the virus without proper safety measures; lack of access to personal protective equipment; and structural racism.

In the midst of it all, thousands of people mobilized on the street to protest sanctioned acts of violence by police, structural inequality that led to the high rates of death due to COVID-19, and demand recognition and reformation of it all.

On June 23, 2020, the San Bernardino County Board of Supervisors declared racism as a public health crisis. The first governing body in the state to do so, the board signed a declaration that acknowledged and named racism as the root for many longstanding injustices that impact Black communities economically, socially, mentally, physically and beyond.

"WHEREAS, racism has given rise to geographic segregation that disproportionately exposes people of color to lead poisoning, poor air quality, inadequate nutrition, and under-resourced recreational and healthcare

At the height of the pandemic, many people associated the declaration with being solely linked to public health, and the disparate outcomes that were made visible.

"But that's not what it meant," explained Diana Alexander, San Bernardino County assistant executive officer. "It meant that any kind of racism in a community impacts the health of the public area at large – because of the lack of access, lack of opportunity, the disparagement, the educational impacts, the health impacts, everything. It becomes a public health crisis."

Following Bernardino's San actions. the Riverside County Board of Supervisors unanimously voted to also declare racism as a public health crisis on Aug. 4, 2020. As the board recognized racism as a pervasive issue that upholds systems of inequity, they outlined a series of actions that county departments would take to extinguish inequitable practices.

The declaration called for the county to "identify and implement solutions to eliminate systemic inequity in all external services provided by the County including, but not limited to, the following sectors: Health; Social Services; Housing; Homelessness and Workforce...."

Three years after 31 jurisdictions made declarations, signed resolutions and outlined actions, the momentum to address racism as a public health crisis appears to have fizzled with residents not seeing much change to their neighborhoods or circumstances following the summer of protests. In some ways, the declarations seem like a distant memory or even a figment of imagination as focus pivoted to COVID-19 recovery and vaccination campaigns.

Were the declarations made by various governing bodies just words to appease enraged residents? And if not, how are residents able to hold their leaders accountable to their words and actions?

These are questions that led to the development and creation of the Racism as a Public Health Crisis Dashboard by research team Alex Reed and Candice Mays of Mapping Black California (MBC), a Black Voice News project that leverages data to support social justice initiatives. With support from The Starling Lab for Data Integrity at Stanford University and ESRI, Reed and Mays developed the dashboard which assesses governing bodies and nongovernmental organizations that passed resolutions acknowledging and declaring racism as a public health crisis — freezing those moments in time for the public to refer to.

Utilizing Starling Lab's technology, MBC was able to authenticate the declarations and related documents, securely storing it in digital ledgers, creating a record of origin for digital content (and moments in time) for the public to refer to in the future.

"We're creating copies of these things [so] that the minute they're captured — and we use some special tools to capture it, either Browsertrix or Webrecorder — it creates a fingerprint," explained Lindsay Walker, product lead at The Starling Lab for Data Integrity. captured."

By using web recorder and blockchain technology, The Starling Lab for Data Integrity creates "immutable content" that is impossible to fake or change pieces of content without leaving evidence of those changes

Blockchain can be described as a digital ledger with hundreds of computer systems recording and validating transactions. Walker described the process as how a bank keeps a record of transactions.

Consider how a bank keeps a ledger of debit card transactions and keeps a record of purchases made. With a bank, there's a single entity like Chase, who is confirming that a transaction occurred and the account holder and the payee trusts the bank's record of that transaction. Blockchain works in a similar way, but with thousands of entities (nodes) recording and confirming transactions. These same records can be kept for pieces of digital content like websites and photographs

"When a major social justice event happens, a lot of promises are made," Mays stated. "And then once the chatter around it, once the protesting around it, once the media around that event dies down — so do those promises."

Researchers identified declarations and sorted the contents using the American Public Health Association's (APHA) analysis template of resolutions as a foundation, and then modified the template to include particular "high needs" of specific regions across the state including COVID-19 and race specific identifiers.

The APHA released an initial dashboard that

tracked declarations made across the country, but was more broadly focused on howall communities of color have been impacted by racism. MBC's dashboard examines the impact of racism on communities of color and analyze show declarations planto address the systemic effects.

The rubric for examining resolutions divides them into two categories: Internal Policy & Governing and External Policy & Community Impact. Among the categories are criteria that includes several elements such as data & accountability, funding, community engagement and education. There are a total of nine elements outlined to analyze how declarations measure, such as which resolutions allocated funding or developed community listening sessions to address racism as a public health crisis.

The researchers examined different factors like census tracts and population sizes to determine population densities. Moreno Valley is identified as "Black dense" because Black people account for a great percentage of the total population.

"It's helping us as researchers target areas that need to have pressure put on them when it comes to making these declarations," said Reed.

Reed explained that including racial density markers allows other counties to learn from one another in terms of having a greater impact in communities that are Black and minority dense in the wake of the declarations.

At the time of the dashboard's publication, California led the country in resolutions and there are 10 states that do not have any resolutions, at any level.

Twenty-five of the 31 city and county governments that made declarations included specific strategic actions related to data & accountability including Riverside, San Bernardino, Oakland and Santa Cruz Counties. The dashboard measures this criteria by declarations that stated they would create a task force for the purpose of data collection, issue data reports or conduct data analysis.

"Our North Star is closing racial disparities," said Darlene Flynn, executive director of the City of Oakland's Department of Race & Equity. "We have to be able to measure whether or not our services are being equitably distributed, because we know that people of color's communities have been disinvested for 100 years on the west coast."

The Oakland Board of Supervisors is one of the few governing bodies that declared racism as a public health crisis later on - in June 2022. With its resolution came actions that called on the city to dedicate financial resources to gather detailed geographic data and allocate up to \$350,000 in funding for a Race and Equity Data Analyst and consulting services.

Other resolutions are less detailed regarding how they will carry out the promises made in their declarations, if any were made at all. For some declarations, acknowledgement of systemic racism was the extent of their actions.

At the height of the pandemic and on the frontlines of racial

unrest, adopting a Racism as a Public Health Crisis declaration was supposed to be a revolutionary act. Years later, for some governing bodies, the act of doing so appears to have been more of a spectacle than a tangible promise.

live in households that are food insecure, and its homeless population grew 12% over 2022, according to this year's Point in Time count.

So what do we get instead for \$6.9 million dollars? Flock Safety's technology captures still images of every vehicle that passes by a particular camera and the information is stored in a database for 30 days. However, the database also stores the color, make and model of each vehicle as determined by "artificial intelligence."

Why should we be concerned? I'll admit license plate readers have been around for a while so this is not necessarily breaking news. What is important to note about Flock and its license plate readers, however, is that "Flock is the first to create a nationwide mass-surveillance system out of its customers' cameras," the ACLU noted about the use of Flock by law enforcement across the nation.

Flock also allows private camera owners to create their own "hot lists." These hot lists, the ACLU explained, can generate alarms when one of the license plates listed is spotted. Flock runs all plates against state police watchlists, the FBI's primary criminal database, and the National Crime Information Center (NCIC).

Compared to other ALPR technology providers that take pictures of license plates, check them against a local hot list and then discard the data if there was not a match, Flock is reportedly building a massive camera network that captures every movement whether around the community or across the nation. That data of our movements is then available to be searched by any law enforcement agency contracted with Flock.

Certainly ALPR technology has its benefits especially in relation to AMBER Alerts, stolen cars, even for toll collection as noted by the ACLU. It is also important that the technology be deployed and used fairly and not just become one more tool the Sheriff Departments will leverage to over-police Black and brown people by deploying these license plate readers disproportionately in minority and low income communities. Residents should demand transparency regarding where they are currently deployed as well as the county's plans for future

deployment.

In March 2022 the ACLU issued a white paper about how Flock is building a new AI-Driven mass-surveillance system. It is important to educate ourselves on this issue.

Flock is making inroads across the county and recognizing that it is virtually impossible to stop a tsunami, there are still some things the community can push for to maintain some guardrails for privacy.

We can begin by demanding the Riverside County Board of Supervisors and the Sheriff's Department follow the guidelines by the state.

In late October, CA Governor Gavin Newsom noted in a press release, "[T]he majority of California law enforcement agencies collect and use images captured by ALPR cameras, but few have appropriate usage and privacy policies in place.

California law governs the collection, storage, sharing, and use of such data. Senate Bill 34 sets requirements to protect data collected through an ALPR system. This includes limiting with

whom this information may be shared. Also, Senate Bill 54, known as the Values Act, provides strict guidelines in the use of these databases to ensure information shared for immigration enforcement purposes is limited to the fullest extent possible in alignment with federal law.

Maybe we've already slid too far down the slippery slope of mass surveillance. Even so, it is never too late to ensure that the Riverside County Board of Supervisors and the Riverside County Sheriff's Department are in compliance with the guidelines established under Senate Bills 34 and 54. We must let officials know that we are watching and demand transparency and accountability.

Of course this is just my opinion. I'm keeping it real.

injection in the muscle, before or during RSV season. The use of this treatment is approved for infants born during or who are entering their first RSV season, and in children up to 24 months of age.

California Department of Public Health Director Dr. Tomás J. Aragón encouraged Californias to be vigilant about upcoming winter respiratory viruses in October, just before Halloween.

"As more people are heading indoors for school, fitness routines, and festive gatherings, Californians are getting exposed to respiratory viruses," said Dr. Aragón in a statement.


"Anyone can be affected by winter illnesses, however, some individuals, including older adults, people with weakened immune systems or chronic conditions, pregnant people and young children are at higher risk for severe illness and death."

He encouraged families to talk to their providers about vaccinations that are appropriate for individuals as updated COVID-19 boosters are now available. The CDC has updated guidance on updated COVID-19 vaccines manufactured by Pfizer-BioNTech, Moderna and Novavax.

Currently, the CDC advises that everyone aged five years and older should receive one dose of an updated COVID-19 vaccine to protect against serious illness from COVID-19. For children ages five to 11 years old who are unvaccinated or who have previously received a COVID-19 vaccine before September 12, 2023, the CDC advises they get one updated Pfizer/ BioNTech or Moderna COVID-19 vaccine.

Additionally, the Biden administration resumed free at-home tests where every American household can order free COVID-19 test kits through the United States Post Office. The government has also encouraged Americans to examine their previous COVID-19 tests that may have an expired date, but now may have an extended shelf-life after reevaluation by the FDA.

the CA vs Hate Hotline, and our collaborative efforts with the CDSS Stop the Hate grant. It is through these comprehensive measures that we will make a positive difference in the statistics we have seen persist for far too long."

Initially created by local government and community leaders in the Bay Area in response to white supremacist rallies in Berkeley and San Francisco, UAHW is an opportunity for local residents to take action in their communities under the simple, yet powerful principle that, when cities and their residents work together against hate, we can restore respect and discourse, embrace the strength of our diversity, and build inclusive and equitable communities for all. Through local events, sharing stories, holding rallies, and connecting with local institutions, UAHW, which runs from November 12 to November 18, is about working together to help combat a national and statewide increase in reports of hate. In California, reported hate crimes have continued to rise in recent years, reaching their highest levels since 2001 - jumping more than 20% from 2021 to 2022.

More broadly, California has continued to be at the forefront of efforts to combat hate. whether through civic engagement, nationleading investments in local anti-hate programs, and the first statewide commission working to track hate crimes and recommend policy. A key component of the state's anti-hate initiatives includes the recent launch of CA vs Hate that aims to help overcome barriers to reporting by offering people targeted for hate - and their communities - additional resources to report acts of hate through a community-centered approach that does not require engagement with the criminal legal system. Whether individuals report to CA vs Hate online or by phone, they are eligible to receive care coordination to ensure they can access resources and support, including legal, financial, mental health, and mediation services.

In the first six months since its official launch, CA vs Hate has been contacted by hundreds of individuals. Preliminary statistics from May through October show CA vs Hate received 513 reports of hate acts across California. Of those reports, 233 were made over the phone and 280 were made via the online portal.

In addition, more than 60% of all individuals who reported an act of hate accepted care coordination services, including direct and ongoing support accessing legal aid or counseling.

More than 75% of California's counties were represented in the preliminary data, up from approximately 40% in the first month following the official launch. Among the reasons cited for the report of hate, race (27%) and ethnicity (18%) continued to be the most reported bias motivations, followed by religion (13%) and sexual orientation (11%).

Approximately one in six reports were made by a witness or advocate. Most reports, however, were made by an individual who reported being targeted for an act of hate.
