KEEPING IT REAL

Sheriff Chad Bianco, Says "Yes" to Handcuffing Children With Disabilities

By any standard for an 11-year-old Black child (or any child for that matter) with disabilities to be tackled and handcuffed by school police is alarming.

But, that is exactly what happened in the Moreno Valley Unified School District (MVUSD) during 2019, not once, not twice, but on four separate occasions to the same student.

Watching a video of one of the incidents that occurred in early October 2019, tears at the fabric of human decency and our shared sense of humanity and compassion for children.

In the video you see the child sitting at his desk with his head down as the officers question him, give him commands and then within 30 seconds, grab him by his arms and shoulders, before proceeding to drag him from his desk, force him to the ground and place him in handcuffs. Even worse, you can see one of the officers use his knee to pin the child to the ground.

As might be expected, a federal lawsuit was filed against MVUSD, former District Superintendent Martinrex Kedziora, Riverside County, the Riverside County Sheriff's Department, and Riverside County Sheriff Chad Bianco for harm caused to the student.

We subsequently learned that MVUSD officials did everything in their power to obfuscate and delay discovery for nearly two years, in essence impeding the progress of the case, until a federal judge stepped in and ordered compliance. It is believed they did so based on an abundance of fear related to the possible impact it could have when the information became public.

It is so unseemly that these officials would work so hard to protect themselves but they gave little, if any consideration, to the mental health and wellbeing of this disabled child who suffered the abuse and potential impact it could have on him in the future.

With a 12% increase in homelessness based on the Riverside County 2023 Point in Time Count, news of the City of Riverside being granted a conditional award of \$4.375 million in state funds to help purchase as many as five homes to create 25 units of housing for young people who are homeless or in danger of becoming homeless is good news for the city and individuals who may benefit.

The local award was part of \$156.4 million in grants announced in November by CA Gov. Gavin Newsom to help cities and counties expand the availability of housing for individuals and

families experiencing, or at risk of, homelessness, according to an official press release. Across the state, 12 projects in six counties will create 556 new affordable homes. Riverside was the only project awarded in Inland Southern California.

"The City of Riverside's commitment to reducing homelessness focuses on preventing people from becoming homeless in the first place," Mayor Patricia Lock Dawson said in the press statement. "We know young people, particularly foster youth, are vulnerable and at high risk of becoming homeless, which is why these funds are so critical to our overall strategy

ung cancer is a pervasive and deadly disease that affects millions of people worldwide. It is the second most common cancer in both men and women, accounting for about 13% of all new cancer diagnoses. Despite advancements in medical research and treatment options, lung cancer remains a significant public health concern.

The American Lung Association (ALA) reports this disease is even more pervasive and concerning in the Black Community. "Black individuals with lung cancer were 15% less likely to be diagnosed early, 19% less likely to receive surgical treatment, 11% more likely to not receive any treatment, and 16% less likely to survive five years compared to white individuals," the organization notes.

Also, according to ALA, nearly two-thirds of the 28 million uninsured people living in America are people of color. Addressing racial disparities in healthcare coverage is critical to addressing the lack of adequate attention in lung cancer care. Studies show having health coverage impacts people's medical care and their health outcomes.

Most discussions about lung cancer included the issue of smoking and the tobacco industry's harmful advertising campaigns that targeted millions of people for about 180 years. From the typical "smoking is cool," and "just what the doctor ordered for calming one's nerves," slogans, big tobacco has grossly targeted vulnerable groups of people, and hooked them on one of the deadliest substances to hit the market.

Time and time again, we have seen messaging and targeted campaigns relating to smoking and lung cancer, encouraging people to quit smoking by showing some of the potential worse outcomes of the habit including the use of an oxygen tank, dependency on an electrolarynx to speak, or even worse—death.

Many of the ads have also focused on heart health, rather than smoking's obvious impact on the lungs.

Attitudes and acceptance of smoking began to shift with the Master Settlement Agreement (MSA) of 1998. The MSA determined the tobacco industry was grossly negligent in targeting specific groups and guilty of the addictions created from minty menthol and smooth ultra packs of cigarettes.

The MSA, however, focused on more than cigarettes. Chewing tobacco and other forms of tobacco were also included in the settlement.

Lung Cancer Disparities in Black Communities: Raising Awareness About Lung Cancer Screening

The American Lung Cancer Screening Initiative is on a mission to ensure the public is aware that lung cancer screenings are typically covered by most health insurance plans, Medicare and Medical and are available to all, regardless of an individual's background or how they identify. The purpose of the agreement was to ensure a reduction in usage of tobacco products, by not only making them much more expensive, but also to specifically prevent children and youth from getting addicted.

The agreement also eliminated tobacco companies' ability to advertise on television and billboards, prohibited the distribution of merchandise bearing the brands and names of tobacco products, and prevented tobacco manufacturers from advertising in newspapers

and magazines.

Impact of tobacco advertising on Black communities

Reports indicate the greatest concentration of tobacco company advertising was in African-American publications such as Jet, Essence, and Ebony. MSA impacted their advertising revenue. However, MSA impacted others as well. Many small, local publications and other media serving the Black community have found it extremely

Moreno Valley School District VOLATED **Disabilities Act: Landmark Ruling** by S.E. Williams Lawsuit against Moreno Valley Unified School District alleges claims of "repeatedly and violently striking and handcuffing an eleven-year-old Black student with disabilities.(Graphic by Chris Allen, VOICE)

Message from the editor:

On November 30, a federal judge ruled the Moreno Valley Unified School District broke the law and violated the American With Disabilities Act. It further ordered MVUSD to change its policing policy. It is believed this could be the first such ruling in the nation and could eventually change the state of policing in schools across the country.

The initials of the child in this case and his parents have been abbreviated to protect their identities.

On October 18, 2023 a federal court slapped Moreno Valley Unified School District (MVUSD) with a group of sanctions as punishment for hiding evidence.

The sanctions were in response to a federal lawsuit filed by HSRD

Partners David Clay Washington and Dan Stormer, in collaboration with Disability Rights California, Disability Rights Education and Defense Fund, and the law firm, Barajas & Rivera APC on February 4, 2021, seeking an injunction and damages against MVUSD, former District Superintendent Martinrex Kedziora, Riverside County, the Riverside County Sheriff's Department, and Riverside County Sheriff Chad Bianco for harm caused to the student.

The suit alleges claims of "repeatedly and violently striking and handcuffing an eleven-year-old Black student with disabilities, " the plaintiffs affirmed in a written statement.

In 2019, 11-year-old C.B., a Black child with disabilities in the MVUSD, was tackled and handcuffed by school police officers on four separate occasions in less than four months according to the suit. Why? According

to attorneys, because the child's disabilityrelated behaviors impeded his ability to respond to directions.

At the age of 11 years, C.B. was about four feet, eight inches tall and weighed only 70 pounds and yet in one of the incidents, officers handcuffed both his wrists and his ankles.

In a separate incident that occurred on October 8, 2019, the officers entered his





classroom to investigate reports that C.B. had thrown a rock the previous day.

While being questioned by the officers, C.B. sat quietly with his head down on his desk while the officers questioned him. But, in less than 30 seconds, the officers grabbed him by his arms and shoulders, pulled him from his desk and forced him to the ground where they handcuffed him. As C.B. laid there, an officer pressed his knee into the child's back.

The suit alleges school police officers "used excessive force and discriminated against C.B. based on his disability and race when they "violently handcuffed him multiple times on MVUSD middle school campuses."

The suit further asserts the "defendants' actions, inactions, policies, practices, customs, and procedures violated and continue to violate

C.B.'s rights under the U.S. and California Constitutions, the Americans with Disabilities Act, Section 504 of the Rehabilitation Act, and multiple state civil rights laws, in addition to several common law torts."

In a statement released by Disability Rights California, C.B.'s father, W.B., declared, "No student should have to experience what our son endured. No police should slam a child to the ground and handcuff them when they aren't doing anything wrong. My son had his head on his desk, being very calm, as he'd been instructed to do."

He continued, "My son should not have had to call me from the back of the police car begging for help, while school officials where the incident occurred, didn't even know what had happened. This disconnect exposes several serious problems. There should be better staff or therapists to help disabled children, and there should not be police at schools, especially when they abuse students that they are not trained to serve or support."

MVUSD accused of hiding evidence

What happened to C.B. is shocking by any standards and what followed has raised an alarming red flag about the ethics of administrators and others involved within MVUSD.

According to details revealed by the legal team who report that for two years and throughout the course of discovery in this case, MVUSD avoided its legal obligation to produce documents and witnesses, "presumably because it was aware of the devastating effect the truth would have if it came to light."

As a result, the plaintiffs' attorneys successfully requested and were eventually granted judicial orders that levied monetary sanctions on MVUSD for its failures in this regard. But, despite these measures, attorneys claimed MVUSD continued to hide Demetrius Owens and Loniesha King, members of the MVUSD security staff who are named as defendants in the case. Both failed to appear for their depositions and even after they were ordered by the court to appear the school

district claimed to have lost contact with King, while other school witnesses either "refused to appear or appeared but [claimed they] had no knowledge of the subjects for which they were called to testify."

According to plaintiffs, the district made repeated attempts to hide the gravity of their systemic abuses of the children entrusted to their care. The coalitions tenacity eventually bore fruit and it was able to gather sufficient evidence that proved beyond all doubt that MVUSD not only authorized its school security and police to handcuff and shackle students without any regard for their disabilities, it also failed to train its school security and police about the special needs of students with disabilities.

Even further, at the school district's direction, MVUSD staff relies on these untrained security officers when a student engages in disability-related behaviors, according to a press statement by Hadsell Stormer Renick & Dai LLP.

When the court ruled on October 18, 2023, it adopted a previous Magistrate's ruling that chastised MVUSD for its "pattern of producing unprepared witnesses, only to withdraw them at the time of deposition, or to cancel the deposition altogether." The Court also chastised Defendants King and Owens, declaring their "failure to follow through on their promises and comply with the court's order has effectively concealed evidence from plaintiff to plaintiff's prejudice."

Students with disabilities are almost nine times more likely to be handcuffed, shackled, and referred to law enforcement than their non-disabled peers. In addition, the ACLU reports that in California, although Black and Latino boys with disabilities are 5% of the state's students, they account for 13% of referrals to law enforcement and 15% of school arrests. The ACLU also found that Black boys with disabilities suffered an arrest rate 5 times the rate for all students.

The plaintiffs pressed the court for a summary judgment on C.B. 's behalf under the Americans with Disabilities Act and Rehabilitation Act, successfully arguing that it is "undisputed that MVUSD's policies deprive disabled students of their rights under these acts."

Although defendants filed a motion to have the case dismissed, on June 17, 2021, a federal judge disagreed, denying their motions and in the process, allowing the lawsuit to proceed.

HSRD partner David Clay Washington called the ruling "a great victory for MVUSD's over 4,000 children with disabilities who have been disregarded and suffered violence for far too long at the hands of administrators, police officers, and security staff."

Attorneys are now gearing up to go to trial on C.B.'s remaining claims, which include excessive force, assault, battery, intentional infliction of emotional distress, and negligent supervision.

Policing in MVUSD

MVUSD, the Riverside County Sheriff's Department (RSD), and Riverside County, partner in the operation of a discipline system that, according to the plaintiffs, discriminates against students with disabilities and Black students, including Black disabled students. Although MVUSD employs its own Campus Security Officers (CSOs) it also contracts with RSD to provide School Resource Officers (SROs) at its schools and calls on both teams of officers—identified as school police officers to 'respond with physical force' to minor and/ or disability-related behaviors that could be managed by teachers or administrators with less harmful methods, such as crisis intervention, de-escalation, patience, communication, and waiting, the plaintiffs assert.

A tort claim was submitted to the defendants

in June 2020, that gave formal notice about the alleged harm to C.B. and sought to eliminate such discriminatory disciplinary practices going forward by replacing them with meaningful accommodations designed to protect and support all students, including those with disabilities.

Shortly after the tort claim was submitted a "Study Session" was held on July 23, 2020 to gather community input regarding the School Resource Officers (SRO) program. During this Session, the MVUSD School Board received nearly fifty public comments, with all but five urging it to abolish the SRO program and reinvest its \$1.3 million-dollar budget in "mental health supports, restorative justice, culturally relevant curricula, and other non-police programming." The Board, however, did not abolish the SRO program nor did it invest in any of the recommended alternative solutions.

The suit also demands MVUSD stop school police officers from mechanically restraining students and intervening in low level and disability-related behaviors, up to and including ordering school police officers to cease patrolling district schools. On November 30, a federal judge ordered MVUSD to change its policing policy.

"Across California, schools are eleven times more likely to subject Black children with disabilities to police than white non-disabled children. As C.B.'s experiences illustrate, MVUSD over-polices its students, particularly disabled students and Black students. Officers' use of force against students creates a dangerous and traumatizing school environment," said Lindsay Appell, Staff Attorney, Disability Rights California.

The judge stated in his ruling that "County Defendants set forth a bewildering argument to dismiss plaintiff's racial discrimination claim."

The Centers for Disease Control and Prevention, reported that nearly 72 percent of children in this country will have experienced at least one major stressful event — such as witnessing violence, experiencing abuse, etc. before the age of 18. As a nation, however, we invest more in school policing than in mental health services in our schools.

According to a report by the ACLU, funding for police in schools has been on the rise, while public schools face a critical shortage of counselors, nurses, psychologists, and social workers. The recommended Student-to-Counselor Ratio is 250:1. Here in California however, the ratio is 682.1.

I agree with advocates calling for the redirection of funds away from school police to mental health services. Data shows the presence of school-based mental health providers not only improves outcomes for students, but can also improve overall school safety.

By contrast, there is no evidence that increased police presence in schools improves school safety.

In the meantime, you can almost take it to the bank that as with any issue involving Riverside County deputies, Sheriff extraordinaire, Chad Bianco, will find his way to a camera for an opportunity to comment. The fiasco in the Moreno Valley Unified School District is no exception.

Last week, during an interview with KCAL News related to this issue Bianco was asked by the news host, "Does any child that small need to be handcuffed?" At the time of the four incidents that occurred in 2019, the child was only four feet, eight inches tall and weighed about 70 pounds.

After pausing and nodding his head up and down silently for several awkward seconds, Bianco finally responded with a one word definitive answer, "Yes."

Bianco then added with a straight face, "On that video I saw nothing that would cause me, as the sheriff or leader of deputies, that could have been handling that, that would have caused me to say 'Oh my gosh, What did he do?"

As is sometimes the case, in the interview it

seems Bianco strives to have it both ways. On the one hand he's purportedly said previously as paraphrased by the news host, 'you can't go by what one sees in a video... that no one can fairly assess that need with one piece of video, one snapshot, one perspective.' And yet, in this instance Bianco asserts that what he sees in this video is enough to make a judgment. That what he viewed in the video was enough to state that nothing he saw would cause him concern as sheriff.

Is Bianco the only one who gets to have an opinion?

In other words, Bianco is challenging us with the old adage, "Who are you going to believe, me or your lying eyes?" Here is a clip from Bianco's interview. I encourage you to watch it.

After reviewing the interview clip I also encourage you to then take a moment to read this week's feature where you will find a link to a video of the incident involving the 11 year old child with disabilities described above and learn why the federal court just made a landmark ruling that the Moreno Valley Unified School District broke the law and violated the American With Disabilities Act.

You be the judge.

Of course, this is just my opinion. I'm keeping it real.

The county asserted that Plaintiff is "[p]laying the race card" by alleging that he is Black and that "there are no factual allegations nor any evidence to support any race based discrimination on the part of the county defendants."

The judge further pointed out that the county appeared to have missed paragraphs in the complaint that allege "[t]he Sheriff's Department's school arrest data show that Black students are more likely to be arrested and

arrested for non-violent offenses than their non Black peers."

Even after being directed to these allegations by the plaintiffs, the county defendants doubled down on their "race card" argument, according to the judge, arguing in their reply that "Plaintiff is in fact playing the race card because there are absolutely no allegations related to any county defendants that plaintiff was discriminated against, in any way, based on his race...."

The judge disagreed and noted that although the county may disagree with these allegations, merely dismissing them as "playing the race card" is not a legal argument, noting the court expects the county defendants to address racial discrimination claims with the same rigor as any other claims, by offering legal authorities and arguments as to why they fail. Instead, he stressed, the county chose to respond with "facile jargon, which is both offensive and legally insignificant." He advised that the county defendants must do better as he rejected their "race card" argument and their other points of contention by allowing the case to continue.

Attorneys are now preparing for trial on C.B.'s remaining claims.

difficult to find other sources of advertising revenue. Although tobacco advertisements helped fuel— the economy, Black consumers were highly targeted. Many may now be experiencing poor health outcomes as a result.

In response to systemic racism and police violence disproportionately affecting Black communities the Black Lives Matter (BLM) movement emerged as one of the most powerful social and civil rights movements in modern history. At its core, the movement advocates for the acknowledgement, protection and empowerment of Black people by highlighting the need for systemic change to address deep-rooted inequalities.

The rallying cry, "I can't breathe," became the slogan for the movement following the death of

Eric Garner at the hands of an NYPD officer for allegedly selling single cigarettes.

Many believe that if all lives matter, we need to look at how we have treated smokers both in the past and the present. Those who have become addicted to nicotine, are victims, and should be treated with care, non-judgment, and grace.

Veterans' Well-being: Addressing Smoking, Mental Health, and Lung Cancer Risks

The well-being of veterans is intrinsically linked to the overall health of our society. By fostering a culture that cares for those who have served, we contribute to the creation of a more compassionate and supportive community. Veterans bring valuable skills, discipline, and leadership qualities to the civilian workforce, enriching our society and economy.

Many of our veterans and active military began smoking upon entering their respective branch of the military—38 percent of current smokers in

the military began smoking after joining.. It also became a way to escape from the horrendous experiences of war and being on the frontline of the battlefields in foreign lands.

Other factors related to lung cancer and veterans include Agent Orange, in which over 300,000 U.S. Veterans and close to a half-million Vietnamese died from the exposure of the herbicide between 1962 and 1971. Additionally, inhalation of asbestos has been linked to the increased risk of lung cancer as well. Many of our service members went to work in factories and other industries that severely exposed them to the deadly substance.

The mental health of veterans is a critical concern. Many struggle with post-traumatic stress disorder (PTSD) and other mental health challenges as a result of their service. Many of these individuals turned to substance abuse, whether it is the use of tobacco products or illicit drugs.

Anyone with lungs can get lung cancer

Over the years, many advocacy and awareness organizations werebirthed with the sole purpose of raising awareness and focusing on lung cancer survivorship.

The American Lung Cancer Screening Initiative, the White Ribbon Project, and Team Draft, just to name a few organizations, have all burgeoned to ensure that those lost to lung cancer, their families who have supported them, and those who are still surviving and/or have beat the disease, are receiving their due recognition, support and love from mainstream groups.

An example of a soul taken too soon from lung cancer is Lakeasha Rutledge Draft, co-founder of Team Draft and wife of retired NFL player Christopher Draft. Keasha was a healthy, vibrant, and intelligent individual, who was preparing for a marathon, when suddenly she experienced trouble breathing. From the time of her diagnosis in late 2010 until her ultimate departure from life in December 2011, she remained vigilant in her efforts to increase awareness about the disease and the importance of listening to one's body. Keasha and Chris made a commitment to change the face of lung cancer.

In 2020, the White Ribbon Project began due to the frustration of survivors and loved ones alike, who felt ostracized due to their lung cance even when they did not have a history of smoking. This sparked the movement to build community amongst families who have been affected by lung cancer, reframe education around the disease, increase awareness globally, and remove the stigma against the lung cancer community as a whole. "Anyone with lungs can get lung cancer," said Mayo Clinic physician, Cathy Madaffari, herself a victim of lung cancer.

Environmental Impacts in the Inland **Empire**

Another factor related to the increase in lung cancer is environmental impacts. Increased rates of lung cancer and respiratory related illnesses are prevalent within communities of color and among families who live in low income communities.

According to the American Lung Association, the Inland Empire has the highest concentrations of ozone in the country and deemed as the top 2 of the most polluted places to live. In San Bernardino County alone, unhealthy air quality days rose from 14.8% in 2019, to 19.7% in 2020. This is even during the global shut down due to COVID-19, in part because of the high demand of online shopping and the increase of consumer demand for products via online shopping during this period.

Earlier this year, The Center for Community Action and Environmental Justice (CCAEJ), released the Region in Crisis Report, along with 60 other advocacy organizations throughout the region, urging Governor Newsom to declare a State of Emergency for the Inland Empire due to the increase of warehouses being built, thus the exponential increase of logistics and trucks commuting through the region.

Dr. Loretta Erhunmwunsee, thoracic surgeon and health disparities researcher at City of Hope, shared recently the effects of particulate matter 2.5 (PM2.5), which is the chemical that we see during high smog days in the Inland Empire, though much of it we cannot see, affects us all the same. Experts believe the push for clean energy and resources for low income, and Black and Brown communities, should be a priority for local and statewide initiatives because we all deserve to breathe clean air.

Improving access to lung cancer screenings and treatment has now been taken seriously by legislators and policymakers with the passage of H.R. 4286, cited as "Increasing Access to Lung Cancer Screening Act." The bill makes it apparent that medicaid will cover the cost of annual lung cancer screening with no cost sharing for certain individuals.

In 2020, California passed a law (SB793) banning the in-person sale of flavored tobacco products. like candy-flavored e-cigarettes and menthol cigarettes, at stores and vending machines. On the ballot in 2022, Proposition 31 maintained the prohibition of the sale of flavored tobacco and enforced the ban on menthol. Other tobacco cessations have shown that legislation is effective in protecting the general public. This ban helps to protect California's future.

Lung cancer screening

The American Lung Cancer Screening Initiative is on a mission to ensure the public is aware that lung cancer screenings are available to all, regardless of an individual's background or how they identify.

Oftentimes, individuals with a history of smoking may not go for screening because first, they may not be aware that lung cancer screening is available to them; and second, they may carry guilt and shame if they are a smoker or have a smoking history. Dispelling the stigma will remove some of the barriers that prevent people from seeking care by way of screening.

Lung cancer screenings, that cost between \$300 and \$500, are typically covered by Medicare and Medicaid and most private insurance companies. If you have questions about your insurance coverage of lung cancer screening, confirm with vour carrier.

Early detection is crucial for improving lung cancer outcomes and all factors must be taken into consideration. Diagnostic procedures may include imaging tests such as chest X-rays, CT scans, and PET scans. Biopsies, where a small sample of tissue is removed for examination, are often necessary to confirm the presence of cancer and determine its type.

Advocating for the lives of others and ensuring that we continue to represent lung cancer survivors with the dignity and care that they deserve."If the people don't see each other and see value in each other, we can't make [the] difference that we want to see. We must care about the people," stated Draft.

November is set aside as Lung Cancer Awareness month. As the month draws to a close we encourage you to share information with your loved ones about the importance of lung cancer screening.
