ne hundred students at Ramona-Alessandro Elementary School were the first of 4,000 transitional kindergarten and kindergarteners from San Bernardino City Unified School District to be gifted a free book from First 5 San Bernardino as part of its Gift a Kid a Book campaign last Friday.

According to First 5 data, literacy rates in young children have declined since the pandemic, and Gift a Kid a Book wants to encourage people to consider the gift of reading this holiday season.

First 5 San Bernardino, which focuses on the early development of children under 5, created a winter wonderland to kick off the book gifting.

During the event, students at Ramona-Alessandro shared in a book reading of "Give a Mouse a Cookie," a holiday sing along and a surprise visit from Santa and Mrs. Claus.

or weeks, residents in Temecula have gathered signatures for a recall in an effort to break the far-right majority on the local school board whose conservative edicts have left students, parents and teachers in turmoil.

effective November 15. The board had typically split 3-2 as it enacted its policies.

Gonzalez listed his Temecula home in October, and sold it this week. Gonzalez told The Press Enterprise in a text that he is moving to Texas "for the next couple years."

"We have decided to live out on our 40 acre ranch and raise cattle and horses." In a letter to district staff, Gonzalez said, "It was a privilege to serve the Temecula community."

At his last board meeting, before announcing his resignation, Gonzalez gave remarks that resembled a farewell speech at the conclusion of the meeting.

"I am really proud of the accomplishments of this board this year," Gonzalez said. "It's rare when a community elects somebody to do something and they do exactly what they said they were going to do, down to the letter, and this community elected three of them."

He also accused fellow board member Steven Schwartz, who is Jewish, of having "vile contempt" for Christians.

"I don't know how people who claim to be Christians can have so much hate in their hearts," Schwartz said in response.

Gonzalez did not respond to a request for a comment.

The resignation comes just a week after volunteers from the One Temecula Valley PAC submitted more than 5,200 signatures calling for a recall of the school board's president, Joseph Komrosky, Gonzalez and Jennifer Wiersma, another member of the conservative bloc, were also targeted for recall but the PAC elected to focus on Komrosky instead. Neither Komrosky nor Wiersma responded to a request for comment.

The conservative trio enacted bans of critical race theory; created a forced outing policy for transgender and nonbinary students; and recently changed board policy to ban "pervasive pornography," profanity and vulgarity from district learning materials. The recent ban stems from a parent's complaint that her daughter was assigned to read the play Angels in America, which examines the AIDS epidemic in the 1980s.

Truancy rates for students in the state of California and across the country are again an area of concern.

During the COVID-19 pandemic, educators, parents, government officials, and community organizations have diligently tracked the effects of chronic absenteeism on student achievement. Chronic absenteeism, involving missing ten percent or more of the school year, has persistently raised concerns among educators, presenting challenges both academically and financially. School districts rely on student attendance for funding, and academic success, another crucial metric, has consistently demonstrated a correlation with attendance.

During the COVID-19 pandemic, educators, parents, government officials, and community organizations have diligently tracked the effects of chronic absenteeism on student achievement. Chronic absenteeism, involving missing ten percent or more of the school year, has persistently raised concerns among educators, presenting challenges both academically and financially. School districts rely on student attendance for funding, and academic success, another crucial metric, has consistently demonstrated a correlation with attendance.

According to the Brookings Institute, "Physically being present in school is one of the most basic conditions for a student's success – if students are not in school, they are not learning what is being taught and could be falling behind in earning the course credits needed to graduate."

Mixed Picture Since Onset of Pandemic

The picture of chronic absenteeism is mixed. Recent student assessment scores show academic improvement over pandemic levels especially among some of the state's oldest and youngest students who, according to the organization Policy Analysis for California Education or PACE, a non-partisan policy institute that partners with governmental institutions to create public policy.

When discussing the latest academic achievement indicators, California State Board of Education President Linda Darling-Hammon

stated, 'These results suggest that California's public schools are beginning to turn the corner on pandemic recovery, with gains on most assessments and a substantial reduction in chronic absenteeism, especially for our most vulnerable groups of students.'

While some indicators are positive, others are still being assessed.

Pandemic Raised Additional Concerns

According to the nonprofit news organization EdSource, an analysis of 30 districts statewide, shows that nearly a third of public school students were chronically absent, — meaning that as of late March, they had missed 10% or more of the school year. That's slightly lower than the same point last year.

However, chronic absenteeism is still considerably higher than before the pandemic continued on page 13

The San Manuel Band of Mission Indians and the Los Angeles Dodgers Foundation joined the City of San Bernardino for a groundbreaking ceremony on December 14, to kick off construction of three new Dodger Dreamfields at the City's Blair Park. Also in attendance were Dodger outfielder Jonny Deluca and third base coach Dino Ebel.

The fields at Blair Park represent the 61st, 62nd, and 63rd baseball and softball fields built or refurbished by the Los Angeles Dodgers Foundation since 2003.

"Everyone deserves a space to play," said Nicole Whiteman, CEO of the Los Angeles Dodgers Foundation. "We couldn't be more thrilled to bring this vital resource to San Bernardino, a city with such great history."

The \$1.7 million investment will support youth baseball and softball. The refurbishments will include new playing surfaces and grass, enclosed fields, upgraded dugouts, upgraded irrigation systems, new pitching mounds, bullpens and LED scoreboards resembling Dodger Stadium. The project is expected to be completed by June 2024.

Fontana's Silent Tragedy: O'Day Short Family Legacy and a Time for Reconciliation

t was the mid-1940's when white racist extremists terrorized and murdered a young Black family with a vitriol and animosity that rivaled any of the worst race-based atrocities experienced by Blacks in the depths of Dixie. But, the incident did not occur in the deep south, this quadruple homicide happened right here in the inland region in the city of Fontana when the family dared to move into a white's only neighborhood. When President Franklin Roosevelt passed the New Deal in 1933, the nation faced a housing shortage. According to Richard Rothstein, author of "The Color of Law", this deal set the stage for a federally sanctioned program that was explicitly designed to not only increase the nation's

housing stock, but also to intentionally segregate it. In essence, according to Rothstein, and as noted by NPR, the housing programs that flowed from the New Deal were nothing short of a "state-sponsored system of segregation." Racists in America leveraged the concept of housing segregation to the extreme using restrictive covenants to work their will.

It would be 15 years (1948) before the U.S. Supreme Court, in the case of Shelly v Kraemer, determined that the government could not enforce restrictive covenants and prohibitions placed on houses, a process that undergirded redlining and prevented Blacks and other minorities from buying homes and living in communities of their choice.

- Dr. Daniel Walker Chair/Arts Initiative Director, Blu Educational Foundation Before the high court's decision, the housing restrictions— including covenants and prohibitions—were perceived as the easiest way to keep Blacks and other minorities out of white neighborhoods. When that failed, however, white homeowners and other community members often took extreme measures to ensure their neighborhoods remained all white. These measures—more often than not—involved violence.

This was the case in 1946, during the peak of redlining and two years before the Supreme Court ruling, a time when racists took extreme measures in the city of Fontana that O'Day Short crossed the color line and bought a home for his family in Fontana. As a Black man during a tumultuous time, his realization of the American Dream came at an unreasonable and extremely high price—it cost him his life and the lives of his wife and two young children.

After being threatened by the local sheriff, Short was not deterred and moved his family into their new home. Sadly within weeks of settling in, the family was killed when their home was bombed. Short's wife and two young children died immediately but Short remained alive for about a month before he ultimately made his transition according to the Color Lines in San Bernardino project.

Dr. Daniel Walker, Board Chair/Arts Initiative Director of the Blu Educational Foundation was the inspiration behind the push to establish the O'Day Short Family Unity Garden to commemorate the lives of O'Day, Helen, Barry and Carol Ann Short at the Randall Pepper Elementary School.

In an exclusive exchange with Black Voice News, Walker shared what moved him to champion this initiative. "The fact that I attended [Randall Pepper Elementary School] and experienced some of the most hurtful things young people can do to one another was already a point of pain and anger for me," he began when asked to share about his involvement with the O'Day Short Family Unity Garden and why he felt it was so important for the community to have this memorial.

Years later, when Walker attended college at San Diego State University he introduced

himself as being from Fontana in a class taught by California's current Secretary of State, Dr. Shirley Weber. "She asked me if I knew the story of O'Day Short and his family."

Walker said when he told Weber he knew nothing about the incident, she sent him to the library to research the story. "When I read more, I knew that the spirits that were working so hard against my existence in that school at that time were the same spirits that killed O'Day, Helen, Carol Ann and Barry Short."

Walker explained how he couldn't figure out which part of the tragedy riled him the most. "Was it the murder of an entire family for simply wanting to live the American Dream? Was it that Barry and Carol Ann were elementary schoolaged children and that the Fontana Unified School District bought the land and put an elementary school right on top of their ashes? No, I know what it was...It was the almost 80 year silence and erasure of their lives," he declared.

For 30 years Walker said he's been telling the O'Day Short family story wherever he went, especially in education settings given that the district still allowed the KKK to use its school facilities for their meetings as late as the mid 1980s.

In 2016, a group of concerned residents including Eduardo Gil, Ipyani Lockhart, and the descendants of Jesse Turner, a Fontana organizing legend, began pushing the school district to acknowledge the crime committed there, to memorialize the family, and to begin a process of using this incident as an opportunity for dialogue and deep programming about unity, growth, and reconciliation, according to Walker.

"In 2020, during COVID, I was the orientation day speaker for all of the employees in the district via zoom and I highlighted the story. When many in the district heard it for the first time." Walker noted how they did their

research, began to take action. It was these actions, from the ground up, that resulted in the Unity Garden.

"For me, to speak at this dedication exorcized 40+ years of hurt, and replaced it with deep hope for my community, the nation, and the world," Walker concluded.

Despite the Supreme Court ruling in 1948, racists and restrictive practices in housing persists, though they often rest on more subtle means like mortgage denials for example.



This has prompted action by school districts around the country to develop tools to address the ongoing issue of chronic absenteeism.

At Riverside Unified School District (RUSD), a dedicated group of education professionals are actively addressing the truancy crisis. They are committed to fostering collaboration among students, parents, and the community, working together to ensure that students are present in school and prepared for learning.

They have achieved success with the district's Attendance Matters: Showing Up Together Campaign. A powerful initiative that motivates students to attend school by not only recognizing outstanding attendance but also celebrating improvement. Awards are given to students with the most improved attendance rates, focusing on those who were chronically absent. Additionally, special recognition is extended to English learners, students with disabilities, and children in foster care who demonstrate significant improvement in attendance. This

comprehensive approach underlines the district's commitment to fostering a culture of attendance and inclusivity.

Another way RUSD addresses the importance of school attendance is through the RUSD Foundation which works with volunteers and community nonprofit organizations to enhance the learning experience and ensure students' academic and artistic success.

RUSD makes important attendance resources readily available to students and parents:

Attendance Resources and Information Page

The district's attendance resources and information page provides news and information on the district's attendance policies as well as community resources.

RUSD Foundation

Provides educational enhancement for students through district and community engagement.

The Black Voice News spoke with district representatives about the situation, what the district sees as important to addressing the issue and where the district currently stands regarding absenteeism. The conversation included Tim Walker, Deputy Superintendent and Raul Ayala, Director of Pupil Services.

Studies show that some of the most vulnerable students are those who are not attending school regularly. Students considered habitual truants or who have an excessive number of absences are subject to closer monitoring as part of the School Attendance Review Team (SART) process. During SART, parents of chronically absent students work with school professionals to determine the cause of the problem in order to assist in providing the help a family needs to be successful. If chronic absence continues however, students can be referred to the Student Attendance Review Board (SARB) for a hearing. If there is still no improvement, SARB may refer the case to the court.

RUSD extends support

RUSD provides students with support and it is working. Its latest attendance results are considerably above the national average with a 95.95 attendance rate, as good as any before the pandemic.

Families can get attendance and contact information on the attendance resources and information page. Families may also visit the district webpage to get the information they need about news, events, meetings and special programs. , the latest news on COVID-19, distance learning, classes for students who cannot attend school directly and board meetings, as well as news regarding important events on the district's website.

Gonzalez's resignation comes as a blow to the conservative effort to push the school district to the right, a trend in many suburban school districts across the nation.

This week, California Attorney General Rob Bonta filed a brief in support of a motion by Temecula students, parents and educators to halt the enforcement of policies that forbid instruction about race and gender and force teachers to out students to their parents.

The motion is part of a lawsuit that was filed by a coalition of parents, teachers and students in August. A hearing on the motion for a preliminary injunction, which would prevent the board from enforcing the policies while the case proceeds, is scheduled for January.

"The attorney general's message is clear. Every student in California deserves a secure and inclusive school environment, which is critical to the health of our democracy," said Amanda Mangaser Savage, a senior attorney at Public Counsel who is representing the plaintiffs. "They're being denied essentially for preparation for college, for careers, and then maybe even most importantly, for participation in a diverse and multiracial democracy."

The UCLA Bruins snapped a nine-year bowl game drought by beating the Broncos of Boise State on Saturday night, in the third annual LA Bowl at SoFi Stadium in Inglewood, 35-22.

Initially played in 2021 as the LA-Kimmel Bowl, matching teams from the Mountain West against the 5th pick from the PAC 12, Boise State (8-6) won the Mountain West Championship and earned their birth against the Bruins (8-5) who earned their bid out of the PAC 12.

The name "LA Kimmel Bowl" gave way to the Starco Brand's LA "Gronk Bowl" this year. So, the LA Bowl, by Gronk was born. The former four-time Super Bowl winner and former NFL All-Pro, Rob Gronkowski sang the national anthem prior to kick-off and embraced his host role with boundless enthusiasm.

UCLA's Colin Schlee connected on a fiveyard touchdown pass to Hudson Habermehl, taking a lead 7-6. Boise State running back George Holani (Bellflower) scored to increase the Bronco lead to 16-7 in the second quarter. Holani would gain an impressive 138 yards on the day.

Trailing 16-7 in the third quarter, Bruin quarterback Colin Schlee (11 of 16 passing) ran the ball on a 44-yard keeper and nearly scored on the play. Dazed after the hit, Schlee would be replaced by Ethan Garbers. UCLA running back TJ Harden had 105 yards rushing and two scores on the night.

The Bruin offense under Garbers imposed their will over the Broncos in that second half. He completed his first eight passes, including a 40-yard gem to J. Michael Sturdivant in the fourth quarter. Garbers was 9 of 12 passing for 152 yards and three touchdowns to earn Player of the Game honors. Bruin wide receiver J. Michael Sturdivant had 142 yards on four catches and a score.

seat. The appointment process would include advertising the post and creating a subcommittee made up of two board members to confirm the eligibility of any applicants. Prospective school board members would then be interviewed at a public board meeting. A board majority would need to approve the appointee, which may be difficult given the board's new 2-2 split.

"This year has been part of our community, and the school board has been chaotic and contentious. This news means that we can breathe a sigh of relief," said David Matics, co-founder of One Temecula Valley PAC. "But the work isn't done. A 2-2 split board can still prevent our students from having textbooks at the start of the year or delay paying teachers the cost of living adjustments they've earned."

If the board does not make an appointment, a special election will be held. The winner would serve the remainder of Gonzalez's term, which runs until December 2026.

Schwartz said a special election could cost up to \$200,000. "I don't want to call a special election. The board has already wasted enough money." Since the conservative members were elected, the district's legal costs have risen from roughly \$17,000 in 2022 to more than \$81,000 this year — an increase of about 377%. "I want to get back to focusing on the children."

"These fields not only represent a place to play, but a place to dream," added Mayor Tran.




